

Editor's Notes

This issue has several articles featuring women, which is a nice change.

Many records from Ireland that were once found only in Dublin or Belfast are now easily researched online. Your editor demonstrates research in several important databases of Irish records in her article about Nellie (Kiely) Halverson of Bridgeport. The Irish records provide evidence for identifying Nellie's birthplace, parents, and seven siblings.

Our 1790 United States census sketches continue with an article about Widow Catherine Olmsted by her kinswoman Patricia Haslam who has contributed several articles to *Connecticut Ancestry*. Catherine lived a long life after the early death of her husband.

Thomas Mindrum previously published in this journal a 1790 sketch of Jeriel French of Huntington. Tom had 25 ancestors living in Fairfield County 1690-1699. In this issue he provides the stories of eight of them: Francis Andrews and his wife Ann, and three generations of Luke Guires and their wives. The first Luke Guire has a single record that names him; he's further defined by records pertaining to his wife Mary (Adams) Guire. We look forward to publishing the stories of additional Mindrum ancestors.

Greens Farms Parish marriage records are concluded in this issue. Look for death records next time. The original registers, held at Fairfield Museum and History Center, have been transcribed by Barbara Dempsey.

Finding Home and Parents in Ireland for Ellen "Nellie" (Kiely) Halverson of Bridgeport

Records in the United States show that Ellen (Kiely) Halverson was born in Ireland about 1865-1870. What research steps should be followed to identify her place of birth in Ireland, confirm the names of her parents and identify siblings?

Nellie in United States records

"Nellie Kiley" married Henry W. Halverson in Bridgeport, Fairfield, Connecticut, on 14 January 1894. At that time the names of the parents of the bride and groom were not requested on the license. Nellie was 24 years of age and born in Ireland. It was her first marriage. Her birth year calculated from her age in this record is 1869-1870.

Nellie died 18 June 1950 in Bridgeport. This record also reports a birth in Ireland. It adds three facts not previously known: birthdate 24 June 1865; father's name Patrick Kiely; and mother's maiden name Margaret "Kellaher." The informant was her daughter Mrs. Harry M. Quinn.² An obituary named her birthplace as "Ireland," and listed as survivors son Harry Halverson of Bridgeport, and daughters Mrs. I. Silvera of Los Angeles, Mrs. Harry M. Quinn of Bridgeport, and Mrs. Paul McElroy of Stratford, and a brother Timothy Kiely in Ireland.³

Nellie was buried in St. Michael Cemetery, Stratford, Connecticut. There is no marker on her grave which eliminates that potential source of information about her place of origin.⁴

A number of individuals with the surname Kieley, Kiely, Kiley or Keily lived in Bridgeport, but no one named "Ellen" or "Nellie" was listed under those surnames 1880-1895 in the Bridgeport City Directory.⁵

Reported ages and immigration years

Often the ages of 19th-century Irish immigrants vary across records. The ages reported for Nellie in US records, the birth years calculated from those ages, and the reported years of immigration were collected into a table for comparison. The span of possible years is fairly small.

Immigration/Naturalization

Sometimes immigration and naturalization records can provide helpful information about a research subject. In the time period covered by the 8-year range reported for Ellen's arrival, ship passenger lists contained only names, ages, *country* of origin, marital status, and sometimes occupations for immigrants. They usually did not include a place of origin in Ireland or a destination in the United States. Several young women with the name were found on passenger lists of ships arriving in Boston and New York. It was not possible to identify which (if any) of these women was the Ellen under study due to vague ages, general occupations, lack of information about origins, and unknown year of arrival. ¹⁵

Ellen became a citizen of the United States upon her marriage to Henry Halverson, and there was no document generated to prove her citizenship or to shed light on her origins.

Church records in the US

The genealogical proof standard requires a reasonably exhaustive research. This would include birth, marriage, death, and baptism records of all of Ellen's children. Roman Catholic church records of Ellen's marriage and the baptisms of her children should provide the names of witnesses and godparents who could be friends or relatives from Ellen's home in Ireland. A request to St. Augustine Parish for those records has not received a response. Because

the point of this article is to use available records from Ireland, the vital records of the children were not examined.¹⁷

Record of a sister in the US

The 1900 US census provides a clue worth investigating. A 22-year old woman named Alvina Kiley, sister-in-law to the head of household (Henry), was enumerated with the Halverson family in Bridgeport. She had immigrated in 1896 and was employed as a label printer. Her birth month and year were reported to be March, 1878. "Alvina" is a highly unusual name for a young Irish woman from that time period, so her actual name may have been misunderstood by the enumerator. Another Irish immigrant, Edward Sweeney, born in 1878 and immigrated in the same year as Alvina, boarded with the Halversons in 1900. His possible relationship to the family was not pursued.

No marriage or death record was found for a woman matching Alvina Kiely over the next decade in Bridgeport vital records. She was not identified in an index to New York City brides in the same time period. ¹⁹ Nor was she identified in the index of deaths in Kings County (Brooklyn) 1900-1910. ²⁰ Alvina was not found on the 1905 census of New York State (when the Halversons lived in Brooklyn) or on the 1910 US census anywhere in the country. Still, given her stated relationship to Henry Halverson, Alvina was a sister of Nellie. We now have three children of Patrick and Margaret Kiley to investigate: Ellen, Timothy (named in obituary), and Alvina.

Records in Ireland

A closer look at the dates in Table 1 shows not only the six-year range in birth years, but also that Ellen's birth date from the 1900 census is different from the date on Ellen's death record—a different month and three years difference in the year. Still, the range of years for Ellen's birth puts that event just after the country began civil registration of births, marriages, and deaths. Unless Ellen routinely underreported her age, and as long as her parents conformed to the new law for reporting births, we should find Ellen in the civil registration. Then, if the parish records are extant, we should find a record of her baptism. Those records will provide a townland of residence for Ellen's parents. Armed with the knowledge from those records, we can search for siblings and fill out Ellen's family tree.

Civil Registration of Births

A search was done of Irish birth records, starting in the earliest records available—1864. A birth record was found for Ellen "Kielly" who was born 25 June 1865 in Millstreet Registration District in County Cork to Patrick Kielly, farmer, and Margaret Kielly, formerly Kelleher, who lived in the townland of Moher. The birth was reported by the father, Patrick Kealy (different spelling) of Moher. (N.B. Spelling of names was quite variable in Ireland in the 19th century as seen in this record. A different spelling cannot be interpreted as a different person.)

In this record we see the expected names for the parents, and we see the birthdate of 25 June 1865 which is a single day off from that found on Ellen's death certificate (where the date is 24 June 1865). Therefore we have high confidence this is the correct Ellen. No other child's birth record came close to matching.

Roman Catholic Parish Registers

A corresponding baptism was recorded in Dromtarriffe Roman Catholic parish which lies within the boundaries of the Millstreet Civil Registration District (see image). Ellen Keily, daughter of Patrick Kiely and Margaret Kelleher, residence Moher, was baptized 2 July 1865. The godparents were John Kiely and Ellen Kiely.



Dromtarriffe Roman Catholic parish is located in the northwest part of central County Cork, near the border with Counties Kerry and Limerick.²³ The location of the townland of Moher can be seen on a map at the website Townlands.ie.²⁴

Siblings

A search was conducted for Nellie's sister "Alvina Kiley" who was enumerated in the US in 1900. No Kiely child met the criteria in a search of the Irish civil registration index. ²⁵ An odd index entry on the second page of hits in the Roman Catholic baptism records caught the eye of the researcher: Jebendam Keily. The record image revealed a transcription error—the baby's given name was "Gobinata." ²⁶



This is Latin for "Gobnait," a saint from County Cork. Other names for Gobnait include Abigail, ²⁷ and a nickname for Abigail is Abina, a name known to be used in Ireland at this time. Gobnait's mother was Margaret Kelleher and her father was Patrick Kiely; their residence was "Muhur." This must be the "Alvina" seen on the census in Bridgeport two decades later. The baptism date is 20 February 1875, three years and a month earlier than the birth information reported on the census.

Searches of the civil registration and Catholic parish registers turned up the Kiely-Kelleher marriage and the baptisms of six more children of parents named Patrick and Margaret (Kelleher) Kiely, including a son named Timothy. (See genealogical summary for the list.) In each case the townland of residence was Moher, the same as when Ellen was born. The surname was spelled several ways (Kiely, Keily, Keely, Keely, Keely, Kiley) but as stated earlier spelling variation was not unusual in 19th-century Ireland. The parents' given names were consistent. The children were spaced about every three years with no significant gaps over a period of 22 years.

Other Irish records of this family *Griffith's Valuation*

No 19th-century censuses of Ireland survive. However, a tax record called Griffith's Valuation lists all of the legal occupiers of property in Ireland in the years 1847-1864. The survey of Co. Cork for Griffith's was completed in 1853. There is no Patrick Kiely listed who lived in Moher townland, or in either of the civil parishes encompassed by the Dromtarriffe RC

parish.²⁸ This likely means simply that Patrick was not the primary occupier—the person who held the lease—at that time. He had married in 1851 and may still have been living with a relative when this survey was done. There are several other Kiely men listed in the area in Griffiths, some of them with the same names as the godfathers of Patrick and Margaret's children. Research in Dublin might turn up an updated tax record from after 1853 which would show where Patrick's land lay.

1901 Census

Except for the civil registration of vital records, no other types of records are available in Ireland until the 1901 census. (Previous censuses and many other records were destroyed by fire in 1922.) There are two Censuses of Ireland that are available to the public: 1901 and 1911.

In 1901 Margaret Kiely, age 60, widow, was living in Moher with Timothy Kiely, 21, whose relationship to her is given as "son." This must be her youngest son who was baptized in 1871, though his age is incorrect by about 10 years. Margaret's occupation was "Farmer's Wife" and Timothy's was "Farmer Son" (even though there was no "farmer" in the household). A third person in the household, Daniel Bradley, seems unrelated. He was a farm laborer, age 84.²⁹

Death of Ellen's father

A death record was found for Patrick Kiely, 85, who died 1 July 1894 in Moher of old age. The informant was Abina Kiely, daughter.³⁰ This was surely the young woman "Alvina" seen on the 1900 census in Bridgeport, so now we have a more dependable report of her name. Patrick's age at death calculates to a birth year of 1809. This may not be completely accurate since the age "85" could be a rounded number or guess, but it is realistic in relationship to the date of his marriage and the dates of his children's births. Irish death records do not name parents, only the person present at death, so we have no help identifying an earlier generation.

Death of Ellen's mother

Margaret Kiely died 1 July 1901 of obstruction of the bowel. She was age 60. Timothy Kiely, son, of Moher, was present at the death.³¹ This is the same age for Margaret given on the census earlier that year, and it calculates to a birth year of about 1841. With a marriage in 1851, this is cannot be correct. She was probably about 70 at the time of her death, born about 1830. With Gobnait/Abina born in 1875, though, when Margaret would have been about 45 years old, it's not likely Margaret was born much before 1830.

1911 Census of Ireland

Timothy Kiely, 36, was listed in Moher in 1911. He was head of a family that included

his wife of nine years Bridget and four children: Margaret, Patrick, Mary and John.³² The names of the first two children indicate they are grandchildren of the Kiely couple we have been studying. This means Timothy married within a year of his mother's death. It appears he stayed on the farm which is unusual because commonly the oldest son inherited. It's possible the older boys emigrated or died. His age here is closer to correct, but still too young by about four years.

CONCLUSIONS:

- 1. Ellen Kiely was born 25 June 1865 in Moher, Dromtarriffe Roman Catholic parish, County Cork.
- 2. Ellen (Kiely) Halverson's parents were correctly named in her death record.
- 3. They have been identified in Irish vital records and church records.
- 4. Seven siblings have also been identified in Irish records, including one who lived in Bridgeport in 1900 and another who was named in Ellen's obituary.

Genealogical Summary

Patrick Kiely was born about 1809 and died 1 July 1894.³³ He married Margaret Kelleher 4 March 1851 in Dromtarriffe Roman Catholic Parish, County Cork. The witnesses were Denis (Latin=Dionysius) Murphy and Arthur Keefe.³⁴ Often the fathers of the bride and groom were the witnesses to the marriage, but given the surnames in this case, it did not happen here, and perhaps the fathers had died. Margaret died 1 July 1901, reportedly at the age of 60, which calculates to a birth in 1840. That would mean she married Patrick Kiely at age 11 and had her first child at age 13, so it is likely the age on the death certificate is underestimated by as much as ten years. If she was born about 1830, she would have been age 21 when she married, her first child would have been born when Margaret was 23 years old, and her last one when she was age 45. This aligns with biological expectations.

Children of Patrick and Margaret (Kelleher) Kiely, all born in Moher (townland), Cullen (civil parish), Co. Cork. (The first four were born before Ireland kept birth records. All were baptized in Dromtarriffe Roman Catholic parish.)

- i. JOANNA KIELY, bp. 28 August 1853. Godparents were Jeremiah Kiely and Abigail Kiely. 35 No marriage or death record found in civil registration.
- ii. DANIEL KIELY, bp. 1 May 1856. Godparents were Jeremiah McAuliffe and Maria or Mary FitzPatrick.³⁶ No marriage or death record found in civil registration.
- iii. PATRICK KIELY, bp. 9 October 1859. Godparents were Eugene M[illegible] and [illegible] Keefe.³⁷ No marriage or death record found in civil registration.

- iv. CORNELIUS KIELY, bp. 9 May 1862. Godparents were Bartholomew Moynihan and Julia Keefe.³⁸ No marriage or death record found in civil registration.
- v. ELLEN KIELY, b. 25 June 1865; bp. 2 July 1865; m. Henry Halverson 14 January 1894 at Bridgeport, Fairfield, Connecticut;³⁹ d. 24 January 1950 at Bridgeport;⁴⁰ imm. to the United States in the 1880s. Six children.
- vi. JEREMIAH KIELY, b. 18 February 1868, birth registered on 10 March 1868;⁴¹ bp. 16 February 1868. Godparents were Daniel Kiely and Johanna Kiely.⁴² Note that his baptism date is two days before his registered birth date. This is an example of a late registration with a false (later) birth date reported in order to avoid paying a late fine.
- vii. TIMOTHY KIELY, 15 October 1871, birth registered 10 November 1871;⁴³ bp. 24 April 1871. Godparent was Catherine Keefe;⁴⁴ m. Bridget Rahilly 11 Feb 1902 at Coolclough, Co. Cork.⁴⁵ This couple was enumerated with four children on the 1911 Census of Ireland.⁴⁶ This is an even later birth registration—months late. This is the brother named as a survivor in Ellen Halverson's obituary.
- viii. GOBNAIT KIELY, bp. 20 Feb 1875. Godparents were Margaret Keefe and Jeremiah Kiely.⁴⁷ She appeared as "Alvina Kiley" in the household of her sister Ellen on the 1900 US census in Bridgeport, Connecticut. She was the official "person present" at the death of her father in 1894, called "Abina." She immigrated to the US in 1896.⁴⁸ No civil registration was found for her birth, or for marriage or death 1900-1911 in Ireland or the United States.

CATHERINE OLMSTED was born c.1722-1726 place unknown, but probably at or near Bristol County, Rhode Island / Bristol County, Massachusetts,² or in Norwalk, Fairfield County, Connecticut, where her likely father first appeared in Norwalk records in 1724.³ No original record exists that would confirm her date or place of birth or christening. Her probable parents are RICHARD PA(R)TRICK and his wife MARY (MUNROW)⁴ who were married 19 Dec 1718 at Swansea, Bristol County, Massachusetts,⁵ and who were in Norwalk by 30 May 1724 when Richard recorded his cattle mark.⁶ She married c. 1750 DAVID OLMSTED probably at Norwalk.⁷ Catherine Olmsted's death date and place of burial are unknown, and there is no probate record for her. Norwalk land records contain no records regarding any Olmsted land having been Partrick land and passed to Catherine's dowry.

Some support for Catherine's maiden name is found in her husband David Olmsted's probate papers in which John Patrick of Norwalk, her probable brother (c.1719-Aug. 1808), was appointed as one of two administrators of David Olmsted's estate. In Patrick was also named guardian of two of Catherine and David Olmsted's children. On 12 Jan 1767 Aaron Olmsted of Norwalk, a minor, chose John Partrick as his guardian, eight years after the death of his father. And on 7 Aug 1770 Darius Olmsted of Norwalk, a minor, chose John Partrick of Norwalk, to be his guardian.

The 1790 Federal census locates her in Norwalk at Cranberry Plain/Poplar Plain as a neighbor of other known Olmsted and Partrick families whose land records confirm that location. Families listed nearby are Samuel Olmsted, James Olmsted, William Fitch, and Widow

Ellen Pa(r)trick (wife of Stephen Partrick who died in July 1779), and Asa Patrick (son of Stephen and Ellen).

Catherine Olmsted is not listed as a head of household in the 1800 Federal census of Norwalk. One of two records likely concerning her is dated 30 August 1804, when her son David quit-claimed his share of his mother's dower land. This does not necessarily imply that Catherine had died. The second record is for "Cathe Olmstead" over age 45, living alone, in the 1810 Federal census of Norwalk, though she does not have the title "widow" there. It this is the same woman, she had remained a widow for over 50 years.

Catherine's husband

David Olmsted was born 6 Feb 1724 at Norwalk, the son of John Olmsted and Mary Small. He was age 35 years *if* he was killed in 1759 while serving in the Northern Army, as a boatman on Lake Champlain. This was at the time of the French and Indian War, when he served in the Fairfield militia company under Col. Nehemiah Beardsley. However, despite this report that he died in 1759, he may have actually passed away after 5 Mar 1760 when he was a grantee to John Husted and before 6 Jan 1761 when administrators were appointed for his estate.

John Partrick and Nathan Burwell, Jun., both of Norwalk, were appointed administrators of the estate of David Olmsted on 6 Jan 1761, 15 and the inventory taken, which was approved 5 May 1761. 16 These papers indicate that he left his widow Catherine and 6 minor children, "the oldest age 10 years, and the youngest a newborn." Most of these children had married before 1790, so that one of the females living with Catherine in 1790 may have been her daughter Mary. The inventory of David Olmsted's estate lists shoemaker's tools, gauges, and knives, indicating his occupation. Real estate as listed in the inventory at that time was:

- Lands in the homestead lying on the East side of the highway containing about 21 acres appraised at £4-8-s. per acre.
- The house and the barn ...
- Lands on the West side of the highway containing about 27 acres.
- The swamp called Lockwood swamp containing about 6 acres.
- Salt meadow at Fruitful Spring "lying for 3 roods."

Distribution of David Olmsted's estate did not occur until 27 Jan 1774, 15 years after his death. Property was set off first to David Olmsted, eldest son, who received 2/3 part of the house plus 2 acres and 108 poles of land the southern boundary of which was land set off to Catherine Olmsted, widow of the deceased. This included "a previledge [sic] of the well and

other necessary previlidges thereof..." Other siblings' distributions in order are: Aaron, Darius, Asa, and Mary Olmsted.

Lastly, is the Norwalk deed Vol. 25:113, dated 30 Aug 1804, referred to above, in which David Olmsted of Rush, Luzerne County, Pennsylvania, for the consideration of \$45 received of "my brother Darius Olmsted of Norwalk, County of Fairfield, CT," have quit-claimed in "all right which I have in one-sixth part of a certain piece of land with a dwellinghouse thereon lying in Norwalk at Chestnut Hill so-called, being the same as was set out to our mother Catherine Olmsted in the settlement of our Father's estate as her Dower during her natural life, the same being in quantity 15 acres... bounded West by highway, North by Samuel Gregory, East by Grumman's land, and southerly by the heirs of James Olmsted, deceased..." One boundary on the piece acquired by Darius Olmsted is the North boundary on Richard Partrick's land. This Richard must be Catherine's nephew, son of John and Bethia Partrick. born 29 Mar 1743 and who died in July 1831 at Schoharie County, New York. 18

Francis¹ Andrews of Fairfield, Connecticut

FRANCIS¹ ANDREWS was born presumably in England and died in Fairfield, Connecticut, before 5 March 1662/3 when his will was proved. A wife, ANNA, is mentioned in his will¹ but it is not known if she is the mother of his children. Anna married, second, Henry Smith² and died in June 1685.³

There is no record of when Francis immigrated to New England but he was living in Hartford, Connecticut, by 1639. His name is listed in Original Distribution of the Lands in Hartford as being one of the 163 settlers before February, 1640.⁴ The name of Francis Andrews is also listed on the Founders Monument in Hartford's Ancient Burying Ground, erected in 1986 by the Society of the Descendants of the Founders of Hartford to replace the original monument that had been erected in 1837.⁵

In Hartford Proprietors Records dated February, 1639, Francis was named as a grantee on six deeds, having purchased a total of fourteen acres of land in transactions with Richard Butler, Nath. Ward, William Andrews and James Ensign. He was also named as a grantor on six deeds, selling twenty-four acres of land to William Holton, John Willcock, James Ensign, Thomas Bull, William Hill and Richard Fellows. One of his purchases was for the north part of Richard Butler's lot on the corner of the present Elm and Trinity streets in Hartford, including a dwelling house that with other out houses, yards and gardens contained about one acre and one rood.

He was a member of the First Church, Hartford where his first two sons were baptized. He removed to Fairfield about 1648.

Francis Andrews wrote his will on 6 Jun 1662 and died sometime between then and 5 March 1662/3 when the will was proved. 10

The will of Francis Andrews of Bankside, near Fairfield. I give and bequeath ... and my son Thomas my five acres ... and half of it from the highway to the ... Thomas to have the other half next to Daniel Frost's meadow in the upland.

Also I give to my son John three acres of my homelot at the lower end and a piece of land 4 rods wide to the cross fence with the house that is upon it conditionally that he is to set his mother up another house as good as that and to make and maintain a sufficient 5 rail fence to the cross fence.

Also I give unto him three acres of meadow called the Hether bite.

Also I give unto son John a gun and to my son Thomas a gun barrel and a stock. Also I give unto my son Thomas a piece of land to set a house on: from my house chimney to John Cromtons land and so to the cross fence.

Also that they shall not sell any part of their land but to their mother or their own brothers. And they are to have their portions at twenty one years of age unless their mother die or marry. And then they are to have their portions at eighteen years of age. Also I give to my son Jeremiah a rapier staff and twenty shillings. And to my son Abraham twenty shillings.

Also I give to my daughters Elizabeth, Mary, Hester, Rebecca and Ruth ten shillings apiece at eighteen years.

Also I give to John Cromton with my daughter Hanna three rood of land next his house which he is to fence around in particular to himself with five rails and to maintain it. Also I give to his daughter Hanna ten shillings to be improved for her use till she is eighteen years of age.

Also I give to my well beloved wife my house and the rest of my land and estate and privileges now or hereafter shall be— And make her whole executrix and desiring Mr. Pell to be overseer of this my will after my decease.

Also I give to my son Thomas Andrews that piece of meadow which lies on this side of the bridge on the north side of the ...

With a total estate of 90£ 15s, Francis was one of the least prosperous of thirteen of the author's ancestors examined in Fairfield County from 1652-1663. Although Francis' estate inventory indicates that he owned fifteen acres of land, no Fairfield deeds survive showing the purchase of the land. His will indicates that he lived in "Bankside, near Fairfield" which is the name that was used to describe modern Greens Farms, Connecticut.

About 1664, Ann Andrews married second, Henry Smith of Stamford. A prenuptial agreement dated 21 January 1664 (1663/4?) concerned legacies to her three children Rebecca,

Ruth and Abraham.¹² Anna Andrews sold the housing and land that she had inherited to Simon Couch on 14 March 1663/4,¹³ presumably because she would now be living with Henry Smith in Stamford. Ann Smith died in Stamford "the second week of June 1685."¹⁴ Henry Smith wrote his will in Stamford on 4 July 1687¹⁵ and died sometime after that.

When Francis Andrews died in 1662/3, his oldest son, John, was only about sixteen years of age and too young to own the land that was left to him in Andrews' will. On 28 February 1673, a deed was recorded in Fairfield for four parcels of land that John had "by legacy from his deceased father Andrews." ¹⁶

Children: Francis¹ Andrews and perhaps Anna (___?__) Andrews had ten children. All were named in his will¹⁷ and listed with details in Jacobus' account of the family.¹⁸

- i. HANNAH² ANDREWS, m. John Crampton of Norwalk. They had a daughter, HANNAH CRAMPTON, who was mentioned in Francis Andrews' will.¹⁹
- ii. ELIZABETH ANDREWS
- iii. JOHN ANDREWS, baptized in First Church, Hartford, 27 September 1646. He married Bethia Kirby. She was born in Middletown, Connecticut, 14 February 1658/9, the daughter of John and Elizabeth Kirby. John died prior to 20 December 1683 when an inventory of his estate was prepared. He left a son and a daughter under age, John and Sarah.
- iv. Thomas Andrews, baptized in First Church, Hartford 2 January 1647/8. He married Elizabeth Porter. She was born in Farmington, Connecticut, 11 January 1653/4, the daughter of Robert Porter. Their children were Elizabeth, Mercy, Thomas, Hannah, Mary, John, Sarah, Ruth, Rebecca, Abigail. Thomas died in Milford, Connecticut, about 1718.
- v. MARY ANDREWS, perhaps married first, Peter Norton of Fairfield and second, after 1670, Hugh Griffin.
- vi. ESTHER ANDREWS
- vii. REBECCA ANDREWS, lived in the Groves family, Stratford, prior to 1673, married 7 July 1678, as his second wife, Samuel Benedict.
- viii. JEREMIAH ANDREWS, married Hannah Gold in Stamford on 8 September 1697, Connecticut. He died by 5 August 1713. Their children were John, Ann, Jeremiah and Jeremiah.
- viii. ABRAHAM ANDREWS, married Rebecca Carrington. They lived in Waterbury where he was a deputy in 1712. Their children were Rebecca, Mary, Hannah, Abraham, Sarah, Rachel, John and Thomas. Abraham died in 1729.



Three Early Guire Generations: Luke, Luke and Luke, and their wives Mary Adams, Rebecca Odell and Mary Adams, of Fairfield

Little is known about the life of LUKE GUIRE, senior, including where or when he was born or died. No birth or baptism record has been found but he married MARY ADAMS on 23 or 25 February 1663¹ so presumably was he born by 1643 or so. He died before 7 August 1671 when his wife (with a different surname) and son were named in the will of his father-in-law EDWARD ADAMS.²

No land records have been discovered for Luke Guire in Fairfield deed books. It is possible that Luke and Mary lived in a dwelling on the land of Mary's father. Luke's name is not mentioned in records of early Fairfield landowners, including "A list of the lots drawn for Sasqua Land in the New Field 8 February 1668/9," "Names of persons who shared in the second division of Sasqua Lands 30 January 1668/9," "A list of the inhabitant's proportions of lands in the commons granted to the inhabitants in the year 1670/1," and "A list of the building lots, pasture lots, and long lots granted the inhabitants of the town January 1670/1." Nor is he named in "A list of the names of the freemen of the town of Fairfield October 1669." A No death record, will, or inventory has been discovered for him.

Mary (Adams) Guire

Mary Adams was born about 1647⁵ and died before 7 May 1712⁶ when her will was proved. Mary's father and brothers are identified in records generated for them but which contain her name. The earliest, dated 7 August 1671, is the will of Edward Adams of Fairfield who named his daughter, Mary "Murwin," and her son, Luke Guire. This document is evidence that Luke Guire senior had died at an earlier date and that Mary Guire had remarried. The will also names Edward's sons Samuel, Abraham, Nathaniel, John and Nathan Adams, who are connected to Mary in later documents, and a wife Mary.

Mary had received a gift of four acres of land in Barlow Plain from her father in 1668⁸ and was to trade that land for a different lot according to a subsequent deed in 1673.⁹ No surname is provided for Mary in the 1668 document.

Marriages

Torrey wrote that Mary Adams "m. 1, Luke Guire on 23 or 25 Feb 1663, m. 2, ______ Merwin, m. 3, Stephen Sherwood." Paul Prindle, FASG, wrote that Mary Guire married, second, Samuel Robinson and, third, Thomas Merwin, citing a manuscript on the Adams family compiled by Edward Bradford Adams and deposited with the Fairfield Historical Society. The usually reliable Prindle apparently misread the Adams source. This manuscript actually states that Mary Guire "m. 1 Sam. Robinson (Jacobus omits), 2. Luke Guire, 3. Thomas Merwin, 4. Stephen Sherwood." No sources are cited.

Jacobus does not mention Samuel Robinson in Families of Old Fairfield. Other accounts of Mary's life do not mention a marriage to Samuel Robinson or the given name of her husband, Mr. Merwin. It is apparent, however, that she married Merwin before her father wrote his will (since she already had the surname Merwin). Mary married last, Stephen Sherwood, as his third wife. Sherwood had married first, Rebecca Turney, daughter of Robert Turney and Mary Odell. He married second, Hannah Jackson Galpin, widow of Philip Galpin and daughter of Henry Jackson. Jackson.

Mary (Adams) inherited from her brothers

Mary's brother, John Adams, died intestate in late 1693. An inventory of his estate along with a "writing card the uncupative will" (should be "nuncupative," i.e. oral) was presented at the County Court in Fairfield on 7 November 1693. The will named his brothers Samuel, Abraham and Nathan, and his sister Mary. John's inventory included £123 in real estate and £22 10s in "moveables" (personal estate). The court accepted the inventory but disallowed the will, and ordered that the estate be divided into fourths, with the three surviving brothers (Samuel, Abraham and Nathan) dividing the real estate equally. Mary was to receive the moveables, with her brothers paying her the difference between her one-fourth share and the value of the moveables. With the total estate valued at £145 10s, a quarter share was worth £36 7s 6p. Thus Mary's brothers owed her £13 7s 6p.

In 1694, Abraham Adams, as administrator for the estate of Samuel Adams, received £8 15s as a debt owed by the estate of John Adams¹⁵ and Nathan Adams similarly received £10 17s 7d from John's estate. ¹⁶ So it appears there was sufficient money available to pay Mary her share. Abraham Adams died with an estate that totaled over £1,630. But for reasons that were certainly not financial, the payment came into dispute. One year later on 6 November 1694, Mary brought suit against her brothers in Fairfield and was awarded £6 16s 6d. ¹⁷

On 4 September 1696, Joseph Seeley and Samuel Lyon testified that they had appraised 9.5 acres of land owned by Nathan Adams at £9 10s, and that Nathan had agreed that Mary's son, Luke Guire, should have the land in payment of his debt to Mary. 18 Three months later, on 26 Feb 1696/7, Mary appointed her son, Luke Guire, "my agent or attorney to demand and receive of the Administrators of my deceased brother John's estate, one fourth part of said estate." Five years later, on 1 March 1700/1, Abraham and Nathan Adams were once again in court to answer Stephen Sherwood, now the husband of Mary (Adams) (Merwin), and were ordered "to pay the fourth part of the inventory which is thirty six pounds and eight shillings." 20 Later that year on 4 November 1701, Abraham and Nathan appealed the case in Fairfield County Court, but lost yet again and were ordered to pay £14 5s 8p and cost of court. 21 Finally on 5 May 1702, "Mary Murwin now Sherwood did declare to Abraham Adams that she did withdraw her review and that he should not now go to Hartford about that case which we understood was the case in which she sued Abraham Adams and Nathan Adams as administrators to John Adams his estate for her part of the same."22 Apparently, Mary had brought suit in Hartford against her brothers who had still refused to pay her share. Whether Mary simply dropped the suit or whether the brothers finally paid her is unknown, but for a dispute over a relatively small amount of money to last nearly nine years indicates some kind of breakdown in the relationship between Mary and her brothers.

Mary's will

Mary Sherwood wrote her will on 22 March 1711/2. The will, along with an inventory of her estate dated 14 April 1712, was proved in Fairfield Probate Court on 7 May 1712, so she died sometime between those two dates. Her will and inventory are reproduced below.

I Mary Sherwood being weak of body but of sound and perfect memory God be thanked therefor knowing the mortality of human nature and that it is appointed for all once to die and being under the apprehensions of approaching death do desire to set my house in order before I go hence to be here no more do make and ordain this as my last will and testament. First of all I commit my soul into the hands of God that created it hoping through the grace of God and the meritorious satisfaction of ... Jesus Christ at the great and general resurrection to be raised unto a glorious life my body I commit to the earth to be decently interred by my friends & relations. My worldly estate which God hath merciful lent me I dispose of as followeth

Imprimis I give and bequeath unto my loving grandson Luke Quire six pair of sheets and six napkins and my sermon book, sundry titles, one title is of the fall of man and a pewter basin and one porringer.

2. I give and bequeath unto my loving granddaughter Hellinah Quire six pair of sheets and six napkins and a good pewter basin and one new porringer and I give her my little brass kettle and my little iron kettle and my best feather bed & one of my wrought cover lids and the other coverlid to Mary.

- 3. I give and bequeath unto my loving granddaughter Mary Quire my bible, six pair of sheets and six napkins and one of my great pewter basins and one new porringer any my great iron kettle & great iron pot & my great chest, my best feather bed.
- 4. I give and bequeath unto my loving granddaughter Hannah Quire six pair of sheets and six napkins and one of my great basins and one new porringer and my great brass kettle and little iron pot & my great coverlid and another coverlid.
- 5. I give and bequeath unto my grandson Ebenezer Quire six pair of sheets one pair being cotton and six napkins and a pewter basin and a pair of cotton pillow beers being half linen also I give him my one of my narrow brimmed platters. Also my will is that what I have give to my grand Ebenezer shall be disposed of to my grandson Luke in case said Ebenezer doth not return from ...
- 6. I give also unto my said granddaughter Hellinah the choice of my two pair of cotton & linen pillow beers and the other of the two pillow beers to my granddaughter Mary.
- 7. Also I give unto my afore named grandchildren to each of them two pairs of pillow beers but my said Hannah one of her part to be laced.
- 8. Also I give unto my grandson Luke Quire one pair of cotton pillow beers and one of my narrow brim platters & towards my burial expenses I give him five yards of ... Also one of my coverlids. Also I give unto each of my fore named granddaughters two pewter platters, a pair of pillow beers that I may have not disposed of to each of them a pair. Also I give to my granddaughter Mary my new scarf and my blue stuff coat.
- 9. I give unto my afore named grandchildren any table cloths and towels to be equally divided between them also I give to my above said granddaughter Hellinah my new chest and to Hannah my old chest.

Also I give unto my fore named grandchildren nine pair of pillow beers sheets to be equally divided between them. Also I give unto my granddaughter Mary my pint and quart pot & I give unto Hannah aforesaid my pint pot and my half pint cup my warming pan I give also to Mary. To Hellinah above said I give my frying pan & tongs and my trammel I give to Hannah.

Also my will and meaning is that in case either of my aforementioned granddaughters die before they are married then what I have given to her shall that shall decease she return to the surviving sisters to be equally divided among them.

Furthermore my will is that if either of my other afore named grandchildren shall contend about what I have given them they shall lose my their part which I gave and that to be equally divided among the rest.

Finally my will is ordain and constitute afore named grandson Luke Quire to be the whole and sole executor of this my last will and testament. And also I appoint John Gold to be helpful to my said grandson in the execution of my will in for the more satisfying performance and confirmation of this my last will & testament. I have signed hereunto this 22nd day of March in the year of our Lord 1711/12. Mary Sherwood, M her mark

Signed in the presence of Daniel Adams John Gold

Daniel Adams and John Gold appeared before the Court of Probates held in Fairfield May the 7th 1712 and made oath that they were witnesses to the above will and testament of Mary Sherwood and that they saw the said Mary Sherwood the testator sign ... the ... will and testament and in their observation they judged her said Mary to be in her right mind and understanding at the time of so doing

The last will and testament of Mary Sherwood late deceased being exhibited to the Court of Probates held in Fairfield May 7th 1712 for and unto of settlement said will being proved is by this Court approved and ordered to be recorded.

Samuell Lyon Apprizers

Luke Guire appear for the Court of Probates held in Fairfield May 7, 1712 and gave oath to the truth of the above inventory and if anything belonging to the estate he will cause it be inserted.

As Mary's inventory refers to her as Widow Mary Sherwood, it is evident that her husband, Stephen, preceded her in death. Her only known son, Luke Guire died prior to 11 April 1699 when his inventory was taken and her daughter-in-law, Rebecca (Odell) Guire had remarried Robert Turney by about 1701, so the only heirs named in her will were her five Guire grandchildren, Luke, Helena, Ebenezer, Mary and Hannah. Each grandchild was to receive six pair of sheets and six napkins along with other assorted linens and household items. Although Mary's house and home lot were listed in her inventory, she had previously given them to her grandson Luke Guire 3rd on 3 March 1711/2. She had also given him her interest in her father Edwards Adams' long lot that she had inherited from him. ²³ Thus, she died owning only the personal effects in her home.

Luke Guire and Mary Adams had one known child:

- 2. i. Luke Guire
- 2. LUKE GUIRE was born before 7 August 1671 when he was named in the will of his grand-father, Edward Adams,²⁴ and died a young man, probably around age 30, before 11 Apr 1699 when an inventory was taken of his own estate.²⁵ He married REBECCA ODELL about 1686 in Fairfield.²⁶ Rebecca was probably born by 1670. After the death of Luke Guire, she married, second, Robert Turney, about 1701. She died before 11 January 1741/2 when her son Robert Turney was appointed administrator of her estate.²⁷

Luke is mentioned twice in Fairfield Land Records and Deeds. First, in December 1673, a deed was recorded that mirrored Edward Adams' will. Edward gave to his daughter Mary Murwin, and after her decease to her son Luke Guire, two acres of land in Barlow's Plain. Since Luke died before his mother, he never inherited this land. The second mention came on 5 November 1690. "John Seeley of Fairfield ... sell to Luke Wire of same place ... that part of Sgt. George Squire's long lot which I had of said Squire ... the whole breadth of it forty rods long the said land lying in Fairfield near the Mill River by the saw mill ... for the same consideration sell the dwelling house that stands on the said land ..." Since Luke's son, the third Luke Guire, was born about this time, it seems likely that Luke and Rebecca Guire wanted a home of their own to raise their family.

Rebecca Guire renewed her covenant at Fairfield First Congregational Church on 14 June 1696, the same date as her children Luke and Mary were baptized.³⁰

Luke Guire left no will. His inventory, taken by Matthew Sherwood and James Bennett and dated 7 April 1699, is summarized below.

Of twenty-five Mindrum ancestors studied in Colonial Connecticut between 1690-1699, their inventory values ranged from £44 to £1719. With an estate of £234, Luke was eighteenth on the list, but he had not had a lot of time to accumulate wealth by the time he died.

The names and ages of Luke's children were noted in the inventory: "Luke the eldest son near 10 years of age, Elenah near 7 years & a half old, Ebenezer about 6 years old, Mary 4 years old, Hannah about two years old, John 9 months old."

Finally, the court noted at the bottom of the inventory document:

Luke Guire deceased, he dying intestate, an inventory of his estate being exhibited to the Prerogative Court held in Fairfield 11 April 1699 in order to a settlement. The Court do approve the said inventory and do order it to be recorded and do appoint and empower the widow Rebecka Guire with her brother John Odell to administer the said estate to pay and receive all just debts due to and from the said estate and make return of the clear estate when called for.

John Odell, Jr. and widow Rebecka Guire, the above named administrators, do acknowledge themselves bound in a bond of two hundred twenty pounds for a faithful discharge of their administration on the estate and to return a true account of the estate to the Court when called for.

Acknowledged before me this 2 day of May 1699, Nathan Gold, Clerk.

In cases of a person dying intestate, as did Luke Guire, the Probate Court would normally determine the distribution of the deceased's estate, with the widow receiving one-third of both

real and personal estate (the widow's dowry) and the children each receiving an equal portion (sometimes the eldest son received a double portion) of the balance. No record of Luke's estate distribution has been found, but it is evident that one was made from the following court documents.

Some of the heirs of Luke Guire being come of age to receive their portion the Court of Probate was held in Fairfield January 3, 1710 do therefore desire and appoint Capt. Joseph Wakeman and Sargt. Gideon Allen to make distribution of the estate of Guire according to a former order of Court for distribution of said estate. Hannah Guire makes choice of their brother Luke Guire to be her guardian and the said Luke Guire acknowledges himself bound to the Court in the recognizance of forty pounds for a faithful discharge of his guardianship according to law.³²

Since Luke Guire 3rd was born about 1689, he reached the age of 21 by 1710, and petitioned the Court to make distribution of his portion of his father's estate. At the same time, his sister Hannah needed an adult male to be her guardian and chose her brother Luke.

In 1716, at age nineteen or so, Hannah Guire chose her mother's second husband, Robert Turney (her "father in law"), to be her new guardian, freeing her brother Luke of the responsibility, as he was married and raising his own family by this date.

Hannah Guire makes choice of her father in law, Robert Turney, to be her guardian which the Court of Probate held in Fairfield January 3, 1716, do approve. And the said Robert Turney acknowledged himself bound to the Court in the recognizance of forty pounds for faithful discharge of his guardianship according to law.³³

Rebecca Odell Guire, who had six children by Luke Guire, went on to have six more children by her second husband, Robert Turney. Two of her children were to become direct ancestors of the author: Luke Guire 3rd, and John Turney, son of her second husband Robert Turney.

3. LUKE GUIRE was born about 1689 in Fairfield and baptized there on 14 June 1696. He died in Fairfield on 10 May 1751.³⁵ He married MARY ADAMS, his first cousin once removed, about 1711.³⁶ Mary was born about 1698 in Fairfield and baptized there on 2 Oct 1698,³⁷ daughter of NATHAN ADAMS and MARY JAMES. She died before 10 Jun 1767 when her will was proved.³⁸ Nathan was a son of Edward Adams and brother of Mary (Adams) (Guire) (Merwin) Sherwood, this Luke's grandmother.

Luke was identified as a carpenter in a 1717 land deed when he was about 28 years of age. However, the inventory of his estate taken after he died in 1751 revealed only a few tools (hand saw, tennant [tenon] saw, square & compass and two chisels) that would be thought of as carpenter's tools, so it is quite possible that he had abandoned carpentry and become a farmer and manager of his large estate.

Luke renewed his covenant at Fairfield First Congregational Church on 23 November 1712, the same date that his first child, Sarah, was baptized. His second child, Ebenezer, was baptized on 27 April 1718 and his third child, Johannah, was baptized on 28 February 1719/20.³⁹ No baptismal records have been found for his eight children born after Johannah. As Luke's uncle Abraham Adams was a founder of Trinity Episcopal Church and his father-in-law, Nathan, was a vestryman there, ⁴⁰ it is quite possible that Luke and family removed to Trinity. Unfortunately, Trinity's early church records (if they existed at all) were all lost when the British burned Fairfield in 1779, so no church records of baptism, marriage or burial can be found.

Despite his relatively humble beginnings, Luke was involved in at least 38 real estate transactions recorded in Fairfield deed books, 23 as the grantor and 15 as the grantee. He died a wealthy man, with a total estate of £5,547 of which £4,211 was real estate. He first acquired land in 1712 at about the age of 22 when his mother gifted him the part of the long lot that she had inherited from her father, Edward Adams. She also gifted him the two-acre home lot and house in Barlow's Plain that she lived in.⁴¹

Luke received additional land on 21 January 1713/4 in an agreement with his uncles Abraham and Nathan Adams and cousins Daniel, Abraham, Junr., David and John Adams. This deed divided part of Edward Adams long lot in Fairfield into seven parcels, each 40 rods in length, 20 rods in width, a total of 6.25 acres per parcel.⁴²

Luke appears to have sold the house and lot he received from his mother to Joseph Wakeman in 1717, 43 shortly before he bought a 1.5 acre lot from his cousin Nathan Adams,

Junr. 44 Also in 1717, "John Adams of Greenwich, blacksmith, for forty-eight pounds [sold] to Luke Guire, carpenter ... one full sixth part of two long lots, one formerly belonging to Edward Adams, the other formerly belonging to Joseph Patchin and bought by my father [Samuel Adams]". 45 In February 1720/1, Luke's fortunes improved dramatically when his father-in-law sold him half of John Tompkins long lot for fifty pounds and gave the other half to Luke's wife (Nathan's daughter) Mary. 46 Nathan and Abraham Adams had bought the long lot from Tompkins in 1715 and then Nathan acquired Abraham's half portion in 1720. In March 1720/1, Luke sold twelve acres in Fairfield to John Morehouse for 140 pounds, on a deed that recorded the consent of Robert and Rebecca Turney. Rebecca was Luke's mother and the widow of Luke's father. Apparently she had inherited property as part of the "widow's dowry" and Luke desired her affirmation that this property was not part of her dowry.

Then in September 1720, Luke expanded his holdings substantially by acquiring John Fitch's long lot from Robert Silliman for 130 pounds.⁴⁷ Then in 1722/3 Luke bought for 150 pounds from Thomas Williams, Junr., one third of the long lot originally laid out to Francis Bradley.⁴⁸ Then in early 1724/5, he traded a fifty-one acre parcel of his land to Ephraim Bradley for Ephraim's portion of the Francis Bradley lot.⁴⁹ Then in late 1735, he traded a parcel of land in the Fitch long lot to Samuel Smith for the "whole right" of the Thomas Staples' lot.⁵⁰

From 1726 to 1751, Luke sold land for cash on eight occasions. He did a land exchange with son Ebenezer Guire in 1742,⁵¹ sold fifty acres in the Staples lot in Reading to son-in-law Enos Lee for £318 in 1744,⁵² did a trade of highways with the town of Fairfield in 1749,⁵³ and gifted 24 acres to son John Guire in 1750.⁵⁴

Luke died sometime prior to 4 June 1751 when his wife, Mary Guire, was named administratrix of his estate. Mary, as principal, and son Nathan Guire, as surety, posted bond of two thousand pounds for a proper accounting of Luke's estate.⁵⁵

On 6 June 1751 Joseph Wakeman, John Andrews and Nathaniel Adams took an inventory of Luke's estate, summarized below.⁵⁶

June 6th 1751 here followeth the inventory of Luke Wire of Fairfield deceased taken by us whose names are underwritten being appointed & sworn according to law (Joseph Wakeman, John Andrews, Nathaniel Adams, prizers) & is as followeth, viz.

With an estate of £5547, Luke Guire was by far the wealthiest of nine Mindrum ancestors who died in Fairfield County between 1726 and 1751.

Because Luke left no will, his estate was distributed on 6 December 1751 by Joseph Wakeman and John Andrews, two of the men who had recorded his inventory. Expenses incurred after Luke's death and debts of £436 owed to 36 debtors had reduced his personal estate from £1336 to £756.

Mary Guire, Luke's wife, received the customary "widow's third" of the personal estate, £251, and real estate, £1327. The distributors then divided the balance of the estate into eleven equal parts. Ebenezer Guire as the eldest son received a double share of £826 14s 4d. The other nine children each received £413 7s 2d. Ebenezer and John Guire had each received gifts of land from their father during his lifetime and the value of this land was deducted from their settlement. Likewise, the married daughters Sarah Raymond, Hannah Lee and Mary Wood, had each previously received approximately £240 from their father, perhaps as a wedding gift, and this amount was deducted from their settlement.⁵⁷

Three of Luke's children, Luke (4th), Ruth and Stephen, were minors when Luke died. Their mother, Mary Guire, was appointed as their guardian and posted bond of £1,000 on 18 November 1751 that she "shall well, truly and faithfully execute and discharge her office of guardian." ⁵⁸

After Luke's death, Mary had numerous real estate dealings of her own, eight as grantor and twelve as grantee. In 1752, she bought land that her children Johanna, John and Rebecca had received in their father's estate distribution. ⁵⁹ She also sold land to Samuel Barlow and Daniel Beers that year, perhaps to fund the payments to her children. ⁶⁰ In 1755 she bought the one-third interest in the house and barn that had been given to daughter Abigail in her father's estate distribution. ⁶¹

On 7 May 1753, the Guire family signed two agreements among themselves regarding Luke Guire's estate distribution document. Perhaps to avoid future legal challenges to the estate distribution document by Mary or any of the children, they all agreed to sign a document signifying that they accepted the terms of the estate distribution—with one exception. The first agreement among Ebenezer Guire, Nathan Guire, John Guire and Widow Mary Guire, stated they accepted the terms of the estate distribution except that Ebenezer would receive the salt meadow, the Saw Mill lot in Fairfield and two acres lying in Tomkin's and Bradley's long lots. The second agreement, among Widow Mary Guire, Nathan Guire, John Guire, Enos and Joanna Lee, Daniel and Mary Wood, Rebecca Guire, Abigail Guire and Daniel and Ruth Sturgis (everyone except Ebenezer Guire), stated that they accepted all the terms of the estate distribution.

Also in 1753, all members of the Guire family were named as purchasers of a parcel of unspecified size from Daniel Bradley for 100 pounds located in Tomkins long lot where they already owned much land. Daniel Sturgis, Junr. who had married Ruth Guire on 11 December 1752, purchased three acres in Tomkins long lot from Mary Guire in June, 1753 for 110 pounds. Mary also gave Daniel ten acres of land in Tomkins lot that Ruth had received from her father's estate distribution while she was a minor. Tragically, Ruth died on 29 September 1755, still a very young woman. On 9 July 1756, Sturgis sold for 5 pounds to "my mother-in-law Mary Guire all my title in Tomkins long lot.

In 1754, Mary sold ten acres in Tomkins long lot to son, Ebenezer Guire, for 200 pounds. ⁶⁸ In 1758, she gave son Luke Guire (4th) a lot of unspecified size in Tomkins lot. ⁶⁹ In April 1767, she gave youngest son Stephen seven acres in Tomkins lot in return for the use of eleven acres that Stephen had received in father Luke's estate distribution. ⁷⁰

Mary died in 1767. Her probate case is a curious one.

- Back on 6 December 1751, Mary Guire was granted the "widow's third" of Luke Guire's real estate, approximately 52 acres valued at £1,327.
- Over fifteen years later, on 14 April 1767, Mary Guire wrote her last will and testament. Shortly after that, probably in early June of 1767, she died. On 10 June 1767, administration was granted to Nathan Guire and Stephen Guire for the estate of Mary Guire and on that same date, Mary's will was proved in Probate Court and Stephen Guire was appointed sole administrator of the will.⁷¹

- On 11 June 1767, the Probate Court ordered that the real estate of Luke Guire that was set off to the widow Mary Guire to use and improve during the term of her natural life, was to be divided in the following manner—a double share to the heirs of Ebenezer Guire, the eldest son, and a single share to the other children or heirs, including the "heirs of Sarah Raymond deceased, late wife of Lemuel Raymond of Norwalk." On 22 June 1767, the distribution of the land to the children/heirs was recorded, approximately 84 acres valued at £1,549. Interestingly, this estate distribution was found filed in the second Luke Guire's probate packet that was prepared in 1751.⁷²
- On 22 July 1767, an inventory of Mary's estate was taken by Ebenezer Banks and Cornelius Hull. Stephen Guire, as administrator of the estate, exhibited the inventory in Probate Court where it was approved and ordered to be recorded. Interestingly, the inventory included approximately 100 acres of real estate, 16 acres more than the previous estate distribution, but valued the real estate at just £223-- £1,326 less than the estate distribution.⁷³
- Two days later, on 24 July 1767, the Probate Court ordered the real estate of Mary Guire to be divided among the children according to the last will and testament of the deceased. This action presumably voided the estate distribution that was recorded on 22 June 1767.⁷⁴

Mary's will may provide a clue about the two documents differing approaches to distributing her estate: 75

In the name of God amen, this 14th day of April ADom 1767, I Mary Guyre of the town & county of Fairfield being weak and sick but of sound mind & memory do make & ordain this my last will & testament.

Imprimis I will & order all my just debts & funeral charges to be paid out of my moveable estate.

Item I give & devise unto my son Stephen Guyre and to his heirs forever all my land & right and interest of land in the homestead land where I now dwell. Said homestead is bounded southeasterly on highway, northwesterly on land of John Roberd, northeasterly on Staples long lot; also all my right & title in the buildings thereon; also all my right & title that I have in the saw mill lott so called; also all my right & interest in the lot called Sherwood side adjoining to Stephens own land; also seven acres of land at or near where Ephraim Beers now lives in Bradley & Tomkins long lots.

Item I give & bequeath unto my daughter Abigail the sum of thirteen pounds New York money out of my moveable estate to be paid by my son Stephen and to enable him to pay said legacy, I give him all my livestock on condition of his paying said legacy to his said sister.

Item I give & devise unto my daughter Rebecca and to her heirs forever all my right & title in & unto that land where she now lives near Thomas Whitlocks.

Item I give & devise unto my daughter Joanna and to her heirs & assigns my land in the den lying in the ten rod lot so called and to begin at the southerly end of her land there in Bradleys lot and to run northerly so far as her land runs.

Item All the remainder & residue of my real estate I give & devise unto my sons Nathan, John, Luke & Stephen to them & their heirs & assigns forever to be equally divided between them they conveying to their sister Rebecca the land where she now lives.

And as to my grandchildren, the children of my deceased son Ebenezer, he having had his full proportion, I make no further additions to them.

Finally I hereby constitute ordain & make my said son Stephen sole executor of this my last will & testament declaring this and no other to be my last will & testament revoking all other wills by me heretofore made. In witness whereof I have hereunto set my hand & seal the day & date first before written.

Mary Guyre, her mark

Signed sealed published & declared by the said Mary Guyre to be her last will & testament in presence of Isaac Oysterbank
Abigail Sherwood
David Burr, Jun'r

Mary gave specific parcels of land to children Stephen, Rebecca and Joanna, and then directed that all the rest of her real estate be divided among sons Nathan, John, Luke & Stephen. (No mention of Ebenezer).

Specifically addressing the heirs of her deceased (eldest) son, Mary stated, "And as to my grandchildren, the children of my deceased son Ebenezer, he having had his full proportion, I make no further additions to them."

It was a common practice at the time for men to leave real estate to their widow "for the term of her natural life" at which point the real estate would be distributed among her heirs. It seems possible that Ebenezer's heirs, perhaps knowing that they had been excluded from the will, tried to persuade the Probate Court to distribute Mary's real estate according to the custom of the time—a double portion for the eldest son (or heirs of the eldest son) and a single portion for the other children. On 11 June 1767, the court did just that, but then reversed the decision, honoring the terms of Mary's will a month later on 24 July 1767.

The inventory of Mary's estate was exceptional only in its simplicity and is summarized below. 76

Other than real estate, she owned a few dresses, her bed and some linen, a few pieces of kitchenware, five sheep and one horse. Since youngest son, Stephen, inherited the "homestead where I (Mary) dwell," it seems likely that she was living with son Stephen Guire and his family at the time of her death, which would account for her having so little in the way of worldly possessions.



Greens Farms Church Records, 1742 – 1851; Marriages, 1805-1821

Transcribed by Barbara Dempsey

This is the twelfth installment of the records from this Fairfield church. In this issue we complete the publication of the 1742-1822 marriages, covering the years 1805-1821.

These records have not previously been indexed, transcribed or microfilmed. Donald Lines Jacobus included the records in *History and Genealogy of the Families of Old* Fairfield, but this is the first time they have been published as a set (though they are serialized—over several years since there are so many). The original records are found in two volumes which are housed at the Fairfield Museum and History Center. We thank them for permission to print the transcriptions. Previous installments of this transcription can be found in Volumes 58 and 59, and in the last issue.

Marriages, 1806 through 1821

A note about these marriage records: There are a number of people who have no surname. Many of them are noted to be "Negro" or "Person of Color" or a "servant of" a member of the church, who is then named. These individuals are assumed to be enslaved people though there is no clear statement of the status of most of them. One is called "free woman" and several have no comments at all. The names of their owners or sponsors are included for context.



Editor's Notes

We continue Tom Mindrum's reports of his 17th-century ancestors from Fairfield. This issue presents Edward Adams and Joseph James. Edward is also an ancestor of Tom's wife.

Do you find the US censuses 1790-1840 to be useful? Many people dismiss them as mere chicken scratches. A short methodology article by your editor describes a way of narrowing down a range of birth years for those enumerated in those censuses.

With the centennial of World War I upon us, we publish a list of Connecticut-specific military databases from Ancestry.com for WWI and others. The list includes the newly released draft cards for World War II, for Connecticut soldiers and the rest of the country.

Member Katherine Dimancescu has written a book about her early Colonial ancestors who lived in Massachusetts, southeastern Connecticut and Fairfield County. Your editor provides a review of this work.

Publication of the Greens Farms Parish records continues in this issue, this time with the start of the list of deaths. So many infants died, many before they had a name. The original registers, held at Fairfield Museum and History Center, have been transcribed by Barbara Dempsey.

A note about the small world of early Fairfield County: Mary Guire, daughter of Luke Guire 3rd (great-grandson of Edward Adams) and Mary Adams (granddaughter of the same Edward Adams) married Daniel Wood⁵ (Jonathan⁴, Jonathan³) who was featured in Fred Hart's series about Jonathan Wood last year.

Your editor welcomes comments, and submission of articles. Remember that **your research can be preserved by publishing** the results in a journal. Besides general articles, we have three series to which you can submit short sketches: Fairfield County residents on the 1790 census, immigrants to Fairfield County, and the One-Page Challenge (bet you can't write just one!). Longer articles are welcome, too.

Edward Adams of New Haven, Milford, and Fairfield, and his Early Descendants

Thomas L. Mindrum

1. EDWARD ADAMS was probably born by 1619. Edward wrote his will on 7 August 1671 and signed it in the presence of Josiah Harvy and William Ward. The same two men conducted an inventory of Edward's estate on 11 November 1671, so Edward died sometime between those two dates. His wife MARY (___?___) married, second, ANTHONY BEERS. Anthony died before 14 February 1679 when an inventory of his estate was taken. Mary died in Fairfield before 18 August 1687 when her estate was inventoried.

Records exist in three early Connecticut towns for a man named Edward Adams. Historians including Savage, Jacobus and Bullard contend without offering evidence that the Edward Adams found in New Haven in 1640, Milford in 1646 and Fairfield in 1653 are one and the same person. Although Adams is not an unusual surname, no other Edward Adams appears in the deeds, vital records, church records, court records, or probate records of the time, leading to the assumption that he lived first in New Haven, then removed to Milford and finally removed to Fairfield. This assumption is supported by the fact that Edward Adams is not mentioned in New Haven public documents after 1640, nor in Milford public documents after 1646.

Testimony in a 1640 court case (regarding the veracity of previous testimony about the delivery of lime to a mill) places Edward Adams in New Haven on that date,⁶ but there is no record of property ownership or freeman status in New Haven.

At a general Court held at Milford on 16 March 1646, Edward Adams was granted a home lot on the conditions "that he will both learn to dress leather or skins and also follow his trade in the town, the lot that is granted him is the lot that was once laid out for a glover, with two acres in the Mill Neck, or thereabouts, and a proportion of meadow."

In 1653, Edward Adams bought land in Fairfield in two transactions, firstly, from Daniel Frost, four acres in the old field, and, secondly, a substantial purchase from Andrew Ward including a homelot, three acres in Barlow's Plain, six acres of meadow near Uncaway, two acres

of meadow in Sasco Neck, and three other parcels containing 13½ acres. In 1656, he bought three acres in Sasqua Neck from Nathan Gold. In 1664, he bought four acres in Barlow's Plain from William Ward. Bedward also sold land on nine occasions between 1656 and 1665. In 1668, he gave daughter Mary four acres in Barlow's Plain. When Mary was bequeathed two acres in Barlow's Plain in Edward's will, it was given on condition that she give back the gift of four acres.

Edward sold five acres "on the other side of the creek" to Henry Jackson in 1669. A sale to Jacob Gray of three quarters of an acre in the "old field" was not recorded until May 1679, over seven years after Edward's death.

Edward Adams' name was not contained in the list of Fairfield freemen published on 10 October 1669. To become a freeman, a person was legally required to be a respectable member of the Congregational Church and a resident of the colony for seven years. Edward certainly met the second requirement but there is no record of his admission to the Congregational Church in Fairfield, nor records of his children's baptisms or of his burial. At one point he was fined five shillings for "driving his cattle towards the bay on the Lord's day" operhaps he was not a religious church member and thus, denied freeman status.

Edward was not listed among those drawing lots for Sasqua land on 30 January 1668/9, Sasqua land in the New field on 8 February 1668/9, or the Compo dividend on 28 February 1671/2. However, he was named in the list of Inhabitant's proportion of lands in the common in the year 1670/1. He was also named in the "list of ye building lots, pasture lots & long-lots granted to ye inhabitants of ye town Jan. 1670-1" and received a building lot of 16 acres, a pasture of 13 acres and a long lot 25 rods (375 feet) in width. The long lots granted by the town of Fairfield became extremely valuable and while Edward died before he could benefit financially from it himself, his children Mary, Abraham and Nathan all became wealthy. [ed.: See an article in *Connecticut Ancestry* explaining the Long Lots. ¹⁸] It is unknown why Edward was sometimes granted land in Fairfield and other times denied grants.

Despite the fact that he died before 11 November 1671, he was named in a list of lots for the Old Indian Field drawn on 22 March 1681/2, so apparently his wife Mary continued to receive Edward's portion. Edward was not the only deceased man to receive a grant. At least four other men who were already deceased, Nathaniel Seeley, William Odell, John Barlow Sr. and George Squire Jr., also received grants, so perhaps it was a custom in the town to continue

providing grants to the families of the original landowners in Fairfield. Mary again received a grant of 3 quarters and 36 rods in the dividend of Old Indian Field on 10 Feb 1682/3. Edward's name appeared again the 1682 list of lots at Compo Neck, receiving 4 acres in the first division and 6 acres in the second division. In 1688, he was named in the divisions of Paul's Neck, receiving 20 rods. Again in 1688, on April 6, he was named in the division of Wolf Swamp, receiving 106 rods. ¹⁹

In his will dated 7 August 1671,²⁰ Edward made bequests as follows:

- Son Samuel Adams, house and homelot except movables
- Son Samuel Adams, one acre in the old field
- Son Abraham Adams, ten acres in Barlow Plain
- Sons Samuel and Abraham Adams, upland in Uncoway Neck
- Daughter Mary Murwin, and grandson Luke Guire after her decease, two acres in Barlow Plain
- Sons Samuel and Abraham Adams and daughter Mary Murwin, commonage and part of his long lot
- Wife Mary Adams, and sons Nathaniel, John and Nathan after her decease or remarriage, all the rest of land, housing and movables.
- Wife Mary Adams was named sole executrix.

The inventory of Edward's estate totaled £145 6p, making him one of the least prosperous of seventeen of the author's ancestors examined in Fairfield County from 1666-1681. His estate included the following:

Household goods including bedding, a chest, kitchen ware and candles	(£16.2s.6d)
Tools, including hoes, an ax, a saw, augurs and peas hooks	(£2.1s.6d)
Food and crops, including corn, oats, peas, wheat and beef	(£21)
Farm animals, including oxen, cows, horses, sheep, swine and four hives of bees	(£46.9s)
24 acres of land	(£60)

It is unclear why Edward's long lot was not included in his inventory but since he had only received the grant in January, perhaps the land had not been surveyed when he died in the fall of 1671.

There is no indication of leatherworking tools in his inventory so it is likely that Edward had abandoned his occupation as a tanner in favor of farming.

Edward and Mary Adams had six children:

i. SAMUEL ADAMS, died in Fairfield before 10 February 1693/4²¹ when his inventory was taken. He was married to MARY MEEKER.²²

- ii. MARY ADAMS, born about 1647²³ and died before 7 May 1712²⁴ when her will was proved. She married first LUKE GUIRE. Edward Adams' will referred to his daughter as Mary Merwin so it is evident that Luke Guire predeceased Edward. Mary married second _____ Merwin, and married third Stephen Sherwood.²⁵ Mary was treated in a previous article with her husband Luke Guire and her son and grandson of the same name and is not carried forward here.²⁶
- 2. iii. ABRAHAM ADAMS, born 6 September 1650 in Fairfield.²⁷
 - iv. NATHANIEL ADAMS, born before 1656, died unmarried before 1693.²⁸
 - v. JOHN ADAMS, died before 7 November 1693, the date that his inventory was exhibited in court.²⁹
- 3. vi. NATHAN ADAMS, born after 1656.³⁰
- 2. ABRAHAM ADAMS, son of Edward¹ Adams and his wife, Mary, was born in Fairfield 6 September 1650.³¹ He was baptized as an adult in Fairfield Church on 9 December 1694.³² He died in Fairfield 9 August 1729.³³ Donald Jacobus speculated that his first wife was possibly SARAH LOCKWOOD, born 27 February 1651, daughter of ROBERT and SUSANNA LOCKWOOD.³⁴ At the time of his death, Abraham was married to MARTHA (___?___). His will makes clear that Martha had had a prior marriage. After Abraham's death Martha Adams married _____ MILLER³⁵ and she died sometime after 20 September 1729³⁶ when Abraham's estate was distributed.

Abraham was a party to at least 27 land transactions in Fairfield from 1673 to 1728, fourteen as the grantor, thirteen as the grantee. A number of these were family transactions related to bequests of land by his father. The first took place in 1673,³⁷ two years after the death of his father, when he received ten acres in Barlow's Plain as deeded in his father's will. In 1678, Abraham sold to his brother Samuel a piece of upland that he had inherited from his father.³⁸ In 1684, he purchased land that brother Nathaniel had inherited from his father.³⁹ In 1689, he sold to brother Samuel, one half of his portion of his father's long lot in Fairfield.⁴⁰ In 1693, when brother John Adams died, Abraham received John's lands that he had inherited from his father.⁴¹

On two occasions, once in 1689⁴² and once in 1714, ⁴³ Abraham and his relatives received divisions of approximately 40 rods of their father's long lot in Fairfield.

In addition, Abraham purchased land in Fairfield from Robert Seeley,⁴⁴ Joseph Patchin,⁴⁵ John Wakeman,⁴⁶ John Thompson,⁴⁷ John Tompkins,⁴⁸ William Hill⁴⁹ and Samuel Morehouse.⁵⁰ He sold land at times to Abell Bingham,⁵¹ Daniel Morehouse,⁵² Gershom Bulkley,⁵³ Elizabeth Gilbert,⁵⁴ Benjamin Gilbert,⁵⁵ Thomas Turney,⁵⁶ and Nathaniel Nichols.⁵⁷ In 1684, he received a grant from the town of Fairfield for ten acres in the Whitewood Swamp⁵⁸ and then sold it back to the town in 1698.⁵⁹

On 7 November 1693, an inventory of the estate of John Adams, fourth son of Edward Adams, was exhibited at County Court in Fairfield, indicating that John had died sometime before that date. A document purportedly detailing a nuncupative (oral) will of John was also exhibited, but the court did not approve it. Instead it ordered that the estate be equally divided among the three surviving brothers, Samuel, Abraham and Nathan, and the surviving sister, Mary. 60 John's house and lands were to be divided among the brothers and the moveable (personal) estate given to Mary, except that to the extent that the moveables fell short of her onefourth share, the brothers had to compensate her accordingly. Since John's estate amounted to 145£ 12s (36£ 8s per heir) and the movables amounted to just 22£ 12s, the brothers were obligated to pay Mary 13£ 16s. One year later, though, on 6 November 1694, Mary sued Abraham and Nathan in Fairfield County Court for the debt due to her. The jury found for Mary, with the brothers ordered to pay her 6£ 16s 6d plus court costs. 61 Nearly two years later, on 4 September 1696, Nathan Adams had a 9.5 acre parcel of land appraised at 9£ 10s and told Mary's son, Luke Guire, that he would give it to Mary. 62 Five months later, though, on 26 February 1696/7, Mary filed a document in court making her son, Luke, "my agent or attorney to demand and receive of the Administrators of my deceased brother John's estate, one fourth part of said estate."63 But over four years later, on 11 March 1700/1, the case still was not settled, as Stephen

Sherwood, now Mary's husband, once again sued Abraham and Nathan. Once again, the jury found for the plaintiff, ordering Abraham and Nathan to pay 36£ 8s to Sherwood, but granted the defendants a review at the next County Court. On 4 November 1701, Abraham and Nathan countersued Stephen Sherwood for all costs and damages, but the jury once again found for the defendants, ordering Abraham and Nathan to pay 14£ 5s 9d, plus court costs. This time the court granted an appeal to the Court of Assistants held in Hartford in May 1702. On 5 May 1702, Mary Sherwood testified that she had told Abraham that she had withdrawn her review and that he did not have to go to Hartford. Whether the brothers had finally paid Mary her fair share or whether she gave up the pursuit of it is unknown.

On 9 December 1694, at the age of 44, Abraham was admitted to the First Congregational Church of Fairfield⁶⁷ and baptized the same day. ⁶⁸ His older two daughters, Deborah and Hannah, were baptized six weeks later on 20 January 1694/5. ⁶⁹ Three of the younger daughters, Mary, Abigail and Elizabeth, were baptized five weeks after that, on 24 February 1694/5. ⁷⁰ This flurry of baptisms causes one to speculate that perhaps Abraham married his wife Martha at about this time. Perhaps her religious convictions led Abraham and his daughters to the church.

In 1698, Samuel Adams, Jr., son of Abraham's elder brother Samuel, died at the age of 21 and Abraham became involved in a controversy with Elnathan Hanford, the administrator of the estate of Samuel Adams, Jr. The disagreement was detailed in the Private Controversies section of the Connecticut Archives. At the County Court held in Fairfield 15 March 1698/9, Adams accused Hanford of pulling down a fence and taking away wheat from land belonging to Samuel Adams, Sr. The jury found for the defendant, Elnathan Hanford.

One document summarized the controversy:

- 1. "Abraham Adams, Daniel Meeker and Mary Adams were appointed administrators of the estate of Samuel Adams and had come by the Court to take care of the children of Samuel Adams."
- 2. Although only about 17 when his father died, Samuel Adams, Jr., was allowed by the administrators "to act for himself and did for a considerable time act and deal as a free agent."
- 3. As a free agent, he grew some wheat on a parcel of land.
- 4. Upon the death of Samuel, Jr., in 1698, Elnathan Hanford was named administrator of his estate.
- 5. As administrator, Hanford took into his care the wheat Samuel, Jr., left on the ground and disposed of it according to the order of the Court.
- 6. "If any person is aggrieved by an act of the County Court, he may appeal to the Court of Assistants for redress and relief on that case. But Abraham Adams did not. Ergo."
- 7. The quantity of wheat was about 18 bushels and 3 pecks.⁷¹



Abraham subsequently did appeal the case and Hanford was directed by Thomas Staples, Constable of Fairfield, to appear at the Court of Assistants held in Hartford on the first Thursday of May, 1700. No record of the verdict could be found, but Elnathan's "bill of cost being plaintiff" survived, in the amount of 5£ 12s 4d, so it appears that Abraham lost the case and was forced to pay the plaintiff's costs.⁷²



At some point, Abraham switched his religious affiliation from the First Congregational Church to Trinity Episcopal Church. On 27 May 1722, he was baptized into Trinity Church by Rev. George Pigot. 73 The baptism was performed in Stratford although apparently "belonging" to the town of Fairfield. This was the earliest baptism recorded at Trinity. Three years later, Thanksgiving Day in 1725, the Abraham Adams family was one of twenty that met for worship at the first meeting house of Trinity Church on Mill Plain Road in Fairfield. That same year, Abraham was a vestryman at Trinity Church. 74 Abraham's gravestone (see image at left) names him a "worthy founder and liberal benefactor to Trinity Church."⁷⁵ The remains

of Abraham Adams and six other founding families of Trinity were found in Sturges Park in Fairfield by a construction crew in 2006. The bones were identified after two years of study by anthropologists and re-buried in Trinity Church Memorial Park adjacent to the church at its current location on 651 Pequot Avenue. 76

On 5 August 1728, Abraham wrote his last will and testament.⁷⁷ He made his first bequest to that Trinity Church, the sum of one hundred pounds, fifty upon his decease and the remaining fifty at the time of his wife's remarriage or death. He then gave his wife "during her life the use of all those lands I received by her in marriage which by her former husband were assigned during her natural life." Further, he gives her the "widow's third" of his real and personal property. The rest of his estate, both real and personal, is given to his daughters Deborah, Hannah, Mary, Abigail, Susannah and Elizabeth equally. A binding condition of the bequests of land, however, was that the new owner(s) would "forever ... annually pay a certain rate or tax to the Episcopal minister of Trinity Church in Fairfield which rate or tax shall be annually levied and paid according to the same proportion as is paid for lands of the like value to the support of the ministry by the inhabitants of that parish." Perhaps this was too much for the sons-in-law to abide. On 12 April 1729 at the Court of Probate held in Fairfield, the Court determined "that the said will shall be set aside and made void." Nathan Adams, younger brother to Abraham and co-administrator of the estate, was "admitted an appeal to the next Superior Court to be held at Fairfield on the last Tuesday of August" and posted bond of twenty pounds.

Interestingly, Henry Caner of New Haven, one of the witnesses to Abraham's will, exhibited that will in Milford, also on 12 April 1729, presumably an effort to have the will proved in Milford. As it turns out, Caner was an active leader of the young Episcopalian church in America. He went on to become the first clergyman to minister to the historic parish of St. Paul's Episcopal Church in Norwalk, Connecticut, that was founded in 1737. It seems quite possible that Caner was attempting to preserve the will's clause about the tax payable to the Episcopal Church by getting the Milford Probate Court to prove the will regardless of the outcome in Fairfield.

Although the result of the appeal has not been found, an estate agreement among Martha Adams and the six daughters and their husbands dated 10 September 1729⁷⁹ makes no mention of the tax. The agreement specified that after funeral expenses were deducted and the one hundred pound legacy was paid to Trinity Church, then the widow would receive one third of the movable estate forever and one third of the real estate during her natural life, plus the possessions that she brought with her to the marriage. The balance would be divided "in even and equal shares in quantity and quality" among the six daughters by 20 September 1729. In the event that they were unable to reach an agreement, they appointed Capt. Moses Dimon, Captain John Osborne and Lieut. Gideon Allen, or any two of them, to "make a division and partition of the said estate" for them.

The estate distribution was dated 19 September 1729 and signed by Dimon, Osborne and Allen. 80 No inventory of Abraham Adams' estate was found, but the distribution details an impressive estate of £1,630 7s 8d, including just under £300 in movables and £1,331 in real estate, approximately 50-60 acres of land. Martha received just under £100 in movable estate (33 per cent of the total) and about £332 in real estate (25 per cent of the total). Each daughter received about £33 in movables and £167 in real estate. The agreement indicates that it was "read and delivered according to the agreement before and unto the widow and heirs this twentieth of September 1729."

Abraham Adams had six children, all born in Fairfield:

- i. Deborah Adams, born about 1678, ⁸¹ baptized 20 January 1694/5. ⁸² She was married to James Bennett, the grandson of immigrant James Bennett, about 1701. He died before 25 October 1726 in Danbury, Connecticut, when his inventory was taken. ⁸³ Their children, all except Deborah baptized at Fairfield, ⁸⁴ were Gershom, Elizabeth, Ephraim, Hannah, Samuel, Abraham and Deborah. ⁸⁵
- ii. Hannah Adams, baptized 20 January 1694/5. She was married to Daniel Morehouse. The died in Fairfield on 24 May 1739 and was buried in the Old Burying

Ground in Fairfield. 88 Their children, baptized in Fairfield, were Abraham, Sarah, Hannah, Daniel, Samuel, Rebecca and Catherine. 89

- iii. MARY ADAMS, baptized 24 February 1694/5. 90 She was married to JOSEPH MARSHALL. 91
- iv. ABIGAIL ADAMS, baptized 24 February 1694/5. 92 She was married to JOHN WHITLOCK. 93 He was named co-administrator of Abraham Adams will along with Abraham's brother, Nathan. 94 He died in Fairfield before 1 May 1733 when his will was proved. 95 The will named John and Abigail's children: JOHN, ABRAHAM, NATHANIEL, JONATHAN and ADAMS.
- v. Susanna Adams, born in Fairfield say about 1688. She married about 1711, John Winton. 96
- vi. ELIZABETH ADAMS, baptized 24 February 1694/5.⁹⁷ She was married to BENJAMIN GILBERT.⁹⁸ Benjamin was baptized 19 May 1695, the son of OBADIAH GILBERT.⁹⁹ Benjamin and Elizabeth's children were MOSES, ABIGAIL, SARAH and BENJAMIN.¹⁰⁰
- 3. NATHAN ADAMS, son of Edward Adams and his wife, Mary, was born presumably in Fairfield and died there before 6 February 1748/9¹⁰¹ when his will was proved. He married first MARY JAMES before 5 December 1687. Mary was the daughter of JOSEPH and MARY (DICKERSON) JAMES. She was admitted to Fairfield Congregational Church on 23 December 1694 and also baptized on that day. Nathan married second JANE BLACKMAN sometime after 29 February 1712 when Jane's third husband, JAMES CLARK, JR., died. Nathan married third ANNA (____?___), who was named as his wife in his will.

Nathan was involved in at least 28 land transactions, 11 as the Grantor and 17 as the Grantee. He first acquired land as an inheritance from his father's estate. According to Edward's will, lands not specifically left to sons Samuel and Abraham and daughter Mary, were given to wife Mary Adams, and sons Nathaniel, John and Nathan after her decease or remarriage. Nathan also purchased from brothers Nathaniel 105 and John 106 in 1686 and 1689, portions of parcels they had inherited from Edward. On 5 December 1687, Joseph James granted land to

Nathan in consideration of the fact that Nathan "married my daughter Mary with my consent." ¹⁰⁷ In 1674, Joseph had purchased 120 acres in Westchester from John Winton. ¹⁰⁸ Nathan sold these same 120 acres "west of Eastchester on the other side of the Bronx River" to Samuel Ward in 1713. ¹⁰⁹

After the death of Nathan's brother, John Adams, Nathan and brothers Samuel and Abraham made an agreement on 18 Nov 1693 in which Nathan received John's house and home lot, a parcel of about seven acres located in Barlow's Plain. 110

On 12 March 1694/5, the town of Fairfield sued Nathan Adams for "fencing and improving and illegal possessing of the town's land." Apparently he had fenced a parcel of land that was not laid out to him by the town. The jury found in favor of the town but granted Nathan a review at the next meeting of the County Court. On 5 November 1695, Nathan sued the town over this issue. The jury found for the defendant and ordered Nathan to return the town's land and pay court costs of four shillings. But on 2 November 1697, the issue was still not resolved. The town of Fairfield once again sued Nathan for "peaceable surrender of a certain parcel of wheat upon the ground which the town recovered of him." Once again, the jury ruled in favor of the town and ordered Nathan to pay court costs of eighteen shillings. This time, he was granted an appeal to the Court of Assistants to be held in Hartford in May of 1698. No record of this court was found, but once again on 11 March 1700/1, the Town of Fairfield sued Nathan Adams in County Court for trespass in fencing in land belonging to the town and once again the jury found in favor of the town, directing Nathan to pay 3£ 7s 6d and cost of court. Again Nathan appealed to the Court of Assistants. On 22 September 1701 the town of Fairfield empowered Mr. Peter Burr to represent it at the Court of Assistants held in New Haven in October 1701. An undated page states that that in the case of Nathan Adams plaintiff and town of Fairfield defendant, the jury found for the plaintiff and ordered a surrender of the wheat in controversy. A bill of Nathan Adams' costs dated October 1701 totaled "in money, cash 1£ 6d, in pay 1£ 16s." Finally after six years, Nathan had won his case against the town of Fairfield and received in addition to his land and expenses, the wheat he had grown in the field. 111

In 1715 Nathan and brother Abraham purchased John Tompkins' long lot in Fairfield. ¹¹² In 1716, in consideration of four acres of the ship lot that was formerly Benjamin Turney's, Nathan exchanged to the Town of Fairfield a four acre parcel of land. ¹¹³ Nathan transferred land to a number of his children and other relatives: in 1711 two acres in Barlow's Plain to John Winton, ¹¹⁴ husband of his niece, Susanna Adams; in 1715 a six-acre homelot to son Nathan Adams, Jr.; ¹¹⁵ in 1721 to Luke and Mary Guire the long lot that had originally been John Thompson's; ¹¹⁶ in 1730 to son-in-law Nathaniel Wilson 8.5 acres that had been part of Edward

Adams' homelot;¹¹⁷ in 1738 to son-in-law Benjamin Sturges 74 acres in Redding;¹¹⁸ in 1749 to son-in-law Luke Guire two acres of Greens Farms salt meadow.¹¹⁹ Other land transactions by Nathan may have been mortgages where he lent money to relatives. In 1731, niece Deborah Bennett (daughter of Abraham Adams) received sixteen pounds from Nathan for a 40 rod division of Edward Adams long lot that Abraham had received.¹²⁰ In 1736 and 1737, son-in-law Benjamin Sturges received 276 pounds from Nathan for land that had belonged to Benjamin's grandfather.¹²¹

Nathan's second wife, JANE BLACKMAN, had previously been married to Joseph Russell, Thomas Griffin and James Clark, Jr. In 1734, Nathan and Jane sold land in Stratford that Jane had inherited from Thomas Griffin, one parcel to Jane's son, Zachariah Clark, ¹²² and another parcel to Zachariah Tomlinson. ¹²³ In 1736, Nathan and Jane sold land in Stratford to Jane's brother, Zachariah Blackman. ¹²⁴ This parcel had been inherited from Jane's grandfather, Moses Wheeler.

Nathan wrote his will on 22 August 1748. Witnesses were James Smedly, Hannah Jennings and Deborah Jackson. The will was proved in Fairfield 6 February 1749/50. In the will, he left to his son, Stephen, the irons belonging to the cart, the plow irons and a suit of his best wearing apparel. He also released Stephen from a debt of sixty five pounds. To grandson Nathan, son of Stephen, he left his gun and sword. To grandsons Nathaniel and Nathan, sons of his son Nathan, he left twenty shillings apiece. He willed that the covenant of "jointure" with his present wife, Anna, be ratified and confirmed. All the rest and residue of his estate both real and personal he left to his five daughters, Ganda, wife of Moses Knapp, Sarah, wife of Benjamin Sturges, Ruth, wife of Nathaniel Wilson, Mary, wife of Luke Guire and Avis, wife of Daniel Crowfoot. He also named his five sons-in-law to be executors of the will.

Nathan Adams and Mary James had ten children, all born in Fairfield:

- i. NATHAN ADAMS, baptized 23 December 1694.¹²⁵ He died before 6 April 1724¹²⁶ when his inventory was taken. He married Rebecca Clapham, daughter of Peter Clapham, about 1714.¹²⁷
- ii. NATHANIEL ADAMS, baptized 23 December 1694¹²⁸ and probably died young.
- iii. CANDEY ADAMS, baptized 23 December 1694. She was variously referred to as CANDEY, CANDA and GANDA. She was married to MOSES KNAPP, 30 son of JOSIAH and

- SYBIL (DICKERSON) KNAPP. 131 She renewed her covenant at Fairfield Congregational Church on 24 August 1712. 132 Moses was grandson of ROGER KNAPP, whose wife may have been the Goody Knapp who was hanged as a witch. Moses died before 17 November 1755 when administration of his estate was granted to his wife, Ganda Knapp. 133 Their children, baptized in Fairfield, were SARAH, DAVID, JONATHAN, REBECCA, MOSES, 134 HANNAH, RUTH, RACHEL, EUNICE and MARY. 135
- iv. SARAH ADAMS, born about 1695, died 4 February 1775. She married BENJAMIN STURGES in Fairfield 9 February 1715. 136
- v. Ruth Adams, baptized in Fairfield 11 October 1696. ¹³⁷ She married Nathaniel Wilson ¹³⁸ and died in Fairfield 13 June 1775. ¹³⁹ Nathaniel was born about 1689, son of Nathaniel and Elizabeth (Hendrick) Wilson. He died in Fairfield 8 May 1769. ¹⁴⁰ Nathaniel and Ruth's children were Robert, John, Ruth and Nathaniel. ¹⁴¹
- vi. MARY ADAMS, daughter of Nathan (4) Adams and his wife, Mary, was baptized 2 October 1698 at Fairfield Church. 142 She married about 1711, LUKE GUIRE 143 of Fairfield, her first cousin once removed. Mary was treated in the Guire article (fn. 26).
- vii. JOHANNA ADAMS, baptized 1 September 1700.¹⁴⁴
- viii. AVIS ADAMS, baptized 29 November 1702. 145 She was married to DANIEL CROWFOOT, 146 son of Daniel. Daniel was baptized in Fairfield 9 August 1702 and died in Redding before 18 August 1772 when administration was granted on his estate. 148
- ix. NATHANIEL ADAMS, baptized 1 October 1704¹⁴⁹ and died young.
- x. STEPHEN ADAMS, born about 1708 and died in Fairfield 5 November 1794. 150 He married, first, SARAH FINCH at Fairfield on 17 October 1727. 151 He married, second, ESTHER HILL, widow of John Hill and daughter of JOSEPH BULKLEY. Esther was baptized 20 December 1713. 152



Author's note: The author and his wife are ninth cousins, twice removed, with Edward and Mary Adams as their most recent common ancestor couple. The author is descended from them twice, through their daughter Mary Adams and their son Nathan Adams.



Joseph James of Fairfield

Joseph James died before 6 January 1687/8 when Abraham Adams and Mary James were appointed as administrators of his estate. Joseph married Mary Dickerson in Fairfield before 15 June 1665. Mary was born about 1641 and died before 21 August 1701.

Joseph James may have been in Fairfield as early as 1664. A receipt from his brother-in-law Thomas Dickerson recorded in 1677 indicated that Joseph had rented the farm owned by his mother-in-law, Mary (Dickerson) (Finch) Pinion, for the past thirteen years and that he had paid the rent in full.⁴

Joseph James first appears in Fairfield documents in 1674 when he purchased a 120-acre parcel of land in Westchester County, New York, from John Winton.⁵ (As to why this transaction was recorded in a Fairfield deed book rather than a Westchester County deed book, one can only speculate that Joseph had a signed bill of sale from Mr. Winton and wanted to record the transaction legally but didn't want to make an arduous journey to Westchester County to do so.) In 1680, the town of Fairfield granted James a one-acre lot located within the Common area of the town.⁶ On 20 January 1684, he traded lots with Samuel Robinson, receiving a 1-1/4-acre lot in Barlow's Plain in return for his one-acre lot in the Common.⁷ On 5 December 1687, about one month before he died, Joseph made a gift of his Westchester County land to Nathan Adams, who had "married my daughter Mary with my consent."

Joseph's name was not among the forty-four men named freemen in Fairfield in October 1669. Nor was he named on:

- 1. List of the lots drawn for Sasqua land in the New field 8 February 1668/9
- 2. Names of persons who share in the second division of the Sasqua Lands 30 January 1668/9
- 3. Those that removed the building lots at the rear of the lots into the half-mile common, 17 January 1671/2
- 4. List for Compo dividend, 28 February 1671/2
- 5. Inhabitants proportions of lands in the Commons granted to the inhabitants, 1670/1
- 6. List of the building lots, pasture lots and long lots granted to the inhabitants, January 1670/1

Neither Joseph, nor his wife Mary, nor any of their children are mentioned in the Barbour Collection of Connecticut births, marriages or deaths, nor in Connecticut Church Record Abstracts of baptisms, marriages or burials, nor in the Hale Collection of Cemetery Inscriptions and Newspaper Notices.¹⁰

On 9 October 1679 the Connecticut Assembly granted Joseph 50 shillings per annum because of disablement, "a wounded soldier in the late wars." Although this would appear to refer to King Philip's War fought in 1675-1676, a search of George Bodge's Soldiers in King Philip's War shows no record of James' participation in that conflict. 12

On 3 February 1686 Josiah Knapp entered a caveat against all land and housing of Joseph James. ¹³ Knapp's wife, Sybil Dickerson, was sister to James' wife and Jacobus suggests that Joseph may have been her guardian at some point. Knapp may have been trying to collect a legacy that had been entrusted to James on behalf of Sybil while she was a minor.

Joseph James wrote his last will and testament on 21 December 1687.¹⁴

The last will and testament of Joseph James in the year 1687. I give and bequeath to God my soul that gave it and my body to a comely burial. Item. I give and bequeath to my wife my house yard lot during her widowhood and at her marriage it shall return to my son Joseph and be his own. Also I give to my wife two old mares and to my son Joseph the youngest mare. Also I give to my wife all my swine. Also I give to my son Edward five sheep and my cow and calf. Also I give to my son Nathan two sheep. Also I give to my daughter Grace and Beth ten shillings a piece. Also I give to my daughter Sarah two sheep, a yo [ewe] and a yolam [ewe lamb]. Also I give to my daughter Sarah all my right in that pese [piece] of wheat that Daniel Burr sowed in Howard's land. Also I give to my wife the rest of my estate. To my wife [sic] also I give to my wife all the rest of my moveable estate. I give to my wife. And my wife to pay all of my debts out of that which I give to her. Also I give to my son Joseph my gun and sword, and Joseph shall pay to his brother Edward ten pounds when he shall come of age of one and twenty years of age. Also I make my wife executor of this my will. Also I will that Robert Seeley and Abraham Adams shall be overseers of this my last will as witness my hand this 21 of December 1687. Joseph James his mark.

This will is important in that it is the first document to name the children of Joseph and Mary James, other than daughter Mary: Joseph, Edward, Grace, Beth and Sarah. (The Nathan referred to in the will is likely James' son-in-law Nathan Adams, who receipted on 5 April 1690 for the two sheep left to him in the will.)

On 6 January 1687/8, a court in Fairfield declared that Joseph James was lately deceased so it is evident that he died in the few weeks between that court date and the date he wrote his will, 21 December 1687. The court appointed his widow Mary James and Abraham Adams, the brother-in-law of Mary James' daughter, Mary, as administrators of Joseph James' estate. 15

An inventory of Joseph's estate was taken on 17 April 1688 by Ephraim Nichols and Eliphalet Hill. 16

The inventory is interesting for what appears to be missing. First, the "house yard lot" that Joseph bequeathed to his wife is not in the inventory. According to land records, he owned a 1-1/4 acre lot in Barlow's Plain. Second, the "two old mares" that he gave to his wife and the "youngest mare" that he gave to son Joseph are not mentioned. Finally,

he gave "my cow and calf" to son Edward, but only the yearling (calf) is found in the inventory.

At average values of the period 1688-1699, a house and homelot was worth about £70, the three mares about £12, the cow about £3, so adding these to the previous total yields an estate of about £119 10s 3p. In terms of value, this estate ranks 22 in a list of 25 estates owned by Mindrum ancestors in Fairfield County during the period 1688-1699. Joseph James was not a wealthy man.

Two receipts survive to affirm that Mary honored the terms of her husband's will. In the year 1690, Sarah James signed her mark on a receipt stating she had received "the full sum of what my honored father was pleased to give me for my portion." On 5 April 1690, Nathan Adams acknowledged the receipt of two sheep from his mother-in-law Mary James, and wrote to "acquit and discharge her as administrator." 17

Despite these receipts, it appears that Joseph James probate case was not closed in the period immediately after his death. For whatever reason, fourteen years later, on 21 August 1701, the court noted that James' 1687 will had been "found" and that Joseph's wife, Mary (the executrix), was deceased and that she "did in her lifetime propose to execute the will," and that the court approved the will and caused it to be recorded, and appointed Sheriff Samuel Squire to "make inquiry after the estate that may be left" in case it had not all been distributed. There is no record of Squire's report back to the court.

Joseph and Mary James had six children: 19

- i. Mary James, probably b. by 1667.²⁰ As an adult, she was baptized 23 December 1694 in Fairfield.²¹ She died before 9 March 1734.²² She married Nathan Adams before 5 December 1687.²³ After Mary's death, Nathan married second, Jane Blackman²⁴ and third, Anna (___?___), who was named in his will of 22 August 1748, proved 6 February 1749/50.²⁵

- iv. Grace James



THE AUTHOR'S DESCENT FROM JOSEPH JAMES



Genealogy Education: Working out a range of birth years based on age categories on pre-1850 censuses of the United States and evaluating the accuracy of the findings

A glance at the United States census prior to 1850 gives the impression that there is little or nothing to be learned from these enumerations. There are lists of the names of heads of households, and then little numbers scattered across the page (or pages) of the census report. How can that be useful? A closer examination of the returns, and manipulation of the data, can result in a better understanding of the birth years of the persons who were enumerated.

What's on the page?

On the censuses prior to 1830 the government did not issue a standard form with printed headers for the columns. This sometimes makes it challenging for researchers to know what categories are represented on a page and to determine into which column the numbers are entered. Therefore, the first step in extracting data from these censuses—from any census—is to download a blank form. The second step is to look at the digital image of the census return so you can be the one to decide which column a number is in, or what the name actually says. The third step is to record the data for the entire household. Finally, follow the steps below for each individual to see if their reported ages are consistent from one census to the next, and to work with the data to get as close as possible to an accurate birth year.

Narrowing down the range of ages for individuals

I will use as examples Constant Taylor and his wife Hannah. Hannah is never named in these censuses—only Constant, as head of household, is identified—but the birth records of her children name their parents as Constant and Hannah,² and her headstone reads "wife of Constant." Therefore, we can assume she was his wife from before 1810 when their first child was born until her death in 1843,⁴ and the woman seen in his household on every census.

Constant Taylor was named on four censuses: 1810,⁵ 1820,⁶ 1830⁷ and 1840.⁸ This table shows the age categories in which he and his wife Hannah were listed.

Table 1. Age categories for Constant (left) and Hannah Taylor (right) on four US censuses, and the calculated range of possible birth years.




Figure 1. Chart displaying the range of possible birth years for Constant Taylor seen on US censuses 1810-1840.

The first line of the left table shows that in 1810 Constant, the only adult male in the household, was marked in the age range of 26-44 years. That means the range of his possible birth years is 1766 (1810 minus 44 = 1766) to 1784 (1810 minus 26 = 1784). To easily visualize the year ranges seen for each census year, the data have been entered into Microsoft Excel. Figure 1 illustrates data for Constant. The boxes in the first row, which represents the census year 1810, are shaded from 1766 to 1784. Similarly, the second row—1820—has the years 1776-1794 shaded, the third row—1830—has the boxes for 1781-1790 shaded, and the last row—1840—has the years 1771-1780 shaded. To deduce a birth year there needs to be an overlap of these ranges in all four census years, but there is not. See a discussion of this discrepancy below.

The same exercise can be completed for Hannah Taylor. The display shows an overlap of six birth years: 1785-1790 for her (light gray).




Figure 2. Chart displaying the range of possible birth years for Hannah Taylor seen on US censuses 1810-1840.

Why don't Constant's data provide an overlap of ranges? Closer examination of Table 1 reveals that the age category for Constant jumps not one 10-year increment between 1830 and 1840, but two (from 40-50 in 1830 to 60-70 in 1840). Could this be an error? Was Constant reported to be some years older in 1840 than his actual age? If he had been reported in the 50-59 year range, overlap would occur in the display, putting Constant's birth range at 1781-1784:

The next step in analyzing these data and evaluating the accuracy of this exercise is to compare ages found in other records. Ages for Constant and Hannah are found on their headstones. The headstones say Constant died 14 July 1847, age 60, and Hannah 9 September 1843, age 56. Calculations put the birth year for both of them as 1787. This does not agree with censuses, though. Hannah was reported in a younger age range in 1810, at a time when they may have been more aware of their ages. The year 1787 is right in the middle of Hannah's calculated range of possible birth years, providing a bit of leeway for her censuses to be correct.

A woman's possible childbearing years need to be considered. If Hannah had been born in 1787, she was age 23 when her first child was born in 1810 and age 35 when her last child was born in 1822. These events fall within the range of biological likelihood. Therefore, assigning Hannah a birth year of 1787 seems reasonable.

The age at death for Constant, however, does not consistently agree with his census age ranges, even using the younger adjusted age range for 1840. The census data predict he was born three to six years earlier than 1787. What other factors can be considered when attempting to reconcile this discrepancy?

Is the headstone information correct? When was the stone erected, and by whom? Did that person know Constant's age? Constant's reported age at death, "60," raises suspicion because it is a multiple of five. The informant who gave Constant's age could have guessed. The same sort of error may have happened when Constant's age was recorded in 1840. Perhaps he himself thought he was already sixty by that time. Considering these factors, it seems reasonable to assume that Constant was born within the year range 1781-1784, meaning his age range on the 1840 census and the reported age at death are both incorrect.

In fact, however, there is a record of Constant's birth: 22 May 1786.¹⁰ Therefore, his age was reported incorrectly in both 1810 and 1840 and the age on his headstone is nearly correct. In summary, calculating ranges of birth years can tell us if census reports are consistent, but deducing a tight range of birth years from pre-1850 censuses is not always successful.

Until recently, only the "old men's" World War II draft cards were available (database named "U.S., World War II Draft Registration Cards, 1942"). Now we see over 25 million cards for US men who were born 1898-1929, aged 18-44 when they registered. The Ancestry.com database includes images of the cards for men from Arkansas, Georgia, Louisiana, and North Carolina. The others, including Connecticut, are linked from the index to images at fold3.com.

The 1917 Connecticut Military Census informed the state of the qualifications of its male citizens in view of the approaching war. An interesting set of questions was answered by men age 16 and over including trade or profession, age, marital status, number of dependents, citizenship, and various skills, including whether they could ride a horse or drive a team, ride a motorcycle, operate a wireless, handle a steam engine or a boat, or swim well. Over 400,000 men responded. "U.S., World War I Draft Registration Cards, 1917-1918" contains records for over 383,000 residents of Connecticut who participated in one of the three drafts.

After the war veterans and the families of men killed in the war were asked to complete a survey for the purpose of memorializing those who served. Questions included "name, birth date and place, citizenship, church, father's name and birth country, mother's name and birth country, spouse, children (names, birth dates and places), occupation prior to and following service, employer, current address, residence prior to service, date and place of induction, unit, rank, branch of service, service history (training, transfers, promotions, engagements, wounds, etc.), comments and personal experiences.

See if you can find your ancestors in these great records.

Greens Farms Church Records, 1742 – 1851, continued Part 13: Deaths, 1744 - 1776

We begin our final section of these important church records—the deaths. These records have not previously been indexed, transcribed or microfilmed. Donald Lines Jacobus included the records in *History and Genealogy of the Families of Old* Fairfield, but this is the first time they have been published as a set (though they are serialized—over several years since there are so many). The original records are found in two volumes which are housed at the Fairfield Museum and History Center. We thank them for permission to print the transcriptions. Previous installments of this transcription can be found in *Connecticut Ancestry* Volumes 58, 59 and 60, and in the last issue.

Deaths, 1744 through 1776

A note about these death records: There are a number of people who have no surname. Many of them were noted to be "Negro" or "Person of Color" or a "servant of" a member of the church, who was then named. These individuals are assumed to be enslaved people though there is no clear statement of the status of most of them. The names of their owners or employers are included for context.

Book Review

Katherine Dimancescu. Denizens: a narrative of Captain George Denison and his New England Contemporaries. Published by the author, 2017. 486 pp, soft cover, \$22.50. Available from Amazon.com.

This book is a collection of nearly 40 essays that center on the author's ancestors who were among the earliest settlers in New England—Mayflower passengers and slightly later arrivals in The Great Migration. The format is unusual—the chapters are separate essays which do not follow directly from one to the next. This makes the reading experience less daunting since each essay can be read independently. They average ten pages per essay, so the book can be digested in short segments without losing track of a specific story line. Photographs of headstones, cemeteries, ancient buildings and historic documents are included.

The narrative style is a travelogue in which the author frequently uses a first-person perspective in reporting the steps she took during her research, and recalling conversations she had along the way. The naming in the text of the resources or repositories consulted or visited tends to distract from the narrative. Most editors would suggest leaving those references in the endnotes and concentrating in the text on the story that is to be told.

The book is something of a prosopography, discussing a cast of characters who inhabited New England at the same time. It provides a series of snapshots that illuminate the lives of specific people, but that combine to provide a generalized picture of the life of the community.

The author did extensive research in original documents at dozens of repositories in England and New England. She has included a 24-page bibliography and 658 endnotes. These references will be helpful to readers who may want to find similar information about their own ancestors. There is also an index of names, places and subjects which will help readers find persons of interest throughout the book.

The book opens on a specific date with George Denison of the title "standing in front of a roaring fire" in his home, reminiscing. This sort of imagined scene is found occasionally in the book and serves to bring the subjects to life. Other sections are highly detailed with research data. A case in point is the discussion of evidence that might support or refute the family story about where Denison recuperated from an injury incurred in the English Civil War (for which he, among others, returned to England from Massachusetts). One disadvantage of the essay format is that a reader cannot go to one place in the book to get a comprehensive view of Denison's life. Bits of it are revealed in various sections throughout the book.

Some of the essays focus on individuals: (12) The Lives and Legacies of Alice (Freeman) Thompson and Robert Parke; (20) The Voyages of Captain William Pierce. Others cover more general information: (13) The Pequot War: A source of Inspiration for *The Eliot Bible*; (19) The Roots of Slavery in the Massachusetts Bay Colony; (30) Summer Beams and Saw Mark Stories: First Period Houses and Homesites in Southern New England. The author connects most subjects directly to her ancestors. Though much of the action takes place in Massachusetts and southeast Connecticut, one essay relates specifically to her ancestors in Fairfield County: (29) Finding Feakes, Winthrop Women, and Shining Sands in Old Greenwich.
