Lewis; Arthur John, born November 27, 1894, married Dolsie Bergan, died January, 1969; Ardis Leah, born March, 1899, married Walter J. Blenko, died May 20, 1996. Two other children, Harry and Margaret, had died by 1895. Ardis (Jones) Blenko mentioned her mother's horse, "sedate old Dolly," and the "high stepping team, Dixie and Dandy" in her story Papa and the Ferris Wheel which appeared in Dickinson Diggings, Volume IX, Number 4 – November 1990. Time set is until May 11th, and it is hoped that all of our women will feel it their patriotic duty to register.

The Sewing club of the Felch school is now working for the Red Cross. They are making clothes for the Belgian babies. The club meets every Wednesday and Friday afternoons and they are working hard to complete two outfits before the school closes for the summer vacation. A few of the women of the community are also making two layettes for the babies.

The school board held their monthly meeting last Monday evening at the school-house and employed the two lady teachers at an advanced salary for the ensuing year. The principalship was left over until the next meeting. Miss Starrine was elected to principalship at the Metropolitan school. Miss Haltug was employed to fill the vacancy in the grammar room at Metropolitan.

The following Red Cross work has been turned out by the Felch township branch: West Metropolitan – Five sweaters, 6 scarfs, 6 pairs wristlets, 14 pairs socks; Felch – Thirteen sweaters, 4 scarfs, 4 pairs wristlets; Groveland – four sweaters, 2 pairs wristlets. This makes a total of 58 pieces, which is considered a very good showing for the number of workers, and we are still keeping up the good work.

Mrs. Jonas Blomquist passed away on Wednesday, and her infant son, for whom she gave her life, died the following day. She leaves to mourn her loss a husband, and seven children, consisting of four girls and three boys. The funeral was held on Sunday from the Swedish Lutheran church with Rev. B.E. Walters officiating. The bereaved husband and children have the sympathy of the entire community in their sad bereavement.

A patriotic farewell party was given at the Aid Society Hall for one of our honored men, August Branback, who left with other boys of the county for Camp Custer on Monday evening. Mr. Fuller, principal of the Felch school, was speaker of the evening and gave a very good talk. A collection was taken up for the honored man, which amounted to more than \$30.00. Coffee and refreshments were served after the entertainment, which was enjoyed by all.

The street facing the St. Paul depot was converted into a ventable [sic - veritable] midway, on which were located stands for the sale of ice cream, pop, lunches and coffee, and the usual "wheel or luck" was A platform was erected on the John Flannigan lawn, from which the exercises were held and from which the parade was reviewed. Old Glory and bunting decorations were in evidence everywhere. At ten o'clock the parade was formed, headed by Doto's Military Band, of Iron Mountain, and marched over the principal streets. At noon a bountiful chicken dinner was served at Idle Hour Theatre, and a large company enjoyed the same. After dinner the sports of the day were pulled off on the streets, and were productive of much fun by those who took part in them as well as the onlookers. The centre [sic - center] of attraction was the tug-of-war between two teams of ten men each representing Sagola and Channing. The rivalry between the two towns was sincere but good natured. The laurels, however, fell to Sagola, the home team fairly outclassing the Channing bunch. An addition to the regular program of sports was the slack wire and ball walking exhibition by Prescott Pringle and son,"Pecky." This was exceptionally good, comparing favorably with professional work. The horse race was a feature, as was also the girls['] race, in which the "overall girls" made a good showing, but suffered defeat. The sports and the winners follow:

After the sports the large assemblage congregated in front of the reviewing stand and listened to one of Rev. James Corcoran's characteristic patriotic addresses. Russell Pringle was the successful bidder for a pedigreed chicken. Frank Fruik was victor over Oliver Olson in forecasting the result of the horse race, and the Red Cross was a winner for the Pablo [sic] consumed. The issues of the Iron Mountain Press. Volumes 22 and 23 for the year 1918, are incomplete and have not been microfilmed. The newspapers were never bound and many are damaged or missing. For this reason the columns for the various settlements in Dickinson County and the surrounding area are being transcribed and printed in Dickinson Volume XXXI. and Diggings, Dickinson Diggings, Volume XXXII, so they will be available for genealogists and historians. The original issues are housed in the archives of the Menominee Range Historical Museum in Iron Mountain, Dickinson County, Michigan.

There is a tremendous amount of information regarding World War I in these issues which is of extreme historic significance.





The Victoria Lodge #262 of the Order of the Sons of St. George, a Cornish fraternal group, marched down the 200 block of East Hughitt Street in about 1905. The Swedish Mission Church (partially visible at far left), the Dr. Joseph Addison Crowell residence at 405 East Ludington Street, and the Nelson P. Hulst School on Madison Avenue with the Fulton School (left) and the Lowell School (right) annexes appear in the background. Dr. John D. Cameron, physician, and Dr. Crowell, physician and surgeon, had their offices at 204, the back portion of Seibert's Drug Store with the awning, in 1902. Matthias Lonprey operated a livery stable at 210, offering "First-Class Turn-Outs, Good Horses, Careful Drivers." Edward Seccombe had just opened his sample rooms (saloon) at 214, in 1892. By 1902 Sarah Seccombe, Edward's wife, operated the Steam Laundry here. The office of *The Monitor*, the only Swedish language newspaper on the Menominee Range, edited and published by James M. Enstrom, was listed at 216 in 1902. Felix Labrook ran a livery, sale and boarding stable at 220 in 1892, but by 1902 John Marsch, a railroad contractor, ran the sales stable. In 1892, John Watsic ran the St. Louis House at 224, advertising "Good accommodations at reasonable rates. A fine bar of wines, liquors and cigars in connection." Watsic was still the proprietor from 1902 to 1913. [Menominee Range Historical Foundation Museum]

here and will bring in a large flock of sheep. He informed the writer that he just sold his championship ram for the largest sum of money ever received for an animal -- \$9,500. Mr. Pratt stated that he had 5,000 sheep of the same strain.

The amount of the third Liberty loan assessed to West Branch township is rather high considering the conditions in the township. It is probably estimated upon the population or voting strength. We have only six families in in [sic] the township that are permanent residents. The balance is a floating population. The allotment would mean \$560 for each family. None of us are in the wealthy class, but, we will do our best, which, I am sure, will be up to the standard registered elsewhere.

The "Hoover" program given in the town hall by the Ralph school children was well attended and enjoyed by all. Patriotic and hoover recitations were given and some new victrola [sic - Victrola] records furnished the music. The last number of the program ended in a pleasing tableau in which the children representing our Allies appeared in costumes carrying flags of the nations represented. In the center of the group stood Uncle Sam and Mother World with the Stars and Stripes floating above them while everyone joined in singing the Star Spangled Banner.

West Branch township, so the writer is informed, will receive a large number of settlers this summer. They are going to be settlers with means to go ahead and make improvements. What we are lacking here is an outlet. We have no good roads to Iron Mountain nor [sic - or] Escanaba. The county road survey, made many years ago, connecting with Marguette county to the east, has been dormant for some time. The survey was made in 1910. I, for one, will refuse to pay a county road tax unless an appropriation is made by the road commissioners to open up this road. If the commissioners can point to one place in Dickinson county where a road is more badly needed, I will pay my county road tax without a murmur. The people of West Branch have shown themselves citizens of the proper stamp in everything they have been called

upon to do and we are surely entitled to some consideration in the matter of highways.

The laws relating to township affairs are wrong, in the opinion of the writer. The whole township board can be composed of non-tax-payers *[sic - non-taxpavers]*. The highway commissioner need not be a tax payer [sic - taxpayer], but the overseer of highways is supposed to be a tax-payer *[sic - taxpaver].* Why the other officers should not be tax-payers [sic - taxpayers] is beyond my comprehension. The overseer spends money as directed by the highway commissioner. This is all wrong. The quicker the legislature changes this law the better. No man should hold an office of any kind in a township unless he pays taxes. Why compel school officers to pay taxes and not township officials? It stands to reason that an officer who is a tax-payer *[sic - taxpayer]* has the best interests of the township at heart and will endeavor to secure best results when expending public money. In this articled there is no intention of casting reflections upon any person holding office. It is only intended to show that a non-tax-payer [sic - non-taxpayer] has not, or cannot, have the interest of the township so fully at heart as a tax-payer [sic - taxpayer], because he is not a part of the township.

#### **WARDENS ARE BUSY**

Round Up Notorious Violator Near Ralph and Kill His Dogs.

Roy Marvin, a member of the colony of Kentukians in West Branch township, a most flagrant violator of all the game laws, was arrested by Wardens Andrews, Leisner and Rough[.] Marvin was allowed to continue at work in order to earn the money to pay the fine which will be inflicted when arraigned in court here in the course of a few weeks.

The wardens were well pleased with their trip, although in order to get Marvin it was necessary for them to keep in the woods under cover for three days and nights. Marvin[,] since coming from Kentucky, with a band of wood-choppers from that state, has been one of the worst deer-slayers ever arrested in the state. For two years he has evaded the game wardens and it was very seldom that he ever showed himself in any settlement excepting those made up exclusively of Kentuckians. Most of his trips to the settlements were made at night when he delivered venison to his friends, who bought it from him. The settlement he frequented most was Papertown, where a large number of wood-choppers for the I. Stephenson company reside.

Marvin was so sly that it was seldom that any of the other men in the I. Stephenson camps ever saw him excepting when he would go to the camp supply houses to buy provisions.

"After a game of watchful waiting which necessitated our staying in the woods for three days and nights we finally landed Marvin," said one of the wardens. "No one could give us any information as to the whereabouts of his shack as he never confided to anyone where he lived. We received a report that deer hounds were killing deer in that district, but who owned them and where they came from no one seemed to know. Being determined to find out who owned the dogs and where they were being kept we

made up our minds that we would stay on the trail if it took us all summer.

"We kept out of sight of every one [sic - everyone], because as soon as a Kentuckian learned we were in the vicinity he immediately dispatched messengers to inform friends to be on the lookout for the wardens.

"After spending two nights in the woods, without hearing anything of the dogs, on the third morning just at daybreak we heard the braying of the honds [sic - hounds] several miles west of us. In our search for the dogs we accidently stumbled on Marvin's shack, which was located in a thick swamp. In it we found three hounds tied up, but the owner was nowhere in sight. In our search we found a large quantity of smoked venison and numerous chunks of fresh venison, which were hidden in barrels, which were sunk in the swamp to keep the meat cool and fresh.

"At dark in the evening Marvin returned to camp with two more hounds and he surely was a surprised man to find us at his shack. We placed him under arrest and proceeded to kill his dogs, which have been a menace to the deer life in that section. We shot the five dogs, all of which were fine looking hounds and everyone [sic – every one] trained to ruu [sic – run] deer.

"He spoke to each dog with tears in his eyes before we shot them. He told each one of them he was sorry to lose them, but it could not be helped and that their good times would soon be over with.

"We were unable to take out much of the venison, as we had to pack it twelve miles, just taking enough to be used for evidence. Marvin is rated as a bad actor and I have heard that he has made the boast that the game wardens would never dare arrest him or even come around his shack."

According to Deputy Rough, Marvin was a very resourceful man and has some excellent smoke houses rigged up in the swamp. He used to hang his venison up with wires in an air-tight barrel over the fire places, which were made in the ground. For storing the meat he had dug holes to the water level in the swamp and he put air and water tight boxes into the holes into which he put the venison in order to keep it. The boxes were covered over with brush.



## DICKEY'S TRADING POST - NEAR QUINNESEC



George Frederick Seibert, pioneer Iron Mountain druggist, recorded his stop at Dickey's Trading Post in his journal during a trip up the Menominee River in 1879.

James S. and William Dickey, among Dickinson County's earliest pioneers, established their trading post on the SE ¼ of Section 34, Town 40 North of Range 30 West (northeast of Quinnesec) in about 1871, trading with the Indians and providing basic supplies to early explorers. Almost all contemporary accounts mention stopping at Dickey's on the old State Road until about 1880, when the Dickey brothers pursued other occupations.

William Dickey settled in Norway in 1880, where he established a livery stable and blacksmith shop. By April, 1885, William Dickey had a livery stable in Marinette, Wisconsin, and James S. Dickey was farming in the Iron River area. The Dickey brothers later moved out West.

Sunday Morning, May 6, 1879: Arrived at Dickey's at 6:30 [p.m.] and was not favorably

impressed by the outside appearance, but found myself mistaken in my estimate of the place. We got a splendid supper and found a very pleasant woman in Mrs. Dickey...Had a smoke and was standing in the store...when two Redmen came in and commenced talking with the Dickeys. The only thing I understood was "kee win" (no friend). The Dickeys being traders and buyers of furs spoke the Indian dialect fluently, and kept up a conversation for over half an hour with them. The Indians took some crackers and drank some - gin, I think it was, and then made as they would go, but they hung around for a long time even after we went to bed. Dickeys, I think, are very nice people, but I don't think they would scruple at anything to make money. The selling of liquor to Indians is punished severely, but they did it. They have furs of all kinds in their store, fisher, otter, beaver, lynx, mink, fox, etc. They keep overalls. cigars, tobacco, pipes, whisky, prints, and groceries. Store is small, but large enough to do all their trading with the Reds.

## The Iron Port, Escanaba, Mich. August 9, 1879

VULCAN – A number of Indians – men, women and children – came into town Wednesday last from Bad Water [sic] for the purpose of selling berries, furs, etc., having with them a lot of regular Indian ponies. They make a novel picture as they go along one after the other, looking more like Indians we read about than those usually seen in civilization, and are always looked upon in wonderment by strangers, though it has long since lost its novelty to the residents here. – The Menominee Ranger
