

### Your Membership Dues



All memberships in the New Brunswick Genealogical Society expire on May 1 of each year.

Membership entitles you to receive four issues of GENERATIONS, namely June, September, December and March of the 12 months for which you have paid membership dues. Presently, dues are \$15.00 annually for individuals and \$20.00 for families.

If you join N.B.G.S. or renew your membership later in the year, we make your membership retroactive to May 1 of that year and supply you with any back issues of GENERATIONS which may have already been published in the 12-month period in question. Due to unusually heavy demands for certain issues it is not always possible to supply all back issues, but we try.

We like U.S. members to pay in currency of their own country because the exchange is offset by the higher mailing costs to U.S. addresses. As of July 1, 1987, the cost of mailing a copy of GENERATIONS to a U.S. address will rise to 86 cents.

One more point-- S.A.S.E.'s from U.S. members should carry Canadian stamps or be accompanied by International Reply Coupons. non-Canadian stamps cannot be used to post mail in Canada.

Pre-1784 New Brunswick Land Grants

Editor, GENERATIONS:

As a researcher, family historian and a member of your Society, the N.S. Genealogical Association, and the United Empire Loyalists, I have been troubled and at times frustrated in "getting the facts" concerning early New Brunswick land grants. Some of the problem results from the fact that New Brunswick was created as a province in 1784 and that land grants up to then (August 1784) were recorded as Nova Scotia entries in Halifax. Currently at the Public Archives of Nova Scotia, there are records of (N.B.) land carded in various ways including Cumberland County (N.S.) and Sunbury County (N.S.?) and references to the Crown Land offices in Halifax and Fredericton.


I have discussed the matter with local officials, including the N.S. Lands and Forests Dept. who maintain the Provincial Crown Lands Records Centre. They provided me with the attached lists of New Brunswick entries which will help researchers; I hope you will be able to publish this letter and the lists. The lists are titled:



—Editor's Note: We know of no place in New Brunswick called Wick. There is a Wicklow Parish in Carleton County and a Wickham in Queens County. Mr Black died 8 May 1899 at age 27 and is buried in the old North End Cemetery, Port Elizabeth, South Africa.






# John Mersereau

## LOYALIST

John Mersereau was a native of Staten Island. He was a grandson of either Daniel or Joshua Mersereau, brothers who came from France to New York via England circa 1688.<sup>1</sup>

He was born in 1735 and married Charity (Gertrude) Van Horne circa 1755. John and Gertrude had five boys; John, Lawrence, Jacob, Andrew and David.

Several of John's cousins were "Patriots" and included spies for General Washington.<sup>2</sup> John Mersereau was a Loyalist and took refuge in New Brunswick.<sup>3</sup> It is only from this point when he was 48 years of age that much is known of his life.

John became Captain of refugee Company 16 which evacuated New York in July 1783 aboard the "Lord Townsend".<sup>4</sup>

Son Jacob, and likely others remained behind on Staten Island to settle their affairs and to keep what they could from the "rapacity of the enemy".<sup>5</sup> It is curious that Jacob found it safe to remain on Staten Island while his father evacuated. John's material losses of 2000 pounds could have weighed more heavily than safety.<sup>6</sup> A claim of that size would have been large if it had been submitted to London. However, John learned of the Royal Commission of Claims of the American Loyalists only early in 1784 and it was too late to make a submission.<sup>7</sup>

### ARRIVAL OF EARLY MERSEREAUS<sup>8</sup>

There were two groups of Mersereaus arriving in Parr Town in 1783. Firstly, there was Captain John Mersereau with sons Lawrence and Andrew. Some Mersereaus hold by tradition that other sons came for a while. Secondly, there was a Paul Mersereau who arrived with sons Paul jr. and David. Paul's other son John may have come to Parr Town.<sup>9</sup>

Both groups of Mersereaus came from the New York area and they were certainly cousins.

D. G. Bell lists two Andrews, two Pauls, two Johns and a Lawrence - but no David. Relationships remain a puzzle but a tentative framework is in the Appendix.

### STRUGGLE FOR LAND

Upon arrival in Parr Town John immediately

went up river to Maugerville. There, in August, he bought half of lot 93 from pre-Loyalists Stephen and (Eliza or Francis) Peabody.<sup>10</sup> This lot is opposite the head of Middle Island.

Mersereau was one of the first Loyalists in Maugerville, moving so quickly as to indicate that his plans were made on Staten Island.

With a lot in hand John returned to Parr Town where he stayed until the spring of 1784.<sup>11</sup> Emergency provisions were being issued at Parr Town and the Peabodys had retained ownership of their 1783 crops.

The summer of 1784 was spent with Joseph Clark exploring the Oromocto River with Maugerville as their base of operations.<sup>12</sup> The two men complained in the fall that they still had no lots of land. It would have been more accurate for Mersereau to have said that he still had no grant of land.

The competition for land around Maugerville was fierce. There were even incidents of turning Acadians off land which they justly owned. Fences were burned, cattle were stolen and root cellars were destroyed.<sup>13</sup> Loyalists would quickly petition for land occupied by others so long as any basis for disputing a claim could be found. The upper Oromocto had only a few "squatters" and was a good place to try to get an early grant with little opposition.

Mersereau and Clark formed a group during late 1784. The group included Mersereau's sons Lawrence and Andrew and eight other families and single men. They planned a new settlement to relieve their "ruinous and unhappy circumstances". The settlement was to be on the South West Branch of the Oromocto River at what would become Bailey (Mersereau Stream).<sup>14</sup> This was well above any other settlement.

Mersereau and Clark believed that New Brunswick would profit from their proposed settlement and they stressed this to the authorities. They would promote a road to Carleton, West Saint John, opening the wilderness.<sup>15</sup> They would also draw settlers to the nearly unoccupied upper Oromocto.<sup>16</sup>

This was a pioneering proposal but the 300 to 500 acres each that they requested was

twice too much, and the whole plan failed on that account. The authorities noted the group's "several (other) allotments" in rejecting them.

Mersereau spent the winter of 1784-85 in Maugerville.<sup>17</sup>

In 1785 John finally received a lot on the South West Branch. Others had taken up lots there also, and John claimed credit for this.<sup>18</sup>

In 1787 John was granted another lot on the Oromocto at Blissville. Again he stressed his efforts in promoting settlement.<sup>19</sup>

John eventually left the Oromocto and returned to his lot in Maugerville where he would spend the rest of his life. He was a farmer.<sup>20</sup>

Many of his descendents lived in the Bailey and Blissville area. Some of the earlier of these were Andrew, Andrew jr., Thomas, grandson John, Gain T., Jacob V., and Daniel W.<sup>21</sup>

#### COUNTY COURTS AND THE ESTABLISHED CHURCH

Mersereau was appointed one of the first Wardens of the Church of England in Maugerville on September 29, 1784 by the Rev. John Sayre. Sayre was the Loyalist Agent who was being assailed for representing the few with more vigor than the many.<sup>22</sup> Mersereau would draw the plans for a rectory for the Rev. James Bissett, one of Sayre's successors and the first College headmaster.<sup>23</sup>

On July 6, 1785 John was appointed a Justice of the Peace in Sunbury County.<sup>24</sup> As a JP he was one of eight members of the Court of General Sessions of the Peace which dealt with criminal matters. He and three others were "justices of the quorum". No lawful General Session could be held without one of them being present.

He was also one of three justices of the Inferior Court of Record of the Common Pleas which dealt with small civil cases.

Being a member of both inferior courts and being a justice of the quorum indicated status. Certainly James Simonds was the leading justice.

Justices of the Peace would not have been termed "Judge" or "Justice" except in court records.

JP's also had administrative duties such as issuing warrants, appointing constables, gaol keepers, assessors, various clerks, commissioners of roads, weighers of hay and so forth.<sup>25</sup> Mersereau ordered payment in 1792 for repairs to the Sunbury gaol.<sup>26</sup>

John Mersereau's fellow justices initially included James Simonds, Thomas Colden, Samuel Peabody, William Hubbard, Gerardus Clows, Joseph Clark and Richard Vanderburgh.

Clark was also a refugee Captain and a sometimes partner of Mersereau. Peabody and Simonds arrived around 1759 and had been justices of the pre-Loyalist Nova Scotia County of Sunbury. Richard Vanderburgh had carried Burton area Loyalist claims to the Royal Commission in London. He eventually returned to the United States.<sup>27</sup> Clows was an officer in the Royal New Brunswick Regiment, and died of a fall from a horse.<sup>28</sup>

John Mersereau was a respected magistrate, but this should be interpreted carefully. Most magistrates brought little education or special qualifications to their office.<sup>29</sup>

#### BOARD OF ARBITRATION

John Mersereau was a property appraiser for the Board of Arbitration in the handling of claims by pre-Loyalists whose land had been expropriated. He apparently ordered new grants for Acadians displaced from the Jemseg area.<sup>30</sup>

Property appraisal was a serious business. In 1784, thirty pre-Loyalist families (233 souls) in Gagetown objected to being turned off their lots.<sup>31</sup> All they could hope for though, was some payment for their buildings, clearings, and other improvements. The Loyalists feared that others might agree that the "squatters" deserved something and proposed that the government compensate them instead. When the Governor threatened to sue the Loyalists if they did not pay what was due, they arranged for Mersereau and other Loyalists to join the Board. Evaluations were rolled back, some drastically. Eventually the Governor changed his mind and compensated the indigent pre-Loyalists directly.

#### RELIGIOUS DISPUTE<sup>32</sup>

There was a good deal of friction between the Church of England and the dissenting Protestants.

A group of Dissenters of the pre-Loyalist "Congregational" church had been using lot 90 in Maugerville for their services. The struggle for land resulted in their being more or less evicted by the Church of England and in 1789 they hauled their meeting house three miles down the river ice to lot 15 in Sheffield.

The preacher was in the midst of a lively debate with his congregation. He was accused of extravagant and whimsical salary demands, absenteeism, dereliction of duty and laziness while present, associating with undesirables, drinking to excess, hot headedness, and some unspecified "scandalous indecencies" involving a young lady. He was not popular.

Faced with an uprising among his congregation, the preacher announced in March 1792 his conversion to the Church of England, "the most indulgent and least censorious church in the world". He continued to preach in his new fashion and

to his new congregation in the lot 15 meeting house. He also kept the livestock which had been his as a preacher to the Dissenters.

During 1793 the Church of England petitioned for lot 15, disputing the Dissenters' claim to that property also. The petition bristles with the aggravation of the established church and was signed by John Mersereau, sons Lawrence and Andrew, and 120 others. They were particularly annoyed at being termed few in number and unworthy of notice. They had no sympathy for the Dissenters who were being forced from lot to lot.

On August 6, 1793 two Dissenters "peacefully" occupied the lot 15 parsonage and stayed despite the arguments of Justice Hubbard and Sheriff DeVaber. DeVaber was one of the most powerful officials in Sunbury.

The next day Hubbard and the Sherriff returned with Justices Mersereau, Clark and Miles, and a man named Carvell. Carvell had two loaded muskets and was criticized for not having brought bayonets.

They all took control of the parsonage, or tried to.

Mersereau and the others said that they were there as justices, but the evidence is that they were there as churchmen. Mersereau, Clark, DeVaber, Hubbard and Miles were signatories of the 1793 petition for lot 15. Miles, Clark and Hubbard were Vestrymen. Mersereau was a Warden.

Hubbard maintained that the occupation had been forcible, but Mersereau finally admitted that it had not. Mersereau was also at a loss to produce a transcript of any lawful proceedings.

The Dissenters played down their own fervour in the affair. It is doubtful that any occupation was ever so gentle as the one which they described. It took two days for six prominent men with two muskets to dislodge them.

Finally the Dissenters kept their parsonage and the established church was given another lot.

#### LIFESTYLE <sup>33</sup>

John was probably comfortable, but was not wealthy. His financial worth by 1814 was 1151 pounds. Nearly all of this consisted of his farm in Mougerville, crops and animals. Furnishings consisted only of 3 beds, 2 tables, 8 chairs, a chest, a carpet and a mirror. Other household effects were few and little of his estate could be turned to quick cash.

The value of the Mougerville farm was average. However, his 25 acres under plow was in the top decile for the Upper District. He had less than the average amount of meadow land and he had no pasture land at all.

Livestock was at a low ebb at tax evaluation time in 1811. The probate inventory of 1814 shows that he had an average amount of livestock from time to time.

A mystery about the inventory is the total absence of cash and of silver plate. His will of November 1813 made cash allowances of 96 pounds to friends and left his silver plate to Gertrude.

#### LEGACY <sup>34</sup>

John Mersereau died on July 9, 1814. They said at the time that he was 93 years old, though he was likely only 79.<sup>35</sup>

Both of John's New Brunswick sons were Captains in the Sunbury County Militia. Andrew is said to have been second in command on the march of the 104th Regiment to Quebec in 1812. The 104th went on to Montreal and Kingston, a march of 700 miles in 52 days. There were heavy casualties in several battles and the cold killed "all the hardest drinkers".<sup>36</sup>

Lawrence established a winter mail service between St. John and Fredericton in 1787. He was a Justice like his father. This sort of patronage was common. He was also a delinquent tax payer.<sup>37</sup>

Three of John's grandsons were militia officers and one was a preacher. Militia service was part time and generally uneventful. However, the value placed on participation in the military by early Mersereaus provides a hint for further research in New York.

#### AUTHOR'S NOTE

This is what has been learned of John Mersereau. Facts outnumber fables, but further research would certainly change parts of the story.

The search was not exhaustive and easy opportunities for further research include the following.

1. Little historical research has been done in New York, as far as I am aware. He must have left records in New York, judging from the number of records he left in New Brunswick.

2. Two land petitions listed in the Archives' index were not found where they were expected.

- a- "Mersereau, John, 1790, Sunbury 224, 230, 265; see Bliss, Daniel"; not found on film F-1037.

- b- "Mersereau, John, 1785, Charlotte 45", (and likely of Company 45); not found on film F-1027.

3. The Chipman Papers include a document relating to Mersereau and the Board of Arbitration. A letter to the National Archives yielded footnote 26 instead.

4. Footnote 20 refers to the Hubbard Papers. This document was known to exist and was obtained by mail. The Papers themselves have not been searched.

#### APPENDIX

##### EARLY MERSEREAU ARRIVALS AND THEIR RELATIONSHIPS 38

Captain John Mersereau, one servant (slave?) and sons Lawrence and Andrew arrived with Companies 16 and 27 at the end of July or in early August. Another Andrew Mersereau with Company 16 remains unidentified.<sup>39</sup>

Gertrude arrived late in the summer with another group.<sup>40</sup>

Paul and Paul jr. arrived with Company 13 on the "Duchess of Gordon" with the June fleet.

David Mersereau arrived in May 1783. If he was a "child over 10" with another group then this would explain his not appearing on D.G. Bell's list. David was apparently Paul's son.<sup>41</sup>

Another John Mersereau arrived with Company 45 under Captain John Ford on the "Mary" in

October. He too was apparently a son of Paul.<sup>42</sup>

John of Company 45 was the one who relinquished a lot in Dipper Harbour to join Captain Ford during the winter of 1784-85.<sup>43</sup>

It is doubtful that Captain John Mersereau was the one who received a lot in Parr Town in 1784. This was likely John of Company 45.<sup>44</sup>

As stated, Captain John's son Jacob remained behind on Staten Island. By early 1786 he was preparing to move to New Brunswick. No evidence has been found that he actually did move.<sup>45</sup>

The tradition that other brothers of Lawrence and Andrew came to New Brunswick for a while is reasonable but unproven.<sup>46</sup>

"Staten Island and its People" by Leng and Davis is said to report that it is difficult to trace John's parentage (undated letter from the Staten Island Historical Society in the FHC).

Notwithstanding the above, Daniel and Joshua were the first New York Mersereaus.

The National Archives has announced that individuals can participate in the Microfilm Rental Program. This program, which is now operating, allows any individual to rent National Archives microfilm. These are the only available microfilm rolls copied directly from the original silver masters maintained by the Archives.

In addition, the program introduces new lower rental fees both for direct participants and for those who order through such institutions as libraries or genealogical societies. These new rates, the lowest available, are \$3 per roll for orders of 4 rolls; \$2.50 per roll when 5-9 rolls are ordered; and \$2 per roll for orders of 10 or more rolls. In addition, the \$3 postage and handling fee is waived for orders of 4 or more rolls.

"We're delighted that the Microfilm Rental Program is now able to offer this high-quality microfilm, not only through libraries, but also directly to individuals," said a spokesperson for the National Archives.

"That way, more researchers can enjoy the benefits of access to this valuable resource. The new program will expand the customer base for the rental program, increase public awareness of it, and continue to build on our reputation for quality customer service."

The new direct-order program does not replace the present rental service which operates through local libraries. Novice genealogists who prefer to have experienced ordering assistance can still order microfilm through participating libraries. Experienced genealogists, however, can take advantage of the efficiency of the direct order program.



## LUNATIC ASYLUM

Daniel F. Johnson

While casually perusing Provincial Government documents, I often encounter *gems* which are far too interesting to pass by. The following reports appear in the *Journals of House of Assembly 1838-1839: Appendix* [Provincial Archives of New Brunswick]

Whether similar reports were published in previous or subsequent Journals remains to be determined. It should be noted that the following information was not transcribed from the Journals, namely: dates of admission, discharge or escape from the Lunatic Asylum. Also omitted in this compilation was the character of the disease which ranged from *ordinary insanity* to *raving lunacy*. In addition to the lists below, the Journals contain interesting general information concerning the treatment and physical condition of the inmates.





## The New Brunswick Museum

It is our sad duty to inform genealogists and other researchers who intend to visit the Library & Archives Division of the New Brunswick Museum (NBM) at 277 Douglas Ave., Saint John, N.B. that services at that institution have been seriously curtailed. In July 1986, hours of operation of that division were cut by 60%. Recently, microfilm reels of newspapers have been completely withdrawn from public access and stored in sealed boxes for an indefinite period. Researchers cope without card index finding aids which have been sent away for microfilming. Recently the interlibrary loan program has been cancelled.

Since the establishment of the New Brunswick Museum in 1930, the institution has fostered research by providing library facilities to the public. Local organizations and individuals have responded by donating journals, diaries and documents which have enabled the NBM to build the largest private manuscript collection in New Brunswick. Many works donated represent the life work of some individuals. Some documents predate the arrival of the Loyalists. The manuscript collection in many cases contains works that are unique to that institution. Until recently, the NBM has attracted researchers from all points of North America.

Local historical and genealogical societies were shocked last July with the sudden announcement, that hours of operation of the Library and Archives Division of the NBM would be cut to two days per week. Researchers who had travelled to Saint John from distant places had to adjust their schedule or abandon their efforts altogether.

Local organizations responded immediately, urging the Museum Board to postpone their decision. The Board cited lack of provincial funding as the reason for budget cutbacks. Their references to local researchers as amateurs and hobbyists underscored a prevailing attitude toward the users of the Archives Division. The fact that there was no cutback in provincial funding has drawn serious criticism.

Despite a public outcry and a barrage of private letters, several months elapsed before the New Brunswick Museum Board organized a committee to meet with concerned groups and individuals. In the fall of 1986, representations were made before the Board's Committee by The New Brunswick Historical Society, The New Brunswick Irish Cultural Society, The Saint John Branch, New Brunswick Genealogical Society, The Queens County Historical Society, The Kings County Historical Society and other university and educational groups. The Committee's report, though presented to the Board at their semi-annual fall meeting has yet (as of May 1987) been made public.

Despite the Board's denial that the Museum is abandoning its traditional role as a centre for educational and historical research, a number of actions have been taken which suggest otherwise.

Alan D. McNairn, Director of the New Brunswick Museum in the March - April 1987 issue of NBM news defines the new direction of the Museum.

" Research (by NBM staff) is the mandate of the New Brunswick Museum which is charged with the exhibition, conservation and interpretation of scientific specimens and man-made objects. In the pursuit of their studies, which lead to acquisition of specimens and artifacts or to the presentation of an exhibition or to the publication of findings in academic journals, catalogues and books, curators require a large research library, laboratories, contact with other specialists and familiarity with the collections of other museums and art galleries around the world."

Obvious by its omission is the role of the Library & Archives as a research centre for the public. The role of this division has been redefined as the personal library of the administration. This indicates that a major shift in policy has been made without public consultation or approval. The recent administrative actions have enhanced concern that the public will eventually lose access to a depository of some of Canada's oldest private manuscripts.

The failure of the Board of the NBM to act has intensified the alienation felt by traditional Museum supporters. Apparently the Board is prepared to sacrifice an essential public service in order to redirect funds for other purposes.

We would request that the editors of genealogical societies in the United States and Canada alert their members who intend to visit Archives & Library Section of the New Brunswick Museum to the present circumstances. The conditions described are unique to the NBM and do not in any way reflect on the excellent service provided by other New Brunswick institutions.
