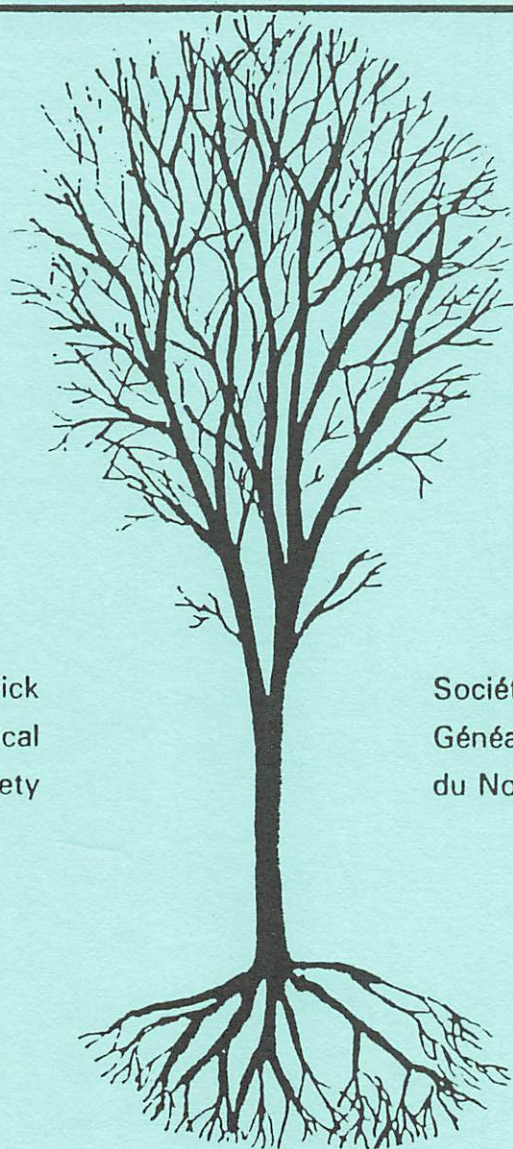

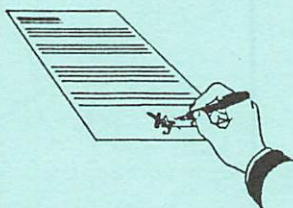

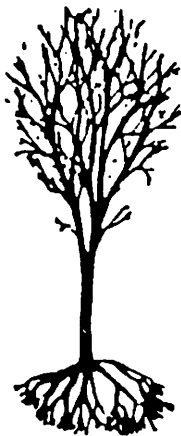


From the Editor's Desk

Compiling and Publishing Your Family History

4. **James VI**, King of Scotland (James I, King of England), was born in Edinburgh Castle June 19, 1566, and died in Theobalds, Herts, March 27, 1625. He was married in Westminster Abbey in 1567 (Scotland), 1603 (England), November 23, 1589 (Oslo), to

5. **Anna**, Princess of Denmark. She was born in Skanderbourg Castle October 12, 1574, and died in Hampton Court, March 2, 1618/19.

6. **Henri IV**, King of France and Navarre, was born December 14, 1553. He was assassinated in Paris May 14, 1610. He was married in Florence, October 7, 1600, to

7. **Maria de Medici**. She was born in Florence April 26, 1575.

Writing the text

1. It is important that you state your purpose and select a numbering system before you start writing the text. You must know what you are going to include and how the material will be arranged; otherwise you may spend many extra hours rearranging and rewriting.

2. If you have never written anything for publication, a short article on one subject might be a reasonable point of beginning. You will realistically be able to reach your goal, you will learn something about writing, and success will build needed confidence. There are many potential places to have genealogical articles published. Your genealogical society newsletter is one.

3. Set a date to finish. Be realistic and allow enough time.

4. Set aside some time each day or each week to write.

5. Don't stop to look up words in the dictionary, and don't worry about your style.

6. Don't allow anything to interrupt your writing time. Try to finish one segment during each writing period.

7. It is difficult to keep many ideas in mind at one time, so while you are writing one segment, don't think about the other segments. Concentrate on what you are doing at the time.

8. In the beginning you may need a lot of self-discipline, but stick with it. Don't quit!

9. Enjoy it. A real pleasure comes to those who write.

10. Compiling a genealogy involves more than photocopying documents at the archives and reproducing them in a book. It involves analysis of facts and making assumptions, concentration and organization, and writing text that is unambiguous. One of the big problems with many genealogies is ambiguous text.

11. The best genealogies are based on solid research. Quantity is no substitute for quality. Primary evidence provides the best base for reasonable conclusions. Genealogist Dr. Neil Thompson often said, "One of the best ways to see where you stand with research is to write."

12. A genealogy should, if possible, be compiled entirely by one person. This does not apply to employing others to research.

13. When compiling a family history for publication, consider doing a draft for circulation to family members and other researchers prior to publication, to identify errors and perhaps bring in additional material.

14. No-one can tell you what to write, only suggest the way it should be done. Your article or book is your presentation and interpretation of your research.

15. Write to provide others with an organized summary of your work, facts and opinions, with a clear distinction between the two, and connections between seemingly unrelated facts.

16. Be direct. Be specific. Think about the facts and present them so that others can reasonably evaluate your work and your conclusions.

17. Be careful to select details that are pertinent and that add clarity.

18. Don't fill your article or book with details

that have no significance.

19. Use direct quotes from records to add clarity and to support your writing. They add flavour and help capture the time period under consideration.

20. Be careful not to take a quote out of context to support a point you wish to make.

21. Never conceal research results which produce conflicting information, or weak points in your research.

22. Take great care in suggesting that one record is "incorrect" when it does not agree with others. Because a record is different, it is not necessarily wrong, although some records are indeed wrong.

23. Draw conclusions. They can be provocative! Research and analysis may raise more questions than it provide answers for. If questions are raised in your mind, it is usually a good idea to pose them to your readers.

24. Be serious! Don't attempt to be overly witty or amusing. Genealogy is a scholarly endeavour. Take it seriously. For example, if you discover that an inventory of goods and chattels attached to your ever so great grandfather's last will and testament contains a "large copper still," it is probably unwise to comment: "probably to cool his milk in???"

25. It is best to avoid acclaim, applause, eulogy, plaudits, etc., and anything that tend to be subjective. Everyone in the family may not agree with you that Aunt Mary and Uncle Charlie were Saints and that great grandfather was a rascal.

26. All multiple marriages should be clearly noted, and those having children by more than one spouse should be documented separately.

27. Use caution when linking one generation to another. Make as strong and as positive an identification as is possible when connecting generations in a compiled genealogy.

28. Knowing major historical events is an advantage for a good genealogical writer. If, for example, your ancestors were Loyalists during the Revolutionary War, it will be to your advantage, and especially to the advantage of your readers, if you gain some knowledge of that war and how it affected those who had to flee.

29. Writers should not judge ancestors on the basis of society today. If you are writing about the 18th century, try to place your ancestors of that time in proper historical and social perspective.

30. Use exhibits such as maps, charts and pictures. Reproductions of original records can be interesting.

31. When the first draft is finished, go over it, correct spelling mistakes and grammatical errors, and insert new thoughts in the margins. Also, ask yourself:

- Do the people, places and times come to life?
- Is the writing clear, concise and logical?
- Can readers distinguish between facts and opinions?
- Are all the facts presented?

32. Give a copy of the draft to at least one other person to read objectively and make suggestions.

General layout

1. Some writers split a family into branches, with a chapter for each branch. This annoys those readers who are interested in the early generations and who must consult each separate chapter to locate the grandchildren. A better plan is to start with the most remote ancestor, followed by the second generation, the third, and so on..

2. Consider writing your family history in parts. This may have merit when the cost of publishing a large volume, of say 500 pages or more, would be so great that the price of a single copy will be prohibitive to many descendants. Publishing the genealogy in two or more parts will reduce the cost of each part, and for the purchaser the cost of the whole publication will be spread over time. This plan also gives the compiler more time to collect data, and an opportunity to correct any errors that may have been discovered.

Finishing touches

1. Be sure that the words you select convey the intended meaning and that all pronouns are clearly understood. When you write, "She was born...", be sure everyone who reads your book or article will understand who "she" is.

2. All words should be correctly spelled, using no contractions, and only standard abbreviations.

3. A cardinal rule, no exceptions - have your manuscript proofread. Running it through a computer spell checker is not the same thing.

4. A family history that is well done is one that:

- Is well documented, mainly from primary sources.

- Places the family in its historical, social and geographical context.

- Is interesting to read without being sentimental or sensational.

- Avoids speculation (Uncle Charlie is believed to have been born in...) unless the author has some

good reasons for such statements.

- Avoids perpetuating legendary statements (Uncle Charlie was an officer in the French Foreign Legion) unless such statements are clearly identified as unproved.
- Does not launder its sources by correcting spelling and grammar errors in quoted passages.
- Avoids manipulation of data to gloss over research problems.
- Is reasonably free from errors in grammar, syntax and typography.
- Is indexed at least by surname and given name, and preferably by selected topics as well.
- Does not duplicate a work already in print, unless the earlier work is inferior or outdated.

Citing sources

There are several guides that can be obtained for citing sources in written records. Two are "Form and Format," published by the Department of English, University of New Brunswick, Fredericton, N.B., and "Archival Citations, Suggestions for the Citation of Documents at the National Archives," published by the National Archives of Canada, Ottawa, Ontario.

In some environments, this is a very specialized technique. Some will debate whether the author's name should be written surname first or given name first, and whether sources should be cited with title first and author second or the other way around.

In my experience, the majority of genealogies that can be found in libraries and archives have no sources cited at all, or very few. So, at this point in time, I don't want to debate the logistics but I do want to impress upon those who plan to publish an article or family history the importance of citing sources, and provide some guidance that may not meet all available standards but which will be acceptable to the industry (so to speak) at its present stage of development.

1. Certain points in a family history or compiled genealogy must have a source cited.

- Always cite any direct quote.
- Always cite any statement that proves a link in a relationship.
- Always give the citation for any point of controversy.

2. Amplification of statements like "it appears" or "Henry Jones probably..." should be made by way of a note, as an explanation of the doubt to aid

other researchers.

3. Never fail to acknowledge the assistance of others, and thank them for their help.

The following explanatory notes were used by Dr. Russell F. Shaw, C.G., in his article, "A Case Study of Colonial Shaws," in National Genealogical Society Quarterly, Vol. 76, September, 1988, and are presented here as examples for authors who may wish to explain certain points in their text.

This source is generally known to researchers as the Studholme report.

Punctuation

1. In book citations, the items of information are presented as a note by researchers in the sequence of (a) the author or compiler, (b) the complete title, (c) the publication facts, (d) the page number(s), and optionally (e) location where the book was seen or can be found. The insertion of punctuation marks in and between elements of a simple book citation is illustrated in the following example:

2. If preferred, and if you have a typewriter or printer that will produce italics, the title of the book may be presented in italics rather than underlined, thus:

- (1) Robert Piercy Dow, *The Book of Dow* (Claremont, N.H.: published by Robert P. Dow, John W. Dow and Susan F. Dow, 1929), p. 29; seen at PANB, microfilm F6731.

3. More complicated notes may require additional punctuation.

Bibliography

1. A bibliography is a compiled list of sources on a particular subject. It is usually appended at the end of an article or book immediately before the index.

2. It is rare, however, that a writer can include every source available on a subject. The term "Sources Consulted" or "Selected Bibliography" or "Works Cited" is usually a more accurate description.

3. Most genealogical writers who use complete and extensive notes will find a bibliography unnecessary. However, writers who wish to use

short citations in the text must have a full bibliography.

4. A bibliography without citations is the least satisfactory method of listing sources for a compiled genealogy. There is no way for a reader to determine where the author obtained each piece of data.

Citation numbers

1. Citation numbers for endnotes in the text should follow the information to which they refer. Place an arabic numeral slightly above the line in the text, and the same arabic numeral in front of the endnote at the end of the article, chapter or book. Raised (superscript) numbers should be consecutive and run continuous throughout the text of the article, chapter or book.

2. Citation numbers for footnotes should be the same as for endnotes, except that raised (superscript) numbers should start with number 1 on each page and be consecutive on each page.

3. If superscript numerals are used to indicate generations, thus Henry³ Jones, (Thomas², John¹), it may be confusing if the same method is used in a genealogy for references to footnotes or endnotes. It may be better to use numbers enclosed in parentheses, thus⁽¹⁾, or some of the customary symbols (*, †, ††, ‡, §, etc.), although some genealogists use superscript numbers both to indicate generations and to reference notes, particularly for endnotes which soon get into double digits and are less likely to be interpreted as a generation number. Personally, I use superscript numerals to indicate generations, and numerals enclosed in parentheses, thus⁽¹⁾, for citations.

4. If only one fact is taken from a source, that source should be cited immediately following the information gained from it; if more than one fact comes from that authority, the reference may be cited at the end of your sentence or paragraph.

Sources in text

1. Some writers place short reference notes in the text or make abbreviated citations to a longer citation in a bibliography. For example:

Henry Jones was born about 1834 [17 in 1851 census], son of..., or

Henry Jones removed in 1832 from Sunbury Co., N.B. to Saltfleet Township, Wentworth Co., Ontario. [Hubbard, Descendants, p. 56] Later, he took his family to...

2. A reader would have to have a bibliography to make use of a short citation like this.

3. Placing short references in the text is a less satisfactory method for a compiled genealogy than using superscript numbers and notes, especially when citing sources for names and dates in lists of children.

Indexing

1. No compiled genealogy is complete without an index!

2. An index listing surname, given name and page numbers is the minimum requirement.

3. Another index that may be useful, either in a compiled genealogy or for managing data, is an event index, showing such things as immigrations, occupations, places of residence, births, deaths, marriages, etc.

4. If an event index is compiled using database software [dBase, for example], it can be sorted on any field [name, event, etc.] and the entries for any name, event, etc., can be viewed on the computer monitor, sent to a disk file, or printed.

5. Some computer word processors and most genealogy database software will compile an index of the names in your file or database. How satisfactory it will be depends on the software used.

6. A file card index can be compiled for an existing publication by preparing a small card for each name encountered in the text, noting the page number on the card each time the name occurs, then sorting the cards alphabetically and typing each name and the page numbers.

7. Consider whether you want to index names once only, or every occurrence. For example, in a compiled genealogy using a descendant format, many names will occur two or more times - once as a child in a list of children, again later when you write an account of the child's family, and perhaps elsewhere. I prefer not indexing names that appear in a list of children (child and spouse) when that child will be discussed later in the genealogy; and the names of parents when they appear in "Henry Jones, son of *John and Phoebe (Brown) Jones*," when John Jones and Phoebe Brown were both indexed to a previous page where Henry Jones was listed as their child. Indexing names twice consumes space, consumes more time when a reader is searching for information relating to an individual, and is unnecessary.

8. Consider how you will index married women. I index all females by their maiden name only.

9. Consider whether you want to index the names which appear in references, such as author's names, the names of witnesses in reference documents, etc.

10. Whatever decisions you make about indexing, be consistent throughout your work.

Abbreviations

1. Use only standard abbreviations, and be consistent throughout. For example, use standard state abbreviations (Md., Wash., Cal.) all the time, or those used by the U.S. Postal Service (MD, WA, CA), but never a combination of the two.

2. Always keep in mind that clarity is more important than saving space.

3. A list of common abbreviations can be found in Form and Format: A Guide to the Presentation of Essays and Reports (Department of English, University of New Brunswick, 1987), and in similar publications.

Place names

1. Never leave readers wondering where places, institutions, etc., are located. Places and institutions that are familiar to you may not be known to your readers, especially your readers 1,000 miles away or 100 years from now. For example:

1. ²Henry Jones (¹John) was born in Summerfield. He attended public school there, and was graduated from Southern Victoria High School in 1979. (Where is Summerfield, and where is Southern Victoria High School?)

2. There are two options. Write "Summerfield, Parish of Wicklow, Carleton Co., N.B.," and "Southern Victoria High School, Perth-Andover, N.B.," or provide a schedule at the front of the book explaining that wherever Summerfield is referred to in the text it will mean "Summerfield, Parish of Wicklow, Carleton County, New Brunswick," etc.

Dates

1. In a compiled genealogy, never write dates using only numbers, thus: 3/4/1898. Americans usually write month/day/year; Canadians usually write day/month/year; and in metric countries (including some Canadians) dates are usually written year/month/day. But readers can never be sure.

2. Never use a contraction, thus: '87, for year. Is

it 1687? or 1987?

3. After avoiding the "nevers," there is no correct way to write a date. The most common forms are 16 Nov., 1898, or 16 November 1898, or Nov. 16, 1898, or November 16, 1898.

4. In a list of children, set out in columnar form, I prefer 16 Nov 1898, without punctuation to conserve space, and with leading zeros for single digit dates to maintain vertical columns, thus:

5. When writing text, I prefer month/day/year, with no abbreviations, and with usual punctuation, because I think the text flows normally and is easier to read, especially when reading aloud, thus:

1. **George² Hayward (John¹)**, was born July 20, 1673, in Concord, Mass., son of John and Anna (White) Hayward. He died July 15, 1725, in Brookfield...

6. Most genealogy software can be programmed to accept dates in one format and print them in one of several other formats. For example, you may be able to input 3/4/1898 and have it output (print) Mar. 4, 1898, or Apr. 3, 1898.

7. Whatever format you select, be consistent throughout your compiled genealogy.

8. For approximate dates, most genealogists use the Latin word "circa," meaning "about," to indicate that the date is not exact, thus: circa 1763; ca. 1763; c.1763, or as I usually do to conserve space, c1763.

9. Never write an exact year if the date is estimated from, for example, the age given in a census return. Record it as "about 1763" or "c1763."

10. What about those double dates, 10 Jan 1725/26, that are sometimes found in old records. Did you notice that they are found only in January, February and March, and never after 1752?

Before 1582, the Julian calendar (established by Julius Caesar in A.D. 325) was used throughout the Christian world. It was discovered that the Julian system of measuring exceeded the solar year by eleven minutes, or 24 hours every 131 years; three days every 400 years. This amounted to about 10 days between A.D. 325 and 1582.

Pope Gregory XIII, in 1582, ordered that 10 days be dropped out of the calendar, thus restoring the equinox (the date when the sun crosses the equator) to its accustomed date, March 21. Also, he ordered that the new year be changed to

January 1st. This system, known as the Gregorian calendar, still prevails.

All Catholic countries adopted the new system of reckoning, but England refused, and did not adopt it until 1752. Throughout the period 1582-1752, the new year in Catholic countries commenced on January 1st, but in England (including its colonies), and in Russia, the Julian calendar, in which the new year did not commence until March 25th, continued to be used. In spite of this difference, in the colonies many people began using the Gregorian system, and in many early colonial records you will find "double dates," generally written thus: "9 March 1656/57," indicating that while it was officially still 1656, some people considered it to be 1657.

How do you write an account of daughters

1. When I use what I will call the family group sheet format, which follows a fairly rigid layout, I show the husband's name, etc., then the wife's name, as follows:

Allen Nevers, s/o Nathaniel Nevers & Hannah (?)
b c1819 (4), N.B. (2), prob Lincoln, Sunbury Co.
d 30 Apr 1891 (4), Lincoln, Sunbury Co., N.B.
m 30 Dec 1843, Sunbury Co., N.B. (1)

Hannah Mitchell, d/o David Mitchell & Lydia (Hayward) (5)
b c1822 (4), N.B. (2), prob Lincoln, Sunbury Co.
d 16 Aug 1886 (4), Lincoln, Sunbury Co., N.B.

2. When I use a text format, similar to that used in the New England Historical and Genealogical Society Register and the National Genealogical Society Quarterly, I show first the person, male or female, who is descended from the most remote ancestor in my compiled genealogy. In the following example, Hannah Mitchell is the descendant and I write an account of her first.

16. **Hannah⁴ Mitchell** (*Lydia³ Hayward, George², George¹*) was born about 1822,⁽⁴⁾ in N.B.,⁽²⁾ probably in the Parish of Lincoln, Sunbury Co., where her parents lived, daughter of David and Lydia A. (Hayward) Mitchell. She died August 16, 1886,⁽⁴⁾ probably at Lincoln, and was buried in the Lower Lincoln Cemetery.

She married **Allen Nevers**, December 30, 1843,⁽¹⁾ at Lincoln.⁽⁷⁾ He was born in N.B., probably in Lincoln where his parents lived, about 1819,⁽⁴⁾ son of Nathaniel and Hannah Nevers. He died April 30, 1891,⁽⁴⁾ probably at Lincoln where he lived, and was buried in the Lower Lincoln Cemetery beside his wife, who predeceased him.

The Soldiers of the King's New Brunswick Regiment

To William Hazen, we are indebted for the only record preserved in the Province of the King's New Brunswick Regiment - the Regimental Record containing the personal account of nearly every officer and enlisted man who served in the corps from 1793 to 1797. Unfortunately, a number of pages have been torn from the ledger, which has impaired somewhat its continuous record. The Ledger was presented to the New Brunswick Historical Society by Sir John C. Allen, Chief Justice of New Brunswick and has the following written on the cover, opposite the first page" "Presented to Lieut. Col. Allen by his sincere friend William End May 12th, 1842. - Jonas Howe, Collections of the New Brunswick Historical Society Vol. 1 (Saint John, N.B.: The Daily Telegraph Steam Book And Job Print, 1894) page 15. (This Ledger, now a part of the New Brunswick Historical Society Collection is deposited at the New Brunswick Museum. A microfilm copy No. F364 is available through inter-library loan from the Provincial Archives of New Brunswick, P.O. Box 6000, Fredericton, N.B. Canada E3B 5H1.)

Only ten years had elapsed since the arrival of the loyalists in New Brunswick when France declared war on England, thus placing our fledgling province in peril. Governor Thomas Carleton was instructed to organize a corps for the Province, the expense of which was to be borne by the Imperial Treasury - the corps to be known as The King's New Brunswick Regiment. The 6th Regiment of Foot, then stationed in the Province was to be withdrawn and the provincial militia was only partially organized and armed. The regiment was largely recruited in Fredericton and Saint John and the settlements bordering the Saint John River; but one company was recruited at St. Andrews, by its commander Capt. Peter Clinch and the men were nearly all residents of Charlotte County. At the end of the War, the King's New Brunswick Regiment was disbanded, the corps having been in service nine years three months and twenty days. For more information regarding the activities of this regiment and biographies of its officers consult the Collections of the New Brunswick Historical Society Vol 1, 1894 pps 13-56.

The following names were transcribed directly from the aforesaid Ledger and therefore may vary with the alphabetized names listed by Jonas Howe. The ledger is incomplete and therefore the names below must be considered a partial list. As the expenses were born by the Imperial Treasury there is a possibility that the War Office or other department in England may house further record of the New Brunswick Regiment.

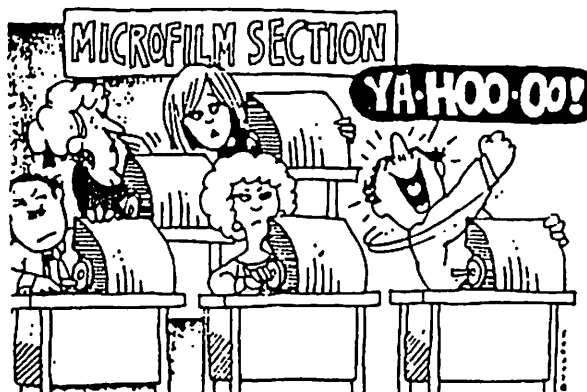

HISTORY OF MY FAMILY

This work began with the old world ancestors of John Yerxa and James & Daniel Gerow, who were Loyalist settlers in New Brunswick, now progress through the John Yerxa line.

JURCKSE = YERKSE = YERXA

GENERATION I

Paulus Jurcksen or Jurckse who married Christina [...] is first recorded March 18, 1657 at Fort Orange. About [...] they were living in Esopus, Ulster County, but shortly after that date, they moved to Albany where they lived until about 1675 when they emigrated from The Netherlands. He died before 1676 in New York. There were nine children: Johannes, Mynno (female), Antje, Hilletje, Cornelius, Wyntje, Dirck, Eegie and Christina.

GENERATION II

Johannes, Paulus or Jurckse, born in Esopus, Ulster County, probably about 1658, married in Bergin Jul 9, 1681 Jannetje (daughter of Jan) Derrit or Dereth, settled in Wysquaqua about 1683. Remove to Haverstraw about 1693. Married about 1697 to Antje Jochems Van Wert (also spelled Annetje Van Weert), widow of Johannes Minne (Minnelay), died about 1701. Children by first wife were Paulus, Greitje, Johannes (died young), Durck (died young), William (died young), Hermen, and Maritie. Children by second wife were Jacobus, Johannes (baptized October 24, 1700). Johannes (2) died and Antje Van Wert married for the third time to Samuel Conklin and had Rachel, born 1702.

GENERATION III

Johannes Jurckes (Johannes (2) Paulus (1)), born in Haverstraw in 1700 (baptized October 24) married October 5, 1723¹ Rahel (Rachel), daughter of Robert Willemse (Williams) resided in Philipsburgh, died before 1750.

Johannes (3) Jurckse died before 1750. The children of Johannes and Rachel Williams (Miller² ?) were: Johannes (4) who was baptized in 1724, Abraham (4) who was born about 1726, Isaac (4) baptized in 1728, Lea (4) baptized in 1729, Antje (4) born about 1731, and Solomon (4) born about 1738.

Antje (4) married Joseph Aertse. Johannes (4) married in 1753 to Anne Hoff. He supposedly died in 1772.

On 16 November 1772 the will of Johannes (4) Jurckse of Yerkes was made. In it he names nephew, John Yerkes, son of brother Abraham (deceased); wife, Ann; brothers, Isaac and Soloman; mother, Rachel Miller (?); sister, Ann Auser and kinsman, John Yerkes (Phillipburg Manor). The Will is witnessed by three individuals, all named Miller. The complete Will is in records of Surrogate Court, New York City.³

In 1609 Henry Hudson, and English navigator in the employ of Dutch service, sailed into the New World by way of the river which now bears his name and claimed the land for The Netherlands. The land was named "New Netherland". In 1621, the Dutch West India Company was organized for trading but fur

traders had migrated in the New Netherland previous to that date.

Fort Nassa had been built in 1614, by a Dutch explorer, on Castle Island, the Hudson River south of the present city of Albany. It served as a fur trading post for the Dutch until 1617, when it was destroyed by an overflow on the Hudson River. A new fort and fur trading post was built on the west bank of the Hudson River and named Fort Orange, which was 150 miles up the Hudson from its mouth.

The city of Albany is on the site of Fort Orange. In 1624 permanent settlement was begun there. In 1625 the town of New Amsterdam was founded at the mouth of the Hudson River at the lower end of Manhattan Island. The Dutch were soon extending New Netherland toward the east to the Connecticut River and westward to the Delaware. Under the Dutch, schools were opened and the Dutch Reformed Church was established. Lower Delaware was annexed by New Netherland in 1655.

In the second Dutch war, England seized New Netherland and formed two colonies in 1664. Their claim was based on John Cabbot. The original New Netherland was named New York after King Charles II's brother, the Duke of York, and also the town of New Amsterdam became New York. The other colony was named New Jersey. The transition from Dutch rule to English was accomplished peacefully.

GENERATION IV

Abraham Yerkse (4) (Jurckse) Johannes (3), Johannes (2), Paulus (1), married **Engeltje Storm**, daughter of **Jan Storm** and **Rachel de'Rievere**. Engeltje was baptized 20 June 1730 in the Old Dutch Church. Marriage record states, "October 24, 1750 Abraham Jurckse (J.M.) and Engeltje Storm (J.D.) both born and live in Phillipsburgh married."⁴

There was one son, born in 1751, who was baptized 8 Oct 1751 with the name of Johannes Jurckse. Abraham died before 1755 when his son was a baby. It is believed sometime in 1752 (?).⁵

Before Johannes was four years of age, his widowed mother, Engeltje (Storm) Jurckse had remarried. "March 1755, Hendrick Bolye, widower, born in Phillipsburgh, and Engeltje Storm, widow of Abraham Jurckse, born on the Manor of Cortlandt and lives here, married."⁶

Henry Bolye by his first marriage to Deborah Carpenter had two sons, John and Joseph Bulyea and two daughters, Mary and Judy Bulyea. Engeltje (Storm) Yerkse and Henry Bulyea had eight children - Deborah Bulyea, Abraham Bulyea, James Bulyea (born 1759), Lavinia Bulyea (born 1761), Robert Bulyea, Henry Bulyea, Jr., Thomas Bulyea and William Bulyea.

GENERATION V

Johannes (5) Jurckse or John Yerkse, (John Yerxa in 1783), Abraham (4), Johannes (3), Johannes (2), Paulus (1), son of Abraham Jurckse and Engeltje Storm was born 1751, in Phillipsburgh, New York; now called Tarrytown.

From August 30, 1745, no mother's names were given in these church records. The phrase attached to the father's name means, "His Child Baptized." As his father, Abraham, died, he was reared by his stepfather, Hendrick Bolye (Boulier) (Henry Bulyea). When Johannes (John) was about 21, his father's brother, Johannes (4) died (1772), and left John Yerkse (as he was known then) the sum of five shillings and his new coat.

John Yerkse married before December 3, 1774 to Catherine Giraud (4) (Gerow), daughter of Daniel Giraud (3) (Gerow) and Elizabeth Coutant. Catherine was baptized in the Trinity Church in New Rochelle, New York.

On December 3, 1774 Daniel Gerow (3) wrote to John Lake of New York City asking him to rent or sell his farm to Daniel's son-in-law, John "Yerkes" whose character he recommended.⁷

John was living on a farm in Cortland Manor between the farm of Henry Bolye (His stepfather) and Robert Bolye (his half-brother).

Revolutionary War broke out in 1776 in the 13 colonies. Thousands of British colonists, whose only crime was loyalty to their King and native country, had their properties confiscated, had no legal rights, and their lives were in danger. They knew they had been treated harshly by their King, but believed that there were better ways of dealing with their problem than civil war. In 1780, John Yerkes went within the British lines. He served under Colonel DeLancey. The signing of the Peace Treaty in 1783, formally ending the war between the new United States and Britain, did not improve the lot of the Loyalists. The harassment became worse. Those with any influence sailed to England. Some went to the Barbados. Most looked to Nova Scotia (New Brunswick and Nova Scotia were then one colony). A few travelled over land to Upper Canada (Ontario) and Lower Canada (Quebec). The size of the immigration exceeded all official estimates and preparations were inadequate or non-existent. The British Government gave them thousands of acres of land and also money, tools, food and clothing for awhile, but they were very poor. Governor Parr was in Halifax, Nova Scotia and it was difficult to deal fairly with the newcomers as he was too distant; and also, not the man for that tremendous task of settling Loyalist.

"The Spring Fleet" arrived at the mouth of the Saint John River in May. Just a wilderness greeted their eyes except for Fort Howe, a trading post, and a very few buildings. This was known as Portland Point. It took a week to clear away the brush wood from the now Market Slip. On May 18, 1783, the passengers disembarked with not a hut to shelter them. Loyalist continued to pour into Nova Scotia Colony from May until November, 1783, in three large fleets, the "Spring Fleet", the "Summer Fleet" which came in August, and the "Fall Fleet" in September, but single ships also brought emigrants all through the summer and fall. They were of all classes - clergymen, doctors, teachers, soldiers, farmers, tradesmen and backwoods men. The professions included graduates from Yale and Harvard Universities. They settled all along the Saint John River Valley and its tributaries to miles beyond Saint Ann's Point (Fredericton) and along the south coast and other rivers. Governor Parr changed the name of Portland Point to Parrtown.

Agents were sent to allot the land grants. There were prolonged delays and nearly 2,000 buildings were built with no land titles. There were unequal land grants, grants given to the wrong owners, grants unfit for settlement, and favouritism shown. Disbanded soldiers arrived in the fall to find that they had no grants allotted. Some of them were forced to live in tents during the winter. Some women and children died from exposure and starvation.

Henry Bulyea (Hendrick Bolye) and Engltie (Storm) Yerxa Bulyea came to Nova Scotia Colony in 1783. They settled at Greenwich Hill in Kings County. All the eight Bulyea sons came and at least one daughter, Deborah, who was married to Richard MacDonald. Some of the sons settled at what is now Gagetown and along the Washademoak River.

Engeltie (Yerxa) Bulyea died in 1805. She and her husband, Henry, are both buried in the Anglican Cemetery at Oak Point, Kings County, New Brunswick. Henry died previously.

In August, 1783 the "Summer Fleet" arrived. John Yerkes (5) (now spelling his name John Yerxa) with his wife, Catherine (Gerow) Yerxa and four children came on this fleet. The children were three sons, Abraham, John, and Daniel and one daughter, name unknown.

John Yerxa and family, along with others, went up the Saint John River to Majerfield (Maugerville) where a small English settlement had been established in 1763. This was a tremendous help for the Loyalist during that first winter. They were given land grants there later.

In July of 1784, Nova Scotia Colony north of the Bay of Fundy became a separate province known as New Brunswick; and Colonel Thomas Carleton arrived in Parrtown as Governor. He received an enthusiastic welcome.

The next year, 1785, the name of Parrtown was changed to Saint John; much to the delight of the citizens, as Governor Parr had been quite unpopular. Thus, Saint John became the oldest incorporated city in British North America. The citizens were dismayed that fall when the seat of government was moved up the Saint John River to Saint Ann and named Frederick Town (Fredericton). This was to lessen the danger of attacks by sea in case of war.

In November, 1784, John Yerxa obtained Lot #31 from the late agents and purchased the improvements of Ebenezer Whitney on a piece of ground in Burton, across the Saint John River from Maugerville. These pieces are in Sunbury County - oldest county of New Brunswick. Some of the older

That he was driven within British Lines in 1780 when he joined the refugees under Colonel DeLancey, in which service he continued til he came to the Province of Nova Scotia now New Brunswick.

He, therefore, hopes the Honorable Commissioners will consider his Sufferings his Losses and Loyalty and make him such Recompense as to them shall hereafter appear Equitable and Just. And as in Duty bound shall ever pray. Saint John, February 17, 1787.

New Claim⁹

February 17, 1787 #747, Case of John Yerxa, late of New York

Claimant says he came in August. Went to Majorfield. Sent by Capt. Vand. Could not send before. Lived in Courtland Manor. Joined the British in the year of '80. Served with Col DeLancey as volunteer.

One cow taken by Continental Militia, but after he got within the Lines, he bought her carried her in. Lost cash, taken from him and money spent in Prison.

William Free witnessed:

Claimant served under Col. DeLancey. Knew the Rebels took a cow from him for his not serving in the Militia. This was in '78, two years before he went within the Lines.

Search And Extract Service

Since 1784 (one year following the arrival of the Loyalist refugees) New Brunswick (Canada) newspapers have become the basic source of genealogical information. The history of our ancestors are reflected in these pages. Almost every event involved people from all walks of life, whether they be prominent business or religious leaders or sailors and shoemakers. The names of ordinary people arose during periods of epidemics, immigration, and political change. The religious papers contain extensive obituaries of farmers and their wives. The county papers contain notices of relatives now living abroad who visit their native New Brunswick families. There are accounts of men lost at sea. Marine examinations identify masters and mates of the schooners that sailed from New Brunswick ports. This information (and more) is in addition to the birth, marriage and death notices normally found in the newspapers. In the past, this treasure mine of genealogical data was virtually inaccessible to the researcher. In order to identify an ancestor, the genealogist required the knowledge of a specific date or would spend countless hours scanning newspaper after newspaper, page after page. For those researchers who lived far, the cost of hiring a researcher was just too exorbitant.

Currently (1992) fifty volumes of ***"Vital Statistics From New Brunswick (Canada) Newspapers"*** have been published. Genealogical extractions from 45 New Brunswick newspapers published from 1784 to 1880 have been cross-indexed by over 250,000 names. Although the published series may be found in over forty libraries across North America, it was available only by purchase. Although each volume is indexed countless hours may be spent by the researcher using this published series while scanning each index and manually extracting entries. Each year six new volumes are published, generating over 30,000 new cross referenced names annually.

As the ***Search And Extract Service (SAE)*** and ***Vital Statistics From New Brunswick (Canada) Newspapers*** series both utilize the same computer files, the information gleaned from this service is an exact duplicate of the extractions which appear in the published volumes. Therefore, the SAE service provides the same narrative or data as it first appeared in the newspaper. Also the original newspaper reference follows each entry extracted.

* ***Surname*** (Although some variations in spelling may be accommodated by the computer search. In other instances a new search may be necessary.

* ***Place*** (Extracts may be retrieved by the name of a specific geographical area ie. (country) "Australia", "Ireland"; (town) "Digby" (Nova Scotia), "Newcastle" (New Brunswick)

* ***Subject*** ie. "barrister"; "loyalist"; "Methodist", etc.

The advance minimum fee is \$ 20 which covers both the cost of the search per key word and the first five (5) pages of information generated by the computer. An additional fee of \$3 is charged for each page generated in excess of five pages. Each page is laser printed 10 pt. font (8 1/2 by 11) and bound. You also have the option of choosing either a global search of all the volumes or selecting specific years by volume numbers.

The following is a write up in a 1898 Portland, Me. newspaper on the occasion of Mrs. John Henry's 99th birthday in which this special lady, through her recollections, provides the reader with a personal account of life during her time.

**NEARLY A CENTURY
MRS. JOHN HENRY'S 99th BIRTHDAY
SHE SAW THE OFFICERS AS THEY RETURNED FROM WATERLOO****
FIVE GENERATIONS WERE PRESENT AT THE SURPRISE PARTY***A
WONDERFUL OLD LADY**

The 99th birthday of Mrs. John Henry of Portland, Me. was celebrated at the home of Mr. and Mrs. George T. Marsters, 147 Franklin Street, Portland. Five generations were present at this family reunion. Mrs. Henry headed the list and then came her daughter, Mrs. Elizabeth Knowles, and her daughter Hazel.

Mrs. Henry had two other children living, Mr. George Henry of Haverhill, and William Henry of Plymouth, Mass. To amuse the guests, music was furnished by Mrs. Archibald Knowles, Miss Morrison and others. Recitations by Mr. Joseph Douglass. Refreshments were served of course and a jollier or more pleasant evening was never passed. Present were the following descendants of Mrs. Henry.

Mrs. Henry knew nothing of this family gathering until the guests were ushered into her presence in the parlor. She welcomed every guest with either a kiss or a handshake, and for those she had never met, she greeted them with an old-fashioned courtesy (curtsy). Nor would Mrs. Henry remain seated while she received her guests; she stood the greater part of the evening and talked with all

comers on a variety of subjects. She knows all of her children, even to the fifth generation by their names, and if any of them were not present at this re-union, they will surely be reminded of the fact the next time they see Mrs. Henry.

Mrs. Henry enjoyed every minute of the musical entertainment. She loves music, and once upon a time was a very good musician herself. She remained the center of the wondering love of all until the last guest had departed and she retired, without the least sign of fatigue. A most remarkable old lady, very jolly, very happy, as well and strong as she was twenty years ago. She reads all but fine newspaper print, which she laments, for she is very much interested in what is going on in the world. It is not uncommon for her to board the street car at Franklin and Congress St., and travel to Danforth St. to visit one of her grandchildren. She frequently walks from Newbury St. to the home of Mrs. Marsters on Franklin St., and this she has done on days so cold and slippery that few people dared to venture out of doors. Mrs. Henry has a remarkable memory and clearly recalls dates, names and events that younger people have forgotten. For the benefit of a PRESS reporter she related the story of her life. It was a genuine pleasure to talk with her, she remembers so well and talks so entertainingly. She answers questions unhesitatingly and her hearing is unimpaired. She held little Hazel on her lap and she answered her childish questions with as much care, courtesy and patience as she did those of older people.

"I was born in Courtmasherry, Ireland, February 6, 1799. That is a small town only a little distance from the city of Cork, near the Bay of Cork. My maiden name was Mary Ann Harley, and my father was a school teacher in the town. I Had two brothers and three sisters. All dead now. One of my sisters lived to be 94, died on her birthday. I can remember the town where we lived very well, and the names of friends and school mates. I left Ireland in 1822. I can remember my father and mother talking about the rising of '98; people never seemed to get tired of talking about that event. My father was of English descent, a Presbyterian and I was raised in that church.

Very well can I remember the day on which two big ships of war sailed into Cork harbor, their decks crowded with men and their masts gay with flags. These ships were bringing us the first news of the battle of Waterloo in which that terror of the world and ogre of history, Napoleon Bonaparte was defeated by our own Duke of Wellington. People went crazy with joy; the bells of the city of Cork were rung, and great bonfires were lit in celebration of the great event. These ships brought home the wounded Irishmen who participated in that great battle and there was great rejoicing on their return. Three of the officers of an Irish regiment were quartered at my father's house for many days, and I remember some of the stories they had to tell of that terrible fight. Their bright uniforms and handsome faces made a great impression on me.

In 1822 I went to visit a lady friend in Queenstown, and while I was there the first steamboat ever to come into Irish waters came into the harbor. Everyone turned out and lined the docks to see the strange craft which moved so swiftly through the waters without sail or oars. It was a wonderful thing then, but I suppose the people of Queenstown see enough such craft now. While I was in

Queenstown I got a letter from my brother William in America. He was a government surveyor, and he wanted me to come over as soon as possible as he said he had a young, handsome and wealthy husband waiting for me. I went home to my parents and it was decided that I would sail for America.

I was one of 150 passengers on a sailing ship which left Cork on May 7, 1822. It was a terrible voyage. I was sick almost all of the way, and glad to see land after seven weeks and three days aboard that ship. I landed at a place called Pockshaw on the Bay of Chaleur. It was a very small settlement then, only a few small houses made of logs. My brother was there waiting for me. We had to walk 75 miles through the woods to get to his home. No roads, no conveyances of any kind, not even a path. It was a trackless forest in which not one tree had been cut. We made our way by means of compass over windfalls and across brooks to Newcastle. We were three nights on the road and we had to sleep in the woods without any shelter. On the fourth night we got to Newcastle, a very small settlement. Eight months after my arrival at this place I married John Henry; he was the man of business and agent for a large mercantile firm. I had nine children and seven grew up and married. I don't know how many descendants I have, but they must number in the hundreds. My husband died 28 years ago (1870). I lived on the Miramachi until after my husband's death, and then I came to the States where some of my children lived. I had a brother named John Harly who built ships on Bolter's Island near Newcastle."

P.S. Mary Ann Henry died 22 days after her 99th birthday. She is buried in Forest City Cemetery on the lot owned by Fred Stevens, her grand-son. The birth-date on her stone is the earliest birth date recorded for Forest City Cemetery.

Mrs. John Henry (Mary Ann Harley) was the great great grandmother of Allen Rowe of Cape Elizabeth, Me.

"Connections" Conference - 1993

"A special occasion for Genealogists With New Brunswick, Canada roots"

If the strong early response is any indication of the numbers of genealogists who will attend the "Connections"-1993 Conference, then 1993 may very well see the largest gathering of New Brunswick genealogists in the history of our Society. In the six weeks following the distribution of fliers in the Summer Issue of "Generations", sixty-five members replied. It is expected, as researchers return from their summer vacations, that the numbers will begin to swell.

The site chosen by the "Connections" Steering Committee of the host Saint John branch for the seminar is the University of New Brunswick Saint John Campus, Saint John, N.B. The campus is within a few minutes drive of the Rockwood Park Golf Course, Cherry Brook Zoo, and driving range.

A number of activities are being planned before and after the conference. Although arrangements are currently under way, special tours of Canada's oldest city will precede the afternoon registration. Saint John has many points of interest such as Market Slip where the Loyalists first landed in 1783. The Old Loyalist Burying Grounds contain many of the earliest stones. The site of old Fort Howe provides a vantage point to see and photograph Saint John. Much of the city's uptown architecture has remained the same since the Great Fire of 1877 while other structures such as the Old Loyalists House dates back to a colonial time period.

Among the confirmed key speakers for the seminars is Dr. Ralph Crandall, head of the New England Historic Genealogical Society Library of Boston, Mass., author of "Shaking Your Family Tree" and popular lecturer at previous New Brunswick seminars. Another confirmed key speaker is David Bell, known to many as the author of "Early Loyalist Saint John". Concurrent sessions will host a number of well known interesting speakers on a wide variety of genealogical topics.

Through organizational displays, computers, etc. every effort will be made to acquaint visitors with New Brunswick records both private and public. Tables will be provided in display areas for individuals who have family charts, books, three-ringed binders. Identification badges will be color coded by New Brunswick County in which an ancestor settled. Organizational tables will be set up on a County Basis as well and color co-ordinated.

Visitors will also have an opportunity to speak directly with certified genealogists and others with qualified backgrounds either through panel discussions or private consultations as time permits.

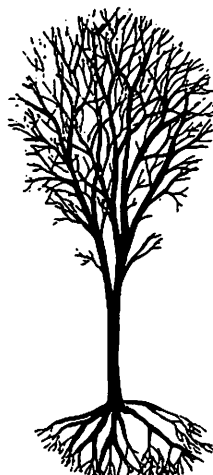

Ludia Mitton Nichol

It was mid winter 1913. The day was cold. The mail had arrived by horse and sleigh just minutes ago. Ludia checked the load of green wood she was drying in the oven to make sure it was OK. Water dripped out on the well worn wood floor. She stooped down and wiped it up, then gave the pot on the stove another stir. Yes, there was time to sort the mail before dinner. Just as she dumped the mail bag on the kitchen table, the door flew open and in tramped the snow clad children from the nearby school. As usual, they had come to pick up their family's mail. The snow they had tracked in soon turned to puddles on the floor. The children gleefully rummaged through the contents of the mail bag on the table. Cebert, sitting in the rocking chair beside the sideboard his father had built years ago, discussed the news of the day with other men who had dropped in for the mail. Again Ludia wiped up the floor, stirred the pot on the stove and wondered how many she would have for dinner that day. Again, she started to sort the mail amidst the noise and chatter. This was mail day at the post office in Steeves Mountain. Ludia went on with her work, never complaining, still pleasant and friendly to everyone as they arrived.

Young Lois Brown was one of those boisterous children who had arrived for the mail. She remembers going home with the mail after school and excitedly telling her parents of the visit to the Post Office at noon hour. She remembers her father sitting in the rocking chair smoking his pipe, calmly saying 'If ever there was a christian lady, it is Mrs. Cept Nichol. In fact, I'd say she was an angel straight from heaven.' Mrs. Brown, who had been busy around the kitchen turned and coldly looked at her husband 'If you ask me, she is a damn fool!'

This was my Grandmother, Ludia Viola Mitton born 2 December 1871 in Little River, Albert County. In 1896 she married Cebert Nichol of Steeves Mountain. They lived on the Nichol Farm which had been established by Cebert's father, James Nichol prior to 1880. They had four children Douglas, James, Cora and Gertrude. Ludia passed away 25 November 1965 in Moncton and was laid to rest in the family plot at Boundary Creek, NB.

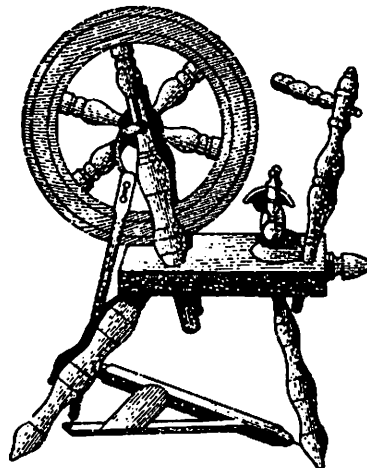

HISTORICAL SKETCH - OLD ATHOL HOUSE CEMETERY, ATHOLVILLE, N. B.
PRESENTED FOR THE CALEDONIAN SOCIETY OF RESTIGOUCHE
AT THE OLD ATHOL HOUSE CEMETERY MEMORIAL SERVICE
AUGUST 6TH, 1972

On behalf of the Caledonian Society of Restigouche I wish to thank the Clergy of the Protestant Churches for helping to make this service possible.

The Athol House Cemetery is the oldest British cemetery in Restigouche County. Shortly after Samuel LEE obtained his grant to the property he set aside land for a cemetery, probably about 1790. Rev. Mr. DRIPPS, a Church of England Missionary, consecrated the ground given for this cemetery. The oldest existing grave marker in the cemetery is dated 1791.

In 1931 at the time of placing the Cairn here in memory of Rev. James STEVEN all Protestant Churches agreed to place the cemetery in the care of the Caledonian Society of Restigouche. This, at the time, was considered the thing to do as most of the dead buried here were Scots direct from the Auld Sod or their descendants.

The old burial records on file at the First United Church at Campbellton show the name of this cemetery as "Old Athol House Cemetery" which is more suitable and certainly less confusing than "Old Mission Point Cemetery" which has been used occasionally in recent times. Old Mission Point is located one-half mile to the west of this point which is known as "Ferguson Point". An old Micmac Indian Cemetery exists at Old Mission Point.

The name "Athol" is derived from the Earldom of Athol. The seat of the Duke of Athol is Blair Castle which is located west of the village of Blair Athol, Perthshire, Scotland. The FERGUSONS came from Perth, Scotland. In fact many of the early settlers were Scots from the eastern part of Scotland, i.e., Aberdeen, Dundee and Perth. There are a few from other parts of Scotland and a few Englishmen and Irishmen. These early settlers were by trade fishermen, coopers, shipwrights, carpenters, blacksmiths and millwrights. The main items of trade at that time were fish and feathers. Lumbering came later.

The British traders were slow in moving in after the Battle of the Restigouche and it was not until 1768 that George WALKER, a Scot, set up a trading post at Walker Brook. In 1769 Hugh BAILLIE, another Scot, and a partner of Walker's, built up a large trade in fish and furs, hides and salted salmon. BAILLIE sold his property to John SHOOLBRED, a London merchant, in 1773. SHOOLBRED established the first permanent settlement on the Restigouche when his agent William SMITH brought out eight Aberdeen fishermen and their families and established his headquarters and a salmon pickling factory at Old Mission Point. Samuel LEE leased this property from SHOOLBRED from 1785 to 1787 but in 1788 SHOOLBRED lost his title and Samuel LEE obtained a direct grant to the property from the Province of New Brunswick.

The records show that the first Protestant church was erected at Miller's Point in 1805. It was afterwards moved to Pratt's and finally from there to the Old Athol House Cemetery.

Rev. J. C. HERDMAN writes in 1883 "When the estate passed into the hands of Mr. FERGUSON permission was readily given". He is referring to permission to move the church. Robert FERGUSON came into possession of the property from LEE's widow in 1810 therefore the church was placed in the Old Athol House Cemetery about 1810. The old church disappeared about 1910 but you will find a picture of it on front of the order of service.

The Church of England, as it was then known, deserves credit for sending out missionaries to remote districts in the early days. A few who came here were: Rev. Mr. DRIPPS, Rev. Mr. GREY, Rev. Mr. YOUNG, and others. They conducted worship on Sundays and taught school on week days. The Anglican Church Archives at Fredericton, New Brunswick and at Halifax, Nova Scotia, have no record of these ministers so it is assumed that they were missionaries working directly out of London, England.

Alexander FERGUSON, a Scot from Perth, Scotland, settled on the south side of the river in 1794 and was joined by his brother Robert here in 1796. They played a large part in the religious and community life and in development of this district. Alexander died in 1803 but Robert carried on the business and in 1810 bought 1000 acres of Samuel LEE's land from LEE's widow, this included the land at Old Mission Point, Ferguson Point, in fact most of the land in what is now known as Atholville. In 1812 Robert FERGUSON erected an imposing residence and store combined which was the first estate permanently established on the Restigouche and was the business centre of the Restigouche - it remained a landmark for over 80 years until it was destroyed by fire in 1896 or 1896. This imposing building was known as Athol House and was a short walk from this cemetery. (See G. J. MOUNTAIN's visit to the Gaspé Coast in 1824). Arch Deacon MOUNTAIN also states that a congregation of 80 to 100 persons assembled at the church on September 12th, 1824, when he visited there 148 years ago.

The Old Athol House Church remained the main place of worship until the Presbyterian Church was built in Campbellton in 1834. The Campbellton Protestant Cemetery was started in 1892 and few burials took place in the Athol House Cemetery after that date.

The first permanent Presbyterian minister was Rev. James STEVEN of New Luce, Wigtonshire, Scotland, arriving here in 1831. He carried on this ministry here until he died in 1864 and is buried in this cemetery. Previous to his arrival here there were no doubt visits from Presbyterian clergymen from other parts of the province. Mr. STEVEN's district extended as far east as New Richmond and at times New Carlisle and Bathurst and as far west as Runnymede and Robinsonville.

It is to revive an interest in the preservation of this cemetery as well as to pay our respects to our honoured dead that this service is being held. As you look around the cemetery you will see that some of the names have disappeared from the grave markers, some grave markers have disappeared altogether with the passing of the years, and stones are broken. Time takes its toll. To our shame, the cemetery is in sad repair and something must be done about it. The offering today will be used for ren-

ovation purposes. The part of the cemetery enclosed within the present fence is filled with graves except that part where the old church stood and I am told that a number of graves are outside the present fence. If and when the cemetery is restored to a good condition it would be fitting to have a plaque prepared listing all the burials that took place here because of the number of grave markers missing. The most of these burial records are in the files of the First United Church at Campbellton.

We have the Fraser Companies Limited to thank that this cemetery is in as good condition as it is. They have kept the grass cut and the fence painted over the years. The gate is kept locked but any responsible person can gain admittance to the cemetery by requesting same at Fraser Company's Office.

A closing note on the historical significance of this area. No other part of the northern area of the Province can compare history wise. History for everyone, i.e., the Micmac Indians, their one and only stockaded town, Tjigog, was here. The Roman Catholic Missionaries were here in 1620. The French Merchants, here in 1653. The Battle of the Restigouche in 1760, on the front door step so to speak. The Scots and English merchants 1768 and on. Other parts of Canada would be proud to have the heritage and history we have and they would be doing something about it.

(NOTE - This address was copied verbatim but it is not known who read it. In recent years a great deal of restoration work has been done on this cemetery, making it a beautiful and pleasing site - very fitting to those who lie beneath. This was done through the efforts of the Caledonian Society of Restigouche, headed by Mr. William ADAMS. Many thanks to Mr. ADAMS for allowing us to have this historical sketch and the cemetery listings printed in our newsletter.)

HANDFAST

The term *Handfast*, (H/F), was used as confirmation of the fact that a couple agreed to be married, and live together as man and wife, in the presence of a group of friends or members of the community, when there was no authority to perform the ceremony. The agreement was good for one year, or until a preacher came to perform the rites. If the couple decided not to marry then they parted and went their own ways. Children born of the couple were considered legitimate!!
