

Tiny Problems:

Genealogical Sources in Andorra

In 1978, the tiny Principality of Andorra commemorated its 700th year of nationhood. Since 1278, when the Count of Foix in France and the Bishop of the See or Urgel in Spain became Suzerains, or co-princes, of Andorra, this nation of 30,000 has somehow maintained its political independence.

Today, the Suzerains are the Bishop of Urgel and the President of France, who now holds the authority of the Count of Foix. The actual governing of Andorra is in the hands of an elected council.

Andorrans speak Catalan, a unique and richly endowed romance language. French and Spanish are also spoken to a lesser degree.

Being well sheltered from the rest of Europe, sandwiched between France and Spain, away from military conflicts, Andorra has managed to preserve many of its written records, including those of genealogical importance.

ARCHIVES

The Andorran archives contains a substantial collection when one considers the small size of Andorra. Most records of archival nature are held at:

VITAL RECORDS

Birth, marriage and death records may be obtained by writing the mayor, or Alcalde, of the municipality in question. The six municipalities in Andorra are Andorra la Vella, Canillo, Encamp, La Massana, Ordino and Sant Julia. No provision for civil divorce exists in Andorra, thus no divorce records are maintained by municipal authorities. Census are sometimes taken on an irregular basis by municipal authorities in Andorra.

CHURCH RECORDS

The Roman Catholic Church maintains baptismal, marriage and death records in each of the six ecclesiastical districts, which roughly correspond to the municipal divisions. These records may be obtained by contacting the parish priest in each district. Church decrees of divorce may be obtained by writing the Bishop of Urgel in Urgel, Spain.
