


The objectives and goals of Saskatchewan Genealogical Society Inc. (SGS) shall be as outlined in the Society Bylaws (1997).

### Research in Belgium - Part 2

Exhaust every available record in Canada before doing research in the "old country."

#### Saskatchewan Land Records

#### **Homestead Records**

There was a period of time when the Canadian government wanted to attract European immigrants to the Canadian West. For Belgium this timeframe included the years 1889 - 1910. The government used immigration agents to inform perspective immigrants about their offer of "free" land in the form of homestead grants of 160 acres. The "free" grant involved a payment of a \$10.00 registration fee, which made the transaction legal. Then the farmer had to fulfill the following homestead requirements:

- had to be male, 21 years old; or a woman who was the sole support for her family;
- had to live on the homestead for at least 6 months of the year for each of three years;
- had to cultivate and crop at least 30 acres
- had to build a house
- had to have a barn and animals
- had to be a British subject, or had to become a naturalized British subject.

When researching your family's homestead records take careful note of the following information you may find:

- Date of entry as a general rule, families arrived in Canada within a three month period before the date of entry. Therefore, knowing this could help you narrow down a timeframe in which the family could have arrived in Canada and thus help you to locate a passenger list record. Also, this date can help you to determine whether they could have been included in the census of 1901 or an earlier census.
- Check the Application for Entry and the Sworn Statements in the homestead file. The Applications for Entry are not always included in the Homestead Records, however the Sworn Statement is and may provide information regarding the number of people in the family when the form was completed. The Application for Entry may also reveal the country and county of origin. It will usually also give the last place of residence.
- The date of Naturalization will give you information about when the person first arrived in Canada.
- Study the signature of the homesteader and note whether it is the same as you've found in other documents signed by this person.
- Who were the people who gave supporting statements? These Sworn Statements will also be found in the homestead file and often are relatives or close neighbours of the homesteader. When they answered the question regarding the length of time they have known the homesteader, it is referring to the length of time they have known the person in Canada.

Therefore, keep in mind that they could have known this person much longer than stated in their Sworn Statement.

 Note whether there is a Seed Grain Incumbrance. If so, there will be information regarding this debt in the Seed Grain Incumbrance files located in the Saskatchewan Archives Board.

Homestead files for Saskatchewan are located in the provincial archives. The paper files are housed in Saskatoon. Both the Saskatoon and Regina offices have the homestead index and homestead files on microfilm. These microfilms were created by the Genealogical Society of Utah and are also available at the Family History Library or through a local Family History Centre near you.

For information on homesteaders who received patent for their homesteads, the National Archives of Canada's ArchiviaNet web site has a searchable database. (http://www.archives.ca/)

#### **Land Titles**

To research information on land transactions, after the homesteader received the patent to the land, consult records held by the nearest land titles office. The legal land description is required for a search to be done.

At present, the land titles system in the province is becoming automated. The new corporation, called ISC (Information Services Corporation of Saskatchewan), is accessible via the internet. The web site address is <a href="http://www.isc-online.ca/isc\_public/scripts/isc.asp?cfgpage=HOME">http://www.isc-online.ca/isc\_public/scripts/isc.asp?cfgpage=HOME</a>. The system is called the LAND. The following information was extracted from this web site:

"The LAND - Land Titles Automated Network Delivery - System is an advanced land ownership record system capable of graphically describing every piece of property in the province, raising title to that property, and recording interests against it, while providing quick, efficient and one-stop service for clients, through the internet.

Implementation of the LAND System throughout the province is underway according to the following schedule:

- May 7, 2001 Plan of Survey searches
- June 25, 2001 Grant Searches, Writ Registry Searches & Titles and Plan Processing in the former Moose Jaw Land Registration District
- December 3, 2001 Regina area Land Registration District and Regina Southeast Land Registration District
- Winter 2001/2002 existing Humboldt Land Registration District
- Winter 2001/2002 existing Saskatoon area Land Registration District and Saskatoon Midwest Land Registration District
- Spring 2002 existing Battleford Land Registration District
- Spring 2002 existing Prince Albert Land Registration District
- Summer 2002 existing Yorkton Land Registration District
- Summer 2002 existing Swift Current Land Registration District

In the Fall of 2002, once the whole Land Titles and Survey systems have been converted over to the new LAND System, on-line Registration will begin." (date of extraction: January, 2002)

#### **Immigration Records**

A passenger list is also known as a ship's manifest. It lists the names, ages, sex, and occupation of the people traveling by ship to an official port of entry in Canada. It may also tell the origin of the person traveling as well as their destination in Canada.

Also they usually noted any deaths at sea and whether a passenger was not allowed entry into Canada.

Passenger Ship Lists are available for the following Declared Ports of Entry:

- Quebec/Montreal, PQ 01 May 1865 1935 (closed during winter months)
- Halifax, NS January 1881 1935
- North Sidney, NS November 1906 1935

- St. John, NB January 1900 1935
- Vancouver, BC April 1905 1935
- Victoria, BC April 1905 1935

The microfilm numbers for passenger lists during the years 1865 to 1935 can be found on the National Archives of Canada web site. www.archives.ca

Here are a couple of the books that are in the SGS library collection:

- Ships' Passenger Lists and Border Entry Lists in PAC (Public Archives Canada now known as NAC National Archives of Canada), RG 76 (Records of the Immigration Branch): Microfilm Finding Aid; 1865 1918. This will help you to find the microfilm you require.
  - Another finding aid in the SGS library is a two volume collection of the descriptions of Department of the Interior files on microfilm. The title is Finding Aid: Department of the Interior Record Group 76. You need to go through these volumes page by page, very systematically, in order to try to determine if there might be any information about your ancestors on the particular microfilm. I looked for every mention of anything to do with emigration from Belgium to Canada during the timeframe when my grandparents came to Canada. I also looked for any mention of the places they may have traveled through on their trip West such as Immigration Buildings where they might have stayed, Roman Catholic Church sponsored immigrant lists, Booking Agent lists, etc. I chose one that I thought might have some relevant information to start searching.

The following is a transcription of the notation I researched first:

RG # 76 Series I-A-1
Reel # C-10316 Vol # 435 File # 657818
G. Van Hersten, Union Ticket Office, Antwerp,
Belgium. Booking agent (lists).
File Inclusive Date: 1907-1921

The key information considered in my decision to search this particular microfilm was:

- "Antwerp, Belgium" because I knew that is where my grandparents left Belgium from.
- The "File Inclusive Date" of 1907-1921 because I knew my grandparents arrived in Canada 07 April 1909.

It is very much a hit and miss type of research, but can be very rewarding. I was able to locate two pieces of correspondence regarding my grandfather on this microfilm.

#### **Census Records**

If you believe your ancestors were residing in Saskatchewan in 1901 check the 1901 census records. Census were usually taken in early April. The area now known as Saskatchewan was a part of the North-West Territories in 1901. The boundaries that were in effect then included the districts of Assiniboia East, Assiniboia West, and the District of Saskatchewan. This is the earliest census for the area now known as Saskatchewan. You will need to know a specific location in order to use the 1901 census effectively. This census has been indexed by Alberta Genealogical Society for the whole province of Alberta. The Manitoba society is in the process of indexing the 1901 census and has completed the RMs in a section of southern Manitoba to date. Those that have been published to date are in the SGS library. The index for Manitoba may be especially useful once the southern half of the province has been completed since there are many French and Belgian communities located in southern Manitoba such as Deloraine, St. Alphonse, Swan Lake, Mariapolis, and Bruxelles. Now we just have to get started on indexing the Saskatchewan portion! Anyone out there interested in this project?

The title of the Alberta index is *Index to the 1901 Canada Census: District of Alberta (No. 202)*. This is an every name index to 60,000 individuals enumerated in the 1901 census of Canada for District 202, Alberta. (Published by the Alberta Genealogical Society, Edmonton Branch.) It is available for sale from the Alberta Genealogical Society at a cost of \$48.00 plus \$7.00 postage and handling.

From the 1901 census records you can learn much valuable information about your family. For example, you can determine who was living in the household on the day the census was taken. In the case of the 1901 census, that date would be 31 March 1901. Other information you may discover is the date and place of birth, age, relationship to the head of household, religion, racial origin,

occupation, year of immigration and year of naturalization.

The 1891 census was taken on 06 April 1891 and asks for birthplace of the individual and the birthplace of their father and mother. It lists each person individually, with details as to age, sex, country or province of birth, religion, racial or ethnic origin, occupation, marital status, and education. (NAC Web site - www.archives.ca)

The 1891 Census has been indexed and copies of these indexes are in the Saskatchewan Genealogical Society (SGS) Library. There is one for the District of Alberta, the District of Assiniboia East, the District of Assiniboia West, and the District of Saskatchewan. They are available for purchase from the SGS. Saskatchewan Archives Board (SAB) has copies of the index and most local libraries should also have them in their collections or can obtain them through inter library loan.

When researching census records it is important to remember:

- Peoples' names were often spelled according to the census taker's interpretation.
- Ages are not always recorded correctly, however the members of the family tend to have been recorded in the order in which they were born.
- Note the places of birth of family members.
   This could reveal details about how the family traveled to their final destination or where the family may have lived previously.
- It is possible that the religion noted in the census return is not the religion of the family but is listed because it was the only church in the community where the family lived.

Census records are available through interlibrary loan from the National Archives of Canada. Provincial archives (i.e. SAB – Regina and Saskatoon), libraries, and genealogical society libraries may also have copies of census microfilm. The 1891 and 1901 Census is available through the Family History Library.

#### Other types of records to search include

church records – baptisms, marriages, burials cemeteries and cemetery records – jot down names that even sound Belgian

court records - wills

funeral home records

**newspaper records** – obituaries, births, marriages. Obituaries of pioneers in Canada often reveal the place of origin of the person in Belgium (as was the case with my grandfather's obituary).

If you write a letter to a genealogical society in Belgium ask that your letter be forwarded to one of their members who is interested in the same family or is researching in the same area that you are researching. Also ask for the name(s) of their member(s) who might consider doing specific searches in local records on your behalf for a fee. Always offer to pay for information and send an SAE and sufficient funds to cover return mail costs. If you are mailing a letter to the French speaking (Walloon) area of Belgium, address your envelope to

Monsieur le Président (Name of the Society) (Address) (Postal Code) (Town) Belgium

Names and addresses of professional researchers are published in genealogical periodicals or may be found by searching the internet.

There is another organization in Belgium which could be very helpful to genealogists:

Service de Centralisation des Etudes Genealogiques et Demographiques de Belgique (S.C.G.D.) 147, Chaussee de Haecht 1030 Bruxelles Belgium.

The following is some dated information I have kept regarding this organization when it was known as *The Belgian Genealogical and Demographic Society (B.G.D.S.)* (I am unsure how old this information is, there is no date on it.)

Since 1944, the B.G.D.S. has been seriously working on the science of genealogical research, collecting, studying, and storing family histories and genealogies. This society has over a thousand members. Its services include:

- publication, *The Genealogists' Intermedium*, which is published six times per year.
- research and inquiry service responds to written inquiries – enclose a contribution to the Society and a SAE.
- documentation center and library
- microfilm service since 1965, thousands of records have been filmed and made available to the public at the National Archives in Belgium. Their resources contain information on virtually every Belgian family.
- promotion service participates in meetings, conferences, and congresses on genealogy in Belgium and abroad. It also maintains close relations with national and international specialized state and local historical societies. The internet address of the web site for this organization is: http://www.SCGD.net

### **Commonwealth War Graves**

They shall grow not old, as we that are left grow old Age shall not weary them, nor the years condemn At the going down of the sun, and in the morning We will remember them.

As I look out of the window of my Somme gite, I see the tiny headstones of Peake Wood Cemetery in the distance, surrounded by the same ploughed fields were the men who are buried in the cemetery lost their lives. However, in 1916 the ploughed fields were the result of incessant shell-fire. This small cemetery of 101 graves is one of the few original battlefield cemeteries that remained after reorganization and work carried out in the 1920s. A large number became 'concentration' cemeteries when many thousands were re-interred from small burial plots. Although a large number of plots were moved to larger cemeteries, many people are surprised to learn that, today, there are more than 2,900 British military cemeteries in France and 621 in Belgium.

When you enter one of these cemeteries for the first time, two things immediately spring to mind: the uniformity of the headstones and the immaculate upkeep of the grounds. When the original wooden crosses were being replaced by stone headstones, it was agreed that, regardless of rank, colour or religion, a standard sized headstone would be used. It would be inscribed with the regimental badge, the rank, number and name of the deceased, the name of the regiment, a religious symbol and, if requested, a brief inscription at the base from the family. Each cemetery also has a stone Cross of Sacrifice and a Stone of Remembrance engraved with the words "Their name liveth for evermore". The upkeep of the lawns and borders we the result of the wonderful work carried out by the gardeners of the Commonwealth War Graves Commission and always give the impression that the grass has been cut only a few hours earlier. A number of these gardeners are related to the original army personnel who stayed after the First World War and married locally.

There are a total of 459,296 named Commonwealth war graves in France and Belgium but there are also 320,153 names on memorials of men who have no known graves. The Menin Gate in leper (formerly Ypres) has over 54,000 names commemorated on its panels. Every night at 8.00 pul, the traffic through the gate is hatted and the sound of The Last Post is hauntingly carried through the air. It is played by the buglers of the local fire brigade in remembrance of the men who made the ultimate sacrifice. After the memorial was designed, it was found that it would not be large enough to accommodate all of the names, so another memorial was built about five miles away at Tyne Cot which, with 11,900 burials, is the largest Commonwealth cemetery in the world. The panels of the memorial are inscribed with 34,888 names.

The largest British memorial is at Thiepval, in the Somme area of France. Designed by Sir Edwin Lutyens and standing some 45 metres high, the memorial was inaugurated by the Prince of Wales in 1932. On its 16 pillars are the names of more than 73,000 men with no known grave who lost their lives on the Somme. Beside the memorial is a special cemetery which contains 300 British and 300 French graves. Each year on I July, there is a service held at the memorial attended by dignitaries from all over the world.

On each of my trips to France, I visit Dud Comer Cemetery which has the Loss Memorial to the Missing inscribed on three surrounding walls. The panels record the name of 20,692 men who were lost forever at the Battle of Loos in September and October 1915. The special visit is to pay homage to my two great-uncles who lost their lives within three days of each other and are commemorated on the panel of the Welch Regiment. On an adjoining panel

# Ranches, Ranchhands and Ranch Owners of the Districts of Assiniboia and Alberta 1880-1906

#### **Historical Background**:

The land in the south-west portion of the District of Assiniboia and the southern portion of the District of Alberta lies within the Palliser Triangle and is more suited to livestock raising than to grain farming. For a period of time from about 1880 to 1900 the policy of the government of Canada was to encourage and develop livestock ranching rather homesteading (farming) in this area. In 1876 the government began issuing grazing leases in 10,000 acre lots. These were 21-year leases and lessees were required to stock 1 head of cattle for every 10 acres within three years of taking the lease. Lessees could hold a maximum of 100,000 acres and many of the ranches of the 1880-1900 era were the maximum size and pre-dated the Dominion Land Survey in the area, although the survey of this portion of the 49th Parallel was completed about 1880. Lands under the 21-year leases were closed to homesteading, that is they were not available for grant under the Homestead Act.

The signing of Treaties #4 and #7 and the arrival of the North West Mounted Police (NWMP) created the first markets for ranches as well as opening up the land for non-native settlers. Some of the first leases were held by NWMP members after completing their 3-year term in the force. One of the first officers to leave the NWMP to take up ranching was Captain William Winder of Lennoxville, Quebec.

Many of the first ranch leaseholders were from the Eastern Townships of Quebec, particularly Compton County. In fact, ranch owners were mostly made up of middle class landowners from Quebec, Ontario, Britain and the USA.

One of the largest ranches in Assiniboia Territory was owned by Sir John Lister-Kaye from Bart, Denby Grange, Wakefield England. founded the Canadian Agricultural, Coal and Colonization Company in 1886. This is more widely known as the "76" Ranch and held ten leases of 10,000 acres in the area west of the current city of Swift Current, Saskatchewan. The company was formed as a ranching and colonization company and the intent was to bring young men from England to work for one year on the ranch and they would then be given the opportunity to homestead on land adjacent to the ranch land. Approximately 110 young English men were enlisted and a similar number from eastern Canada were also enlisted. The first contingent arrived in August 1888 although no record of their names appears to exist. This was the only attempt at colonization by Sir Lister-Kaye, all future operations were confined to ranch work.

In the early 1890's government policy changed and in 1896 the original 21-year closed leases were terminated. New leases after 1896 allowed lease land to be taken up by homesteaders and in 1903 land policies again changed to allow leases to be terminated on 2 years notice and limited leases to land south of Township 29. After 1903 a large influx of homesteaders from the USA encroached on most of the ranch leases. The winter of 1906-07 was one of the most devastating in remembered history and many ranches lost as much as 60% to 70% of their herd. The staggering losses along with the wave of homesteaders brought to an end the era of the great ranches in southwest Saskatchewan and

southern Alberta. Although ranching is still a large force in the area, the size of the ranches does not compare to the ones of the 1880-1906 period.

The intent of this genealogical study was to find surviving records of the 'cowboys' who worked on the great ranches. Mostly an itinerant group, they moved from ranch to ranch looking for seasonal work – such as the round-ups and branding of cattle. It is the unsettled nature of their existence that creates problems for genealogists one hundred years hence. Except for a few surviving personnel records created by the ranch owners there seems to be few records of this group, however, we do know a few things about them in general. Ranch personnel records will often consist of nothing more than a paylist. Some of the ranches of today have existed since the time period being studied, but the current owners did not respond to requests for information for this study.

Many cowboys and ranch hands came from the United States, traveling with the great cattle drives of the era. After the Civil War ended in the USA, ranchers found their grazing areas being taken up by settlers and they were forced to move their herds northward in search of grazing land.

Young, single Englishmen were also common amongst ranch hands. Often the younger sons of well-to-do families they came 'out west" for adventure and were often financially supported by their families back in England.

Many ranch hands eventually took up homesteads or grazing leases and it is in these records that researchers may find the first reference to them.

#### Repositories:

Repositories for ranch information consulted for this study include the National Archives of Canada, the Saskatchewan Archives Board, the Glenbow Museum and Archives, the Medicine Hat Museum and Art Gallery, the Swift Current Museum, Moose Jaw Public Library, Regina Public Library, the Maple Creek Old-Timers Museum and the Saskatchewan Genealogical Society. The Western Heritage Centre on the Cochrane Ranch near Cochrane Alberta, another repository of ranch records has been closed due to funding loss but continues to hold a large collection of material that may be available by writing to the librarian.

The following notes on holdings may be of help to genealogical researchers.

A database of vital statistic registrations for the Maple Creek and surrounding district for the years about 1916-1969 (primarily 1916-1945) that may have names of ranch hands etc., especially if they died in the area.

The collection includes NWT/ Alberta Brand Books – 1889, 1900, 1907-1913, 1915, 1916-18. These are the registry of cattle brands used by ranchers to identify their herd. The Brand Books include the ranchers name and the ranch location.

Using the search word "ranches" in their site search engine finds over forty (40) references in the Finding Aids and further searching within the Finding Aids finds a wealth of references, too numerous to list here. This repository is a "must do" for any genealogist searching for ranching ancestors.

## Holdings at the Saskatchewan Genealogical Society Library

Local History books and Family Histories found at the SGS library contain many references to ranches.

## Holdings at the Regina Public Library, Prairie History Room

The Prairie History Room at the Regina Public Library holds many books on ranching history and the collection of local history books is a rich source of ranching family names in Saskatchewan. Most of the books listed in the attached bibliography can be found in the Regina Public Library, in either the Prairie History Room or the general collection.

## Research Strategies for finding ranch hand ancestors:

- determine if there might be homestead records as well as ranch records. Many cowboys and ranch hands took up homesteads and grazing leases of their own, so while they may not be found as ranch hands they may appear at later times as land or lease holders.
- search census records. For instance, the 1891 census for the district of Maple Creek lists 71 men as ranch hands or ranch workers of some sort.
- cemetery records and census might be the only records where they will be found if there was no land ownership involved.

#### **Summary:**

For a short period in the settling of western Canada ranching was promoted by the government of Canada as the best use of the semi-arid area of what is now southwest Saskatchewan and southern Alberta. Large ranches operated in the area and employed many itinerant workers as cowboys, herders and stockmen. The surviving records for the period can be used to identify the owners and operators of the ranches, but few records exist that identify the average working cowboy on the ranches. They may eventually appear in the records of homesteaders and grazing leaseholders but otherwise it is very difficult to trace their years as ranch hands.

# **Post-1901-Canadian Census Release-Recent Developments**

#### September 2001

 Senate Committee meets to review Senator Lorna Milne's Bill S-12. Presenters were The Hon. Lorna Milne (Sponsor of the Bill), Ian Wilson (National Archives of Canada), Michael Sheridan (Statistics Canada), George Radwanski (Privacy Commissioner of Canada), Chad Gaffield (Canadian Historical Association) and Gordon Watts (Canada Census Committee).

#### October 2001

- Heritage Minister Sheila Copps states on a CKNW Vancouver talk show that she is very much in favour of allowing public access to Historical Census Records
- Senator Lorna Milne issues a press release demanding that Statistics Canada stop breaking the law and allow the release of post 1901 census records to the National Archives of Canada.

#### November 2001

Bill C-312, presented by MP Murray Calder (identical to Senator Lorna Milne's Bill S-12), is deemed not-votable. Therefore, it will receive one hour of debate in the House of Commons before being dropped from the Order paper. Members of the sub-committee of the House Standing Committee on Procedure and House Affairs that made this decision were Carolyn Parrish, Michel Guimond, Jay Hill, Bill Blaikie, Garry Breitkreuz and Marcel Proulx.

- The Department of Canadian Heritage posts an online questionnaire for the purpose of the development of new directions for federal heritage policy in Canada. The econsultation ended November 30.
- Upcoming public consultative town hall meetings and focus groups are announced for citizens to voice their opinions on potential changes to the Privacy Act as it relates to historical census records.

#### December 2001

- The Senate Standing Committee on Social Affairs, Science and Technology passes Bill S-12-An Act to Amend the National Archives of Canada Act and Statistics Act (census records), without amendment. The Bill will now be referred back to the Senate in Report Stage and will receive more debate. Following debate, Bill S-12 will be given third reading and if passed will then be referred to the House of Commons.
- Details regarding the upcoming town hall meeting and focus groups are made known. In Saskatchewan they will be held in Regina on January 25 at the Ramada Hotel & Convention Centre, 1818 Victoria Avenue, from 2:00 4:00 pm and 6:00 8:00 pm. Those who are willing to do so are encouraged to speak and present argument for the release of Post 1901 Canadian Census Records. There are a limited number of spots available for presenters. In order to request a time slot you must contact Environics Canada by email (censusconsulatations@environics.

- ca) or by telephone (613-230-5089). There will also be room for spectators at these meetings.
- Totals of signatures collected on petitions are in excess of 13,000 to the House of Commons and in excess of 20,000 to the Senate



# **Book Reviews**

A Genealogist's Guide to Discovering Your Irish Ancestors. How to Find and Record Your Unique Heritage. By Dwight A. Radford & Kyle J. Betit. Published by Betterway Books, F & W Publications, Inc., 1507 Dana Avenue, Cincinnati, Ohio, 45207-1005. 2001, 296 pp, 8½" x 11", illustrations. Softback. Price: US \$19.19 or CAN \$29.99. Available in Canada from Interlink Books for \$37.44 including postage.

This useful book combines much of the helpful information that Dwight and Kyle published in their two previous books and in their journal The Irish At Home and Abroad. However, they have added new resources that you can access here in North America or Ireland. Although there is a chapter on Internet Resources you will find many of the addresses you need along with printed references in each section of the book. Of particular value are the symbols found in the margins throughout the book pointing out such items as sources, warnings, research tips, techniques, definitions and important facts you need to know to help you with your research. In addition the authors provide strategies to use in order to make the best use of the resources they discuss. Emphasis is placed on the need to trace all members of the family to find the place of origin in Ireland. To do this they have included chapters on using sources in Canada, United States Australia, New Zealand, Great Britain and The British West Indies, Each of these chapters provide excellent tips for anyone doing research in these countries.

For those who are doing research in Canada should note that the Passenger Lists and Border Crossing Records are now available to 1935. The passenger lists from 1920 - 1924 are found on individual forms arranged in alphabetical order. The disadvantage of this arrangement is that you do not see who travelled together. An important feature, for genealogists, is that the form asks for the name, address and relationship of the nearest relative in the country of origin and who they are joining in Canada. The records for 1925 - 1935 are

indexed on the Immigration database on the National Archives of Canada homepage http://www.archives.ca under Archivianet. The questions found on the individual forms are now part of the passenger lists. The microfilm numbers are found on the site.

I would recommend everyone read this book. The beginning genealogist will learn basic genealogical research skills and the experienced genealogist will learn techniques and sources may have been overlooked.

SGS members please note: The major resources listed in A Genealogist's Guide to Discovering Your Irish Ancestors are found in the SGS library collection. Members living in Canada can borrow the books from the library. Those items found on microfiche are for use in the library but can be searched for a small fee.

STRAYS! An Index to the OGS Strays Project. Volume 6. 97 pp. & STRAYS! An Index to the OGS Strays Project. Volume 7. 81 pp. Published by The Ontario Genealogical Society, 40 Orchard View Boulevard, Suite 102, Toronto ON M4R 1B9. 2001, 7" x 8½". Softback. Price \$10.00. Non-Canadians to pay in US funds but deduct 20% from the total cost including postage. Postage and packing: In Canada \$4.00 first item + \$1.00 each additional item. Canadians must add 7% GST to both book and postage charges. Outside Canada \$6.00 first item + \$2.00 each additional item.

A stray is defined as a person who is described in a record of an event as being from, or connected with, a place outside the area in which the event took place. The persons listed all have their origins in Ontario but have "strayed". Some only moved within the counties of Ontario while others moved further afield. These books are part of an ongoing series of indexes which have been and will be published over the years. Each entry provides the name of the person, maiden name, if given, date and place of birth and death and the source of the information.

One-Place Genealogy. By David Hawgood. Published by David Hawgood. Distributed by ABM Publishing Ltd., 61 Great Whyte, Ramsey, Huntingdon, Cambridgeshire PE26 1HJ, England. 2001, ISBN 0 948151 22 6, 64 pp. Softback. From ABM Publishing price including UK postage £4.30, overseas surface mail £4.50, airmail £4.85 (currently US \$7.00). Other on-line bookshops include the Federation of Family History Societies (Publishing) Ltd www.familyhistorybooks.co.uk and the Society of Genealogists www.sog.org.uk.

This book aims to help genealogists seeking ancestors in a particular place. It describes One-Place Studies in which researchers put together information about the people in a place from a variety of sources, and make the information available to those researching their family history in that place. Studies are listed alphabetically by county, with descriptions of records included and contact details for compilers. It describes the variety of these studies and the organisations involved with them. It gives ways of finding other studies, both using the internet and using libraries, and ways of finding other information about places. Most of the studies listed are from England with a few from the Isle of Man, Scotland and Wales.

The following book review was done by Glenn Schwartz of Zichydorf Village Association. The books have been purchased by Zichydorf Village Association and are available in the SGS Library.

### Heimatbuch der Heidegemeinden Heufeld-Mastort-Ruskodorf

Tells the story of three villages about 80 km northwest of Zichydorf near Hatzfeld. It contains a detailed history, many lists, including householder lists and lists of people who died during the War, copies of historical documents, many maps, some family group sheets, and over 250 pages of pictures.

Accompanying the main volume are three books of transcribed records.

One is baptisms (Taufen 1771-1837), another is marriages and deaths 1771- 1851, and the third is a supplement (Nachtrag 2000). The Taufen book also contains a few marriages from 1844-1851. The marriage and death book contains several articles about Banat, many of them focused on people of French heritage from Lorraine. The supplement adds some marriages from 1799-1852, corrects and expands on some of the deaths in the second book, contains some information on immigration of some individuals to the US (and transiting to Canada), and gives details about each house address, the property that was attached to it, and the owners through the first few decades. There were indications that several Zichydorf families came from these villages, but, upon reviewing the book, there were fewer likely connections than I had hoped.

Nonetheless, if you think your family may have come from this area, these books are a great resource. Although it is in German, much of the information is in lists that are easily deciphered.

# **Computer Column**

# **Enhance Your Internet Connection with Mailing Lists**

Santa left that brand new computer under the tree and you have succumbed to SaskTel's promotion for High Speed Internet with unlimited hours. Now you find you are getting bored with endlessly surfing the Net. What else can one do on the Internet?

Here is one of my favourite ways to use my Internet connection: I belong to several genealogy mailing lists (Listservs or just plain Lists.) Mailing lists for genealogists include the following types:

- Surnames
- Counties
- States
- Provinces
- Countries
- Ethnic and special interests
- Genealogical computing

You can connect with a living breathing relative: someone who can help you with your family tree and whom you may be able to assist with his or hers. (I have several times and solved some long standing family mysteries.) There is much mutual sharing. Many genealogical acts of kindness occur in cyberspace.

I like to compare Lists to the old general ring of the rural telephone exchange, one general ring and the message goes to everyone. Likewise you write one email and post it and everyone who has subscribed to that List receives the posting. You will receive the posting as well. How do you find out about these Lists? An excellent source is this URL for Rootsweb: http://lists.rootsweb.com/ Rootsweb has over 23,726 mailing lists from which to choose. Here is the information given on the Rootsweb site about subscribing to the Saskatchewan List. (This is only an example. Please note that every mailing list is unique and you need to read the directions when you subscribe.)

# to join CAN-SASKATCHEWAN-L, send mail to CAN-SASKATCHEWAN-L-request@

**rootsweb.com** with the single word subscribe in the message subject and body.

You will receive a message confirming that you have joined this mailing list and giving information about how to post messages and how to unsubscribe. It is important that you keep this information because you will want to unsubscribe when you are away from your computer for an extended period of time or you may have to wade through hundreds of email messages when you return.

Some of the Lists generate a great deal of traffic and if you don't wish to receive so much email you can subscribe to the digest mode. The digest format puts together anywhere from 5 to 30 messages into a single email.

Many of the lists also have archives in which messages have been stored since the inception of that list. Information is given when you subscribe to the list.

Every mailing list has a moderator. This is the list owner who makes sure everyone stays on topic and that no one is insulting anyone or breaking other Net etiquette. Remember writing in CAPITAL letters is thought of as screaming and may be offensive to some.

# **Cemetery Program**

The following tidbit of cemetery history comes to us via the Internet. It is interesting to consider how people of earlier times did not segregate places for the living and places for the dead as we do in modern times.


Before embalming and other sanitary measures, graveyards were often littered with bones and bits of charnel. Shallow graves allowed maggots and scavengers to dig up and scatter the remains along with any contagion they might also carry. Despite this unhealthiness, the living used churchyards as social centers where they conducted markets, played games, and, in Scotland, prepared for that massive corpse-producing activity known as war by practicing archery or other weapons drills. The English Parliament suspected that funeral and burial customs played a role in spreading the Black Death. In 1665, it legislated against unnecessary visits by friends and children, large funerals, and, most importantly, graves less than six feet deep. Joel GAzis-Sax (on his Internet site "History of Cemeteries")

Notes to the Financial Statements December 31, 2001

### 1. GENERAL

The Society is incorporated under the Non-Profit Corporations Act of Saskatchewan. Its primary objective is the promotion and development of the study, research, and preservation of genealogy and family history in Saskatchewan.

### 2. SIGNIFICANT ACCOUNTING POLICIES

The Society has adopted the practice of recording capital assets as expenditures in the year acquired. This procedure was adopted in order that grants received, which are based on anticipated capital expenditures, as well as usual operating expenditures, might be more closely matched with the corresponding expenditures.

In order to accurately reflect the financial position of the Society, the capital assets are then recorded with an offsetting credit to "Equity in Capital Assets". Amortization is recorded on the straight line basis on computer equipment at 40% per annum and 20% on other equipment. This is recorded as a charge to "Equity in Capital Assets".

Total capital assets charged to operations during the year were \$2,800 (2000 - \$2,783)

By its nature, estimates are subject to measurement uncertainty and the effect on the financial statements of any changes in estimates could be significant.


