

GENEALOGICAL RESOURCES IN BERKSHIRE COUNTY LIBRARIES

DALTON FREE PUBLIC LIBRARY

Main Street, Dalton Doris Lamica, librarian

The Dalton library is in the front section of the Dalton Town Hall on the ground floor. It is quite large and very pleasant. A small special room houses the town's history and genealogy books. The collection here has special emphasis on Dalton, much of it donated to the library by Winthrop Crane.

Special books about Dalton are interesting and varied. "The Dalton Plan," a new progressive educational plan of the 1920s is in eight books, probably the most complete set around. Others are: Dalton and the World War, 1917-1918, 150th Anniversary of Dalton, 1784-1934, The First 175

Years of Crane Papermaking, History of Dalton Methodist Church, and Down Memory Lane by "Cap" Couch, (a weekly column in the Dalton News-Record).

Veterans Graves in Dalton has maps of all Dalton cemeteries from the Revolution through W.W.I. Other books about the military are Civil War, Company K, 49th Regiment (Byron West was commander of Company K) and Personal Sketches - Dalton in the Civil War.

Other pertinent Dalton items: Town Reports, 1866 to the present, and the Guest Register for the Great Hearth Lodge on Mount Weston in Dalton, 1888-1893. This lodge was owned by Lieut. Gov. Weston. The history of the library is recorded in a book picturing the interior and scrapbooks of newspaper items about the library from 1925 to the present.

There are genealogies and biographies on William Frances Bartlett, William Cullen Bryant, Josephine Boardman Crane, W. Murray Crane, Zenas Crane, Kirch Kirchner, Mathias, and Sabina and Col. Ephraim Williams.

Dalton was included in the series Massachusetts Vital Records to 1850. The library has copies of Dalton Vital Records to 1850 and fifteen books for mostly Berkshire County towns.

There are bound copies of The Dalton News-Record, 1961 to the present with some gaps, and U.S. Army newspaper The Stars and Stripes, February 1981 to June 1919.

The genealogist will find such standard reference works as Child's Gazeteer of Berkshire County, Beer's and Smith's histories of Berkshire County, Western Massachusetts History (4 vols.), and Commonwealth History of Massachusetts (5 vols.), and a few histories of surrounding towns published in recent years.

Atlases are available: Berkshire County 1904; Massachusetts 1891, 1895, and 1904; also the Statistical Atlas of the United States 11th Census (1898).

The librarian will answer genealogical questions by mail that do not involve extensive research.

Library hours: Monday and Wednesday, 12 noon to 8:00 P.M.; Tuesday, Thursday, and Friday, 12 noon to 5:30 P.M.; Saturday, 11 A.M. to 4:00 P.M. Telephone 684-0049.

Town Clerk's Office. One is able to go directly from the library into the town clerk's offices, so all records there are easily accessible. The town's vital records begin in 1843; earlier records are in the previously mentioned Dalton Vital Records to 1850. This office also has the Acts and Resolves of the Massachusetts Supreme Court from 1939 to the present day, often good sources for the genealogist.

EGREMONT LIBRARY

South Egremont Mrs. Florence Wheeler, librarian

The Egremont library is small but pleasant. It occupies the ground floor of the building that formerly served as the Town Hall (next to the cemetery). The 1832 building was used as an academy for fifty years until it became the Town Hall.

In this library are two books on the Goodall-Goodale Family (Salem and South Egremont). One finds the large well-known History of Berkshire County and histories of surrounding communities. Egremont has only one town history - Egremont, written for the Bicentennial.

There are no church records, newspaper records, or vital statistics here. Some Egremont town reports are in the library but most are upstairs, packed in boxes and piled loosely on the top shelves. They would be very hard to use, may not be complete, and no one knows how far back they go.

The second floor of the building is devoted to a fine, small historical museum. Large old books are on every available shelf, ones not found in many libraries. Leather bound too! The eight volume set Records of the Colony of New Plymouth in New England covers deeds, court orders, laws, judicial acts, etc., from 1620 to 1682. Another surprise — Massachusetts Public Documents, a complete set from 1895 to 1906, a good source of information for the genealogist. The number of volumes for each year varies, but for 1895 alone there are twelve volumes.

The Commonwealth of Massachusetts sends a bound copy of Acts and Resolves to every library in the state each year. At first libraries were given instructions to keep them, but later were given permission to dispose

of them if not used. Most libraries have given up trying to store them. They can be a valuable source and in this museum one finds them, all in excellent condition. The first set consists of thirty-two volumes of Acts and Resolves of the Province of Massachusetts Bay, 1692-1803. Beginning in 1804, the Acts and Resolves contain cases in the Supreme Judicial Court of Massachusetts. Only a few volumes are missing from 1804 to 1934.

Egremont, unfortunately, was not included in the Massachusetts Vital Records to 1850 series. But carefully stored in the second floor museum are 154 volumes of this set. Some still have their paper covers on! Genealogists look for these because they include not only the town vital records but the local church and gravestone records.

The museum has a number of scrapbooks on local people and events, Beers' Atlas of Berkshire County, and the Massachusetts Historical Commission's Historical Site Inventory of Egremont.

DENIS J. LESIEUR, HEAD OF THE LENOX LIBRARY, LENOX, MASS.

The appointment of Denis J. Lesieur to the position of Librarian of the Lenox Library was announced by the Library Trustees. The Berkshire Family History Association recently honored him and his wife, Shirley, at an appreciation dinner to celebrate this event. Mr. Lesieur had been supervisor of the local history and genealogy division of the Berkshire Athenaeum.

Founding president of the Berkshire Family History when it became an independent organization in 1979, Denis served as president for three years. He has initiated numerous successful programs for the Association, including publication of The Berkshire Genealogist, which he edited from the first number through Volume 3, Number 1. He has served as research director and member of the board of directors, responsibilities he will continue after assuming his new position in September of this year.

Mr. Lesieur was honored by the Board of Directors in 1983 by presentation with a life membership in the Berkshire Family History Association.

ANCESTOR TABLES

We begin the printing of Ancestor Tables with great expectations and with some trepidation.

Expectations spring from the values of the Tables as stated by Donald Lines Jacobus, who began the printing of Ancestor Tables in the January 1955 issue of The American Genealogist. He saw the values of this feature as: allowing subscribers to record for themselves and family their known ancestors through their great-grandparents; starring progenitors about whom little is known and correspondence invited; and providing information for those with cognate lines.

Trepidation arises from the comments of George McCracken, successor to Mr. Jacobus as editor of TAG, on the occasion of the printing of the 200th Ancestor Table in January, 1971: "...it should be said that the Editor would not weep if no more (Tables) arrived, but since they seem to be popular he resigns himself to more drudgery of this kind." Part of the frustration must have arisen from contributors deviating from the "carefully considered" rules "either through misunderstanding or deliberately". We ask that you carefully follow the the simple rules below.

Trepidation arises, also, from the realization that the Editor may not have enough "general genealogical knowledge" to detect or suspect errors in the ancestry in the Tables. In another context, Donald Jacobus took to task editors of genealogical publications: "Some of them, I feel, make a mistake in including ... lines of descent of members. Material of this type is too often prepared by amateurs of insufficient experience and should be checked before acceptance by trained editors who possess a great deal of general genealogical knowledge." TAG 40:1:63 (January 1964). We ask that your Tables be based on careful documentation.

Rules for Submission of Ancestor Tables

- 1) One Ancestor Table will be printed for the ancestors of a member and one for the spouse of a member.
- 2) Limit Tables to six generations. If member wishes to submit more than six generations, the line of a parent or grandparent may be substituted, indicating the relationship. The line of a descendant will not be printed.
- 3) Numbering system. You are number 1. Your father is number 2; your mother number 3. The number of trhe fathers in succeeding generations is twice that of the child; the number of the mother is that of the father plus one.
- 4) Give the full name of each person; birth and death years; main places of residence; limited to three.
- 5) Place names: use standard, not postal, abbreviations; i.e. Mass., not MA. If places of residence are the same for husband and wife, do not repeat for wife. State names need not be repeated if no misunderstanding will arise.
- 6) No Table will knowingly be printed if it is in print elsewhere unless significant new material has been added.

- 7) Where no information is known, indicate thus: 27. or 52-55.
- 8) An asterisk (*) may be used to indicate that more information is requested.
- 9) Single line entries are preferred. We are still experimenting with format, but at present a line is 75 spaces.

Tables not complying with these guidelines, or whose data seem open to question, cannot be printed.

THE BOOKSTALL

by Denis J. Lesieur

Records of The People of the Town of Bethlehem, Albany County, New York, 1689-1880. Edited by Florence Christoph and Peter R. Christoph. Selkirk, N.Y.: Bethlehem Historical Association, 1982. ix, 460 pp., illus., index. \$25.00.

The increasing popularity and practice of genealogy has fueled an equally strong surge in the publication of local records. This book by Florence and Peter Christoph is especially welcome, given the difficulties inherent in trying to locate and use local records in New York State. While not a complete substitute for the actual records, published versions do allow initial research to proceed and reasonable assumptions to be made.

Most of the records contained in the volume begin in 1793, although actual settlement of Bethlehem occurred more than a century before. Since the town was not incorporated until 1793, earlier records are scattered in other surrounding jurisdictions of which Bethlehem was a part, including Rensselaerwyck and the Town of Watervliet. It is unfortunate that the Christophs did not include at least a brief mention of the extent and location of these earliest records, particularly since they cover a long and significant segment of time in the development of the town, as well as Albany County.

Those records included in the book, however, are well done. The researcher is given a wide span of local records with which to work, ranging from church and cemetery records to the U.S. Census reports for Bethlehem from 1800-1840. Since each type of record is copied in its original format and to its conclusion, each has its own section. A brief historical introduction precedes the segments, explaining the genesis and location of the original records. A composite index for the entire contents is also provided. As an added feature, frequently encountered surnames are listed in front of the index, together with their English and Dutch variant spellings. Such a guide is welcome for a work that deals with the Hudson Valley area and its heavy settlement by the Dutch.

The technical production of the volume is also impressive. The type is large and easily read, with a minimum of typographical errors detected. This last point is especially important for any published records, because even the smallest error can create havoc with genealogical research. Illustrations of the various records are interspersed throughout the text, together with historical photographs of Bethlehem and some of its prominent inhabitants. Unfortunately, the reproduction of 1767 and 1866 maps of the town are rather blurred, rendering them difficult to read.

Beyond such minor problems, however, Records of the People of the Town of Bethlehem is a fine work that should serve as a model for similar efforts by other towns. It is to be hoped that the publication of local records will encourage the study of the social and economic development of small towns and families, the basic elements of American history.

THE QUERY SECTION

by J. Bradley Cooper

Queries, while just that, should be more than requests for information. The Query Section can be a forum facilitating the interchange of genealogical material. The ideal query should suggest the possession of other information which the generator of the query will exchange with anyone who answers the query, should this be desired.

For example: a query such as "John Doe born about 1870 married Mary Moe about 1896. Need lineage and all data on John and Mary." displays a lack of homework. it indicates also that the generator of the query has little information to share with anyone answering the query. It is unlikely that anyone who may have spent years accumulating material from 1620 to 1870 will bother to present the results of such a search as an answer to the query. Nor should the originator of the query expect that this will be done.

Had the query been worded differently the prospect of securing results might have been increased. For example: "John Doe born 2 July, Sheffield, married Mary Moe, Lenox, 5 June 1896. Need parents of John and Mary." is much more likely to secure results.

Once the parentage of John and Mary is obtained, the next step would be to generate a similar query as to the grandparents. In this step-by-step method the entire lineage chain could be constructed. It is much more likely that other researchers will share bits and pieces of their findings than the complete genealogical structure. This may be a time consuming process but so was the accumulation of the information to which the generator of the query desires access.

A number of queries have been received which present considerable information but do not ask a question or state what is desired. These cannot be published because the nature of the desired response is not disclosed. The query must begin or end with a specific request or it cannot produce results. If there is only a wish to correspond with anyone with a similar interest, this should be stated in the query.


