

STATE CENSUS OF MASSACHUSETT, 1855: BECKET

Abstract by Meta Stark

Introduction by Marcia Eisenberg

The taking of a census in 1855 was mandated by an act of the General Court of Massachusetts, 21 May 1855. The act provided that a census of each city and town be taken between 1 June and 1 October 1855. The census was to be "as of" the first day of June of the census year.

Reports on the taking of the census stated that the instructions were generally "well observed." Some enumerators, however, were so negligent or heedless that their reports were "scarcely fit to be received." Cautions, still appropriate, were given against relying too absolutely on the census because of "the great liability to error" and the "usual difficulty of arriving at the truth" arising from ignorance and prejudice.

To secure uniform reporting, blank forms were provided and the following data were to be recorded:

- 1. Dwelling houses numbered in the order of their visitation.
- 2. Families numbered in the order of visitation ("family" being all those living in one house, public house, or institution).
- 3. Name of every person whose usual place of residence was in this family 1 June 1855. Note: Excluded were those born after 1 June. Included were those who had died after 1 June and those temporarily absent.

Relationship of household members to the head of family was not recorded. An aid in establishing relationships exists, nevertheless, in the requirement that the enumerator arrange names in a given order: master first; mistress second; children in order of age third; male domestics, etc., next; female domestics, etc., next; and lastly boarders, etc.

- 4. Age. To be given as of last birthday unless next birthday would be within four months, then age at next birthday.
 - 5. Sex.
 - 6. Color. B for Blacks, M for Mulatto, no entry for Whites.
- 7. Profession, occupation, or trade of each male over fifteen. For clergymen, initial letters of denomination.
- 8. Place of birth. State or territory if native born; country if foreign born.
- 9. Whether deaf and dumb, blind, insane, idiotic, pauper, or convict.

GENEALOGICAL RESOURCES IN BERKSHIRE COUNTY LIBRARIES

MASON LIBRARY

Main Street, Great Barrington

Miss Marlene Drew, Librarian

The Mason Library Genealogy Department is in a special room on the ground floor - one must ask at the desk for admittance. In a pleasant, bright room one finds all the genealogy and related books as well as a microfilm reader. The material available is truly outstanding and varied.

Separate genealogies cover the following Great Barrington families: Averell-Averill-Avery; Avery; the Groton Avery Clan; Fairchild and Park; S. Putnam Avery; N. Barker of Sandisfield; Benjamin; George Dewey; Dexter; Ellis; Fairchild; Field; Goodrich; Graham; Gross; Hallock; Haven; Hooker; Hopkins; Huntley; Joiner; Knight; Koger; lawrence; Leavenworth; Loomis; Mason; Mills; Munsey; Newhall; Noble; Partridge; Patterson; Pier; Pixley; Pomeroy; Pulsifer; Pyncheon; Rhodes; Robinson; Sahler; Seymour; Spragues; Steevens; Van Deusen; Van Deursen; Vosburgh; Weaver; Whiting; Wadhams; Ward; Washington; E. Washburn; Wickware; Wrinkle; and Wood.

Newspaper records: The Berkshire Courier has been printed in Great Barrington since 1834. The library has an almost complete run of the Courier from 1834 to 1900. The originals, stored in acid-free paper, are not available.

Church records in bound volumes: early records of Great Barrington's First Congregational Church (1740-); St. James Episcopal Church (1740-); and a small volume of Sheffield, Mass., early church records.

Cemetery records: volumes of tombstone inscriptions for Great barrington, Sandisfield, Egremont, Monterey, Mount Washington; Bordertown Cemeteries which includes Granville, Tolland, Sandisfield, Southwick, Sheffield, Otis, Stockbridge,

West Stockbridge; Revolutionary soldiers' graves in South Berkshire County prepared by the DAR.

School records: reports of the School committee 1865-1888; extensive collection of Searles High Schoolyear books; bound school records showing pupils and teachers 1891-1902.

Town reports of Great Barrington 1886 to present; Fire District history.

There is an outstanding collection on Connecticut history, vital records, and genealogy. There are books on the early history of New York, Pennsylvania, and Virginia.

Bound volumes include a complete set of the the New England Historic Genealocal Society Register dating from 1847; the New York Genealogical and Biographical Society Record 1915-1933; Mayflower Descendant 1899-1937; Massachusetts Soldiers and Sailors of the Revolution; individual volumes on different regiments in the Civil War; many histories of Massachusetts and Berkshire County. Among the extensive collection on genealogy and heraldry was noted the Rottenberg book on Jewish genealogy.

Not to be overlooked: records of the quarterly courts of Essex County 1636-1683; probate records of Essex County 1635-1681; and many volmes of the Acts and Resolves of the Massachusetts legislature.

Great Barrington was included in series <u>Massachusetts Vital</u>
<u>Records to 1850</u>. The library has the volume for its town and 194
of the other volumes of that series.

Arrangements can be made with the librarian if photocopies are needed. Genealogical inquiries are answered if extensive research is not involved; personnel is limited. A donation for such service is appreciated.

TYRINGHAM LIBRARY

Main Road, Tyringham Mrs. Irma Clark, librarian

Here is a small town library at its best, where many residents are working, under expert guidance, toward a goal. The town Historical Commission has assembled in one small room in the library all the history and genealogy of the town and its people. Everything is systematically arranged and filed. The townspeople are working together to assemble books, records, early town

histories, scrapbooks, journals, pictures, hand-written genealogies, etc. The commission is in the process of indexing this material - making it invaluable to the researcher.

Tyringham, fortunately, was included in the Massachusetts Vital Records to 1850 series. The library has 168 volumes of this set, covering almost that many towns and cities. In addition to their printed Tyringham Vital Records to 1850, all the town vital records from 1762 to 1980 have been photocopied from the original town books, an excellent, inexpensive way to make this information accessible to the genealogist.

A Family Genealogy file has material on the following families: Battle, Binney, Canon, Chadwick, Clark, Gardiner, Garfield, Gilder, Hale, Heath, Langdon, Lankton, Moore, Myers, Northrup, Palmer, Rouse, Thompson, Tucker, Van Rensselaer, West, and Wilson.

Church records: the Tyringham Baptist Church records 1827-1912; Methodist Episcopal Meetinghouse in Hopbrook records 1825-1826, 1899-1919; Tyringham Federated Church records 1912-1920 and the Ladies Aid Society records of this church 1913-1916; the Cheshire Baptist Church report of 1901; and the History of the First Congregational Church of Monterey 1900.

Town Reports from 1859 to 1977. All Tyringham town histories, namely, Tyringham Old and New (1905); Hinterland Settlement (1963); and Old Tyringham, a Pictorial Record (1979). Histories of a few nearby towns.

Other pertinent Tyringham items: a History File for every year from 1900 on; photo albums, postcards, and picture file; the town census photocopied for the years 1790, 1830, 1850, and microfilm of all federal censuses for the town through 1900; scrapbooks of local activities and Mrs. Lucian Moore's journal from 1841-1901.

Several prominent writers have lived in Tyringham: Jean Webster, who wrote <u>Daddy Long Legs</u> there, Richard Watson Gilder, and Francis Leupp, to name a few. A collection of their books has been started.

Standard genealogical reference books: Massachusetts Soldiers and Sailors; Confederate Soldiers, Sailors, and Marines; Savage's First Settlers of Massachusetts; Berkshire County histories by Beers, Birdsall, WPA Writers Project; Child's Gazateer, the Minister's history, and the Biographical Review. A few unusual ones- Ghosts of Berkshire and Berkshire Hills Historic Month-ly Magazine, 1900-1906. Also five volumes of Records of Massachusetts, 1633-1686 and Plymouth County Records 1633-1692, including laws, acts of the Commisssioners, etc.; Massachusetts histories by Pope, Hale, and Nutting.

Upstairs: <u>Massachusetts Acts and Resolves</u> from 1829 (a few missing) and <u>Massachusetts Public Documents</u> from 1861 to 1910.

Newspapers - the <u>Valley Gleaner</u> from 1857-1870 and a few for early 1900's. Atlases - Berkshire 1870; Massachusetts 1884-88; Boundaries of the Towns of Berkshire County 1915.

Mrs. Clark answers genealogical question by mail if possible. Hours: Monday 3:00 P.M.-5:00 P.M. (If a holiday, Tuesday.)

NEW MARLBOROUGH LIBRARY

Mill River

The town of New Marlborough covers a large area and there are five sections of the town - Mill River, New Marlborough, Hartsville, Clayton, and Southfield. The town library in Mill River is in a fine building near the Town Hall. The very active historical association has headquarters in the Town Hall. Genealogical material exists in each building.

The library has its historical and genealogical books in a small room, reserved for safe keeping. A locked chest holds the following record books: History of the Southfield Congregational Church; Mill River Church Aid 1851-1875; New Marlboro Congregational Church 1870-1910 and the Pastor's Record for that church 1909-1913; Mill River Congregational Church Records 1871-1960 (when it joined the United Church in New Marlboro). Also records of Seymour Library Association of Southfield (now merged with Mill River Library). There is a ledger for a meat business in the 1800s, no name or exact date; a town meeting record for New Marlboro for 1794; town treasurer's book 1847-1850; and another town record book 1794-1860. This chest may soon go over to the Historical Association rooms.

Town histories: New Marlborough Bicentennial History; one by Turner. Histories of Berkshire County by Beers and Adams, Child's Gazateer and an interesting Picturesque Berkshire, published in 1893 (one of a series on counties by Eaton and Chamberlain).

Other standard reference books: Bradford's History of Massachusetts; Massachusetts Soldiers and Sailors (14 volumes); Civil War Soldiers, Sailors, and Marines; Massachusetts Records of War of 1812; Biographical Review 1899; four volumes of New England States 1897; and Historic Markers of Massachusetts Bay Colony, 1930 Terecentenary Edition. Also, Biography of Major General William Francis Bartlett (Civil War hero) and details of the statue by Daniel Chester French and its dedication at the Massachusetts State House.

In the attractive main room of the library is a special

bookcase with bound volumes of the newspaper Berkshire Courier from 1862 to 1888. In the attic are the Acts and Resolves from 1952 to 1980; Journals of the Senate from 1952 to 1958.

Library hours: Winter-Tuesday and Thursday 1:00 - 5:00 P.M., Saturday 9:00 A.M. - 12 Noon. Summer - same hours, plus Tuesday and Thursday 7:00 to 9:00 P.M. Telephone 413-229-6668.

Genealogical material is also available at the Historical Association room in the Town Hall There is an index of those buried in the thirteen cemeteries of New Marlborough; a fine collection of old photographs - families, schools, graduating classes, etc.; a file of New Marlborough families as follows: Adams, Alexanders, Bergmann, Blackmer, Brennan, Brewer, Casson, Conners, Cook, Dodge, Doyle, Freeman, Frost, Gibson, Hart, Hollister, Hudner, Huntley, Joyner, Kair, Keyes (Sen. Loren P.), Moran, Palmer, Pease (Dr. Seth), Rhoades, Rogers (Marcus), Shea, Sheldon, Sisson, Smith, Stanard, Stevens (Ebenezer), Stevens, Turner, Underwood, Ward, Wronkle; town reports from 1872; several family scrapbooks; many fine historical antiques. The room is open by appointment with Mr. John Sisson or the Rev. Mr. Thomas Bigham.

The vital records of the town are available in the same building at the Town Clerk's office. They date from 1734 and have been recently been microfilmed. Office hours are Monday -

HISTORY OF WEST STOCKBRIDGE, MASSACHUSETTS

In place of a long history, I will give here a brief synopsis of my early, more complete history, West Stockbridge, Massachusetts, 1774-1974. The most recent history of this town is included in The Berkshire-Litchfield Legacy, by Willard A. Hanna, published in 1983 by Universities Field Staff International, Hanover, N.H.

Environmental factors played a very important role in the development of our early towns. The Berkshire Barrier begins just west of the Connecticut River and extends twenty miles westward to the valley of the Housatonic River and the Taconic range to the New York line. It is a high, rolling plateau rising abruptly from the Connecticut River valley, dropping down again in northern Berkshire into the valley of the Hoosic River.

This barrier was described as a "hideous howling wilderness" and, because of the terrain, transportation was most difficult so that it was not settled until about a hundred years later than the eastern part of the state. When the settlers finally overcame the difficulties, they found the area beautiful as well as rich in natural resources.

They brought with them the intelligence, the "know how," and the willingness to work hard to develop these natural resources. The terrain in West Stockbridge, which has mountains bordering on the east and west with the Williams River and its tributaries lying between, prompted the early building of dams for milling lumber to build their homes and grist mills to grind their grains for flour. The area became an agricultural and milling community. Later other mills were built: saw mills for sawing the marble found in the area, fulling mills, tanneries, etc.

The destuction of most of the forests began with the making of charcoal for the furnaces in West Stockbridge and Richmond that were used in the smelting of iron mined in those towns. These forests have now regrown, following the demise of those industries.

The town in its early days was a part of Stockbridge, or Indiantown, and was called Queensborough or Qua-pau-kak. Its boundaries were within the six-mile-square town to be settled under the guidance of John Sergeant, Indian missionary, who with four chosen white families, was to make the town a model for the Indians. Owing to political/religious problems, this village separated from its mother-town in 1774, during the same period when our country revolted from its mother-country.

The town was made up of various hamlets: West Stockbridge Center (now West Center), Maple Hill, State Line, Williamsville,

Rockdale, and Freedleyville. The northern and western parts were settled earlier than the present-day village (where Elijah Williams, son of Ephraim Williams, one of the four white families chosen to settle in Stockbridge, built a dam and iron works).

The earliest settler in West Stockbridge Center and the "Gore" area in 1758 was John George Easland (Islein on the Proprietors' map). This is where Kingsmont Camp is now located, an area abutting Austerlitz, New York, on the west. Augustin Bryan (or Bryant) of Caanan, Conn., settled in State Line on the southeastern edge of "King's District" in 1764. The name "Queensborough" was derived from its proximity to that town, thus complementing that name which later became Caanan, N.Y. This area is a natural mountain pass to the Williams River. Easland was soon joined by many other settlers.

Proprietors' meetings were held, including both Indian and white settlers, and the entire town was surveyed with the exception of the Gore. The Gore had already begun to be settled by persons from the New York colonyand the boundary line was in dispute for more than a century, bringing intervention by both King and Congress, until it was finally settled in 1787 and boundary markers were placed in 1797.

A very incomplete roster of early settlers, which may aid some researcher in genealogy is:

State Line area: Increase Hewins and his son, Joseph; Joseph Hull; Joseph Arnold of East Haddam, Conn., and sons Josiah and Asenath; Jonathan Woodruff of Farmington, Conn., and sons Roger, Asaph, and Amasa; Amos Smith of New Marlboro, Mass. Amos Smith's son Obadiah married Asaph Woodruff's daughter, Lucy, and they still have descendants in town. Peter Hull came from Killingsworth, Conn., in 1767, and his son Peter, Jr., married his neighbor Esther Parmelee, and had a family of ten children.

West Center area: Icabod Miller of Litchfield, Conn.; Simeon and Moses Parmelee, who had a grist mill with the Mudges (David, Reuben, Samuel, and possibly Jarvis) in 1773 on the Whitwood Brook where the old stone bridge was built. At this point a road turned east (before the bridge was built) to Maple Hill, where early settler Simeon Gillett from Winterbury, Conn., lived.

Others from the West Center area: Elijah Slosson, a cousin of Ann Lee (founder of the Shakers), and son Eliphalet. Eliphalet married a neighbor, Rebecca Gillett, and both became Shakers. Elisha Coan, who married Joseph Hull's widow; David Skeel of Claverack, N.Y.; John Ford of Farmington, Conn.; Jonathan and Esther Rawson; Matthew Benedict from Ridgefield, Conn.; Theophilus Westover; Caleb Palmer; Lambert Burghardt; Christopher Brazee from Mt. Washington area; Benjamin Culver; Jacob, Lewis, and Alvin Arnold; Isaac McNeil of Litchfield, Conn.; Kileon and John Minkler; Ambrose Collins; Caleb and Elias

Palmer; Jonus Standish and Christopher Parks. These settlers were from the oldest part of town.

On Maple Hill: Benjamin Lewis and son Samuel H. of Farmington, Conn.; Augustus and Festus Drake; Ovid and Naomi Drake; Moses Roots; Johannis and Nicholas Race (or Reese) of Egremont and sons Isaac and Abraham; Simeon Hooker; Benjamin Johnson of Durham, Conn.; Josiah Stevens; Amos Fowler; and John Deming from Canaan, Conn.

With the advent of the railroad, West Stockbridge truly grew by leaps and bounds because of its industries and potential growth factors. The first railroad into Western Massachusetts was the Hudson and Berkshire Railroad, constructed 1836 to 1838, running from Hudson, New York, to State Line. Freighting marble, iron ore, etc., was the stimulus and backbone of the enterprise. Many other railroads soon followed. With their coming, the center of town shifted until most of the business and industrial life and much of the home life settled into the present village. it was the first Western Massachusetts town to become a railroad center.

Dairy farms abounded in the early part of the twentieth century but the trend in more recent years has been to earn a livelihood in other ways and to reside on the old farms. More recently, housing developments have taken over much of the farm land. Changes taking place on the main street of the village have brought the commercial area back to life. Life here is still good and the town perhaps a better place to live.


