THE OTHER SIDE OF SHAYS' REBELLION1

Compiled by R. W. Fischer

Nineteenth century historians have characterized Shays' Rebellion as groups of ruffians, outlaws, and other undesirables bent on overthrowing the new government. While it may be true that ruffians, outlaws, and other undesirables joined up with disillusioned yeoman farmers, it could also have been recorded that these insurgencies were acts of desperation...not unlike the original reasons for the War a decade earlier. The Warning signs began appearing in taverns and inns, then in the town meetings. What more proof could one want after reading the manuscript that follows?

Late summer of 1786 was a crucial time. The transition from 'patriot' status to self-rule had been a disappointment to the many who found themselves losing ground in order to pay for the late war.

Massachusetts created a constitution in 1780 to organize the concepts for self-rule. It became a model for the Federal constitution. The Massachusetts constitution, however was based on the English law, and could not easily be changed. The burden of paying for an ongoing war was taking its toll, and a reputable financial system did not exist.

It was apparent, by 1786, that the carry-over of the old English-style law in Massachusetts constrained personal liberties and prosperity. Debtors were imprisoned unless a friend or relative could pay off the debt. As the decade progressed, the war-debt burden continued. Towns westward from Boston were especially hard pressed to pay their assessments to the commonwealth. People could not sell or trade their assets to pay taxes. There was an extreme shortage of money. They were increasingly in debt, and disenchanted with this new liberty. Groups of farmers and townspeople gathered to address their many grievances. By 1786, the grievances were so widespread that the establishment of coordination conventions took shape.

The main drive was from the outskirts of Boston where available money was more rare. Across the state, towns were documenting their grievances. Representatives were chosen by the towns to attend a convention in Worcester to coordinate their grievances. The convention leaders would present the grievances to the General Court for redress. Worcester became the center for the discontented community leaders to voice their grievances. This act could be considered seditious, but the issues would be carefully presented by the organizers with all due subservience and respectability. Further west, the uproar became more frenzied. Massachusetts was not alone in this plight. A disenchanted farmer named Daniel Shays became the leader of a group of the disillusioned. As the word spread, the number of followers increased. The rest is history.

It was our good fortune to find a copy of the Grievances presented at the Convention in the several hundred manuscripts found during the Dalton Town Records inventory. Unfortunately, this manuscript was misplaced, and did not resurface until after the publication of *THE DALTON PAPERS*. It provides a revealing picture of the attitudes of the many grieved prior to the start of Shays' Revolution. That manuscript is presented here for the first time.

The following manuscript, Inventory #813, follows Inventory #803, "Grievances", dated 31 August 1786, in *The Dalton Papers*.

FOR DALTON/1786 (VIA PITTSFIELD)

Berkshire Ss. To the Select Men of the Town of Dalton ---

Gentlemen - Whereas we have reviewed the petition & doings of the County of Worcester in Convention, hereto subjoined by virtue of a resolve thereof, with a request that we would communicate the same to this County & use our influence that the same may undergo a public inquiry & we willing to answer the expectations of all good Men in the impartial discharge of our duty, without exciting any popular dissentions, or originateing any measures that in the least degree interfere with the Legal administration of the Government of the Commonwealth of Massachusetts, or attempting to exercise any power, but what is clearly authorised by Law & a sense of common danger & distress, which pervades all orders of men & which danger & distress a great majority of the people of the Commonwealth have by public & prevailing opinion declared may be removed so far as to restore peace & union through the intervention & influence of County Associations or Conventions; And we being deeply impressed with a sense of the public calamity & disorder, & anxious to check & if possible remove the same, & to promote union of sentiment & measures in such way as to calculate (and) to meet the approbation of the public - do without further apology request you to communicate the Worcester Petition & doings to the Inhabitants of your town, for their consideration, to act thereon as they think prudent & expedient - and to appoint (if thought proper) one or more persons of ability to meet at the Meeting-house in Pittsfield on Monday the ninth day of November next at one o'clock afternoon, to consider the doings of said Worcester Convention - to investigate the causes of the present Public discontent, & opposition to Government, & lay them before the General Court by Petition & (remonstrance) if thought proper-

Pittsfield Oct. 10th 1786--- Daniel Hubbard > Committee of Thomas Gold > Pittsfield---

To the Honble Senate & honble House of Representatives in General Court assembled—The Petition of the Convention of the County of Worcester consisting of Delegates from forty one towns—Humbly Sheweth—That your Petitioners being chosen Delegates from the several towns to meet in Convention to collect the sentiments of the good people of this County respecting their present Greivances: and to petition the General Court for redress. After mature deliberations and by the collective sense of the county that the inhabitants wish relief from the Greivances published by the last meeting of this Convention, viz,

Art. 1st That the sitting of the General Court in the town of Boston; in transacting the business of an infant Nation embarrassed with debts, it is highly incumbent to study occonomy & dispatch; for which great purposes the town of Boston, for reasons which may be obvious to the Honble Court is by no means adapted--

Art. 2d The want of a circulating medium subjects the Inhabitants to the greatest inconveniences -- The people in general extremely embarrassed with public & private debts -- No money can be obtained either by Sale of Mortgage of real Estate -- The produce of the present year & the number of our cattle, were we even to sell tho while are totally inadequate to the present demand for money -- such has been our situation for sometime past -- an amazing flood of Law (wants) has taken place -- many industrious Members of Society have been confined in Gaol (jail); many more are exposed to the same Calamity in a word -- without relief we have nothing before us but distress & ruin. In this deplorable condition your Petitioners humbly seek for protection & redress from the wisdom of your Honour's & pray that a portable representation of Property may be contrived for the relief of the People -- and that such prudent Laws may be framed as shall have a tendency to wire at the evil arising from the present scarcity of money & to induce the man of wealth to deposit his property in the Lands and produce of this Country rather than speculations in Public Securities, or in any Commercial Line & that our Bretheren in Boston & other maratime towns, may be induced by premiums & encouragements to the manufacturers of our own Country, instead of importing goods from foreign Countries ---

- Art. 3d The existance of the Court of Common Pleas & Court of General Sessions, in the present mode of their Administration, has given general dissatisfaction -- These Courts are an amazing expence to the people, & in our opinion without the least conceivable advantage -- not more than one action in forty brought to our lower Courts is ever designed for Trial, & Those causes which are disputable little dependance is placed upon their decission -- the feelings of the people deeply wounded when they see the Officers of these Courts living in the elegance of the Eastern magnificance; when at the same time they reflect that the money was extracted from their distress.
- Art. 4th It is with indignation that the good people of this Country have seen more money lavished upon one officer of Government, who has rendered himself disagreeable to the people in general, than can be obtained by a whole Life of industrious Labor, and the fees of whose office we conceive to be fully adequate to his services. ----
- Art. 5th Your Petitioners are of opinion that the appropriation of Revenues arising from the Import & Excise to the payment of interest on State Securities is a Greivance, as we have no other resource for the obtaining money, adequate to the payment of Interest on the Foreign Debt.
- Art. 6th Your Petitioners conceive that in the present distress + poverty of the people, that the utmost prudence & occonomy should be introduced into all the branches of Government, And further that the servants of Government are too numerous & their Salaries are too high. And we cannot but think but that the example of the adjacent Sister States is worthy of our imitation in this aspect—
- Art. 7th The present Practice of Law & the enorbitance of the Fee-table are universily complained of by the good people of this Country & are apprehend not without good reason-- And we think that your Honour's will be of the same opinion if you turn your attention to the records of the Clerk's office, the Rules of the Bar, the influence and Increasing wealth of the Partitioners --
- Art. 8th We further pray that the Hon^{ble} Court will use their earnest endeavors that account between this Commonwealth & the Continent may be speedily settled, as we apprehend we have been disproportionably burdened--and we conceive it a peculiar hardship that we have no relief from the expences of the Penobscot Expedition-- We also pray that the Hon^{ble} Court will pay attention to the situation of the holders of Continental money which lies dead on our hand + without interest, while we are taxed to pay the annual interest of the Securities, the holders of which Securities are exempted from the payment of any taxes thereon, & we conceive that the granting the Supplimentary fund is inconsistent with the Republican Principles & very grievous to the people--
- Art. 9th We pray the Honble Court that the time of the payment of the first moiety of the present Tax may be prolonged--
- Art. 10th We further pray that the Probate Courts may lie so regulated as to be more expeditious & specific in their operations, & less burdensome to the subject, as in the present mode many small estates are nearly swallowed up by the expense of time & traveling, attendance--
- Art. 11th The present mode of Registering Deeds is thought inconvenient as we conceive it may be done with a small part of the expence in our respective towns--
- Art. 12th And whereas there are many actions commenced by the Absentees against good people of this Commonwealth and no doubt by the policy of our once subtile Enemy & we conceive that the Creditor has too great advantage of the debtor by reason of the great scarcity

PITTSFIELD WARNINGS OUT

From Pittsfield Records, via the Edward R. Knurow Collection, in the Berkshire Athenaeum.

At Pittsfield - General Sessions of Peace, March 2, 1762, Warning Out. Robert Noble & Lidia his wife, Elizabeth Noble, Benjamin Noble & Francis Noble, children of the sd Robert, also Jacob Newcomb & Elizabeth his wife & their children, viz., Bethel, Unice, Lois & Sarah, Also William M'Elroy & Mary his wife - also Joshua Owen & Hannah his wife & their children, viz., Ruth, Margaret & Hannah. Also Hannah Wattson, the wife of Robert Watson, Junr. & all her children, viz., Robert, James, Judith & Mehitabel each and every one of them have been warned to depart & leave the Town of Great Barrington by Thomas Pier, Jr., Constable of the sd Town - as by Warrant

To The Constables of the Town of Pittsfield in the County of Berkshire, or either of them, greeting.

Whereas it has been represented to us that Elisha Eggleston, his wife & family; John French, his wife & family; Calvin Dunham, his wife & family, are likely to become burdensome & chargeable to the town if they continue their residence in it, these are therefore to authorize & require you to forthwith to warn & notify the above-named persons that they, with their families, immediately depart & remove out of the town, & not to return again without giving security to the town.

Given under our hands this 22nd day of May A.D. 1782, Woodbridge Little, David Bush, Stephen Crofoot, James Dn. Colt, Selectmen of Pittsfield

To the Constable of the Town of Pittsfield.

It being reported to us that Nathan Philips, Timothy Thompson & Ichabod Ellithorpe with their Families have lately moved into the Town, & that there is danger that they may become burdensome & expensive to the Town - You are therefore hereby required upon Receipt of this to Notify & warn the said Philips, Thompson & Ellithorpe that they, with their Families, are directed Forthwith to depart from this Town, under the pain & penalties of the Law in such cases made & provided - and this shall be your Warrant therefor, & of your Proceedings herein you are to make Return to some one of us as soon as may be - Given under our Hands at Pittsfield this first Day of April A.D. 1781.

Woodbridge Little, Samuel D. Colt, Mathew Barber, Stephen Crofoot, Selectmen

Agreeable to the within Warrant I have warned the within named Persons to depart this Town within 14 Days from this Date, Pittsfield April 2, 1782. Stephen Fowler, Constable

of money, therefore we pray your attention to every means proposed for the relief of Debtors as far as is consistent with the Treaty of Peace & National Faith.--

Art. 13th And your Petitioners earnestly pray the Honble Court as soon as may be (possible) issue (forthwith?) to the Select-Men of the several towns & the Assessors of unincorporated Plantations directing them to convene the qualified Voters (in) their respective Towns & Plantations for the purpose of collecting their sentiments on the necessity or expediancy of revising the Constitution & if it shall appear by the returns that two thirds + if the qualifyed (voters) throughout the State who shall assemble & vote in consequence of such precept are in favour of such revision & amendment the General Court is hereby solicited to issue precepts or direct them to be issued from the Secretaries Office to the several towns to elect Delegates to meet in Convention for the purpose aforesaid--and we pray that your Honours will pay perticular attention to the above greivances & that they may speedily be redressed---and your Petitioners as in Duty bound will ever pray---

In Convention of the County of Worcester begun & held by adjournment this 26th of Sept & continued to the 20th. Forty one towns being present. Deacon Hall in the Chair. Voted to choose a Committee of nine to correspond with other Counties in Convention & inform them of the doings of this convention in order to produce a Union & to agree to send our Petitions by Counties (unreadable) together as may be-- Chose Doctr Sam Willard of Uxbridge, Col. Luke Drury of Grafton, Att. Jacob Welch of Lunenberg, Mr. Josiah Putnam, Western Doctr James Freeland Sutton, Maj Martin Kingsley Harwich, Mr Hezekiah(?) Chapman Uxbridge Doctr Jnº Barnard of Sterling, Capt. David Bigelow, Worcester--a Committee chosen for the above purpose -- Voted - that the Committee be directed to meet in three weeks from this present Thursday the 20th Septr - to consult & advise with any other Committees that shall join with them -- To meet at Mr. Patches in Worcester - A true copy from minutes of Convention -Jacob Welch Clerk -- In Committee - Voted that Majr Martin Kingsley be desired in behalf of the Committee to go to the Counties of Hampshire & Berkshire for the aforementioned purpose-- That Doctr Freeland communicate with the Counties in the Provence of Main, for the above purpose - That Mr. Welch communicate with the Counties of Middlesex & Essex - That Mr. Chapman with Suffolk - Bristol & c.

A CUMULATIVE CENSUS OF PERU, MASSACHUSETTS, 1790-1920

UNDERSTANDING THE CENSUS

The index books made to help the research of federal census records easier have eleven pages devoted to explaining why there are so many mistakes found on census sheets. The following are listed as possible causes:

- 1. How well educated was the enumerator? Penmanship, etc.
- Spelling by sound.
- 3. Multiple lettering.
- 4. Reduction of letters.
- 5. Vowel interchanging.
- Misformed letters or look alike letters.
- 7. Listing of ethnic names.
- 8. Nicknames and abbreviated names variations.
- 9. Voluntary and involuntary information from the resident.
- 10. Americanizing and aliasing of names.
- 11. The small "F" and "S" bloopers. (Jesse-Jefse, etc.)
- 12. Missing a letter or letters.
- 13. Resident not home. Neighbors answered questions.

Census lists of the years 1790 thru 1840 give the name of only the head of each family listed by the Census Enumerator. The above years also lists by number the males and females who reside with the family head in that house. Census years 1850 thru 1870 list all individuals in each home by name, age and sex but not their relationship to each other. Years 1880 thru 1920 add relationship and other things which could be useful to the researcher. There is a sheet with each census year showing what information was asked by the Census Enumerator. This sheet can be found by checking the Census itself at any Federal Archives. Space did not allow it to be done here.

Names in each ten year Census 1790 thru 1920 are listed alphabetically by last name, first name, line number and page number. Also for the years 1850 thru 1920 the residents of each household are listed in the same order as shown on the Census take4n by the Census Enumerator; page, line, first name, last name, age, and place of birth. Each house listed will begin with [I] first name last name. From that name to the next [1] are the only residents of that house. The first name which has the [1] in front of it is listed as the head of that house.

The years 1870 and 1910 were the most difficult to interpret. When the name could not be read on any of the census sheets the line number will still appear on the index sheets with a question mark and possible the first or last name and gender of the individual. Every possible Town record was used to check names that were difficult to read; Assessor', s Birth, Death, Cemetery and Vital records. Pleas note that as was written in the first part of this introductory that the spelling was copied as written unless it was so far out that it seemed best to help the poor dead and departed Enumerator write what he should have in the first place.

Charlestown Land Records, by the Record Commissioners of the City of Boston. Facsimile 1999 reprint, soft bound, $5\frac{1}{4} \times 8\frac{1}{4}$, 262pp, index of land owners, persons, places and key landmarks. Price \$23.50 plus \$4.00 S/H. Order from Heritage Books, Inc., 1540-E Pointer Ridge Place, Bowie, MD 20716.

These records, originating as early as 1638, were deteriorating to the extent that a commission was appointed in 1377 transcribe and publish them.

Charlestown at one time was comprised of part of, or the whole town, of Burlington, Cambridge, Malden, Medford, Reading, Somerville, Stoneham, West Cambridge and Woburn.

On January 26, 1638 Abraham Palmer was chosen to record all properties of houses, lands, meadow and pastures in the possession of any of the inhabitants of the town. A fine was exacted from those who did not provide him with the required information. There are very detailed descriptions of around 300 holdings and involving 119 individuals listed in a name index. Most of the entries are prefaced with the statement that any of the stated area measurements are estimates and not the result of a precise survey. The various holdings are described in detail. There are a number of street layouts in which the route is specified by naming the individuals along the way. Some of the terminology is interesting. One was allotted "Haulf a milch cow common."

The text covers the beginnings of the Quaker movement in England in the mid 1600's with George Fox as the founder, missionaries coming to America around 1656. The movement was not well received in Massachusetts, soon becoming the repeated target of legislation.

The final ninety odd pages of the book are devoted to supporting evidence of the extremely cruel and inhumane treatment the Quakers received. This includes vitriolic wording of the legislative acts pertaining to the Quakers and the resulting punishment accorded violators of the several statutes. The appendices leave little doubt that this was a very intolerant time in our history.

A difference regarding baptism caused the formation of two factions in the Congregational churches of Hartford and Wethersfield. The dissenters engaged John Pynchon to secure land from the Indians to accommodate the formation of a new town, Hadley, in 1659. The Indian wars of the time are detailed with the inclusion of Hadley.

Much of the book is devoted to the development of the church in Hadley and the people contributing to its growth. One chapter is devoted to the development of the school system, and the final chapter describes the countryside, its charm and wealth of resources.

In the series of Boston records this is the Thirtieth Report and it contains the recorded marriages in Boston from 1752 to, and including, those of 1809. First to be covered are the marriage intentions 1752 through 1761, grouped by year and giving names of both parties. The record of marriages 1762-1809 gives the full name of both parties, the name of the officiating clergyman and the date of the marriage. Listed also are marriages from Brattle Street Church (1752-1802), Hollis Street Church (1792-1807), Rev. Samuel Stillman (1761-1787), Kings Chapel (1752-1776), New North Church (1762-1797), New South Church (1752-1809), Second Baptist Church (1775-1787), Trinity Church (1752-1807) and West Church (1752-1809).

The book is presented as a work in two parts. In the first part the author assumes the role of a traveler moving about the town, meeting various people of historical interest and observing the activities of the period. There are descriptions of the customs, the activities of the day and visits with numerous historical figures who contributed to the development of Concord and the colony in general from 1635-1692. Many historical incidents, such as the Indian wars, are described in detail. The material is both fact and fiction but is presented in a manner permitting easy determination as to which is which.

The second part of the work covers the settlement of the town and its history from 1654-1692. The Indian wars are treated in detail with information as to the structure and membership of the military organizations involved in the conflict.

SOME INTERESTING PITTSFIELD PROHIBITIONS

Sept. 5, 1791 It was voted, the following by-law for the preservation of the windows in the new Meeting House, viz.,

Be it ordained by the said Inhabitants, that no person, an Inhabitant of said Town shall be permitted to play at any game called wicket, cricket, base ball, bat ball, foot ball, cat, fives or any game or games with Ball within the distance of 80 yards from said Meeting House - and every such person who shall play at any of the said games with ball within the distance aforesaid shall for every instance thereof, forfeit the sum of 5 shillings to be recovered by action of debt brought before any Justice of the peace to the use of the person who shall sue and prosecute thereof. And be it further Ordained that in every Instance where any Minor shall be guilty of a breach of this law, his parent, master, mistress or guardian shall forfeit the like sum to be recovered in manner & to the use aforesaid.

August 24, 1778 It was voted, That as the practice of Horse Racing is attended with many Evil Consequences & is productive of much Mischief & is totally contrary to the sense and Approbation of this Town and that all Persons who hereafter shall encourage, abet or promote such Evil practice shall not only be held in Contempt in this Town but have their Names published as persons Counteracting and opposing the desire of the Honorable The Continental Congress.

SOME SUGGESTIONS FOR WRITING QUERIES

- 1. Give the full name, including middle name or initial, of the person subject to enquiry.
- 2. Establish identity of the person by giving place and date of birth, place and date of death, parentage, place and date of marriage and identity of spouse to the extent these data are known, as:

John DOE b Hartford, CT 12 Jan 1900; d Fairfield, CT 19 Mar 1967 s/o Richard & Abigail (WESTON) DOE m Hartford 11 June 1923.

- 3. If unable to give a complete description of the person under enquiry, start with a son or daughter for whom more information might be available and ask for that person's ancestry.
- 4. Identify spouse in manner described in (2) above.
- 5. State what information is desired, as:
 Need ancestors of John and Abigail.
- 6. Place the question at the end of the query.
- 7. Do not abbreviate the names of persons or towns.
- 8. For any locale outside Massachusetts, be sure to identify the state.
- 9. Dates should be written: day, month, year as: 13 Oct 1743.
- 10. Use multiple queries rather than several parts to the same query.
- 11. Queries should not exceed four or five lines and should be submitted as an ASCII file on a diskette or E-mailed to bfha@berkshire.net marked as a query on the subject line. Printed or typed queries will also continue to be accepted.
- 12. Well-known abbreviations may be used but elaborate use of them is not required.
- 13. Address for reply should be stated on each card so that the Editor is not obliged to keep their envelope as well in order to have a complete record.
- 14. Acknowledge receipt of all replies and reimburse respondent for postage and the cost of any material copied. One should not be left out of pocket for having answered a call for help. If the submitted material is of little use, that is the risk assumed in transactions by correspondence.
- 15. When requesting information, always include a SASE.
- 16. Help your query editor judge the effectiveness of this section. If you make a contact that provides significant help with your search, won't you let us know?
