## Tips and Experiences

STERLING SILVER TEASPOON

Flora Dutton Jaquish

A lovely sterling silver teaspoon helped me dig out another bonanza in the Daughters of the American Revolution Library in Washington, D.C. this summer. While attending the three-week Genealogical Institute at the National Archives, it was my privilege to spend several days in this exceptionally fine DAR Library.

On research trips, I try to concentrate each time on one line of ancestors. This trip was to be for the Dutton surname lineage. The DAR Library has a surname file. I made out call slips for every book listed in the Dutton surname file. I managed to copy most of them and had many sheets to bring back to Saginaw for further study. I noted a "Doty-Doten Family in America" book by Ethan Allen Doty in a locked cabinet there. It reminded me that according to the first bonanza I found in Boston, John Huntley of Lyme, Connecticut book by Iva Huntley Horn, that my great-grandmother Delia Briggs Huntley's parents were Isaac Huntley and Sarah Ann Doty.

Delia Dutton had given a silver teaspoon to her grandson (my uncle), Orly Huntley Dutton for a keepsake. The spoon traveled from Richfield, Otsego County, New York, with the Duttons when they migrated to Wisconsin in 1850. O. H., as my uncle preferred to be called, gave me the spoon when I visited him and Aunt Jeanne at Buckeye Lake, Ohio, where they had a deluxe antique shop called "The Duttons". Customers came by appointment to see their collection of antiques. O. H. knew the value of the teaspoon when he presented it to me, saying, "You, Flora, remind me of her so much that I want

you to have this spoon with her Huntley maiden name engraved on the handle, to remember me by." He went on to tell me about her, thus revealing his deep affection for her. He thought of her as a very special woman. With pride I added this spoon to my collection of souvenir spoons, little knowing that one day I would be so interested in Delia Briggs (Huntley) Dutton because of the enthusiasm in genealogy that is more fun because of Delia's lovely spoon.

In Book I, Issue 2 of "Timbertown Log", is the story of the Dutton Family Migration. While attending a seminar at the New England Historical and Genealogical Society in Boston, two of the speakers kept saying, "Don't forget your supplementary families. You frequently find clues in the research for them to add to your major family histories." Dr. Gilbert Doane and John I. Coddington re the kind of speakers you remember, and you follow their suggestions. Remembering the Huntley silver teaspoon, I looked for and found my grandfather, George Ellsworth Dutton, as Delia's son, right back to the progenitor of the family, John Huntley. I found, too, some of the family history in England and Scotland back to 1498. At fifty cents a sheet I xeroxed the pages that were her direct line. After I came home, I found I missed one generation and frequently wanted to know more about other members of the family. On another research trip I found the book in Newberry Library in Chicago. There I had a microfilm of the book made so that I could study it any time on my micro reader at home.

Early in the search for the Duttons on a trip to Galesville, Trempealeau County, Wisconsin, I searched the newspaper files of the Galesville Republican Newspaper and found the obituaries of my great grandparents, Rev. John Dutton and Delia (Huntley) Dutton. Then I went to Evergreen cemetery near Centerville, a few miles out of Galesville. I took rubbings from their gravestones and found that my great-great-grandmother, Betsy, wife of Samuel Dutton, was buried next to her son, Rev. John Dutton, so I copied her stone. I did not find where Samuel died or was buried but do suspect that it was in New York state and that John brought his mother to Galesville to live with them until she died. Later I found the Trempealeau County History in the Wisconsin State Historical Society Library in Madison. It gave a good biography of Isaac Arthur Dutton, a brother of my grandfather George Ellsworth Dutton, son of John and Delia Dutton.

Delia's lineage in the Huntley book established the fact that her parents were Isaac Huntley (497) and Sarah Ann Doty. Delia's #1186 in the Huntley book and in the Doty book, she is #683. Her parents were William Doty #187

and Mercy Doty #60 in the Doty-Doten book and her parents were cousins.

After finding these books, the real work of proving that the information in the books is accurage began. The most acceptable proof for any patriotic organization is vital records, census records. County histories and books of family history are frequently inaccurate. Proof of authenticity is demanded by patriotic societies and this same care I will use before publishing any findings on my ancestors and their descendants. When I find bonanzas like this, my next step is to try to prove the data in three ways, either by newspaper extracts, census records, vital records, land records or wills.

National Archives in Washington has microfilms of all censuses that are available. The Trempealeau County History book stated that Delia Huntley and John Dutton were married in Utica, Oneida County, N.Y. in May 1846. The Huntley book said they were married in Richfield, Otsego County, N.Y. but gave no date. In my search of all Oneida County census microfilms at the Archives, I found none of the Dutton or Huntley families. The Richfield, Otsego County, N.Y. film listed the Isaac Huntley family in the 1850 census, but did not list Delia as part of that family, for she had married in 1846/6. So far my search gives no clue to where the Duttons resided in New York. This means I must continue searching microfilms, county histories, newspaper extracts, vital records, land records, etc. until proof is found that Delia was the daughter of Sarah Ann Doty, the wife of John Dutton and the mother of George Ellsworth Dutton, to the satisfaction of The Mayflower Society.

My files contain the birth, marriage and death certificates to prove each family up to Delia and John Dutton. Death certificates recently received from the State of Wisconsin show John died 5 March 1907 and Delia died 4 April 1911. John Dutton's certificate simply states his parents were Samuel Dutton and Betsy Dutton. Delia's death certificate gives the full names of both parents which establishes proof by vital records that she is the daughter of Sarah Ann Doty and a descendant of Edward Doty, An Emigrant by the Mayflower, 1620. With other proofs the lineage goes directly from Edward Doty through to the thirteenth generation who are my grandchildren, as follows:

First generation, Edward DOTY (1) m. Faith CLARKE in Plymouth, Mass., 6 January 1645/6.

Second generation, Edward DOTY (2) m. Sarah FAUNCE in Plymouth, Mass., 25 February 1662/3.

Third generation, Captain Samuel DOTY (19) m. Anne BUCKINGHAM,

in Saybrook, Conn., 3 December 1706.

Fourth generation, Samuel DOTY (45) m. Margeria PARKER in Saybrook, Conn., 3 April 1733.

Fifth generation, Samuel DOTY (110) m. his cousin Mercy DOTY (60) in Saybrook, Conn., early in 1758. Mercy's parents were Benjamin DOTY (21) and Hester BEMAN (sometimes spelled BEAMOND).

Sixth generation, William DOTY (187) m. Sarah ROSEKRANS in Albany County, N.Y., 3 June 1795. Identical information in both Huntley and Doty books state they were the parents of Delia.

Seventh generation, Isaac HUNTLEY (497) m. Sarah Ann DOTY (347) in Stephentown, N.Y., 22 October 1826 and they resided in Richfield, Otsego County, N.Y.

Eighth generation, Rev. John DUTTON, m. Delia Briggs HUNTLEY (1186) in Huntley book and (683) in Doty book, in Richfield, Otsego County, N.Y., 15 May 1846.

Ninth generation, George Ellsworth DUTTON, Sr., m. Jennie Avis BAR-NETT, in Galesville, Trempealeau County, Wisc., 9 July 1885.

Tenth generation, George Ellsworth DUTTON, Jr., m. Martha Eliza BEL-LINGER in Charlevoix, Charlevoix County, Mich. 19 December 1906.

Eleventh generation, Paul Edward JAQUISH, m. Flora Avis DUTTON, in Saginaw, Saginaw County, Mich., 19 December 1928.

Twelfth generation, Paul Edward JAQUISH, Jr., m. Ellen Agnes WEISS, in Frankenmuth, Saginaw County, Mich. 16 May 1953.

Thirteenth generation, Paul Edward JAQUISH, III, b. 7 January 1954, d. 30 July 1968 at Palos Verdes Estates, Calif.; Gail Ann JAQUISH, b. 12 March 1955; and Marshall Kent JAQUISH, b. 15 April 1956, were all born in Saginaw, Saginaw County, Mich., and are now residing in Orinda, California.

The lovely sterling silver teaspoon led me into two big bonanzas, which gave me confidence that my genealogical research and findings will bring verification and eligibility of membership of The Mayflower Society and Daughters of the American Revolution.

In the Portrait and Biographical Record of Saginaw and Bay Counties, published 1892, William Harrison Warner is described as one of the early pioneers of Saginaw who had undaunted courage and great vision for the development of East Saginaw.

Mr. Warner was born in Enfield, Conn. Attained his apprenticeship at the trade of carpenter and joiner in Springfield, Mass. After a brief time in Mt. Clemens, Michigan, he moved to Saginaw in 1854. In partnership with Mr. L. H. Eastman, Mr. Warner established a foundry and machine shop, the first of its kind in the entire Saginaw Valley. This association continued for twenty-five years after which the business was sold to A. F. Bartlett & Co.

Mr. Warner was twice married. His first wife was Miss Clarissa Davis Barrett of Hinsdale, N.H. She died in 1863 and in 1865 he married Miss Eliza Eldred, a native of Erie Co., N.Y.

Mr. Warner was among the Republican ranks. He was one of the original stockholders in the organization of the First National Bank and for several years was vice-president.

Mr. Warner's nature was deeply spiritual and in 1857, Mr. and Mrs. Warner were among the group of interested persons who met to take under consideration the organization of a church. At this meeting the vote was in favor of forming a church which should be called, "The First Congregational Church" of East Saginaw. On Oct. 31, 1857 Mr. Warner was chosen as one of the Deacons of the Church.

In the Historical Memoranda of the Church and Society, published in 1873, Mr. and Mrs. William Harrison Warner were given the honor of being listed as No. 1 and No. 2 members.

The first record we have of the SPENCER family, pertains to three brothers -- Christopher, David and John.

CHRISTOPHER SPENCER was a gentleman living at East Orcherd Castle, a fine mansion in the parish of St. Athens, Glamorganshire, South Wales. He married Mary, daughter of Nicholas Evans, Esq., of St. Athens.

DAVID SPENCER, of whom it is only known that he died in the East Indies.

JOHN SPENCER, brother of Christopher and David, resided at Searer, a farm about two miles from St. Athens, on the Cowbridge Road. Although now destroyed, its site is indicated on the ordinance map.

St. Athens is a pretty village, situated in the most southerly part of the vale of Glamorgan, just two miles from the Bristol Channel. The mountainous part of the country with its extensive coal and iron mining, being about twelve miles distant. The district is purely agricultural, abounding with capital farms and good residencies, also numerous castles of former Barons and petty princes, who in olden times were often at war with each other. At least, half a dozen such being within as many miles of St. Athens.

This article pertains to the descendants of John Spencer mentioned above.

JOHN SPENCER married Martha, daughter of Mr. Roberts, gentleman of St. Athens; she was b. 1726; d. 21 Dec 1778. A tablet to her memory is in St. Athens Church. John Spencer married three times and had a numerous family.





## Michigan Genealogical Conference

Michigan State Genealogical Council drew approximately 150 delegates for its first all-state conference September 6 at Kellogg Center, East Lansing.

Under the direction of Richard J. Hathaway, Michigan Department of Education State Library Services, the all-day conference was planned and ably hosted by the Mid-Michigan Society of Lansing.

A get-acquainted coffee hour began the day. At 10 a.m. Lenard S. Zorn, Michigan Council President, welcomed the overflow audience. Mr. Zorn explained that the Council was composed of two delegates from each of the 12 genealogical societies in the state. The Council meets three times a year, in October, January and April, to coordinate the work of local researchers, to get acquainted and exchange ideas and to assist with finding, compiling and preserving unpublished materials from materials throughout the state.

Keynote speaker, Dr. Willard Heiss, Genealogical Columnist for the Tri-State Trader and National Authority on Genealogical Research and Church Records, rapidly and deftly detailed the development, location and value of church records. Delegates were sent a list of sources by mail.

Luncheon in Kellogg Center with Director Hathaway as Master of Ceremonies was delicious and beautifully served. Mr. Howard Lancor, Executive Director of the Michigan Commission on the Bi-Centennial, outlined Michigan's plans to date. Michigan's emphasis in the national observance will be transportation.

Opening the afternoon session, Early Detroit Church history was presented by Mrs. Alice Dalligan, assistant chief of Burton Historical Collections of the Detroit Library.

Following Mrs. Dalligan, a panel discussed "The Location of Church Records in Michigan". On the panel were representatives of the Michigan Historical Collection at Holland, Michigan, and the Church of Jesus Christ of the Latter Day Saints in East Lansing.

All during the day, in an exhibit room, the various societies displayed their projects, publications, results of research methodists and supplies for researchers. Mrs. Margaret Wilgus and Mrs. H. E. Kapphahn of the Mid-Michigan Society were in charge of exhibits.

## Programs In Review

In order to keep the membership informed of all programs presented and the general content of these programs, this review is presented.

May 14, 1973, Lenard S. Zorn presented a program designed to prepare the membership for "reading" the Bridgeport Cemetery Saturday, May 19. The memorials in a cemetery contain much information of genealogical value and the recording of this information will be of inestimable value to genealogists now and in the future. The data found in the cemetery will be made available to Bridgeport Township as well as copies for the library and the membership through Timbertown Log.

President, Mrs. Flora Jaquish, read the purpose of the Society from the Constitution and explained the advantages of incorporation as a non-profit organization. She noted that efforts toward incorporation had begun.

A show of hands regarding the destination of the next trip indicated the membership desired to visit Burton Historical Library in Detroit.

Wayne Seltzer, chairman of the Michigan Genealogical Council, announced that a seminar would be sponsored September 6 at Kellogg Center in East Lansing. The topic will be Michigan Church Records, with Willard Heiss as the speaker.

A gift of three hundred dollars from Mrs. Elsie Lent, a former Saginawian, was presented at the June 11 meeting to encourage the publication of Timbertown Log.

Bernard Forster, chairman of special events, reminded the membership of the upcoming seminar at Kellogg Center in East Lansing on Thursday, September 6, and offered to assist anyone in need of transportation.

Leland R. Watrous, chairman of the committee on Constitution and By-Law changes, read the proposed changes in the constitution and stated that these changes would be voted upon at the annual meeting of September 10,1973.

Mrs. Flora Jaquish reported that the incorporation papers had been approved and received by her and that they would be placed in a safe deposit box. The necessary paper work to achieve non-profit status had been initiated, but that it was difficult to know when approval would be forthcoming.

Mrs. Ruth Fisk Zorn, the speaker of the evening, gave her impression and experience in the National Library of the DAR Society in Washington. Mrs. Zorn emphasized the need to "Do your homework first", before arrival at any library to achieve the maximum in the allotted amount of time. The DAR library was

established in 1896 for verifying data on applications to the Society and has grown from 126 volumes to one of the finest genealogical libraries in the United States. It is open to the public, for a small fee, except during the month of April when it is reserved for members. It is entirely a reference library and no books may be rented, borrowed or sold.

At the second annual meeting of the Saginaw Genealogical Society September 10, 1973, annual reports were read by officers and committee chairmen. The nominating committee presented the ballots and the membership elected the following officers: Bernard F. Forster, president; Mrs. Douglas E. Peabody, vice-president; Mrs. John J. Haigh, recording secretary; Leland R. Watrous, corresponding secretary; Mrs. Rex J. Napora, treasurer; Mrs. William Terzia, historian. An amendment to our constitution having been approved at this meeting, nominations for the positions of directors were made. The membership elected the following directors: Mrs. R. W. Kempton, three year term; Mrs. Lenard S. Zorn, two year; Cloyce Dean, one year.

Following the installation of officers and directors by Miss Mattie G. Crump, program chairman Lenard Zorn introduced Martin McLaughlin of the Michigan State Archives. Director McLaughlin detailed the purposes and problems of the Archives. He concluded his presentation with a question and answer period.

The newly-installed president, Bernard F. Forster, thanked the Society for their confidence shown in electing him and recognized the past officers for their success in establishing the Society. As Mr. Forster's first official duty of the new year, the chair brought the meeting to adjournment.
