

A HOBBY WITH CULTURE

This phrase can well describe our Genealogical hobby as well as the Genealogy Societies. Those of us who are interested are of a wholesome and caring nature. The roots of genealogy go back as far as records and traditions were ever reported - i.e. printing on the walls of tombs. Gathering of this informative data gives a satisfaction in the knowledge that we are part of the human race and as such are responsible for the history and culture We are a people interested in history and traditions qiven us. and this interest is growing and expanding markedly. Education has become big business. Museums are becoming larger and special libraries are more numerous. We believe in the sharing of this knowledge and are constantly providing aid and incentive through printing of history and statistics and the gathering of sources and the presenting of oral programs.

One of the many programs evolving from this interest is the Seminar's given by the genealogical societies. Our own CCGS gives a seminar each year and if you have not attended one, you have missed an enjoyable day. The visitation of many like interested people at these sessions is great. Humor is evident, and the knowledge gained leaves one feeling that a day has been well spent. Not unlike taking a trip to that area spoken of by the speaker. Hearing of the complaisant attitude for these programs leads one to wonder how a program such as these could be thought of as mediocre. Much time and effort of the society is spent to provide this information and incentiveness and is attended by many people. Some even coming from other States.

Webster says a Seminar is "a group of students persuing an advanced course of study in a college or with a special teacher". Was it our colleges which first had the inspiration for such programs? We have been customized with the idea that if needing more training or education on a subject we should take a course at a college, forgetting that our hobby can be augmented by the education from our own CCGS seminars. Attending a seminar with an attitude of learning, is exhilerating and encouraging and might lead to answering a particular problem of ones family history. After a hard and tiresome winter this amounts to the recharging of the spirit, mind and genealogy.

The speaker will be one who has spent a comparable lifetime of study on the subjects and area's of which he or she is speaking. He has practically lived in the environment, so can give more correct and newness of information than we can obtain from books. Many speakers use this opportunity to sell his own books thus giving us a chance to build our own libraries. Also the CCGS and other societies sometimes have their books on sale at the seminar.

History is the main topic of these courses. This is the one subject of which we can never get enough information. It is the backbone of our own family history. The culture, dreams, habitations, nationalities making standard lifestyle's which influenced that ancestor. The more we know about traditions the more fascinating the present. The more we glean from the sources of history of the times and culture of the ancestor, a more understanding reproduction of that ancestor we will apprehend. We as a reproduction artist, become a keeper of tradition.

It becomes more important to gather all information, sources, history, or what-ever it may be, as it is these traditions that keep a group together. Traditions serve a purpose in life and a purpose of continuity of which we gain a perspective on our present. The traditions of farms, families, education, inventions and religions is part of the genealogical fascination that adds to our genesis of life and should be kept and cared for.

HARRY BLACKSTONE WOUNDED IN FRANCE

Letters from Harry Blackstone who was wounded in France, to his mother, Mrs. Annie Blackstone, and sister, Mrs. Jessie Dean.

Aug. 29, 1919

Dear Mother: --

Sometime ago I wrote you a nice long letter before we left our town to move to the front, but before I could get it censored, and mailed we were on our way and I find that the mail service is not very good at the front so as a result the letter is in my coat pocket, in the trenches. I am writing this letter in the hospital. I received two small shrapnel wounds . The nurses are taking such good care of me here that it will only be a little while, I think, until I will be walking again. It certainly seems queer to me to be off duty and lying in a nice bed with real whte bed clothes, where they haul me around in a chair and carry my food to me. It really is so "soft" I guess I will just stay with them. One of my wounds is in my right leg, the other is my chin. I suppose I'll not get my mail here, until I get back to my company again. You continue to write me at the same address. Now mother, don't worry about me at all for I am cared for just as well as I possibly could be at home and I will be back at work again by the time this reaches you. Remember that every day and hour I am fully trusting in Him whom I have always believed in for guidance and with Him I can fear no harm. Don't let any long period between letters worry you because we have no chance to write while at work. If anything serious happens you will be notified at once. Now write often.

VANCOUVER REGISTER

The "VANCOUVER REGISTER" has been abstracted from papers on file at the Clark County Historical Society by JANE GERMANN, a member of C.C.G.S.

Saturday, May 4, 1867 - Vol. 2 #33

FIRE DEPARTMENT.... The several companies of the Fire Department have elected three members each to the Board of Delegates. The Board will be composed of the following persons: From Vancouver No. 1. R. J. MOORE, DAN LEAHY, H. G. STRUVE. From Gen. Allen No. 3, GEO. T. HODGES, J. EDDINGS, P. BUCKLEY. From Vigilance H & L No. 1, H. COCHRAN, Capt. BAKER, C. F. SHORT. The first regular meeting of the board will be held on the 2d Monday in May at the rooms of Gen. Allen No. 3. is quite an excitement over the election of Chief Engineer and Assistants, which takes place on Monday next. Vancouver No. 1 has unanimously placed in the field as candidates the following persons: W. H. TROUP for Chief Engineer; J. D. HEALY, 1st Assistant; H. C. MORSE, 2d Assistant; all of them members of that company. General Allen No. 3, has ratified the nomination made up Vigilance H and L No. 1, of H. COCHRAN for Chief Engineer, and nominated J. CASTLE and CHAS. BOWLING for Assistants. Mr. G. W. BRADY of Gen. Allen No. 3, has his posters out as an independent candidate for Chief Engineer. The polls will be opened at the house of Vancouver No. 1, on Monday next at two p.m. and will be under the supervision of Capt. BAKER, Capt. HAKES and H. G. STRUVE, who were appointed as Judges of election by the Common Council at their last meeting. The total number of active firemen enrolled is 138, which number is apportioned as follows: Vancouver No. 1 has 51 members; Gen. Allen No. 3 has 60 and the H & L Co. has 27 members. [3/1]

PIC-NIC.... The private school of Messrs. SPINK and HATHAWAY went on a pic nic excursion last Monday to the "General Harney place" about two miles above town. The day was pleasant and the little ones enjoyed themselves to their hearts content. [3/1]

CEMETERY.... The commanding officer of the Post deserves great great credit for his efforts to beautify and ornament the cemetery near this city. It is now one of the prettiest spots on the coast. A large number of shade and ornamental trees have been planted, and numerous serpentine walks and paths have been tastefully laid out and graveled. The relatives and friends of deceased persons have also been busy in adorning the graves of their friends with flowers, shrubbery, & c. A number of beautiful monuments have also been erected among which, as deserving of especial mention, are those erected by the Masonic Fraternity, to the memory of JOHN AIRD and J. W. NYE, who died last year.

He is going to San Francisco on the next steamer to undergo medical treatment at the hands of Dr. TOLAND, a celebrateed occulist.

A GENEROUS DONATION.....JAMES CRAWFORD and JOSEPH LOCKWOOD, Esq's, during the last week donated to Gen. Allen Fire Engine Co. No. 3, sixty new firemen's hats, that is, they offer to pay for them. The offer was accepted of course and Mr. GEORGE HODGES the Foreman immediately telegraphed to San Francisco for them and they are expected up shortly. The price is about \$8 apiece. This generous act speaks well for public spirit and liberality of the donors.

LUMBER YARD....Mr. S. D. MAXON is about to establish an extensive lumber yard in this city. He has already received his first installment, consisting of some 65,000 feet, a large portion of which is dressed lumber. He also intends to keep in connection therewith a large assortment of doors, windows and other building material. This is a sign of good times coming.

IN CONTEMPLATION....We are informed that Mr. ANTON YOUNG of this place contemplates the erection of a large brewery to be built of brick and of 40 x 100 feet in size. It is to be two stories high and is to be located in the vicinity of the Public Square. [2/4]

They have abundant encouragements and there is no reasonable doubt of the success of the project. Mr. CONLISK is a practicle hand at the business, having been engaged in it for some fifteen years. PROCEEDINGS OF THE COMMON COUNCIL.... The Common Council met last Monday eve.' Present, the Mayor, Messrs. BRANT, O'KEANE, FLETCHER, WHIPPLE, PRESTON and EDDINGS.

The Mayor, for the first time, took his seat with the Council, and after he had called the meeting to order, he made a short speech in which he said that during the time he should have the honor of presiding over that honorable body, he should endeavor to discharge his duties as presiding officer to the best of his ability.

The minutes of the last meeting were read and approved.

A petition was received signed by some one hundred citizens asking the Council to grant the Sisters of Charity the use of certain streets for purposes set forth in their petition. A number of bills were then ordered paid.

On motion the returns of the Firemen's Election for Chief Engineer, and 1st and 2d Assistant Engineers, were examined.

- W. H. TROUP having received the highest number of votes was declared duly elected Chief Engineer of the Fire Department of the city of Vancouver.
- E. H. FREEMAN, and JOHN CASTLE having received the highest number of votes cast for Assistant Engineers, were duly elected. E. H. FREEMAN as 1st Assistant and JOHN CASTLE as 2d Assistant.

Mr. PRESTON, as Chairman of the Committee on Cemeteries, asked further time to report. Granted.

The petition of the Sisters of Charity was then taken up, and on motion of Mr. FLETCHER a Special Committee of three were appointed with instructions to take all the papers - the petition in favor and the remonstrance against it, together with the Ordinance which fully describes the premises - with authority to take legal advice in the matter, and ascertain what, if any right, the city had to grant the privilege prayed for. The expense of such advice to be defrayed by the Sisters. Carried.

The Chair appointed Messrs. BRANT, FLETCHER and PRESTON as the said Committee.

On motion the Council adjourned.

During Mr. STRUVE's absence he promises to enliven this sheet with a weekly correspondence, descriptive of the business, prospects, and ultimate destiny of the various places at which he may sojourn.

Of course, in this, as in all contests where honor or profit is the stake, there necessarily are some "sore heads." We are confident, however, that the utmost fairness characterized the whole affair, and a quiet conformity to that democratic principle that a majority rule, is the best and only legitimate course open to the defeated parties. COMMUNICATION

Editor Register:

As there are reports in circulation in this county that I have squandered money in my official capacity as road commissioner on the Washougal bridge, I would ask the privi- of a small space in your columns to correct such eroneous report, as nothing can be more foreign to the truth or more false. The facts are these: I have received found hundred and ninety six 97-100 dollars in currency, which was worth last November at the time the money was paid out, 70 cents on the dollar, amounting to less than three hundred and fifty dollars in coin, and in addition to the above I have received one ten dollar county order which I passed at currency rates and one twenty-five dollar county order which I have now on hand. The above mentioned sums comprises all the available means that I have received, the money appropriated by the Territory has not been paid. I am in possession of Territorial Warrants amounting to one thousand dollars, which can at any time be seen by calling on Mr. G. T. McCONNELL in Vancouver.

There has already been expended on the bridge for labor, timber, provisions, iron, spikes and other material necessary to carry on the work the sum of one thousand and forty seven dollars in coin, of which I have paid five hundred and five dollars in coin which would be equal to over seven hundred dollars in currency. 

EARLY CLARK CO. PEOPLE

WOODLAND SYNOPSIS

In the Eighteen-Fifties the early settlers started occupying that area north of the Lewis River, now known as Woodland, Washington. The bottom land both north and south of the North Fork was recognized as Clarke County. The only mode of travel so early was by boats with St. Helens being the nearest and quickest town of any size. The address for these folks was Lewis River, Washington, and later a post office was established at Pekin. The Lewis river had much more water capacity then and the steamboats came up the East Fork of the Lewis River as far as La Center and to Woodland on the North Fork. Not much notice is given those early Clarke County people as the territorial legislature in 1873 set the Clarke-Cowlitz boundary line at the North Fork of the Lewis River thus making Woodland of Cowlitz County.

History books record that from 1845 to 1854, to name a few of those early settlers, it would be those of william Bratton, A. LeeLewis, Columbia Lancaster, Sam Gatton, J. Brandt, Squire Bozarth, H. L. Caples, Gallaton, William and Samuel Kinder and Daniel Gardner.

Woodland was named after Squire Bozarth's farm. This town like many others had it hardships, with floods and in the fall of 1855 Indian outbreaks occurred. And in March 1856 a warning to all citizens of Clark County commanding them to flee to safety as Indians had burned Fort Cascades and Killed settlers there. The citizens gathered together and decided to go to St. Helens as there was better protection for the women and children. The men would boat back across the Columbia in the daytime and work on their farms, taking turns at guarding each other. They remained this way until June when they returned without any further trouble.

Today, Woodland is in the midst of a rich agricultural district. About 7,000 acres of land around Woodland have been protected from floods by a dyking system built at the cost of more than \$6,000,000 and from those lands come some of the state's best berries, small fruits and flower bulb's. The town also gains a rich "harvest" of smelt which go up the Lewis river each year.

THE BOZARTH'S

Squire Bozorth [sometimes spelled Bozarth] was the grandson of John Bozorth who was one of two brother's, natives of the province of Lorraine, France and who fought in the Revolutionary War. They migrated to Kentucky and later helped to organize Grayson County now Hardin and Grayson counties. Here one of their number was named the first County Judge.

Squire was born in Kentucky January 11, 1792. He moved from Kentucky to Missouri about 1819, and on April 18, 1845 left Wahaska, Iowa and with his family crossed the plains. Believing that oxen had more stamina than horses for such a trip, they used a yoke of four oxen to pull a large prairie schooner, and a family carriage with one yoke of oxen and driving 25 head of cattle. Nine children crossed the plains with him and his wife.

At Council Bluffs they waited two weeks for reinforcements. Fifteen more wagons and thirty one men, not counting women and children, joined them.

The usual Indian stealing, with one man getting lost and their traveling long and hard to find watering places, the trip was without serious incidents. They reached Grand Ronde Oct. 7th and Oct. 7th and October 31st they were at The Dalles and on November 9th they started down the Columbia. The stock were driven down to Vancouver on the Washington side of the Columbia river. By the middle of December they reached Vancouver.

Mr. Bozarth bought a place at Gales Creek Oregon and later one just opposite fancouver on the south side of the Columbia the latter part of December 1846, where he split and hauled rails at 90ϕ per 100, that winter for Hudson Bay Company.

In 1852 he was living and farming at a place he called Woodland Farm, on the north side of the Lewis river. Squire Bozarth died their March 1853 and his wife Millie Hoard (Willis) Bozarth died March 1856.

The children of Squire and Millie Bozarth numered eleven. Owen Willis (1820-1875), Mary Ann (1822-1860) who married Solomon Strong, John Shaw (1824-1882), Sarah Ann (1826-1874), Loraine Ellen (1828-1880), Christopher Columbus (1832-1914), Julia Ann (1834-1863), Squyire Jr. (1836-1905), Milly Willis (1838-1883) all born in Missouri, and the youngest Emma Caroline born in Iowa 1852 and the oldest child was Elizabeth born in Kentucky.

Christopher Columbus served in the legislature 1860-61, and was county assessor for four terms in Clark County commencing in 1856 and two terms for Cowlitz county 1874-78. He married Olive Goodwin in 1865. In 1871 he went to Umatilla county, Oregon, and in 1880 opened a hotel there. In 1881 Chris opened a store on north bank of the Lewis river and founded the twon of Woodland, thusly was appointed first postmaster of Woodland.

Squire J. Bozarth Jr. spent his years in farming and logging the original Donation Land Claim which comprised six hundred forty acres. It was practically all in timber and brush and he created a splendid farm.

The line that came down from Elizabeth the eldest child of Squire and Millie Bozarth, born in Kentucky 1817, brings us to the honored pioneer daughter of the Washington Genealogical Society, Lena Irene (Millard) Hamblen.

Mrs. Grace Davis and Mrs. Lena Hamblen recently attended the Daughters of Pioneers of Washington meeting held in Battle Ground. Lena was presented a life membership card at that time. Her ancestry is traced in early day settlers, Squire and Milly Bozarth, who settled and named the town of Woodland, before the turn of the century. Her grandfather, Samuel Gatton crossed the plains with his grandparents in the year 1889, at the age of 17. The following year Samuel assisted with the first base line measurement from the coastline in the foothills of Mount Hood and in 1852 passed through the Lewis River Valley as they made the baseline north and later the west line south as far as French Prairie. He was also a volunteer during the coastal Indian War.


Family and friends of Lean Irene Millard Hamblen gathered on June 17, 1988, at the Hillhaven Convelescent Center in Vancouver to watch her receive one of twenty special certificates given to Washington residents who can prove they were here before Washington became a state. She was 98 years old and was born in Woodland, Washington August 10, 1889, just two months before Washington joined the Union.

The first name in the Baptismal records of Woodland Presbyterian Church belongs to Hamblen, as she was the first infant baptized in the church almost a century ago. She can remember when a child, she went on shopping trips to Portland with her mother which took three hours by steamboat.

At the age of 13, her family loaded all their belongings on a ferry boat and moved to Vancouver, B.C. and as a young lady of 18, she returned to Washington to settle in Seattle. There she met and married her husband who was a policeman.

The "Lady of Honor" passed away Saturday September the 17th 1988. She was the grand-daughter of Samuel Gatton and Gideon Millard. Also she was the Grand-daughter of Elizabeth Bozarth Millard and great-grand-daughter of Squire and Millie Bozarth.

Survivors were a daughter-in-law, Elsie Hamblen of Carson; three grandchildren, Herbert Hamblen and Ila Mae Thompson, both of Carson and Annette Lauppe of Temple City, Calif. and four great-grandchildren. Interment at Woodland.






