

THE PRICE THEY PAID

Have you ever wondered what happened to those men who signed the Declaration on Independence?

Five signers were captured as traitors by the British, and were tortured before they died. Twelve had their homes ransacked and burned. Two lost their sons in the Revolutionary Army; another had two sons captured. Nine of the 56 fought, and died from wounds or the hardship of the Revolutionary War.

What kind of men were they? Twenty-four were lawyers and jurists. Eleven were merchants; nine were farmers and large plantation owners — men of means and well-educated. But they signed the Declaration of Independence knowing full well that the penalty would be death if they were captured. They signed, and they pledged their lives, their fortunes, and their sacred honor.

Carter Braxton of Virginia, a wealthy planter and trader, saw his ships swept from the seas by the British navy. He sold his home and properties to pay his debts, and died in rags.

Thomas McKean was so hounded by the British that he was forced to move his family almost constantly. He served in Congress without pay, and his family was kept in hiding. His possessions were taken from him, and poverty was his reward.

Vandals, soldiers, or both looted the properties of Ellery, Clymer, Hall, Walton, Gwinnett, Heyward, Rutledge, and Middleton. Francis Lewis had his home and properties destroyed. The enemy jailed his wife, and she died within a few months.

at the Battle of Yorktown, Thomas Nelson, Jr., noted that the British General Cornwallis had taken over the Nelson home for his headquarters. The owner quietly urged General Washington to open fire, which was done. The home was destroyed, and Nelson died bankrupt.

John Hart was driven from his wife's bedside as she was dying. Their 13 children fled for their lives. His fields and grist mill were laid waste. For more than a year he lived in forests and caves, returning home after the war to find his wife dead and his children vanished. A few weeks later he died from exhaustion and a broken heart. Morris and Livingston suffered similar fates.

Such were the stories and sacrifices of the American Revolution. These were not wild-eyed, rabble-rousing ruffians; they were soft-spoken men of means and education. They had security, but they valued liberty more. Standing tall, straight, and unwavering, they pledged: "For the support of this declaration, with a firm reliance on the protection of the Divine Providence, we mutually pledge to each other, our lives, our fortunes, and our sacred honor."

They gave us an independent America! Can we keep it?

EARLY CLARK COUNTY PLACES Shot into spotlight,

junction now quiet

Duluth is a tiny, quiet community about 10 miles north of Vancouver.

However, nearly 15 years ago the community was catapaulted into the headlines as the result of bizarre and senseless shootings. It was on a warm Saturday afternoon in July 1965 that John Frederick Anderson, then a 20-year-old college student, burst into a Duluth barbershop and began firing a pistol wildy at everyone in sight.

Today, the barbershop building is gone, and Duluth has reverted to a quiet crossroads neighborhood where newsworthy events seldom happen. The residents say they like it that way.

Duluth's roots go back less than 50 years. Its history dates to 1930, according to oldtimers.

It was in that year that the late Fred Pearson, who came to be known as the Mayor of Duluth, opened a fast-food restaurant on the southeast corner of the intersection of Northeast 10th Avenue and Northeast 219th Street. At that time, 10th Avenue was the route of Highway 99, a torturous and crooked two-lane road that offered the only link between Portland and Seattle.

The name Duluth was assigned to the community by Adolph Sauvie who opened a service station and store near the intersection. Sauvie's firm also served as a bus stop and the bus company insisted the community should have a name. Sauvie chose Duluth for his old hometown of Duluth, Minn.

Bob McIntyre, who moved to Duluth in 1935, recalled that in that year Sauvie's store and Pearson's restaurant made up the entire business district.

Today, a Minit-Mart convenience store, Harry's Duluth Tavern, a Texaco service station and a driveway and excavations firm have been added.

Pearson's original building was constructed of wooden boards covered with slabs from a sawmill. These slabs, with the bark intact, gave the building the appearance of a log cabin.


Today, a drive-in cafe occupies the same site as the hamburger haven, but a cement block building has replaced the original wooden structure.


McIntyre said the tavern was just under construction when he arrived there 45 years ago. Since then, not much has happened, although a big shopping center nearly located there. The plans for the center were dropped because of sewage problems.

In July 1965, Anderson, a journalism student at Pepperdine College in Los Angeles, flew to Pearson Airpark in Vancouver in a rented plane. He subsequently robbed and killed a woman taxi driver, stole the cab and was pursued through the county by lawmen at speeds of 100 mph.

At the Duluth intersection, Anderson failed to negotiate the corner and the cab crashed into Howard Morford's barbershop. Anderson leaped from the cab and began firing wildly. He killed Morford, who was trying to protect his customers, and wounded two barbershop patrons.

Anderson pleaded guilty to second-degree murder and was sentenced to life imprisonment. The state Board of Prison Terms and Paroles set 35 years as the minimum sentence to be served by Anderson, but the man was released from the state penitentiary in 1975, 10 years after the crime.

LAND RECORDS: by Jane Germann


You've just found the name you've been searching for in the land records and you are bewildered by what it says.

Wilson, Thos. J. H#473 Sec 19 T3N R2E

Translated, this reads that Thomas J. Wilson, Homestead #473 found in Section 19 of Township 3 North and Range 2 East. To locate it, you need to know about townships, ranges and sections.

At first land was simply described often using monuments such as rivers, lakes, rocks, fences, etc. to describe the area. "Along side Brown's land" or "to the middle of Rock Creek and up to the top of the hill" lost meaning after Brown moved or the creek changed course.


The metes and bounds method uses a starting point and describes the property as so many feet (meted or measured) in such direction (bounded). Usually found only in cities that have already been surveyed, plated and recorded, this method is worthless if starting point is in error. Using the degrees of a circle, lines are established are shown below:




The rectangular or government survey was adopted in 1785 and contains a legal description stating a Section, Township, and Range. The ordinance originally established townships 6 miles square, containing 36 sections. A starting point is determined and the Principal Meridian (North & South) and Base Line (East and West) are drawn. Then six-mile sided "squares" or townships are drawn in and numbered out from the center point. Every four townships (twenty-four miles) a correction line is drawn in that runs parallel to the base line and called a standard parallel. However,

true north-south and east-west boundary lines were geographically impossible and some alterations were necessary. "Added acreage" will be found on the north and west lines as shown below. [The border between Clark and Skamania Counties show an example at the First Standard Parallel.]

The location of a township is determined by how many "squares north, south, east, or west" it is from the center point. It will be ___ North or South of the Base Line (called a township) and __ East or West of the Principle Meridian (called a range). Thus a description of T2N, R4W means this township is two North of the Base Line and four west of the Principle Meridian:



The lines for this area were drawn when Washington was a part of Oregon and the starting point is near Portland. The main North-South line is called the Williamette Meridian and runs through Ridgefield, and the standard parallels number all the way to the Canadian border.



Once the township is located, then the section can be located. A section is 1/36th of a township and equals 640 acres or one square mile in area. Note the numbering of sections begins at the north-east corner, goes "backwards" or west, down one and then to go the east, then west, etc.


Each section can be divided into a variety of ways. Quarter-sections of 160 acres each are common.


Another division of the section into sixteen squares indicates where the expression "the back forty" comes from!

Various divisions are possible and may use various measurements: 160 rods - 1/2 mile - 880 yards - 2620 feet - 40 chains - 4000 links, etc. As property was divided up either to be sold off or inherited, land descriptions have become more complex. Other examples of how a section can be divided up:




Here in Clark County, Arnold's county map shows the township and ranges. Also, the Historical Society has a set of township maps for Clark County that show property owners about 1880 and have drawn in location of modern streets, so it was easy to locate the property of Thos. J. Wilson a bit north of Pleasant Valley School.




The government survery method <u>does not</u> apply to the original thirteen states, New England states, Atlantic Coast states (except Florida) or West Virginia, Kentucky, Tennessee and Texas — land descriptions using the old method were in use. In general, each state using the government survey method has its own starting point.

WILLIAM HENRY and JANE BRINN SHOBERT

William Henry Shobert married Susan Jane Brinn in Vancouver on May 6, 1878 and they lived to celebrate sixty-three years of married life. Henry's mother Catherine Mace was the daughter of William Jacob Mace and Polly Rebecca Kettner. She was born in Pennsylvania on February 18, 1818, and was six years older than her husband Frederick who was born February 2, 1806, in Luzerne Co., Pennsylvania. Frederick's parents were John Shobert and Catherine Harmon. William Henry Shobert was born September 14, 1849, Elk Horn Creek, IL.

Susan Jane Brinn was born May 6, 1878/9, at Salmon Creek, the daughter of Clark County pioneers Andrew Jackson Brinn and Mathilda Weigle. Andrew "Jackson" was born in 1830 in White Co., IL, and came to Portland, OR, with a cattle drive. He met the Weigle family and moved to their DLC on Salmon Creek where he met and on January 2, 1853, married Mathilda. Her parents were George Weigle and Susan Klingensmith.

According to the family, both the Shobert family and Weigle family came west in the same wagon train in 1852. Henry was only three and had an older brother Stephen who was 15 and three sisters, Amanda, Polly and Catherine. Uncle Napolean had been a scout for the train. "Jackson" Brinn had come west the same year, helping drive a herd of cattle.

The first Shobert home was a log house 18 by 15 feet with three or four windows and stood not far from their house which in 1988 was added to the National Register of Historic Places. An intermediary "box house" was built and used until the mid 1870's and the old log cabin was used as a store house. This was at "Shobert's Landing" and up on the ridge that became Union Ridge and is now known as Ridgefield.

There were Indian paths along the river and Indians would often come to the house to sharpen their knives on the Shobert's grindstone. At one particular time, the Indians in the area had become somber and rumors has spread that local Chief Umtux was planning to attack the whites and that the Yakimas would join them. A warning came one night when Henry's father was away and his mother got the children quietly away and up the trail, and they spent the night in a hollow stump cuddled about the family dog. The family then took temporary refugee across the river to St. Helens blockhouse as did many of the early pioneer families.

They got their first kerosene lamp in 1878, taking care to not let it "blow up" as many did. The children still used the tallow candles made from their own rendered tallow with their candle molds. Many of their tools were made with the anvil that had cross the plains with them.

Game and fish were plentiful and it was reported that Henry had killed 60 dozen ducks in one day's shooting for market in Portland. Even the duck feathers were traded for goods. The founder of Meier and Frank department stores, Aaron Meier, began his trade in the area by tramping through the Ridgefield area selling goods from his peddler's pack.

One of the early pleasures in the area was a barn-raising. It was a great social event and Henry would fiddle while someone else would call favorites "Pop Goes the Weasel" and "Girl I Left Behind Me."

The Shoberts and related families have been written up in Clark County Pioneers: A Centennial Salute. The first issue of the Fort Vancouver Historical Society's annuals has an excellent story on the Shobert family (p64-66) and other stories on the Ridgefield area. The Vancouver Columbian's Washington Centennial Issue published July 31, 1953, was the source of the photo in this article and is a rich resource of local history. William Henry Shobert was interviewed in the late 1930's for the Federal Writers' Project. A short typewritten biography included a reference to interviews with Mrs. Minnie Shobert Mills and a March 10, 1966 article in The Columbian.


