

## ANOTHER STUMBLIN' AROUND STORY

Some years ago, my mother, Dot Parker, told me of her life on her father's farm in Marion County, near the Willamette river town of Fairfield, OR, which is now only a site. According to mother, there was a large, well to do farming family that lived up the road from the Parker's farm and mother was sweet on one of the boys. Apparently the feeling was mutual as a wedding was being planned for the two. Then mother met my father, Rodney Grafton. He was from Oregon City. The original wedding plans were canceled when mother married Rodney on June 4, 1921.

For many years this was just an interesting story, as my mother had only mentioned it once and I never gave it much credence. The other day I received a phone call from a rather hesitant and hard of hearing, old man. He asked of my mother and father and was somewhat taken back when he learned that they had both passed away a few years ago. He told me that we were related through a certain uncle in the Parker family and went on to tell me about former Fairfield people I had never heard of. He finally mentioned two names I recognized and I tied him down to some specifics, gaining information I did not have on burial places and some of the children. It was enough to give me a looking place.

This old gentleman finally introduced himself as a member of the large family that lived up the road form the Parker's, and I laughingly told him my mother's tale. There was a long silence over the phone line, finally the old timer said, "Yes, I'm familiar with that incident, I am the one that Dot was going to marry."

My mother and father were born in Sept. and Oct. of 1899 and mother passed away in 1986 and dad passed in 1989. My mother's old beau must be well on his way to the century mark. You never know when or how a bit of information will come into your possession. Listen to the elders, retain or file what you hear and perhaps that information will be what you need to fill in a piece of family history; but by golly, I had just never thought of my mother as a femme fatale before.

## Joseph Lewis Gaither

Our ancestral heritage is a rich treasure that surprises us, for often we are not aware of the role and importance that family members played in the forming of this country. The physical boundaries and principles held by this great nation are due in large part to the contributions of people from Ohio, Indiana, Iowa, New York, Connecticut, Pennsylvania, Missouri, Kentucky and Illinois. The Civil War historical chronologies spend considerable time and effort detailing the battles that took place in Virginia and the East Coast of the U.S. This is due in large part to the eastern location of both Union and Confederate Capitols and partially by a reverence for General Robert E. Lee by a worshipping audience of Southern and Northern writers who felt compelled to narrate this important U. S. history in a slightly biased manner. It is important to realize that a great majority of this country's strength existed beyond the Shenandoah Mountains of Virginia in 1861, and it is due in large part to the contributions of the people from this region that the North won the Civil War. I have felt compelled to research the contributions made by a family of Union "Gaithers" from the North that has driven me to write at times as early as 4:30 in the morning due to ideas and thoughts that bombard me from sound slumber. I oftentimes find myself in old bookstores in areas only a year ago I wouldn't have had any interest.

On Saturday November 23, 1991, I found myself looking at a book put out by the Catholic Art Publishing Company in 1897. What drove me to the information contained in this book and its importance to the Gaithers will be detailed in the following manuscript.

This is a narrative summary of the progress to date in the research for the travels of Joseph Gaither, our grandfather who hailed from Indiana. Joseph Gaither was the fourth child of Perry and Betsa Ann (Ketcham) Gaither, born 16 July 1842 in Smithville, Clear Creek Township, Indiana. My father, George P. Gaither Jr., during a trip to the Washington, D. C. area, in October 1988, gave me Joseph Gaither's discharge papers, which had been in a safety deposit box in Portland, Oregon. At first I believed that the paper I had was a copy, until further discussions with father revealed this paper to be the original discharge, which is over 130 years old. Only Union Army personnel routinely received discharge papers in the Civil War period, and the U. S. Government did not keep a record copy of this unique document. I made arrangements to get the discharge paper preserved in May 1991, and have had it encapsulated in a plexiglass ultra-violet resistant frame that allows both sides of the document to be viewed. This also allows the handling of this fragile paper without further damage or tearing. I have had discussions with people from the Prince William County, Virginia library system, knowledgeable in the science of preserving old documents. It seems that the paper used for documents before 1880 had a much lower acid content in it during manufacturing that kept it from yellowing and deteriorating lie the paper from the early 1900s.

I have done a considerable amount of study, and believe I now understand a lot more about the western theater of the Civil War. I also believe that there are many Gaithers that most of us weren't aware of as indicated by the newsletter, Society of *John Gaither Descendants*, which I first received in 1986. Telephone discussions with Eva Gaither Thornberry from Louisville, Kentucky on the evening of August 5, 1991 indicate there is much more information to be obtained from research done in Indiana, and North Carolina areas.

Joseph's parents, Perry and Betsa Ann (Ketcham) Gaither were married December 23, 1836 in Monroe County, Indiana. Perry was a Republican, well respected in the community, and served several terms as Clear Creek Township trustee. The Perry Gaither log house, built in 1842, has been modified with several frame constructed rooms, and is still standing today. The Gaither family with Joseph as fourth born is listed below:

The Joseph Gaither Civil War discharge had been hanging on the wall as a framed document in a previous time because you can see the line where a frame bordered the document. I have conducted research in the National Archives and have received information that reveals additional facts about Joseph Gaither. Hopefully this will make the reading more interesting.

This is the correct transcript of the discharge; it contains much useful information:

#### To All Whom It May Concern:

Know ye that Joseph Gaither a Private of Captain H. L. McCalla's Company (G) 31st Indiana Volunteers who was enrolled on the fifth day of September One Thousand Eight Hundred and Sixty One to serve for During the War is hearby discharged from service of the United States this second day of August 1862 at Murfreesboro, Tennessee by reason of gunshot wound received in battle of Shiloh. Said Joseph Gaither was born in Monroe County in the State of Indiana, is nineteen years of age, five feet ten inches high, fair complexion, grey eyes, brown hair, and by occupation when enrolled, a farmer. Given at Murfreesboro this second day of August, 1862

(signed) Charles Cruft Col CMNDG 31st Ind. Vols.

reverse side (approval in margin) Head of Army of the Ohio Huntsville July 13th 1862 Command of Maj. Gen. C. Buell Signed across front of form: Paid in full August 16, 1862 by Hoyt Sherman Paymaster, USA

On August 5, 1861, Grandfather Gaither was part of a company of volunteers from Monroe County, Indian recruited by Henry L. McCalla to serve in the War of the Rebellion. This company of 95 volunteers, all native sons who were raised within a few miles of each other, traveled from Clear Creek Township (now Smithville) to Terre Haute, Indiana, where volunteer regiments were being assembled. This was a distance of about 40/50 miles from Joseph's hometown of Smithville, Grandfather Gaither, age 19, spent several weeks in Terre Haute at Camp Vigo awaiting uniforms, gear, mustering in, and learning military drill procedures. On September 5, 1861 he became a member of the 31st Indiana Volunteer Infantry (Company "G") by taking the Oath of Allegiance.

Nation Archive Record Returns, and the Indian report of the Adjutant General reveal that the 31st and 44th Indian Regiments were equipped with 1853 "British" Enfield Rifle Muskets in .577 caliber and weighing approximately 9 pounds. This single shot muzzle loader was the British infantry standard musket, comparable with the .58 caliber U. S. standard Springfield rifled musket, which was very difficult for most western states to obtain because of the demand in Washington, D. C. for arms in 1861.

From Terre Haute, about the 20th of September, the Company/Regiment, now equipped with basic outfits, took the train to Evansville, Indiana and went into camp on the North bank of the Ohio River (Camp Cruft). It was during this period that the farm boy from Indiana, young Gaither, first sighted a steamboat.

The first week in October, the Regiment was relocated by "transport" (four steamers) up the Ohio River to Owensburg, (Henderson) Kentucky. They camped the first evening in an old tobacco barn. This barn was big enough to house the whole regiment. The Union forces were showing the "Flag" in Kentucky which was a neutral state. They were assigned guard duty at Lock number 1 on the Green River near Spottsville, Kentucky and from there performed several foray trips up the Green River. They soon moved semi-permanently to Camp Calhoun (Kentucky) on the Green River on October 15, 1861. They joined two Union Kentucky Regiments which were forming up at Camp Calhoun (the 17th and 25th Kentucky Volunteers). Winter quarters were established however, Camp Calhoun was a miserable location with poor sanitation and the right time of year for outbreaks of flu, measles, winter viruses, mumps, sore throat, etc. There were many soldiers of the 31st who died from disease at Camp Calhoun. All the soldiers were very happy to move on January 15, 1862 to Camp Jackson in South Carrolton, Kentucky via the steamers Mattie Cook and Hetty Gilmore. The weather during this latter part of the journey was cold with freezing rain.

The Union forces, located in this area, numbering about 5,000 troops, were under a total force of 20,000 under General Don Carlos Buell, Commander, Army of the Ohio. They were part of a contingent facing the Confederate forces stationed in Bowling Green, Kentucky under Confederate General Hardee (22,0000 troops). Gaither was in camp on the Green River through the winter of 1861; spending a good part of his 19th year as an Indiana Volunteer infantry soldier.

Most Confederates believed the Union would attack through a frontal assault on Bowling Green, Kentucky. General Grant, under Major General Hallbeck, had other ideas, these included the best way to move troops — by riverboat. Grant's limited success at the Battle of Belmont proved to him the value of river "steamers" for quick troop movements. Grant had several close military associates who made his operations easier. He was a man of few words to his superiors, but got along well with those peers who didn't challenge his authority. Grant was anxious to move and do something, while Halleck, and especially Buell were methodical planners. Grant worked out several attack scenarios that included Navy Admiral Foote and his armored gunboats. This was a new way of doing business for any army of the time. (Armies historically operated on their own strength without any naval support.) Grant convinced Halleck (because President Lincoln was pushing for successful battle campaigns) that he should proceed upon Forts Henry on the Tennessee River and Donnelson on the Cumberland River in February 1862. General Halleck was convinced he could take personal credit for a U. S Grant victory at Forts Henry/Donnelson, so he readily agreed to Grant's proposal, including a contingent of additional forces needed for the river campaign. Thus, Joseph Gaither was transferred, along with a number of troops from the Army of the Ohio, on February 9, 1862, arriving at Paducah, Kentucky on the evening of the 10th, steaming for Fort Henry on the Tennessee River the following morning. All of the 31st Indiana Regiment of approximately 1800 men, equipment, horses and an artillery company traveled by a large side-wheel steamboat the *Ben Adams*. Joseph Gaither's regiment was now assigned to the Army of the Tennessee under General Ulysses S. Grant.

Forts Henry and Donnelson were separated by approximately 11 miles of land between the Tennessee and Cumberland Rivers. Fort Henry was too close to the river water line and, since the Tennessee River was at flood stage, it was an easy task for Admiral Foote's seven armored gunboats to pummel Fort Henry into submission without taking any damage to their ships. The Fort was then occupied by a total force of 70 Confederates manning the cannons. It fell after two hours of bombardment on February 6th. The remainder of the escaping Confederate troops from Fort Henry had scampered away to more heavily fortified Fort Donnelson before General Grant's troops arrived. Because of the wet weather, most of Grant's troops got bogged down in the mud, with creeks so full that when they crossed them they were up to their waist cartridge belts in the water.

The 31st Indiana, which arrived as reinforcements after the fall of Fort Henry were too late to take part in a campaign they were all anticipating, and Admiral Foote's seven gunboats, the flagship *St. Louis, Louisville, Carondelet and Cincinnati*, all ironclads, and wooden gunboats *Conestago, Tyler* and *Lexington*, were ordered to proceed down the Tennessee, up the Ohio to the Cumberland River to attack Fort Donnelson. It took about four days to accomplish this protracted river trip.

Grandfather Gaither marched upon the Confederate entrenchments or breastworks surrounding Fort Donnelson, after having disembarked from the steamer *Ben Adams* about 4 miles down river from Fort Donnelson. The 31st Indiana Regiment had camped, without provisions the previous evening, February 13th, aboard the *Ben Adams* when they arrived at 11:30 p.m.

Admiral Foote's gunboats acting as a diversion to troop movements, didn't have as easy a time with the bombardment of this Fort on the Cumberland as they did with poorly constructed Fort Henry on the Tennessee. Fort Donnelson was located on slightly higher ground and had a better capability of bringing large cannons to bear on the armored Northern gunboats who's naval crew were overconfident after the easy capture of Fort Henry. They approached the Fort from down river (north) and came within easy shelling distance of this Fort's well manned mortars and cannons. As a result, Foote's gunboats were seriously damaged and were forced to retreat down river. Grant brought his infantry against Fort Donnelson from the land side, (from the west) and laid siege to the Fort on February 12th just prior to the arrival of the 31st Indiana and the armored gunboats. Joseph Gaither and several Smithville boys were assigned "picket duty" on the Union right position the evening of the 14th of February, as an advanced protection against Confederate forays. It snowed that evening and turned very cold. Joseph and the other pickets were relieved early on the morning of February 15th, shortly before the Confederate against the Union right position. He was probably tired and upset because no one had relieved him all evening. The Union counterattack was successful mainly because the Confederates were ordered to fall back to their previous position.

The next day, February 16th, the Confederates holding Fort Donnelson surrendered. Resolved not to hold the Fort against a determined attack had been decided by the Fort's commanders, John Buchanan Floyd and Gideon J. Pillow, who escaped with a contingent of Confederate infantry after turning over command to the next senior Confederate, Simon B. Buckner. Buckner felt that since he was a good

friend of Sam Grant that things would go easier for him during surrender of Fort Donnelson. Grant's famous reply to terms of surrender was "unconditional surrender." Grandfather and the 31st Indiana had received their initiation into battle. They probably fired about 40/50 rounds of ammunition from muskets that were capable of being fired at a maximum rate of 3 rounds per minute. Colonel Cruft, 3rd Division Commander, and later Regimental Commander at Shiloh, was wounded, and treated by the Brigade Surgeon, Thomas W. Fry.

Captain Henry McCalla, Captain of Company "G", spoke of experiences included the Fort Henry and Donnelson campaign: "I raised a company for the three years service in August 1861 and was ordered to report to Terre Haute where the 31st Regiment was being organized. I went into camp with 95 men. The regiment was mustered into service September 5, 1861. The mustering Officer Colonel, now General Wood, mustered the Companies in the order of their fullup. My company was the 2nd mustered. We were told that the rank of the regiment would be determined by lot, not so. Colonel Cruft assigned the first 4 places to his friends, 3 of them from Terre Haute, the place of his residence. The commanding officer assigned to the second place was not filled until the regiment was ordered to march to Kentucky, and was then filled by taking men from the 43rd Regiment. In this I considered that I had been wronged. I commanded the (color)? Company in the Battles of Fort Donnelson and Shiloh. At the Battle of Fort Donnelson our company was thrown into confusion, Lieutenant Colonel Osborn commanding the regiment retired as he said "To rally the fugitives," leaving the Regiment in the command of Major Arn. Osborn did not make his appearance until the next day, when the Fort had surrendered. While in his absence the the regiment had participated in the gallant charge against the enemy's works, late in the evening of the 15th. Soon after a paper was presented to Colonel Osborn ashing him to resign." This paper was signed by all the Field, Staff and Line Officers present. The above was written by Grandfather Joseph's Company Captain, also from Monroe County, Indiana in October 1862.

Joseph Gaither stayed at Fort Henry in reasonably comfortable quarters from February 17, 1862 until March 9, 1862. From March 1st through March 9th, Grant made some raids on Savannah, Tennessee, and a place 9 miles up-river called Pittsburg Landing, which had emplaced Confederate artillery to harass Northern river traffic. Northern gunboats made short work of this small artillery unit and the Confederate forces didn't return to Pittsburg Landing. Union forces now had the capability of easily traversing the Tennessee River from Cairo, Illinois to Florence, Tennessee. Grandfather may have been involved as a member of the supporting troops during these sorties.

On 10 Mar 1863, river steamers with bands playing (Grant detested music and was probably nowhere around), regimental flags waving, escorted by Admiral Foote's gunboats, started moving the troops located at Cairo, Illinois and Fort Henry for the trip to Savannah, Tennessee and Pittsburg Landing, about a four day riverboat journey upstream. This was a very imposing sight, impressive to all the volunteers traveling up the Tennessee River, and you can rest assured to anyone on the river bank who viewed this transfer of troops. The river steamers had to stop about once every other day and load up on cord wood for the steam engines. Grant had to establish Union Army managed refueling areas on the Tennessee River that could be used for reoccurring river traffic.

The 31st Indiana, initially stayed a day or so on board the steamer after arrival at Savannah, Tennessee, where the steamer transports were anchored five deep, a mile in length at the river landing, with horses and associated artillery pieces still on the steamers. Many Union troops were deathly ill and dying from drinking contaminated river water. They dipped canteens and containers into the same water that served as a conduit for animal and human relief.

Sherman fortunately decided a day after Grandfather's arrival to move to Pittsburg Landing about 9 miles up-river. The 31st Indiana set up camp just at the top of Pittsburg Landing, about a mile from the high bluffs, on the edge of an old cotton field, near a fresh clear water spring, on March 15th. It was a typical March season with a little more rain than usual, as the Tennessee River was at 18 feet above flood stage. Grant was planning on attacking Albert Sydney Johnston, the Confederate leader located in Corinth, Mississippi, as soon as Don Carlos Buell's reinforcements of 40,000 troops arrived from Nashville, Tennessee.

Grant was the type of military commander who was brilliant on offence, understanding the fears and mentality of his opposition, but possibly a little short sighted on defense. The Union Army was in "Southern Territory" and received scant information concerning Confederate movements and intentions from the local populace. Additionally, General Grant had General Sherman working under him, which could have been problematic, except that Sherman respected Grant as an individual and leader. Sherman had been relieved of command earlier in the year due to stress related fears, and had just recently been reinstated. Sherman was concerned that people would be critical of any fear he showed of Confederate forces. As a result, he squashed any suggestion that Union troops were vulnerable when they were camped at Pittsburg Landing. The thought of digging battle trenches for defense was discussed and dismissed by Sherman, as potentially demoralizing to the camped Union troops. Scouts and advanced guards were posted in a minimal haphazard manner. Grandfather Gaither was getting a little bored waiting at camp, cleaning gear, standing inspection and doing routine chores associated with camp life.

On Sunday morning, April 6, 1862, just as breakfast was being prepared in camp, with the smell of frying bacon drifting slowly across the spring stillness, 40,000 Confederate forces, under Albert Sidney Johnston, arrived from Corinth, Mississippi, a four day cross country trip to go twenty miles in the rain, and attacked the 36,000 Union troops at Pittsburg Landing. The Confederate name for this location was "Shiloh", named after the Methodist meeting house about three miles from the bluffs of Pittsburg Landing. Grant was at Savannah, about four miles north (downstream). Upon hearing of the start of a skirmish he jumped on his steamer, the *Tigress*, and headed for the landing. Grandfather Gaither's 31st Indiana Regiment, with Colonel Cruft in command, was put into brigade formation with the 44th Indian, 17th Kentucky, and 25 Kentucky as part of General Hurlbut's 4th Division troops on almost the extreme left of the battle field.

dated August 4, 1879, stated that he helped carry Joseph Gaither from the battlefield. He may have been assisted by close associates and 31st Indiana troops, Silas E. Grimes ans Henry L. McCalla. Silas Grimes later married Joseph's younger sister, Susan Gaither

The Union Sanitary Commission, predecessor of the Red Cross, was working very hard to clean up the casualties. They carried Joseph and other casualties aboard a transport steamer and sent them north on the Tennessee River to a section of Army camp near Cairo, Illinois, known as "Mound City." Mound City was a steamboat repair facility and hospital location. The hospital that he was checked into was the Simons Hospital. It took about four days to reach the hospital aboard the steamer, which was not prepared to treat the injuries of seriously wounded servicemen. A statement in Angels of the Battlefield describes the history and condition of the Mound City hospital.

"Except in Mound City everything was in a chaotic condition, compared with the complete arrangements afterward. The hospital at Mound City occupied a block of brick stores, built before the war to accommodate the prospective commerce of the war. They had not been occupied, and as the blockade of the Mississippi rendered it uncertain when they would be needed for their legitimate use, they were turned over to the medical department for hospital use. At the time of my visit the Mound City Hospital was considered the best military hospital in the United States. This was due to the administrative talent of Dr. E. S. Franklin of Dubuque, Iowa, who despite poverty of means and material, transformed the rough block of stores into a superb hospital, accommodating 1,000 patients. Fifteen hundred had been crowded in it by dint of close packing. The most thorough system was maintained in every department.

There was an exact time and place for everything. Every person was assigned to a particular work and held responsible for its performance. If anyone proved a shirk, incompetent or insubordinate, he was sent off to the next boat. A shaker-like cleanliness and sweetness of atmosphere pervaded the various wards; the sheets and pillows were of immaculate whiteness and the patients who were convalescent were cheerful and contented. The Sisters of the Holy Cross from Convent of St. Mary', St. Joseph's County, Indiana were employed as nurses, and by their skills, quietness, gentleness and tenderness were invaluable in the sick wards. Every patient gave hearty testimony to the skill and kindness of the Sisters."

Joseph was checked into Simons Hospital on the 11th of April and 15 days later was checked out of this military facility on April 26th by Hammond, the Union Medical Commander. The difficulty and concern caused by the type of wound that Joseph received is spelled out in the following narrative from *Angels of the Battlefield*.

"The soldiers were remarkably kind to one another. They went around the battlefield giving what assistance they could, placing the wounded in comfortable places, administering cordials, etc., until such a time as the nurses could attend to the wounded and sick. I remember one poor soldier whose nose had been shot off, who had almost bled to death and would have been missed had we not discovered him in a pen, where some kind comrade had placed him before he left the field, every other place of refuge having been occupied. His removal from the pen caused great pain, loss of blood, etc. The blood ran down his shirt and coat sleeves, down his pantaloons and into his very boots. He was very patient in the boat trip up river. On his arrival in Cincinnati he was placed in a ward in our hospital. Shortly after his arrival in the city a gentleman came to Cincinnati and called at the Burnett House, which was then used as a military hospital, inquiring for his son. After searching everywhere else he called at St. John's Hospital. I met this sorrowing father just as I was leaving the hospital to attend to some business. From the description he gave I concluded that the boy without the nose must be his son. I took him to the ward. When we reached the bed where the man lay the father did not know him. Well, said he, if he is my child I shall know him by his head, running his fingers through the boy's hair he exclaimed, my son! my dear boy!" This account was related by Sister Anthony of the Sisters of Charity, who served at Shiloh after the battle.

What happened during this stay in the Simon's Hospital at Mound City is hard to accurately predict. The major evidence indicates that home, family and friends visited this 19 year old Gaither youth and helped get him out of a "different state" hospital is the National Archive military record that shows him in the hospital at Evansville, Indian during the month of June 1862. However, Joseph's pension application from Indian on October 1862 indicates he went directly from Simon's Hospital to his father's home. Other pension records indicate that his father, Perry Gaither, came to the hospital at Mound City to take him home.

Procedure were taken early in July of 1862 to effect the discharge of Joseph Gaither. Henry S. McCalla, his company Captain, signed the statement on the Certificate of Disability on July 3, 1862 at Athens, Alabama. Major J. B. Armstrong, Regimental Surgeon, signed a statement dated July 4th at Athens, on the bottom of the same certificate. E. C. Franklin, Brigade Surgeon, signed

They were located to the right of a stream called "Lick Creek", and were ready to support Prentiss' Division, which had already encountered Breckinbridge's and Bragg's Confederate forces, about three miles away, and had been retreating and fighting them since about 8:00 a.m. By about 9:30 a.m. the Confederates had captured a considerable amount of territory previously known as "Union Campground."

Joseph Gaither's regiment was deployed at midmorning and they advanced from their campsite to an old abandoned sunken wagon road that interconnected the Savannah Hamburg Road and the Corinth Road leading to the Pittsburg Landing. The 3rd Brigade was facing opposing Confederate troops and organized from right to left as follows: Hickenlooper's Battery, 31st Indian, 44th Indian, 17th Kentucky, 25th Kentucky, and Mann's Battery. The half-mile section of road where they located was to be known in history by several names due to the ferocity of the battle that was fought there. The section of open field area near a peach orchard was known as the "Hornets Nest". Confederate Generals Bragg and Breckinbridge's troops charged the Union 4th Division forces (Joseph Gaither in Company "G", 31st Indian, 3rd Brigade, 4th Division) a total of approximately ten times while they held at the sunken road between 12 Noon and 2:00 p.m. on the 6th of April. Colonel Cruft, who was seriously wounded during the battle in the head, leg and shoulder, described the Confederate troops as advancing to within ten yards of the 31st Indiana Infantry position before being forced to retreat. The regiment had fired approximately 100 rounds per man according to Colonel Cruft. Most officers, mounted on horseback, were a much more visible target and Major Arn, who had previously commanded the 31st Regiment at Fort Donnelson, was killed in this battle, becoming one of the 13,000 Union troops that were wounded, missing, or killed during this two day conflict.

Sometime during this period, between 12 Noon and 2:00 p.m., on the afternoon of April 6th, Joseph Gaither was seriously wounded. According to the pension records obtained from the Nation Archives, Captain McCalla attests that it was in late afternoon. This wound may have been received during a flanking exercise attempted by Confederate forces. Joseph may have looked up from reloading his rifle in time to see another charge coming his way with the troops in very close proximity, probably close to ten yards away. The minnie ball was shot directly in his face with such a force that it entered the right side of the border (bridge) of his nose, severed the nerves of his right eye including the ones that controlled the eyelid, went through the roof of his mouth, broke part of his upper and lower jaw, and exited below his right ear, taking off the lower portion of his right earlobe, and destroying the hearing in his right ear. It is amazing that he survived the gunshot wound and the subsequent ordeal that followed. It was to his advantage that the bullet did not remain lodged in his face or head, but went completely though. Civil War surgeons, who knew nothing about germs, were inclined to probe for embedded projectiles with dirty hands. Family stories recalled and passed down about Joseph, are that a portion of the minnie ball remained embedded and worked its way free in later years.

Between 2:00 and 5:00 p.m., the 3rd Brigade and the 4th Division were outflanked and had to pull back towards the landing, leaving Brigadier General Benjamin M. Prentiss and his 4,000 troops to hold the "Hornets Nest" area on the sunken road. Where was Joseph Gaither during this period?

He may have been removed rearward, away from battle by his close company companions. But it is also possible that he had not been removed from the battlefield due to the constant fighting activity that was taking place at the time. Finally, about 5:00 p.m on the afternoon of April 6th, Prentiss' troops surrendered to the Confederate forces after being surrounded. There were approximately 2,200 men remaining from the original 4,000, the rest having been shot or killed during the constant battle for this left flank of the Union Army at Pittsburg Landing.

The Confederates decided to rest for the evening, due to the lateness of the hour, the fact that it was getting dark, and the lack of human energy left in their forces. They had just fought a pitched battle for over ten hours, and everyone was weary. What they didn't realize was that Union reinforcements were just now arriving! General Don Carlos Buell with 40,000 fresh troops from Nashville was just embarking to steamboat transports from the east bank of the river at 6:00 p.m. and arrived on the west bank, to the relief of many of Grant's troops. Joseph Gaither lay somewhere on the battlefield, or aboard a transport steamer, unable to talk because of his injury (a combination of blood, congestion, drainage and damaged larynx). Perhaps he laid somewhere near the sunken road and the "Hornets Nest."

That evening after dark it started to rain, like it can so often in the South, with attendant lightning and thunder. Grant had stationed the two Union gunboats, the *Tyler* and *Lexington*, on the Tennessee River to keep Confederate troops from advancing past the gully formed by Dill Branch, the left flank of the remaining Union forces. The Tyler and Lexington were firing approximately every fifteen minutes up this depression toward the encamped Confederates. The sounds of their cannon was deafening and kept both the Union and Confederate forces awake all night in the steady down pouring rain.

Joseph Gaither must have been in terrible pain, and barely able to keep his sanity. Hopefully, the shock of the wound saved him from the terrible anxiety of being potentially in Confederate held territory on a battlefield of many dead soldiers with lightning flashes that identified in strange relief all the dead people and animals around him. His grandson, Joseph Gaither, recalls hearing the story related, that the only way his grandfather could get relief from his wound that evening on the battlefield, was with his head propped up between the legs of a nearby dead man. The next day, April 7th, the Union troops, that were now increased by 40,0000 fresh troops from Buell and 7,0000 troops from Wallace, advanced on the Confederates and by 3:00 p.m. had beaten them back to the original location of the Shiloh Church. By later in the evening, the Confederates were retreating towards Corinth, Mississippi.

Joseph Gaither was either found during the day of April 7th by people that knew him, or prepared for evacuation earlier. A James N. Bennett, who was also from the 31st Indian Volunteers, in a letter to Joseph Lewis Gaither from Leadville, Colorado,

the final statement on the certificate giving Joseph a 50% disability. This statement had the same date as the discharge papers, August 2nd, and must have been filled out in Murfreesboro, Tennessee, where the 31st Regiment commander, Colonel Cruft, was stationed during this period.

The assistant Adjutant General, J. W. Wright, appears to have taken the paper work from Athens, Alabama to Huntsville, where Don Carlos Buell signed the discharge papers. He then traveled by train to Murfreesboro where Colonel Cruft filled out the front part of the form. Wright then took the train to Indianapolis, Indian, where he observed the results of Joseph Gaither's mustering out physical on August 8, 1862.

On August 8th, a majority of the personnel from the newly formed 18th Indiana Light Artillery, under Eli Lilly, were undergoing their muster in physical at Camp Morton at Indianapolis. One of the members who kept a personal diary, a William H. Anderson, describes seeing "A man that had been in the Pittsburg Landing fight. He was shot through the face by a small bullet. The shot entered about middle ways his nose; and came out his right ear, which deprived him of sight in one of his eyes. It shattered one jaw bone. He lay under the doctor most ever since; and is now on his way home." This may not have been Joseph Gaither however, the description of the wounded man who is receiving a muster out physical depicts Joseph's location, condition and intentions during the exact time frame.

Joseph Gaither applied for a pension from the U. S. Government on October 13, 1862, hiring J. S. Smith Hunter from Smithville, Indiana, as his lawyer. His statement of service and claim was witnessed by Erwin Grimes and Moses A. Service, both from Smithville, and signed by George A. Buskirk. His pension file of over ninety pages is available from the National Archives.

The office of the Adjutant General in Washington, D. C., reported Joseph Gaither's status to either the San Francisco Pension office or a Washington Territory pension office on July 10, 1865, indicating Joseph had recently moved west.

Joseph must have became interested in Washington Territory, and the Homestead Act, through some close friends that were contemplating migration west, between October 1862 and 1865. He applied and received Homestead #524, Township 4, North Range 1 East in Clark County, Washington Territory between these dates. His neighbor on the Lewis River was John H. Timmens, who attested in pension records that he knew Joseph since 1863. This would indicate that Joseph took the Oregon Trail west in April of 1863.

A good example of experiences coming west on the Oregon Trail during this time periods is presented in *Bound for Idaho*, the 1864 journal of Julius Merrill available from the University of Idaho Press, Moscow, Idaho.

Under the headings of small world category, a John Wilcox from Madison, Ohio fought at Fort Henry, Donnelson, and Shiloh in Company "I" of the 7th Ohio Infantry. Wilcox is an ancestor of Walter R. Degroot's wife. The Degroots currently reside in Arlington, Virginia. I've known Walter, who is in the Foreign Service, Department of State, since 1981. John Wilcox was promoted from Private to Sergeant, to 2nd Lieutenant during this period. He became disenchanted with his Company Captain and resigned his commission in September 1862. In April of 1863, he rejoined the Union as an officer in Company "B", 7th Ohio Cavalry and saw duty in 1864 and 1864 along the Oregon Trail at Forts Kearny and Cottonwood.

During his trip west, possibly in August or September of 1863, Joseph became acquainted with John Timmens. John ran a ferry service for wagons from The Dalles to Portland, Oregon and Washington Territory. John was 13 years older then Joseph and due to Joseph's wound and Civil War service they found they had a lot in common. John had served as 3rd Sergeant in Captain William Bratton's "Lewis River Rangers" during the Indian Wars of 1855 -1856.

#### History of the Webb Family

Benjamin and Lydia Ellige Webb, parents of Mary, Hannah and Sarah Jane, were born in Kentucky and moved to Illinois ca 1830. They moved to Marion County, Missouri and lived there until the spring of 1853, when they decided to take their seven children and head west to better their fortunes. Word of the gold fields in California caused some excitement during the trip, there were some arguments amongst the immigrants and the party split with some heading for California. The Webb family continued on to the Northwest.

The Webbs arrived at The Dalles, Oregon where they were met by John Timmens and his steamboat the North Star. Heading for the Cascades, they encountered strong head winds and were forced to camp three miles down river. Timmens bought some potatoes, which the Webb children were delighted to see because they had not seen any for six months. Young Timmens took particular notice of pretty Mary Webb, who told him they were going to a cousins by the name of Scholl at Bonner's Ferry, 12 miles from Portland. The family arrived in Portland in October of 1853 and settled at School's Ferry on the Tualatin River in Washington County, Oregon.

That winter, Mary Webb wrote a nice letter to John Timmens, so he visited the family to ask for her hand in marriage. Instead, Mary and John decided to elope, taking the steamer *Multnomah* to St. Helens, Oregon, where they were married by Judge Courtland. Her family followed in "hot pursuit" but after finding that they were legally married, they returned home. The Timmens settled on a donation land claim in Clark County. Mary died in childbirth July 16, 1955 and her baby boy died six months later.

Meanwhile, in the spring of 1854, Benjamin and Lydia Webb and their unmarried children moved to Sterlingville, in Jackson County, Oregon, where he struck gold. His name is on the assessment rolls of Jackson County in 1854. He died there in 1855. The family stayed on until 1856, when Marcus Webb, age 23 is found in the census record.

In the spring of 1856, the family headed north and settled in a 159.60 acre donation land claim in sections 24 and 25 on the Lewis River in Washington Territory. The family now consisted of Lydia and her two sons and three unmarried daughters. Her daughter Hannah married John Timmens in 1860.

The next event in the life of Joseph Lewis Gaither was his marriage to Sarah Jane Webb on March 8, 1866. Joseph was twenty-three and Sarah was fifteen. The wedding ceremony was conducted by G. Greeve, a Justice of the Peace in Clark County. The wedding was performed at Lewis River, probably in the home of one of his close friends.

Joseph's first child, George P. Gaither Sr., my grandfather, was two years old when the 1871 census was taken. His small daughter, Sarah J., was one month old.

In 1871, at age thirty, Joseph applied for an increase in his Civil Warpension, which at that time was a hefty \$15.00 per month. The application, dated September 7, 1872, describes the full nature of the wound he received at Shiloh, Tennessee. This is the first real indication of the extreme nature of his injuries. The following description was provided. "Disabled in the following manner to wit: by a gunshot wound striking on the bridge of the nose, passing under and behind the right eye and coming out at the tip of the right ear, by reason of which the right nostril has grown up so that he cannot breathe through it. Also causing a chronic "catarrh" in the head. Has entirely lost the use of the right eye and also the right ear. Is unable to close the right eye and is annoyed by a continual running of fluid from the same." "Has lost a portion of the upper and lower jaw bones, including the socket or joint of the XXXX on the right side. In consequence of this wound has lost many teeth and the rest are constantly decaying that a great portion of the same is unable to perform any manual labor whatever." signed Charles Brown, Attorney

Joseph and or other residents of the Lewis River area convinced Joseph's older brother, John K. Gaither and his younger sister and her husband, John C. and Mary Jane Gaither Miller, to migrate west to Clark County. John Gaither brought his family here in 1874.

John Christian Miller and John Ketcham Gaither ran a country store in La Center for many years. John Gaither was also the postmaster there for about 30 years. He succeeded John Timmens, who was the first postmaster at La Center. On most of the census records and Civil War pension records, Joseph Gaither is listed as a farmer, although later records give his occupation as Mechanic. There is a great possibility that he worked on the river steamboats and equipment that docked at La Center on the Lewis River.

Joseph Lewis Gaither and Sarah Jane Webb had eight children born in La Center. My grandfather, George P. Gaither Sr., who was later an accomplished river boat pilot, was his oldest son and as such accepted a lot of responsibility in the family.

Joseph Lewis Gaither died on September 9, 1895, at the age of 53. J. H. Montgomery M. D. of Portland, Oregon, who treated him from June 29, 1895 until his death, stated that he was suffering from atrophic or dry catarrh of the nose, atrophic pharyngitis, atrophic laryngitis and tuberculosis of the lungs. Joseph left his widow Sarah, and three children under sixteen years of age, Nettie age 12, Frank age 9, and Arline age 3 years. Joseph is buried in La Center, Washington. In 1895, my grandfather George Gaither sent a short letter and enclosed a funeral notice to his aunt in Indiana telling of the sad event. Copies of this are in the Eva Emery Doty book on Gaither history.

The very extensive, well organized records, available from cousin Eva Emery Doty of Indianapolis, Indiana, have made a lot of missing family pieces come into perspective. Especially the Indiana connections that none of the Oregon or Washington Gaithers that I queried were aware of. I hope to find additional information of grandfather Joseph including information on his westward travel from the Oregon California Trails Association, the potential people influenced him in his travel, and the people in Indiana he left behind by studying available manuscripts and additional resource material. I continually update this manuscript as information becomes available.

# Pucker Brush name lost out

IVIr. Burton, whoever you were and wherever you are now, be assured your name lives on.

It is perpetuated in the Burton School and Burton Road, in subdivisions with names like Burtonwood, and in the history of a huge wartime housing project called Burton Homes.

The Burton area lies along Northeast Burton Road and

Northeast 28th Street, east of Andresen Road and west of Northeast 162nd Avenue. There was once a Burton School District, swallowed up when the sprawling Evergreen district was formed.

One of the earliest mentions of Burton was in the Vancouver Columbian of May 18, 1901: "At a school election and by a vote of 15 to 14, the new school house in the Pucker Brush community was named Burton." Another item in this edition noted


there would be no further news datelined Pucker Brush, but news of the Burton area would be forthcoming.

There is no mention, however, of why the school and community were named Burton. Was Burton a pioneer resident of the area? No one today seems to know. The name does not appear on maps showing early property owners, and historians at the Fort Vancouver Historical Museum could find no trace of anyone named Burton.

The area did have a short-lived post office. Burton Homes, established on Nov. 15, 1943, as a branch of the Vancouver Post office, served shipyard and other war industry workers. This post office was discontinued in less than one year.

Burton Homes was a huge complex of wartime housing

units built at the beginning of World War II. It consisted of 1,500 two-bedroom dwellings and was located north of Northeast Burton Road, in the general area of the present Peter S. Ogden School.

Before the war ended, the layoffs began at the shipyards and Burton Homes was closed. These were row houses built only 18 months before but already they had started to fall apart.

On Sept. 20, 1944, the first contract for removing the rows of houses was let. The first 34 homes were dismantled and shipped to Morton, Wash.

On Oct. 13, 1945, the end came when the Vancouver Housing Authority checked out the last three tenants from Burton Homes.

The end of the Burton School District came on Jan. 27, 1945, when seven county districts voted 277 to 87 to consolidate and form the Evergreen district. They were Burton, East Mill Plain, Fisher, Harmony, Orchards, Proebstal and West Mill Plain.

There were three Burton schools over the years,

according to Isabelle Blair, former secretary of the Evergreen School District. One was the building at Brown Seed Co., 12101 N.E. 28th St., she said.

The big old Burton Homes school, located on the south side of Burton Road just east of Andresen Road, also served as a district school building for a time. This building also housed the Burton Homes School for Boys, opened by a religious organization on Sept. 19, 1955.

The new and modern Burton Elementary School, part of the Evergreen district, is located at 14015 N.E. 28th St., just west of the district headquarters.

Another educational institution in the Burton area is the Clark County Christian School, 7915 N.E. Burton Road, that serves students from preschool through high school and which last year graduated its first senior.

Whatever its origins, the Burton area must be about the fastest-growing community in the county. Subdivisions, bearing such pastoral names as Meadowbrook, Foxcroft, Oakbrook and Willowmist, are springing up on all sides.




