

# Recommendation to NOT increase FY98 Dues Justified by Success of "Balance the Budget" Yard Sale despite Wet, Windy, Cold Weather in a Swampy Field By Mary Katschke

Back in February when the Finance and Budget Committee were preparing this year's CCGS Budget, our projected expenses exceeded our projected income for the year by \$490.00. They recommended that we have a yard sale to make up the difference. Counting the sale of excess CCGS equipage and the sale of donated items from 43 CCGS families, it looks like the Pre-sale and the real sale earned the society about \$1,150 after expenses. Besides the wonderful quantity

and quality of donations, a small core of 32 members and friends of CCGS worked very hard to benefit the society as a whole. The table at the end of this article details those you need to thank if you are glad there was not a recommendation to increase dues. If I have left anyone's name off, it was inadvertent and I'd like to know about my mistake. These volunteers worked very hard physically lifting and carrying heavy boxes and working in the wet, windy, cold to set-up, sell and clean-up after the sale. Each person involved in this project deserves our praise and gratitude for service way above and beyond the call of duty. Without them, we would not have succeeded. I so appreciate those wonderful people with vans, station-wagons and pickups who gave up their Friday afternoon to load their vehicles in Battle Ground and were willing to have the merchandise at the sale site at 7:15 a.m. Saturday and then helped unload and set-up in the wet, windy and cold weather. Some of these people like The WARRENs, Jack CROWLEY, the St.JOHNs, and Shirley BACHMAN worked on transport both early in the morning and late in the afternoon. I hadn't expected to see Jack BABOWICZ in the morning or Mary KIER. Nancy ELLIFRIT or Barbara WASMUNDT in the afternoon but their help arrived just in the nick of time. And the Valiant Volunteers who withstood hours of the miserable weather standing on the soggy ground with rain blowing in on them to help sell our merchandise or real heroines in my book! Another heroine deserving of mention is our President, Jane GERMANN, who delivered hot take-out containers of macaroni and cheese for the noon shift. Phyllis and Paul DALE donated to CCGS the cost of the disposing of some items that Goodwill would not take. Thank you.

Jennifer PETERSEN, one of the three co-chairs of this committee, coordinated with Phyllis Hyder, the owner of "Take A Peek" in the Historic Padden House at 5206 NE 78<sup>th</sup> Street to provide the society with a free, outstanding wide-open location on a busy arterial street with lots of parking for our sale. Jennifer also loaned the society three large shelters and 4 tables which she put up two days before the sale. Through the influence of Jennifer, Phyllis Hyder loaned CCGS her brand new shelter to help keep our merchandise dry. Jerri St. John and Wayne and Kathy Cardoza also loaned shelters. Those cute magnetized reminder postcards about the sale that got passed out at the general meeting was another brainstorm of Jennifer..

Pat BAUER, another of the three co-chairs, created a special page within our home page to advertise our sale and created the flyers. It was Pat's idea to have a "by ticket only" presale. Interestingly, almost \$450.00 of the total sales came from the presale event. Pat was a member of the 1995 Parking Lot Sale team. Her tried and true techniques for pricing helped on the 29<sup>th</sup> when her daughter, Linda Emery, joined the rest of the team doing the pricing (Chuck & Marian Thompson, Jennifer Petersen, Kathy Cardoza) and on Yard Sale Day with her table signs (made by her husband, Don) and her Sack sale signs. Both these talented women pressed their husbands into service and have been so supportive throughout all phases of this fund-raising project.

Roy KATSCHKE's willingness to let the committee store the merchandise in his garage and workshop for almost a month and his outstanding ability to load and unload vehicles coupled with his help all day long on 3 October is sincerely appreciated.

Each donation is appreciated but special recognition is due to Tom and Winnie OLSON who brought over 3 van loads of donations and to Shirley BACHMAN, Nancy ELLIFRIT, Jane GERMANN, Kathy CARDOZA, Maureena CRAVENS, Jennifer WARREN, Pat BAUER, Anita ROBERTS, who each brought an entire vehicle full of donations. However the Hon Filing Cabinet donated by Margaret DENNY was probably the most sought after item followed by the color TV and VCR donated by Beverlymae ISAACSON. #### Getting to know our Life Members

Jennifer expressed some regret at not having a formal degree, seeming to have gone to school forever but it ever evident that it has been beneficial to her. She has been employed in San Francisco, Winston-Salem and Seattle. Jennifer has also enjoyed some wonderful trips abroad as sales bonuses. Based on her skills, she decided that she could set up and run a direct mail business better than her previous employers and soon had Boeing and Microsoft among her clients as proof of that effort. She met her current husband, Jerry, in Seattle and they moved to the Salmon Creek area seven years ago. Arlen is currently the President of the William Cannon Chapter of the Sons of the American Revolution (S.A.R.) as well as the State Secretary of the Oregon State S.A.R.

and the first life member accepted under our current dues schedule. CCGS is honored to add him to this special list. He holds the distinction of being the only male individual life member among 24 others.

He was born 24 May 1943 in Roseburg, Douglas County, Oregon. The family moved to Clark County about 1944. He served with the U.S. Army for three years in Ft. Hood, Texas and in Vietnam after basic training in Ft. Ord and Chemical School in Ft. McClellan. Arlen earned a Bachelor of Science

Degree in Chemical Engineering from the University of Washington in 1970 and in 1972 accepted an engineering job in Juneau, Alaska, where he met his wife, Lucy, and worked for the next seventeen years prior to returning to Clark County in August 1989. He is currently a Registered Professional Engineer (Civil) in the Construction Management Section of the Clark County Public Works Department. An article he authored on Wastewater Treatment Plants was published in the "Public Works" magazine in 1985.

Arlen received his initial introduction to genealogy in the sixth grade as a class project but became seriously interested in pursuing this growing hobby in response to his efforts to "date" a long case clock belonging to his uncle with an ancestor's name (Nathan MATLACK) engraved upon it. This couple, who share many interests together, joined CCGS in Fiscal Year 1994 and have renewed as a joint membership every year since. Their jobs preclude attendance at daytime meeting so their life member cards and certificate were presented to them on Saturday, 30 May 1998 at the

CCGS Library where they volunteer as librarians once a month. They've been married 17 years and each have two children from previous marriages.

Dennis was born in 1947 in Vancouver, Washington and is the eldest of six children, who were also born and raised in Vancouver. Tragically, his younger brother, Allen, was killed in a car accident a year after Dennis and Carol married. After graduating from High School, he went to college for a year and served a four year electrician apprenticeship to become the Industrial Electrician he is today. He prefers to go by his nickname of "DOC..." which has an interesting story behind it. At one time, he had a business account in the name of D. R. Clark. He began to receive a complimentary subscription to Reader's Digest, followed by copies of the New England Journal of Medicine, J.A.M.A. and the British Lancet. They were all addressed to Dr. D. R. Clark or Dr. Dennis R. Clark so his fellow electricians started sending for the "DOC" to fix thinas.

The Newsletter was to be distributed at the next meeting following publication. Genealogical or family books would be reviewed in return for a copy donated to the library. Areas to be covered included materials of Genealogical and Historical nature of Clark Co. WA. and early Clarke Co., Oregon Territory. Family genealogies would be Queries were free to members. Bible records and pedigree charts were asked for publishing in the newsletter. Queries were sent to Mrs. Carol Burger and correspondence to Margatetta Zimmerman or Courier was the type used. Mildred Finley.

The eight pages of this issue contained 2 pages of the 1850 census; a listing of cemeteries with reader/chairman; Fishers cemetery records (1 ½ pages); a short excerpt from Lockley's History of the Columbia River (1/2 page) about the establishment of Clark county; and the first 21 land claims in Book A or the court house.

The name Trail Breakers was adopted by Vol. 1, No. 2 issue.

#### GOT IT IN THE NECK

#### Q. M. Sergt. Oliver J. Clancy Pinked by a Mauser

John D. Clancy, on Monday, received a letter from his brother Oliver J. Clancy, the quartermaster-sergeant of company G, First Washington, volunteers, whose name was among those reported wounded at the battle of Santa Ann six weeks ago. The letter is dated Manila, Feb. 8, from which the following extract is taken:

"No doubt, if the newspaper are as enterprising, now as when I was at home, you have heard that I was slightly wounded. I am not very badly hit. A Mauser bullet hit me in the neck, on the right side of the windpipe and passed through my neck without hitting anything dangerous. I expect to be back for duty in about two week. I am out of hospital and am up to quarters now on a pass. There were only four men in G company hit an none killed. Our regiment is now the banner regiment of Manila. We fought our way, from Paco to Santa Ann, a distance of four miles, and then captured the latter place, which we have since occupied. You may be sure G company was not in the rear. We had to ford and swim two creeks while charging."

He spoke of the personal bravery of certain members of the company and stated that his brother, Nicholas Clancy, was acting in the capacity of quatermaster-sergeant while Sergeant Clancy was disabled. . . .

Vancouver Independent, Mar 23, 1899, p.3

Washington's birthday, Feb. 22, 1899

EDITOR INDEPENDENT. – Company G has been in the field constantly for the past three

weeks. Ever since the fifth of Feb. 5th we have been on the march pursuing or fighting the Insurgents daily. Our company has been under fire a dozen times and in three hot skirmishes. Several of the boys and some very narrow escapes, but every man in our company is still alive and in good health. Clancy, Kays and Duncan, who were wounded on the 5th, are recovering rapidly and will soon be well again. . . . While we were peacefully eating dinner behind the graveyard wall, with stray shots flying over us, one bullet swept between Fred Tempes and Sam Lawrence and struck the rifle of Jack Cairns, the company cook, and Jack dropped the rifle as if it were a red hot brick. The boys laughed a little over the occurrence and went on eating their dinner. Altogether the little incident created about as much excitement as when a bug creeps upon a table-cloth at a Salmon Creek picnic.

...Random firing has continued all day, and stray shots are flying over our trenches as I write. Charles Hall, Joe Goddard, Arthus Cochran and Casey O"Donnell are peppering away at some Insurgent sharpshooters.

Yesterday we received the sad intelligence of he death of Dr. Thompson, our regimental chaplain. Dr. Thompson was one of the pioneer preachers of Washington, and his death will be regretted by his many friends in Clarke county and other parts of our beloved state.

on the fold." If the admirers of Lord Byron could have seen Jim Woolf during the charge on Santa Ana Knoll, Feb. 5<sup>th</sup>, they would be able to appreciate the strength and beauty of this poetic line. On one of our flank movements on that memorable Sunday one of our boys fell into a

wayside well and one of the boys had to stop and help him out. This incident gave rise to the following nursery rhyme:

"Ding dong bell, someone's in the well; Who pulled him out? Sgt. Sayres so stout."

For several days succeeding the battle of Santa Ana, Charles Hasson suffered from the delusion that he belonged to G troop, but he has since been made sergeant of the band and now sticks closely to his post.

Our assistant cook, Jerry Fleming, forsook the soup kettle to participate in the charge of Santa Ana, but he has been coaxed back to the kitchen again. Mort and Chape Mills, Roy Parcel, Ralph Wilson and George Spurgeon take to the life in the trenches like ducks to water. They jump up at midnight, fire several rounds to help repel the Phillipinos and within ten minutes are sound asleep again.

Since we have been in the trenches Oscar Ray, Billy Breman, Harry Fleming and Bob Morin have done enough foraging to make Dan Baker retire in shame. G troop almost lives off of pigs and chickens.

This afternoon while Captain Ellrich was pointing out the position of the Insurgents to some Japanese officers, his efforts were kindly assisted by the enemy, who sent a mauser bullet whistling, by their ears.

The boys say that a liberal translation of San Pedro Macati is Saint **Patrick McCarty**. This translation is extremely liberal. *Vancouver Independent*, April 6, 1899, p3.

The remains of **Edward S. Moore**, who was killed at Manila on March 2, were shipped form Manila on the transport Morgan City on March 12, and will arrive at San Francisco about the 15<sup>th</sup> inst. The body will be immediately brought to Vancouver, where the funeral services will be held, conducted by Vancouver lodge No. 6, Knights of Pythias, of which order **Toddy** was an honored member.

Vancouver Independent, April 6, 1899, p3.

Thomas White, a private in Co. B, 24<sup>th</sup> Infantry, was drowned in the over-flow pond,

immediately northeast of the commissary building, on the government reservation, last Monday afternoon, while swimming. White, in company with two other persons, had sum across the pond, and was returning when he gave out and sank to the bottom hardly without a struggle. His body was recovered in about an hour, and was buried in the government cemetery on Tuesday. He was 18 years of age. *Vancouver Independent*, July 26, 1899 p3.

Oscar Baker arrived home from Manila last Tuesday Evening. Oscar has passed an eventful time during the past year, having gone with his regiment the 4<sup>th</sup> Infantry, form Fort Sheridan, Illinois, to Santiago, and participated in the battle and siege of that name, and after returning to Fort Sheridan, he went with the 4<sup>th</sup> Infantry to Manila by way of New York and Suez canal route to Manila, where he participated in the fighting for several months. He was discharged June 15, and came home, having participated in the campaign in Cuba and the Philippines and made a tour of the world with in the space of a year. Vancouver Independent, July 27, 1899 p3.

Geo. M. Duncan, Co. G. 1<sup>st</sup> Wash., arrived in San Francisco last week form Manila and is in the hospital. He was wounded in the arm by a Mauser, and it was thought for awhile that it would be necessary to amputate the injured limb, but he is now getting along very nicely.

Washington, arrived home last Tuesday morning form Manila. He has resigned his commission and will be mustered out Sept. 2. Lieut. Weigle says our boys have experienced lots of fighting, and have always acquitted themselves with honor. The health of the company was good, only a small per cent being sick. Charley Weston and Fred Man\_ were both out of the general hospital, and convalescing. He thinks the boys will start home within a month or so. Vancouver Independent, Aug. 10, 1899, p3.

Among news in another column: [see note about Damphoffer at the beginning of part 3, last issue]

The awful news of the conviction and sentence of death by court martial of Corporal George Damphoffer, Co. B. 16th U.S. Infantry, was received from Manila last Friday morning. It appears that Corporal Damphoffer, in company with several comrades, criminally assaulted a native Filipino woman and for this he and Private Conine were sentenced to be shot, and another comrade 20 years imprisonment. The news was officially confirmed by General Otis on Mondav. and nothing can now save these unfortunate boys except intercession by the president. Corporal Damphoffer was born in this city in 1879, and lived here until he enlisted in the 16th Infantry in 1896. He was through the battle of Santiago and received a wound in the shoulder. Last winter he spent several month at his home here, and departed with his regiment for Manila last March. The sentence will not be carried into effect until the case has been reviewed by the war department. Vancouver Independent, 21 Sept 1899, p3.

The Manila Freedom, of August 10, states that the trial of the three members of the 16<sup>th</sup> Infantry was going on, and that the corporal, presumed to be **George Damphoffer**, would also be tried for neglect of duty, by failing to arrest the culprits. A letter, dated August 20, has been received from the corporal, and he does not mention that he was under arrest. There are some aspects in this case that are beyond understanding at this distance. *Vancouver Independent*, Sept. 28, 1899, p3.

Captain A.V. Richardson and wife left this morning for Fort Thomas where the captain is ordered to join his company.

W.H. Eldridge, chief clerk in the US Commissary Department has received orders to report to the commissary officer at New Orleans for Duty.

Lieut. Elting, who left Vancouver with Troop E, 4<sup>th</sup> cavalry, for Manila, over a year ago, returned home last Saturday, and after his leave of absence expires will join the 6<sup>th</sup> cavalry.

The transport Pennsylvania, bearing the returning regiment of First Washington volunteers,

is expected in San Francisco, October 8, according to the estimate made by the owners of this ship.

Another column reports on the 85<sup>th</sup> US Volunteers organized at the post of Vancouver Barracks leaving for the Philippines. Roster of field, staff and line or officers was included. *Vancouver Independent*, Oct. 5, 1899, p3.

#### OUR COMPANY.

Company G, sent from this city, held its place on the firing line along with the regiment and participated in all its battles and marches. It left Vancouver in command of Captain M. F. Ellrich, First Lieutenant M. V. Rinehart and Second Lieutenant W.E. Weigle. Lieut. Rinehart resigned before the company reaches Manila, and Lieut. Weigle resigned Sept. 2. Sergt. Ried was promoted 2<sup>nd</sup> lieutenant but never received his commission. W. G. Cotchett was then made. Second lieutenant and he resigned to enter the Eleventh Cavalry. Reigle is now 2<sup>nd</sup> lieutenant, Oliver Clancy first sergeant, and Arthur Fletcher quartermaster sergeant.

The company lost one man by drowning, and the wounded were Sergt. Clancy, Privates George M. Duncan, William J. Keys, Robert E. Morin, Joseph B. Doman, J. Weatherby and George McNeil. The company left 23 men in Manila who re-enlisted in the volunteer regiment organized there. Those of the company now in the hospital at San Francisco are Martin L. Kays, T.J. Rinehart, J.T. Sayre, L.B. Smith, J.S. Loubert and Albert Herbert. Kays is reported to be in a critical condition.

The company will be home within three weeks and they will get a rousing old reception. Welcome home our brave boys, you have fought a good fight.

"Our Boys in Manila" was also a column in this issue. Vancouver Independent, Oct 12, 1899, p3.

#### LIEUTENANT HARRY BOUTELLE KILLED

In the dispatches form Manila last Friday, it was announced that Lieut. **Boutelle** has been killed that day. This information, though meager, was sufficient to convince his friends that

Lieutenant Boutelle has met his death, as he was known to be in hat section of the island where the army was operating. His death cast a cloud over the joy of receiving our volunteers, as he was universally liked by a large circle of acquaintances in this country and state. He was the only son of Captain F. A. Boutelle, retired, who is well known in Vancouver and through the army, his father having served for a member of years in the department of the Columbia, and was stationed here as inspector of small arms practice form 1892 until 1894.

Lieutenant **Boutelle** was appointed to the Third artillery July 8, 1898, transferred to the Fourteenth infantry December 24, and transferred back to the Third artillery in January, 1899.

Lieutenant Boutelle had seen hard service with his regiment while in the Philippines, and showed a degree of courage and soldierly qualities which gave promise of being the beginning of a brilliant career for the young officer had his life been spared. Vancouver Independent, Nov. 9, 1899, p3.

# A ROYAL WELCOME Given to the Returning Volunteers Last Saturday Evening

Our boys are home. Eighteen months service in the army of the United States a year of which was spent in the Philippines, and seven month of which was spent on the firing line, had not wrought great havoc among them; but yet they all look the worse for wear and fear of their service. Several come home broken in health and debilitated, and one or two \_\_ained, but time will doubtless heal these and before many months they will be themselves again. They have seen service, and hoard service, too, and every mother's son of them are glad to get home and be among friends again. Perhaps they now know what their friends and relatives think of them, and they also know they are welcome, thrice welcome home.

The Washington regiment landed in the Philippines in November, 1898, and upon landing was assigned to outpost duty I the Paco district, and were there until February 4, when the Philippine insurrection broke out and they took to the fight and stayed with it until August 31. No volunteer regiment in the islands had so long a service as our regiment, and none have participated in more battles than they. Their fighting

opened at 2:30 o'clock on the morning of February 5, when every one of the twelve companies formed a part of the battle line in front of Santa Ana, during the first attack by the rebels on Manila. The fine reputation they earned at this battle was sustained during all the campaign. In all the First Washington engaged in Twenty-seven battles and innumerable skirmishes, and in every one of these, Company G took an active part. As Captain Ellrich said at the auditorium, "when there was a light in sight, Company G. was always there."

It was definitely learned last Thursday that the boys would arrive in Portland on Saturday, and from the first ferry until after noon, fond mothers, and anxious fathers went their way to Portland to greet their sons as soon as the train should arrive. By 4:30 when the train arrived over a hundred Vancouver people organized themselves into a reception committee, with Co. G. Washington National Guard, under command of Captain Sparks, as an escort. The train was in two sections, and out boys were on the first car. They come in with a cheer and were greeted with cheers from one hundred onlookers ... ... The boys were escorted to the Auditorium, where a sumptuous repast had been prepared. The boys lost no time in getting on the outside of a goodly portion of this. Parents were invited to participate in the banquet with their sons. The hall was gaily decorated with flags, bunting, cut and potted flowers, and set of by the brilliantly shaded lights, making a magnificent display of colors.

The exercises of the evening then came on. Mayor Eastham delivered a brief address, extending a hearty welcome home to the volunteers. Addresses were also made by Judge A. L Miller and Chaplain L. R. Groves. Miss Lennie Snodgrass read an original poem entitled "Vancouver's Welcome to Her Boys," written by Mrs. Clara L. Ryan of this city, which was warmly applauded. : Mrs. E.E. Coovert sang "The Star Spangled Banner" and other patriotic selections. The appearance of Captain Ellrich upon the platform in response to persistent calls from the audience called forth another ovation. He made a brief address and was followed by Lieutenant Reigle and Glenn Ranck. Owing to the crowded condition of the hall, it was impossible to hear the speakers, but their addresses were all good, short and were well chosen.

Six of the boys, Charles Weston, Nelson T. Hubert, Nicholas Geoghegan, Jos. Trotter, Arthur Cochran and Chas. O'Donnell arrived Friday evening.

#### CLARK COUNTY, WASHINGTON

(from Vol. 1, No. 1, page 8, Trail Breakers)

"What is now know as Clark County was originally called the District of Vancouver. It was established by the Oregon Provisional government on June 27, 1844, and included all that part of Oregon lying north of the Columbia River. On Dec 22, 1845, the provisional legislature changed the title from the district of Vancouver to Vancouver County. On July 16, 1849, the Territorial Legislature changed the name from Vancouver County to Clarke County. Clarke was in honor of Capt. Merriweather Clarke of the Lewis and Clarke Exposition. Gen. Joseph Lane, first governor of Oregon territory, appointed William Ryan sheriff of Clarke County on Sept. 8, 1849. David Stone was appointed prosecuting attorney for the third Judicial District, which included Clarke, Clatsop and Lewis counties. The first election for county officers was held of July 1, 1850. A quarter section of land was granted for a county seat. Fisher's Landing was considered but was never voted on. The site finally selected was the present site of Vancouver, but in the early days was called Columbia City. The first purchases of a lot was John Kelly, for lot No 5 in block 2 on Oct 22, 1850, for \$1,000. But this land claimed by the Hudson's Bay Co, and by the War Department, as a pat of the reservation and by Amos Short and later his heirs, and part of by the Catholic Church. After much legal debate a site was finally selected and on January 26, 1855, the name was changed to Vancouver. A contract was given to C. C. Stiles to build a courthouse on Feb 18, 1854, to cost \$983. This building was used as a military barracks for the volunteer force, in the Indian was of 1855-56. S. D Maxon was given a contract to build a jail.

The act establishing Washington Territory, from the then Oregon Territory was passed on March 2, 1853.

There were five U. S. land offices in Washington Territory; Vancouver, Olympia, Walla Walla, Spokane Falls and North Yakima.

On the following pages we have listed some of the Original Locators of Land in Clarke County, Oregon Territory.

### POSTAL INFORMATION

Typed envelopes will reach addresses one day earlier than those handwritten.

Postal machine scanners read envelope from the bottom up, starting with the zip code. If anything is typed lower than the zip code, the letter will be held until it can be manually sorted. Mail will also reach its destination at least a day sooner if you use zip codes, and using the additional 4-digeit number is even better.

Self-addressed stamped envelopes (SASE) folded inside a letter is a violation of postal regulations because they jam postal sorting machines. It is recommended that you use a No. 9 envelope, which will fit inside the regular No. 10 business envelope without folding. Also, the post office sells a "message reply" double postal card for forty cents. If you're requesting a brief reply this is the most economical way to go.
