## VANCOUVER POST OFFICE NEWS LETTER

From July 1944 through January 1946, the Vancouver Post Office published newsletters that were mailed to their employees who were serving in the armed forces. CCGS member Pat Bauer shares these newsletters from her collection.

Vol 1 No. 2      August, 1944      Free to YOU

Ye olde editor - Leo Belisle

Time that we state our editorial policy. We believe in our job, in the new job you are doing, and we'll be glad to see you back at your old job. We stand for freedom of the press, but who has enough sugar for the grapes. Women should be in industry . . . during fishing season. Pursuit of happiness is OK if people wouldn't call you a chaser. Puns offset guns. Allow us our gags. If you've heard ones like 'em, credit us with giving an old tale another twist. This News Letter is a creation by the entire Post Office personnel. A return address means someone had to hold this baby pending changes. Hope you appreciate the Letter, knowing that paper is scarce. Then why am I using up so much?

Card was received from Selma and Ed Bunkley who are, at present, sojourning at Ed's home in Brunswick, Georgia.

Eugene (Jack) Ritter reports from Camp Fannin, Texas, such language, tsk tsk. Carl Wastradowski is at the Main PO at Farragut, Idaho, and he also has some nice things to say about the News Letter. (Atta boy, Carl).

Dwynella Taylor is home on furlough from Farragut, Idaho. She says lots of times she does not go ashore when she gets liberty, wonder what the attraction is, or should I say "Who?"

Cpl. Ralph C. Chapman writes that he has been transferred from the Military Police to the 232d Inf., and is at present at Camp Gruber, Oklahoma. Del Echtle writes from Astoria, Oregon, saying some nice things about the News Letter. (and do we eat it up!) Earl Herman writes from San Francisco, California, with some practical suggestions for relieving Walt Strong's trouble with his "stool." W.E. Died - At his residence in this City March 6th, 1876 at 10 o'clock p.m. **Joseph Petrain** in the 56th year of his age. **Joseph Petrain** was born at St. Francis in the Dominion of Canada in the year 1820. He was one of the earliest settlers of this county having emigrated to Vancouver in his boyhood in the year 1836, and was at that time in the employ of the Hudson Bay Co. in whose service he remained for many years. He was married in the year 1848, went to the California mines in 1849 and shortly thereafter returned to Vancouver. With the exception of the time spent in the mines he has been a resident of Clarke county since he came here 40 years ago. He faithfully served the county as Judge of the Probate court for several years. He was a man of energy and excellent business capacity and leaves a wife and nine children to mourn his loss. About eight days ago he was taken sick with pneumonia and in spite of all the efforts of skillful physicians gradually grew worse until he died. His death is a irreparable loss to his family and the community mourns the departure of a good citizen. And Messrs. **Fletcher**, **Steward**, **Cradlebaugh**, **Caples** and **Daniels**, of Vancouver. **U. S. Marshal Hopkins**, and **Sheriff Coffey**, with their Bailiffs and Deputies were also in attendance.

Tuesday afternoon the following named grand jury was empanelled sworn of charged. **Jacob Proebstel Jr.** **Foreman**, **J. H. Campbell**, **Jacob Proebstel Sr.**, **E. N. Kimball**, **P. H. Perkins**, **Henry Shoemaker**, **Thos. Gillihan**, **H. D. Tenny**, **J. H. O'Donnell**, **A. F. David**, **P. M. Buchanan**, all of Clarke County. **S. H. Jones**, **Hugh Adams**, **Jo<sup>a</sup>**, **Haskell**, **John Cropton**, of Klickitat and **M. Sherridan**.

**Judge Greene** read a written charge to the grand jury which was listened to by them with marked attention and approval. The charge was an able document, comprehending the broadest scope of political morals and embracing the most cogent pertinent reasons why grand jury men who are placed foremost by the people for the time being to bear the brunt of executing the law should be faithful in the

**H. L. Caples Fxecutor vs. Jas. Holmes**, also **H. L. Caples Executor vs. William Shepard**, certified from Justice **Hayden's** Court, decision reversed.

**James M. Thompson vs. A. S. Castbrook** default and judgement.

**John M. Carty vs. S. S. Hawkins** etux, confirmation of sale.

**Jonathan Helterbrand vs. James Bybee**, action for damages, cause continued for the term.

**Joseph Petrain vs. School District No. six**. Suggestion of death of Plaintiff and administrator made party on the record and cause referred to the Judge for decision of the law questions involved.

**G. W. Johnson etal, vs. the Cascade Railroad Company**, action for \$100,000, damages for alleged wrongful taken of land for railroad purposes, motion for judgment in favor of defendant on the pleadings denied, cause on trail with a jury during the afternoon of Wed and Thurs. Judge Strong for the Defts, and **J. N. Dolph** and **J. M. Fletcher** for the Plffs.

On Thurs the following named persons were admitted to citizenship **Henry Eves**, **Dennis O'Brien**, and **Patrick O'Donnell**.

On Thurs morning the grand jury returned into court four true bills of indictment on the part of the Territory, and were discharged on the part of the U.S.

In the case of **Johnson etal. vs. The Cascade Railroad Co.** after the argument of council and the charge of the court the jury retired and in an hour there-after were ready to return a verdict. At six o'clock the jury came in and gave their verdict in favor of the plaintiff for \$5400, damages. Judge Strong gave notice of a motion for a new trial.

Indictments for selling liquor to minors have been found against **Mat. Brown**, **John E. Francis** and **J. E. Sipe**. The defendants were arraigned and plead guilty. Two other indictments were found and warrants issued for the arrest of the parties but at the time of going to press we are unable to learn anything further in regard to them. The grand jury returned not a true bill against **L. A. Lyons** and others for riot.

Last Saturday sentence was pronounced by the court against **M. HEALY**, **MAT. BROWN**, **E. J. SIPE**, **JOHN E. FRANCIS** and **JAMES SHEA**, for selling liquor to minors. All but **SHEA** were sentenced to pay a fine of \$20 each and costs, be imprisoned one hour and have their licenses revoked. In consideration of the fact that **SHEA's** license had just been renewed his fine was fixed at \$5. Various civil causes have been disposed of during the term as follows:

**G. W. JOHNSON et al. vs Cascade Railroad Company** on motion of **J. M. FLETCHER**, the attorney for the Plff. \$4,400 of the verdict was remitted and a judgement entered for \$1,000.

**THOMPSON vs. ESTERBROOK**, judgment entered for plaintiff, for \$779.98.

**JOS. WISE vs. HENDRICKSEN & TATE**, judgment entered in favor of plaintiff.

Administrators of **JOSEPH PETRAIN vs. The Vanc. School District**; the court sustained the action of the plaintiff, and made the temporary injunction perpetual.

**O'CONNELL** against **KEEGAN**, judgment entered for plaintiff in the sum of \$703 and costs, and for order of sale of mortgaged premises.

**LYONS** and **KELLY** indicted for affray had their trial on Tues. **J. M. FLETCHER** appearing for the deft. **KELLY** and **J. H. CRADLEBAUGH Esq.** for the deft **LYONS**. The jury returned a verdict of guilty, and recommended the deft **LYONS** to the mercy of the court. **LYONS** was let off with a fine and a good sober talk by the Judge, who complimented him for being a young man of courage but recommended him to hereafter use his courage in a better cause. **KELLY**, the soldier was sentenced to two months imprisonment in the county jail.

Upon the trial of **LYONS** and **COX** for affray the jury returned a verdict of not guilty.

It is said that an indictment was found against an individual for perjury committed in the procurement of a marriage license and "that as soon as the warrant issued the inditee departed out of these coasts."

**GEORGE GOODMAN** was in court Tues. and testified in the case of the Territory vs **LYONS & KELLY**. He looks like a used up individual.

The petit jury was discharged on Tues. and the grand jury which was also discharged made the following report:

We have examined the several county official offices and find them all kept in a good and lawful manner, also have examined the county jail and find it neat and can with no prisoners in it. ## SEMANTICS: THE STUDY OF MEANING

By Gene Kuechmann

As I started to compose an article for this issue, I wrote, "To a genealogist, a family Web page is not a credible source." When I re-examined this sentence, I knew I was in trouble. We tend to "bat around" certain terms without having a clear sense of their meaning, and this realization sent me to my unabridged dictionary to look up some terms frequently encountered in genealogy.

**Source:** Any thing or place from which something comes, arises, or is obtained.

**Evidence:** Ground for belief; that which tends to prove or disprove something; proof.

**Proof:** Evidence sufficient to establish a thing as true, or to produce belief in its truth.

**True:** Being in accordance with the actual state or conditions; conforming to reality or fact.

**Fact:** That which actually exists or happened; reality; truth.

**Reality:** State or quality of being true, not merely ostensible (professed), nominal, or apparent.

**Data:** Facts, information, statistics, or the like, historical or derived.

**Clue:** Anything that serves to guide or direct in the solution of a problem.

**Reliable:** Trustworthy; dependable in accuracy.

**Accurate:** Conforming to truth; free from error or defect; precise; exact; correct.

**Credible:** Capable of being believed; believable.

**Valid:** Sound; just; well-founded.

**Probable:** Having more evidence for than against.

**Computerize:** To control, perform, process, or store (information) in an electronic computer.

**Digitize:** To convert (data) to digital (numeric) form for use in a computer, as by scanning.

**(Computer)-enhanced:** Made greater; magnified (by computer).

**I now offer the following opinions, based on these definitions:**

Probability is a reachable goal in genealogy. Truth, fact, and reality are more elusive.

The value of data as evidence depends on the reliability of its source

I can reach a valid but false conclusion from credible data.

A family Web page may be a credible source.

Digitizing sources (by scanning) and computer-enhancing digitized sources should not affect their reliability one way or the other.

Digitized sources are easily altered in the computer.

**Here is an exercise for you.** Classify each of the following popular sources as evidence or clues, and don't hesitate to add conditions regarding reliability and credibility to your classifications (assume the reliability of the digitizing and enhancing processes.)

**Example:** An original public record is generally credible evidence if the recorder was reliable.

“When they used to ask me [if I’d been wounded], I would reply ‘No, I was lucky . . . Now I say . . . Everybody was wounded in Vietnam . . . everybody.’” John C Dibble

Fifty-six men are honored on the War Memorial outside the county court house entrance for their service during the Vietnam War. Two panels have been dedicated to area men (no women appear on this list) and have been placed on the north and south sides below the World War II lost. The list includes men from surrounding area. Five new names have been listed below: Anderson, Atchley, Baker, Hall, Lowery; corrected spelling for Fjermestad. Not all these names appear on the Vietnam Memorial Wall in Washington, D.C. Names on that memorial were limited in geographical location and the parameters of the Clark County Committee included other factors. \* denotes additional information, P denotes photo.

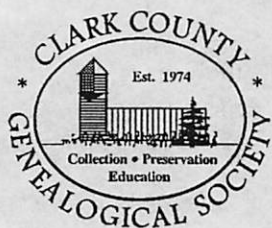
