

PATERNAL ANCESTRY & ENGLISH COLONIAL ORIGINS OF LOVINA O. WETMORE, A NINETEENTH CENTURY HOMESTEADER ON THE MAMOU PRAIRIE by Elba Anthony Dardeau, Jr.

One member of the GATY family who left Illinois in 1878 to homestead on the Mamou Prairie of Louisiana, was Lovina Orr WETMORE, the wife of Jesse Franklin GATY. Two of the GATY children, Charles Albert and William Henry, and Jesse Franklin GATY's mother, Nancy FEARS, accompanied Lovina and Jesse Franklin to Louisiana. Later, other family members joined this group (1).

Lovina's ancestry remained a mystery until October, 1980, when her Bible, the WETMORE-GATY Bible (2), was located in Ville Platte, Louisiana. It had probably not been opened since her death in 1917. Shortly afterwards, a century-old published WETMORE genealogy (3) was also found.

This article covers the WETMORE/WHITMORE line beginning with Thomas WHITMORE (ca. 1615-1680), who emigrated from England to the New World in 1635. It continues for nine generations (indicated by Roman Numerals) and traces the lineage from Thomas WHITMORE to Lovina WETMORE's children and grandchildren, as follows:

Each of the above names in Generations II through VII are underlined in the text. Principal sources of data used to prepare this article were the published WETMORE genealogy (Generations I through VII) and the WETMORE-GATY Bible (Generations VII through IX). Supplementary data sources are noted where appropriate. Corrections or additions to these data are welcomed.

Settlers from Plymouth Bay, Massachusetts established themselves along the Connecticut River in 1634. One of the first to arrive in the new Connecticut colony was Thomas WHITMORE, who was born ca. 1615 in England. His ship departed from the western part of England (Bristol?) and arrived in Boston in 1635. Neither the parents nor any other relatives of Thomas WHITMORE have been located in England. However, the WHITMORE surname can be found among the gentry of Cheshire, Stafford, and Salop. Possibly, Thomas was related to the other WHITMOREs of New England. Unfortunately, no connection can be established. Generations I and II, Thomas WHITMORE and his family

Thomas WHITMORE, his father-in-law, John HALL, Sr., William SMITH, Samuel STOCKING, and Robert WEBSTER were the first to settle the plantation of Mattabesek, which on 23 Nov. 1653 became the town of Middletown, Connecticut. Thomas was made a "freeman" by the Ceneral Court at Hartford on 20 May 1652. The qualifications required to become a freeman at that time were that a citizen be "orthodox, twenty years of age, and worth\$200 (pounds). He was also required to take an oath of allegiance to God and to the crown. Later, Thomas represented Middletown at various sessions of the General Court.

Records on the three marriages of Thomas WHITMORE are as follows:

Thomas WHITMORE married (1st) on 11 Dec. 1645 to Sarah HALL a native of Hartford who died 7 Dec. 1664/65. Thomas WHI MURE married (15t) on 11 Dec. 1049 to Saran MALL a native of nartion who used / Dec. 1004/05. Sarah was the daughter of John HALL, Sr., b. ca. 1584 England, d. 26 May 1673, and Ann WILLCOCKE, d. 20 July 1673. Ann WILLCOCKE was the daughter of John WILLCOCKE. John HALL, Sr. had been at a family estate before he left England; he came to New England ca. 1633. HALL was one of the original grantees and the third appointed town clerk of Middletown.

Thomas WHITMORE married (2nd) on 3 Jan. 1667 to Mary PLATT who died in June 1669 after giving birth to her only daughter, Mahitable. Mary was the daughter of Richard PLATT of Milford, Connecticut and widow of Luke ATCONSON (ATKINSON?).

Thomas WHITMORE married (3rd) on 8 Oct. 1673 to Katherine (Catherine) LEET who died 13 Oct. 1693. Katherine was the widow of ______ ROBARDS.

Interestingly, five of Thomas WHITMORE's children, Samuel, Joseph, Sarah (II), Mahitable and Hannah (II), all married into the BACON family. Three other children, Hannah, Israhiah, and Beriah, married STOWs.

Thomas and his children used the surname, WHITMORE, in the public records of the Connecticut colony. The change of name from WHITMORE to METMORE probably began in the third generation. Possibly, some of Thomas' children also changed their name. By the fourth generation, the WHITMORE surname was no longer used. Reason for the name change has not been established.

The Probate Court records of Hartford contain the Last Will and Testament of Thomas WHITMORE, Sr., dated 20 July 1681. He died on 11 Dec. 1681 at the age of 66 years. Besides his widow, Katherine LEET, sixteen of his children ranging in age from one to thirty-six years, survived.

Nathaniel BACON, Sr. married a second time to Elizabeth PERPONT.
- 8. Israhiah WHITMORE, b. 8 March 1656/57 Middletown (9 March 1656?), d. ca. 1742, married 13 May 1692 to Rachel STOW, b. 13 March 1666/67, the daughter of Rev. Samuel STOW, b. 1622 England, d. May 1704, and Hope FLETCHER, daughter of William FLETCHER. Israhiah WHITMORE was Magistrate of the Town of Middletown from 1721 through 1728. Rev. Samuel STOW, son of John STOW and Elizabeth BRIGGS, d. 21 June 1638, came from Kent, England to Roxbury, Massachusetts in 1634, graduated from Harvard College in 1644, studied for ministry and became first pastor of the First Orthodox Congregational Society in Middletown.

Beyond Generation IX Lovina Orr WETMORE and Jesse Franklin GATY had three children but only their youngest son, William Henry GATY, had offspring beyond a single generation. Four of Henry's daughters from his two marriages have descendants. Lovina's progeny have Louisiana surnames such as THIBODEAUX, MANUEL, FONTENOT, KNIGHTEN, GWYN, DUPUIS, DECUIR, DIDIER, BENNETT, DARDEAU, and HANKS. Outside the boundaries of the state, there are a number of others who can count themselves among her offspring.

JEANNE MONTFORT GUILLORY by Albert Tate, Jr.

In <u>La Voix des Prairies</u>, Vol. 3, #10, pp. 52-54 (July, 1982), certain information about the birth and parentage of Jeanne MON(T)FORT, a native of Belle-Ile-en-Mer, was set forth, as well as conjectures about further directions of research. The source of this data was Mlle. Marguerite Daligauit authoritative local historian of Belle-Ile, today in the Department of Morbihan in France. The present addendum will include certain additional research information furnished by Mlle. Daligauit by her letter of 21 April 1982 to the writer.

My initial paper had documented Jeanne MONTFORT's birth at Le Palais, Belle-Ile, on 8 February 1693, and it included Mlle. Daligauit's suggestion that the marriage of her parents, Nicholas MONTFORT and Renee SAMZUN, would probably be found in the registers of the other three parishes (Locmaria, Sauzon, Bangor) of the island, because "Samzun" was the surname of a long-established family of Belle-Ile. In the 21 April letter, Mlle. Daligauit further reports:

"I have not found the marriage of Renée SAMZUN and Nicholas MONFORT in the other parishes of the island. Then is it (the marriage) Belle-Ilian (billiloise)?

"One must not forget that the Capuchin (monk or perhaps author's name, Le Capuchin) born in 1677, author of the first history of Belle-Ile-en-Mer, has written thus: 'More than seventy-five families had lost by it (construction of the new fort?) for them and their descendants their houses and even the ground of their property. That forced most of these families to cross the sea, in order to search for what to live on the continent, to establish themselves there. At the end of five years 14 May 1694...' (Note by Albert Tate, Jr.: In the first article, Mile. Daligauit speaks of the destruction of the old town to build the new fort, with indemnities paid in 1794 to those who had lost their property to the fort during its five years of construction between 1689-1694.)

"But where to search? Auray, Vannes, Nantes, Quimperle.....?" (End of Translation)

Further Lines of Inquiry

The writer now suggests further avenues of research to document the marriage of Jeanne's parents, Nicholas MONTFORT and Renée SAMZUN, ca. 1685 in continental France, and of Jeanne MONTFORT and Francois GUILLORY, ca. 1707-1713, either in continental France or in the French Colony of Louisiana, probably in the Dauphin Island (Mobile) area.

MONTFORT-SAMZUN Marriage: Mlle. Daligauit's research has negatived that the marriage occurred on Belle-Ile, but she suggests that Renée SAMZUN may have been of a Belle-Ilian family transplanted to continental France as a result of the destruction of the "old town" of Le Palais because of construction of the fortification there 1689-1694. As she suggests, location through the bride of the parish of marriage will be difficult, because of the number of potential parishes to be searched. However, if her earlier suggestion is correct that Nicholas MONTFORT was an engineer or officer of Marshal VAUBAN (1633-1707) in his great French fortification program, it should be possible through the military archives in Paris to locate, if not reference to the marriage, at least Nicholas' movements immediately prior to his appearance in Belle-Ile for the baptism of his child, Marie, on June 12, 1689.

However, works published about the famous VAUBAN may provide a swifter means of obtaining the information. In the brief afternoon available to him for research at the National Archives in Paris this summer, the writer located the title of a work that may provide this clue: Abrégé des services du marechal de Vauban f it par lui en 1703, published by Augoyat, Paris, 1839. The catalogue described this summary "agrégé" as an exact and complete chronological summary of the marshal's military career, with interesting notes by the editor. The work was unavailable to me at the time, but the original and perhaps a 1911 is available at the Biblioteche Nationale in Paris, as well as possibly in American libraries. Through the indexed (but incomplete) list of military pensions, the writer located original documents signed on 11 Sept. 1739 and 2 Sept. 1740 granting a year's pension in each instance to the "Sieur de Montfort". We of course do not know if this is Nicholas, father of Jeanne.

(Jeanne Montfort Guillory Cont'd)

Marriage of Francois GUILLORY-Jeanne MONTFORT: The best hypothets for this marriage (see earlier paper) are that it probably occurred either after Jeanne or her father came to Mobile (if they did) in connection with the construction of Fort Condé in Mobile in 1710, or else on one of the voyages of Graveline or the Chauvin brothers from Mobile to France (LaRochelle, Rochfort, etc.) 1708-1710, if Francois accompanied them to France. Since Francois moved to Dauphin Island in 1709 and was there to repel a British attack in 1710 (see earlier paper), this would tend to narrow the search to 1708 voyages. Again, Nicholas MONTFORT's service record may show that his movements intersected with Francois', either in the Mobile area or in France. Although the surviving Mobile civil records do not show the marriage, it is possible that the marriage was performed by a military chaplain (see below) if MONTFORT was a military man.

Jeanne MONTFORT's Possible Re-Marriage: As the earlier paper notes, Jeanne was born in 1693, widowed before 1726 by Francois' death, and quite possibly alive when her son Gregoire married at Mobile in 1739. Considering the shortage of women in the colony, it is not readily conceivable that this 33-year-old widow did not remarry. However, Jacqueline Olivier Vidrine has searched the civil records of marriages in the Mobile Diocesan Register for the period, but nevertheless finds none for a MONTFORT, nor any for a TORTILLIER (see below) immediately preceding September 1744. However, in Governor Vaudreuil's papers note is made of a marriage of a soldier TORTILLIER of Derneville's Company to a widow MONTFORT (1tr. 8 Sept. 1744), and of Vaudreuil's disapproval of it because the woman was of an age not to have children, as well of the governor's injunction that in the future permissions to marry must come from him. B. Barron, The Vaudreuil Papers 344 (Polyanthos, 1975). Since this marriage is not in the civil records, it was probably performed by a military chaplain, possibly locatable through military archives in Paris. On examination of a photocopy of the original 1744 Vaudreuil letter, it includes no clue as to whether this "widow MONTFORT" is Jeanne, widow of Francois Guillory (and of perhaps an intervening husband also).

JOHN M. SMITH by Sherry Manuel

John Moses SMITH was born on 26 Oct. 1846 in Grand Chenier, Louisiana, according to his civil war pension record. His brother, P. (Pickney) C. SMITH was born two years later in 1848. Their father died while the boys were quite young and their mother remarried an ARMSTRONG. In the Spring of 1864, John joined the Texas Cavalry (Ragsdales Battalion, Company B, attached to Griffins Battalion) at Nibblets Bluff near Vinton, Louisiana. He served as a bugler and prisoner escort in the Beaumont, Texas area. Near the end of the war, he was transferred to Hempstead, Texas and it was from that location that his company was disbanded at the end of the war.

The next records on this family appear in the St. Landry Parish Courthouse. Marriage #5437 records that on 16 Aug. 1869, John M. SMITH married Mary Anaise HENRY. On 5 March 1874, his brother P. C. married Hortense COURT.

P. C. SMITH appears to have lived in the Mermentau area until his death, based on tax assessments and land records in Acadia Parish. P. C. SMITH's succession lists ten children: Oniel who married Euchariste LANDRY, Emile who married Euma BENOIT, Manuel (Emmanuel) who married Frances LEBLANC, Emma who married Louis HENRY, Eumea who married Ozeme BENOIT, Raymond, Alice who married Curly MIERS, Armand, Ida who married James FORMAN, and Leonie.

John SMITH and Mary Anaise HENRY lived in Ward 5 of Acadia Parish and had four children: William (Buddy), Ellen who married Ariste PESHOFF, Adeleine, and Josephine. Mary Anaise HENRY died and John remarried on 8 May 1882 in Cameron Parish to Virginia YOUNG, b. 24 June 1865, the daughter of James YOUNG and Irene DOUCET. At the time of his second marriage, John owned a sailboat and made his living by hauling freight on the Mermentau River from Mermentau to Cameron.

John and his second wife Virginia, had nine children: Matilda who married John Aurelian HEBERT, Elridge who married Ella MURPHY, Estelle who married Adam DAIGLE, Mary who married Lawson K. BONSALL, Emma who married John DAIGLE, Ida who married Paul FLOYD, Virginia who married Burton LEMKE, Irene who married Bob CARSTARPHEN and Margaret. The family lived in Acadia Parish for a while, but in 1896 they moved to Cameron Parish in the area around Creole, Louisiana and remained there until their deaths. John SMITH died 31 May 1935 and Virginia YOUNG died 15 Aug. 1947. Both are buried in Sacred Heart Cemetery in Creole.

The parents of John and P. C. are still shrouded in mystery with only a few tantalizing leads to inspire those who search for them. The 1850 Census for Calcasieu Parish lists a Mrs. John M. SMITH, a Mrs. Peter SMITH and two boys, John (age 4) and Pichney (age 2) living in the same household. A John M. SMITH (perhaps their grandfather) is listed on the 1840 Census for Lafayette Parish. Henry Perrin's book, Southwest Louisiana Biographical and Historical, has information on a John M. SMITH who was one of the first settlers in the Grand Chenier area. So far, the rest of this family's story lies in the ashes of burned courthouses and church records. I request that anyone who has information on this family or who is interested in them to please contact me. I will be delighted to share any information that I have gathered. Sherry Manuel, P. O. 

THE GLAZE FAMILY OF SOUTH CAROLINA & LOUISIANA by Dr. Robert M. Helmer

Gabriel GLAZE who married Philodocia was among the early settlers of the Charleston community, arriving there from England in the latter part of the seventeenth century. In 1694-1696, he purchased Eagles Plantation, Traveller's Rest, and other lands in Berkeley County from the Lords Proprietors of the province. He served as a member of the Commons House of Assembly from 1695 to 1698, was a planter, a Notary Public, Justice of the Peace, and one of three commissioners appointed to advise on the fortification of Charleston. Upon his death in 1699, his lands were bequeathed to his eldest son, also named Gabriel, who seems to have died in 1712 or thereabouts - preceded in death, however, by another son named John. Both appear to have been without issue.

At that time, the surviving heirs of this second generation in America included the sisters (1) and (2) Ann, and their brothers (3) William and (4) Malachi, than a minor child. The first daughter (1) was in all likelihood named Sarah, married to George BARNETT, and had issue, George BARNETT, Jr. and Philodocia BARNETT. The second daughter (2) Ann GLAZE, married BRANFORD. William GLAZE (3) married "Siky" I'OOR, a sister of John I'OOR of Charleston, but apparently had no direct heirs at the time of his death in 1730. Malachi GLAZE (4), born between 1690 and 1698, became a planter, a Notary Public, Justice of the Peace, and a member of the Commons House of Assembly. He married after 1773 to the widow of Colonel Charlesworth GLOVER, her name was Sarah of St. George's, Dorchester. Malachi GLAZE was appointed a Captain in the St. Augustine expedition and died there of "the flux" in 1740. It appears from the records that Sarah GLOVER GLAZE was a JACKSON and, also, that Malachi GLAZE had a former wife who may have borne the surname JACKSON. Both were named Sarah, nevertheless, and the first wife was very likely the daughter of Captain John JACKSON of Pond Pond, Colleton County, South Carolina. Known children of Malachi GLAZE are: Sarah GLAZE, Esther GLAZE, John GLAZE, William GLAZE, Malachi GLAZE, Lawrence GLAZE, James GLAZE and Susannah GLAZE, the latter two in all probability being issue of the later marriage.

Children of Malachi GLAZE:

Sarah GLAZE of St. Philip's, Charleston, married 1st Richard BAKER, of St. Philip's on 13 Sept. 1/31 and married 2nd Rivers STANYARNE of Wadmalah Island, Colleton County. She had issue the following: Joseph, James, William, and Sarah, the latter two born after 1738.

Esther GLAZE married a WILSON.

John GLAZE, b. before 1723, d. 1769, and Mary, his wife, were the parents of two children, John, Jr. and Mary. John Junr., b. ca. 1750, d. ca. 1818 and in later life known as Colonel GLAZE, was a member of the First Council of Safety of the Revolutionary Party and of the Board of Commissioners of Highroads of St. George's Parish, Dorchester, an official and charter member of the St. George's Jockey Club, a Senator representing St. George's 1789-90, a member of the Mt. Zion Society of Winnsboro, and an extensive planter. He was a delegate to the convention which ratified the constitution of the United States on May 23, 1788, and voted to ratify. He first married Sarah PEYRE (b. 29 Nov. 1753, d. June 1774), a daughter of Samuel PEYRE (b. 1715, d. 7 March 1758) and Sarah CANTEY(b. 29 March 1720, d. 24 Dec. 1771) on 20 May 1773. They were without issue and after her death he married Margaret McNEIL of Dorchester in 1775, the widow of Dr. Archibald NcNEIL. Later, on 14 March 1781, Colonel John GLAZE married Johanna DAWSON, daughter of John and Joanna MONCK DAWSON, granddaughter of Joanna BROUGHTON, great-granddaughter of Thomas BROUGHTON, the Lieutenant Governor of South Carolina from 1730 to 1735 and Governor until 1737, the year of his death. The latter's wife was a daughter of Sir Nathaniel JOHNSON, Governor of South Carolina from 1703 to 1709 and sister of Colonel Robert JOHNSON, Governor from 1730 to 1735. Joanna DAWSON GLAZE died at the Congarees in 1781. John GLAZE's sister, Mary GLAZE, was granted large plots of land in Craven County and seemingly died a spinster.

William GLAZE of Ashley River, Charleston married Esther BULLINE (?), daughter of Thomas BULLINE of St. James, Goose Creek. William GLAZE was the father of several children whose names have not yet been ascertained. He died ca. 1765.

Malachi GLAZE, Jr. of Wadmalah, Colleton County, died ca. 1762 with no issue.

<u>Lawrence GLAZE</u> apparently died before the time of his father's demise in 1740, probably in childhood.

James GLAZE, b. 11 June 1737, d. 2 Feb. 1769, married Hannah NASH of St. Bartholomew's on 23 Aug. 1759. James died at Round O, Colleton County on 2 Feb. 1769.

Susannah GLAZE of St. Bartholomew's, Colleton County, married Thomas FORD, a planter of St. Bartholomew's Parish on 28 Aug. 1755. They had the following children: Thomas FORD, Jr., b. 1757, Lawrence FORD, Malachi FORD, and Tobias FORD, b. 1764. Probable later marriages of Susannah GLAZE were to Thomas HALL of St. Philip's on 6 Sept. 1770 and to Samuel BRYAN of 4 May 1790.

The aforementioned members of the family had rather extensive holdings along the Ashley River and were the owners of several plantations outside Charleston, such as Traveller's Rest, Tranquil Hill or White Hall, Eagles, The Ponds or Weston Hall, Glaze's Plantation, Spring Grove, etc. After the Revolution, they also acquired large tracts in the Catawba River area of Camden District, South Carolina.

In addition to those children of Malachi and Sarah JACKSON GLAZE listed above, it is felt that there was another son, named Patrick GLAZE, probably born ca. 1730, who married into the illustrious MIDDLETON family of South Carolina and who lived in Chester and Lancaster Counties, Camden District, South Carolina. In the early eighteen hundreds, viz. 1818, one of Patrick's sons, Middleton GLAZE of Columbia, Richland County, South Carolina, together with a relative, James BOATWRIGHT of the same city, bought large sugar plantations in central Louisiana, and, later, with their families and slaves, migrated to that area. They were soon joined by the family of Aaron PRESCOTT and his wife Elizabeth (?) GLAZE, thought to be a sister of Patrick GLAZE, by two of Middleton GLAZE's nephews, James Braden GLAZE and Zachariah GLAZE (both grandsons of Patrick GLAZE), and by the family of James Ward MURDOCK, a son-in-law of Middleton GLAZE. Previously, in the early 1790's, the family of Col. Frederic KIMBALL, brother-in-law of Patrick GLAZE, had moved from South Carolina and purchased land in East and West Feliciana, Pointe Coupee, and Avoyelles Parishes. Another brother-in-law of Patrick GLAZE, Capt. George WADE, moved his family to Louisiana right after the turn of the century. The three were apparently married to daughters of Donald McDONALD (Daniel), wealthy planter of Craven County, St. Mark's Parish, South Carolina, and heir of the renowned Clan MacDonald of the infamous massacre of Glencoe in 1692. A grandson of Capt. WADE, William Center WADE, was Parish Judge of Feliciana from 1819-1822 and built the beautiful Ellerslie Plantation near St. Francisville. It was with these members that the Louisiana branch of the family was established. They had come from South Carolina to become landholders in what is now seven Louisiana Parishes, to wit, St. Landry, Evangeline, Avoyelles, Rapides, East and West Feliciana, and Pointe Coupee.

VILLE PLATTE IN 1870 by Albert Tate, Jr.

Ville Platte was incorporated as a municipality in 1858. In the federal census of 1870, it is shown to have a population of 135, of whom 100 were reflected as "white" and 35 as "colored". The population included six males and one female of foreign birth, all from France except one male, August MOLITAR, a tanner from Prussia. At the conclusion of this paper, the 1870 enumeration will set forth name by name. However, a few preliminary observations may be appropriate.

From the census enumeration of the 31 dwelling houses and families of the municipality, it is apparent that Ville Platte was primarily a trading center for the surrounding agricultural area. In addition to the druggist, Yves VIDRINE (1), a tanner, and two blacksmiths in town, there were eight retail merchants, while a number of the other households represented dwelling houses inhabited by their employees or house servants. By far the largest retail established was owned by Emile LATOUR, age 27, with a valuation of \$2,000 real estate and \$15,000 personal property (2). The next largest was owned by Marius COREIL, age 58, born in France, with a valuation of \$3,000 real estate and \$3,000 personal property. The third largest retail establishment was that operated by the brothers-in-law, Onezime TATE, age 32, married to Malvina DARDEAU, and Oscar DARDEAU, age 24, married to Coralie TATE (3), with a combined valuation in their single establishment of \$2,000 real estate and \$2,500 personal property.

Ville Platte was in the Fourth Ward (population 4,289) of St. Landry Parish (population 25,553). From the census enumeration, it appears that the post office address for Ville Platte residents was "Bayou Chicot" (4), as was that for residents of the Fourth Ward, which seems to have run north and west of the town, the ward's only incorporated municipality. The post office address of "Flat Town" is found in the census only in a small area of the Third Ward, around (from the names enumerated) Tate Cove. This Third Ward ran north and east of Ville Platte and included the much larger municipality of Washington (pop. 907), whose post office address served most of that ward. The population of Opelousas, the largest town of St. Landry Parish was only 1,544, and that of Grand Coteau, the only other incorporated St. Landry municipality, was 470 (5).

At least as of 1868, Yves VIDRINE was also the postmaster of Ville Platte. See note 4 below. Emile LATOUR, b. 14 May 1843, was the son of Alexis LATOUR and Catherine DESHOTELS. He had married Marie Elizabeth LAZARO, the daughter of Alexandre LAZARO and Elizabeth VIDRINE on 17 May 1866. Alexis LATOUR had died on 16 May 1870 at the age of 65 years, two months before Ville Platte was enumerated on 14 July, 1870. Dates are as reflected in Rev. Donald J. Hebert, Southwest Louisiana Records, Volumes 4 (1976), 8 (1977), and 9 (1977).

Onezime TATE, his wife Malvina, and her sister, Aurore DARDEAU, a member of his 1870 household (see below) were all to die of yellow fever in September and October, 1870, shortly after the census was taken. See Dardeau, "The Dardeau Manuscript", La Voix des Prairies, Vol. 3, No. 9 (April, 1982), 23 at 24, 26.

The "Coralie DARDEAU", age 16, listed in the joint household (#10) of Onezime TATE and Oscar DARDEAU, is Coralie TATE, b. 16 Dec. 1853, m. Oscar DARDEAU on 21 June 1870, shortly before the census enumeration. She was the daughter of Hilaire (Eli) TATE, b. La. 1828 (household #18 on the enumeration), and the enumerator was in error in checking her father as of foreign birth. See Dardeau, Id.

The Census of 1870

The enumeration of the municipality of "Ville Platte, in the Fourth Ward" is found at pages 243 through 245 of the 1870 federal census of St. Landry Parish. It was taken on July 14, 1870, by T. H. THOMPSON, Assistant Marshall for (census) subdivision No. 98, with post office address of Bayou Chicot, LA, who enumerated all of St. Landry Parish.

The enumeration of each household below will include (a) the census-enumeration number of the "dwelling house" and the "family" (which were the same for all enumerations in Ville Platte), in order of enumeration; (b) the name of the person enumerated, and that person's (c) sex ("M" for male, "F" for female), and (d) color ("W" for white, "B" for black, "M" for mulatto, as designated by the census). Indented below a name will also be the following information, if listed on the census: occupation; place of birth, only if other than in Louisiana (no notation means the person is shown as born in Louisiana); whether father or mother or both were of foreign birth; and, if a child born within the year, the month of birth reflected by the census. We should also note that, except in the case of children born within the year (age designated by fraction of 12/12), the census instructions required that the age be listed as of the last birthday before the date of enumeration (i. e., for Ville Platte, July 14, 1870).

The census columns also reflect other information that may be of interest but which is now omitted for reasons of length. The listings include information as to the value of real estate and of personal property owned, whether the person could not read or could not write (1870 Ville Platte included 30 adults unable to read or write), whether the person was deaf, dumb, blind, etc. (none listed for Ville Platte), and whether the person was a male citizen of the United States eligible to vote or not. It also included a space to mark the date of marriage if married within the year; however, this information completed for no Ville Platte couple. One interested in such data as to a particular person is sed to consult the 1870 census enumeration itself. (A microfilm printout of the Ville Platte enumeration is on file at the Evangeline Parish Public Library in Ville Platte.)

FRANCOIS GUYON DESPRES d'HERBANNE, EARLY LOUISIANA PIONEER by Thomas M. McBride

Francois GUYON Despres d'HERBANNE was born at Beauport, a suberb of Quebec, in 1671. His great-great-grandfather, Mathurin GUYON, from the House of de la Rochefoucauld, lived near Rouen about the year 1530. The ancestral GUYON chateau-forte is located at the town of la Roche-Guyon, on the Seine River, northeast of Paris, almost halfway to Rouen. His grandfather, Jean GUYON, who added the name de DuBUISSON to his name as his lands were of that Seigneurie, arrived in Canada in 1634 while his father, another Francois, was born in 1639 at Quebec and married Marie Madeleine MARSOLET de Saint Aignan. It was this Francois GUYON who added DesPres to his name. They were wed in 1662. Marie Madeleine MARSOLET was the great-great-grand-daughter of Etienne MARSOLET of Rouen. Her great-grandfather, her grandfather, and her father were all named Nicolas MARSOLET. Our subject, Francois GUYON, added d'HERBANNE to his name. The progression of surnames tacked on to GUYON is explained: de DuBuisson was the tract of land granted to Jean GUYON; DesPres meant the lands were meadows; d'Herbanne meant the weed, Queen Anne's lace, grew in profusion on the meadows!

Francois GUYON Despres and Marie Madeleine MARSOLET had twelve children, enough to qualify for a cash grant from King Louis XIV. Their fifth son was Francois d'Herbanne. As the son of the leading naval merchant in Canada, he matured into an adept seaman and businessman. No doubt, Francois knew some Indian languages as Nicolas MARSOLET de Saint Aignan, his grandfather who had arrived as a lad with Samuel de CHAMPLAIN on the first voyage to Canada in 1603-04, was an explorer as well as the French Ambassador to the Indians. Nicolas MARSOLET had helped the Jesuit and Recollet fathers in establishing missions and translating the Indian languages into French for their catechisms. Francois d'Herbanne gained further experience in frontier life as an "engagé" of Pierre-Charles LeSUEUR, a mining engineer who travelled as far as St. Anthony's Falls (present day Minneapolis) in his search for mines. Francois was familiar with all the Great Lakes regions as well as the Illinois country.

At that time Canada was alive with intrepid explorers. The LeMOYNE family produced five famous ones with Pierre LeMOYNE, Sieur d'Iberville the brightest star. It was with d'Iberville that Francois d'Herbanne sailed to France in 1698, helped outfit the four vessels that eventually left from Brest on 24 Oct. 1698 with 200 colonists plus soldiers aboard. The earlier sailing from LaRochelle was aborted as the flag ship, LaMarine, was shipping water. Their destination was the Gulf Coast, territory recently claimed for France by LaSALLE. France was anxious to establish a colony on the Gulf Coast before the English could claim it for their own. Francois was Commander of the fourth ship of the flotilla, Le Voyageur. They arrived at Mobile Bay on 31 Jan. 1699, but sailed westward to where Biloxi/Ocean Springs now stand as the anchorage was better. Francois along with d'Iberville and the other colonists, planted the French flag on the sandy beaches of Isle de Maurepas. They set about building Fort Maurepas immediately. By 1702 the colony had established Fort St. Louis at Mobile and Francois d'Herbanne was listed as "garde magasin du Roy" on Isle Dauphine. In July, 1699, he captained the boat that ferried supplies to the colony from Saint Domingue (Haiti). Between 1699 and 1717 he explored the Mississippi, Missouri, and Red Rivers. In his memoires he states he was the first white man to explore the Missouri River for upwards of 400 leagues. He led trading expeditions to the Spanish forts in Texas and the Rio Grande; he was Governor Bienville's business agent, kept records of the colony's activities and even returned to France for supplies with which to trade with the Spanish and Indians.

It was inevitable that the colonists would clash with various Indian tribes of the deep South, although, on the whole, relations with the Indians were rather peaceful. The Chitimacha Tribe were retaliated against after members of this tribe murdered the missionary priest St. Cosme in 1707. Three raids against the Chitimachas resulted in perhaps seventy-five or more Indian prisoners who were taken to Biloxi and Mobile. One of the prisoners, an adult maiden, became the slave and housekeeper of Francois for three years; then his wife. Her name was Jeanne de la Grand Terre (Ce' Pinu'nc in Chitimacha). They were married in 1710 by Pere Alexandre HUVE. A son, Jean Baptiste GUYON Despres d'HERBANNE, was born to them on Isle Dauphine.

Francois and Jeanne heeded Governor BIENVILLE's order to establish Fort St. Jean Baptiste at Natchitoches. They joined in the founding of that post in 1714 and three years later, in 1717, moved permanently to Natchitoches. Five more children were born to them. One of these children, Gaspard Derbanne, is in direct lineage to this author. Darbonne Lake, Bayou Darbonne and Darbonne State Park are named for Gaspard Derbanne.

The stories are legion about those indomitable Canadians and a heritage of great value was passed on to their descendants. There is a wealth of Derbanne descendants who can take pride in the pioneering accomplishments of Francois and Jeanne.

1816 DYE RECIPES Submitted by Josie Griffith Horne

The two recipes that follow were written in a student's notebook, now in the possession of Josie Griffith Horne. The notebook belonged to E. BURNETT, a student of B B Academy, St. Landry Parish, 1816 and 1817.

Saxon Blue

1 tb. of Indigo 5 tb. of Smoking Sulphuric Acid, Or, 8 tb. of Common Sulphuric Acid 12 tb. of Rain water,

The indigo in fine powder is to be mixed with the acid gradually, stirring all the time, the vessel (earthenware or glass) containing the acid sitting in cold water or ice, Then it must be closely covered for forty-eight hours, And then the water added to it. When used it must be diluted with four or five times as much rain water - The preparation is put in glass demijohns will Keep for an indefinite length of time.

This is the most beautiful of all blue dyes. But it is expensive and requires a skilful workman to manage it, and is not fit to be used by any but who have been taught dying as a trade.

The hot indigo vats prepared with bran, potash, madder, etc, can not be used except in regular dying establishments. The preparation requires a length of time, and proper fumacis.

To dye a pure black, first give the stuff a bluetinge the same as if you wanted a permanent blue, and when thoroughly dry, dye it black.

[Editor's Notes: The word "demijohns" is a large bottle of glass or earthenware, with a narrow neck and a wicker casing and handle; the word "madder" means any of a number of related plants that yield medicines and dyes, especially, a vine with small, yellow flowers and berries; or the red root of this plant or a red dye made from this; a bright red or crimson.]

English Blue for Cotton, Cold Dye

1 tb. of Indigo in fine powder

3 tb. of Coperas, good

3 tb. of Slaked Lime

Mix the indigo in three gallons of boiling water-Rain water of river water - Then add the lime, Mixing all well together. Dissolve the coperas in three gallons of boiling water-Rain water or river water. Mix the solution of coperas with the indigo and lime mixture, and stir frequently during the first twenty four hours.

The vat ought to be wood or earthen-ware.

The cotton yarn or cloth to be dyed must first be boiled in weak lye, or, what is better, a weak solution of soda, say half a pound in ten gallons of water, Then dried in the sun or before a fire, Then dip it in the indigo vat, and let it remain ten minutes stirring it about, Then take it out and hang it to drip over the vat, Then dry it as before, Then dip it again as at first in the indigo. Then dry it again, And so on until you get the tint as deep as you want it. Three or four dippings in the indigo vat will give a deep blackish blue, - Once dipping will make a light blue, Twice a shad deeper, etc.

After the last dipping the material must be well dried, and then rinsed well in water contained one fluid ounce of sulphuric acid to ten gallons - and then in clean water. Well water will answer as well as any for this rinsing. To dye wool it must be entirely cleaned of grease by washing in soap suds and then rinsed in clean water and dried, Then it must be boiled for half an hour in strong alum water, Then dried, and then dipped in the indigo vat, and remain there several hours; and then be dried and boiled again in the alum water for a few minutes; and then dried, and dipped in the indigo vat, and permitted to remain there several hours as at first, stirring it about frequently, The same procedures to be repeated until you obtain the desired tint, After the final drying it must be rinsed through clean water only.

In all the operations of dying the material whether cotton or wool must not be wrung out, or the dye stuff will be washed out. Gentle handling and thorough drying alone will fix the colors. Nor must it ever put dripping from one fluid into the other.

This is the cheapest and most permanent blue dye of the English manufacturists.

[Editor's Note: Coperas is properly spelled "copperas"; ferrous sulfate, FeSO₄.-7H₂ - A green, crystalline compound used in dyeing or the making of ink]

PIERRE TRAHAN & ANNE BRASSEUX by Terry Landreneau

(Mr. Landreneau has inquired, for the past several months, into Anne BRASSEUX and Pierre TRAHAN and feels that he has found the proof that Pierre TRAHAN, son of Honore TRAHAN and Marie CORPORON, married (1st) Anne BRASSEUX and (2nd) Pelagie GAUTREAU. The following is his explanation of that research.)

I have not yet been able to find the marriage records of Pierre TRAHAN and Anne BRASSEUX, so in order to prove parentage, I began with the 1777 census of Opelousas. Anne BRASSEUX of Opelousas is shown as being age 23, putting her birthdate ca. 1754.

Referring to Acadian Exiles in the Colonies, p. 131, at Georgetown, Maryland in 1763, I found (1) Elizabeth BRASSEUX, (2) Pierre, (3) Marguerite, (4) Marie Magdalen, (5) Marie, (6) Blaise, (7) Ann, and (8) Marie

In <u>Some Late 18th Century Louisianians</u>, p. 433, is a list of Acadians who left Baltimore, Maryland and 'arrived in <u>New Orleans</u>, LA on July 27, 1767. On that list are (1) Isabel (Isable) BRASIEN, age 50, (2) Blaise, son, age 15, (3) Marie Marguerite, daughter, age 22, (4) Marie Magdalen, age 20, daughter, (5) Marie Anne, daughter, age 18, (6) Anne, daughter, age 14, (b. ca. 1753), and (7) Marie Rose, daughter, age 12. Also listed separately is Pierre BRASSEUX; he was married and had a child by that time.

*In the 1777 census of Opelousas, I found the following BRASSEUX; (1) Blaise, age 25, (2) Anne (wife of Pierre TRAHAN), age 23 (b. ca. 1754), (3) Marie Rose, age 20, (4) Marie, age 30, and (5) Marie, age 28.

In Bona Arsenault's <u>Histoiré ét Genealogié des Acadians</u>, new edition, it shows Cosme (Come) BRASSEUX . married to Elizabeth THIBODEAUX and their children as Charles, b. 1735, Joseph, b. 1742, Margaret, b. 1744, and Marie Magdalen, b. 1746. Because of the dates of birth of the children in the records above, I feel certain that this is the same family that shows up in Opelousas.

Regarding Pierre TRAHAN, I used the census records above and an article in <u>La Voix des Prairies</u>, Vol. II, #5, that tells how this group of Acadians arrived in Louisiana. Also, the census of 1788 does not show any women old enough to be of child-bearing age, only children, so it appears that Anne BRASSEUX was deceased by then, leaving only Pierre TRAHAN and children in the household.

The most significant or conclusive evidence I have is derived from the sale correction made by Etienne TRAHAN. Etienne TRAHAN, son of Pierre and Anne BRASSEUX, gave his brother, Pierre, power of attorney to sell his property. Pierre sold it, but there was a problem in the amount of land sold. Etienne, in a sale correction to avoid legal problems with the purchases, states that he received this property from his deceased father Pierre, and part of it came from his deceased grandfather Honore TRAHAN. Also, in separate sales are Pierre and Charles, Marie Rose (children of Pierre TRAHAN and Anne BRASSEUX) and Alexandre (son of Pierre TRAHAN and Pelagie GAUTREAU) who all sell their shares of their undivided estate of their father, Pierre TRAHAN. There are three different documents here, and all show that the undivided estate of the children of Anne and Pelagie have the same boundaries.

From these four documents I conclude that (1) Pierre TRAHAN married twice, first to Anne BRASSEUX and second to Pelagie GAUTREAU, and (2) that Pierre TRAHAN is the son of Honore TRAHAN and Marie CORPORON.

If anyone has more information on Anne BRASSEUX and her parentage, I would appreciate any help.

THE SYLVESTERS OF THE SPANISH OPELOUSAS POST AREA, 1766-1803: Reflections of Their Origins and on Further Lines of Research Inquiry by Albert Tate, Jr.

The SYLVESTERs of the Evangeline-St. Landry Parish area stem from one of our earliest colonial settlers. Joseph "SILVESTRE" purchased land in the Grand Prairie area in 1774. Therese (also called Marie) SILVESTRE, wife of Jacques BRIGNAC and possibly Joseph's sister, was among the French soldiers from French Alabama who came with their families to the Opelousas Post area and were listed in the 1766 Opelousas census. The information on two documents in the St. Landry Parish Catholic Church records, the death of his daughter Françoise on 26 Aug. 1815, Vol. 1, p. 146, church records and the marriage of his son Pierre to Jeanne (Eugenie) O'CONNOR (the ancestors of all of the present-day SYLVESTERS in Evangeline and St. Landry Parishes) on 7 May 1816, Vol. 1, p. 284, provide important clues to Joseph's origins and to the identity of his wife, Catherine. This paper attempts to set forth, for SYLVESTER researchers, various SYLVESTER data that, collated with the information on these two church records, suggests further lines of inquiry. The paper also includes information as to Theresa (Marie) SYLVESTRE and her husband, Jacques BRIGNAC, also among our earliest settlers.

Joseph SYLVESTER, described as age 44, and his wife Catherine "AYRE", age 30, with child Marie, age 10, first appear in the Opelousas census of 1777 (see Voorhies, p. 290). The two church records are of interest as corroborating that Joseph originally came from French Mobile and also as perhaps affording a clue to the family identification of his wife Catherine. In the various church records of the baptisms of her children, her name is variously spelled as HAIS, HOLLER (HOYE), HOYERS, HAILE, etc.; one supposition is that she is a sister of Marguerite, wife of Jean Baptiste GUILLORY, and of Magdalene, wife of Joseph La Rose FONTENOT pere, who were daughters of Nicholas HAY (HAYER, HAYDE, HEYD) and Marguerite FOLCH (VOLZ), who were deported from Metz in 1753 and first settled in St. Charles where they appear with daughters in a census in the 1760's.

We should also note the following documented facts concerning Joseph SILVESTRE: he first acquired land in the Opelousas Post area on 15 Oct. 1774 (see State Archives, Opelousas Colonial Records). Prior to that, he was in Iberville Coast area where he appears as a sergeant in the militia, described as age 30 in a February 1770 and a 1771 muster roll (La. Genealgoical Register, Vol. 9, p. 54 [1962]) and where he shows up in the census for Manchac of 1772 described as age 35 or 39 (figure hard to read) with his wife of age 24, a son of age 2, and a daughter of age 5 (see GI-PPC legajo 202, folio 240 at 242). In AGI-PPC leg. 202, atp. 202, the commandant mentions "SILVESTRE", described as an interpreter, and that individual's claim to a preferred land for his grant because he was the "first settler in the Manchac" district.

With regard to the two church records, the death record of his daughter Francoise of 26 Aug. 1815 identifies her as the legitimate daughter of Joseph SYLVES" and of Catherine " - - - - - ", originally from Mobile. This would corroborate the indications from other SYLVESTERS (the Therese married to BRIGNAC, for instance) that Joseph SYLVESTER (SILVESTEE) was among those who left French Alabama after its surrender to the British in 1763, like the FONTENOTS and the GUILLORYS. Unlike the latter, however, Joseph apparently migrated just across the line into the Manchac area, before arriving in the Opelousas Post area. What is further of great interest about this death certificate, however, is its indication that Joseph's wife Catherine also was originally from Mobile. While the accuracy of this information is doubtful (the person who so informed Fr. BARRIERE, the priest making the notation, did not even know Catherine's family name), if in fact it is of some truth, then it would appear that Catherine came from one of the Mobile families, probably a French "HAY" there then. (I should note that Francoise was baptized on 4 Oct. 1777 in Opelousas so that she was born apparently after Joseph came to Opelousas—her 1815 death certificate describes her as 36 years of age, which is close enough to be assured she was the same person.)

With regard to the second church record, the marriage of Pierre SYLVESTRE and Jeanne O'CONNOR (Eugenie O'CONNOR) of 7 May 1816, it describes Pierre as a "native of this parish" (St. Landry of Opelousas) and the legitimate son of Pierre SYLVESTER, a native of Alabama and of Catherine HAYDEL, a native of the river (parishes—i. e., St. Charles, St. John the Baptist)". Although the priest wrote the father's name as "Pierre", it is most probably (but not certainly) a mistake, and that the groom is the Pierre SYLVESTER, son of Joseph and "Catherine HAY", b. 9 Oct. 1789 (Opelousas baptismal records, v. 1., p. 156) This record should be checked to see if by any chance grandparents' names are inscribed; the reference is to Fr. Hebert's abstract of it (Hebert SW La. Records, Vol. I, p. 531). No other Pierre SYLVESTER is abstracted in Hebert as baptized during the years in question. This marriage record leads to two lines of query at least: (1) the reflected identity of Catherine HAYDEL, if the spelling is accurate and (2) the possibility, not great, that the groom's father was correctly reflected as a (previously unknown)

Pierre SILVESTER.

With regard to (1): If indeed the correct spelling of Catherine's surname is HAYDEL and she came from the river parishes, her family can be placed as a descendant of Ambroise HAYDEL, who came about 1720 or 1730 and one of whose sons was Nicholas HAYDEL. This would seem to negative her being a sister of Marguerite and of Magdalene HAYER (wives of J. Bte. GUILLORY and Joseph LaRose FONTENOT respectively) since the records definitely indicate their father as a Nicholas HAYER (HAIDE--really HEYD) who is with

a fair amount of certainty identified with a Nicholas HEYD who was deported to St. Charles in 1753. However, the "HAYDEL" spelling by the priest may be in error. The surname was constantly misspelled, and perhaps the surname was really "HAIDE" (one of the HEYD variations) and perhaps she is truly the sister of Marguerite and Magdalene. The baptismal certificates of the eight children of the Joseph-Catherine marriage should be scrutinized for clues, as well as the marriage certificates of those children who survived to majority and the baptismal certificates of their children.

As a further aside on Catherine's identity: Whether Catherine's father was a HAYDEL or Nicholas HAIDE, one must wonder where and how Joseph met and married her. So far as we now know, Joseph was in the Manchac area about 20 miles below Baton Rouge some time after 1763, while the HAYDELs never left the St. John the Baptist area about 30 miles further downriver. (However, until St. Gabriel was established in 1769, the downriver St. Charles and intermittently St. John the Baptist churches were the closest Catholic Church. See C. E. Nolan, A Southern Catholic Heritage, Vol. 1, Colonial Period, 1704-1813, [1976].) Of course, it is not impossible that Joseph went accourting from the then-wilderness of Manchac to the settled St. John area. Also, after the English acquired the northern side of the Manchac Bayou in 1763, the Spanish government made efforts to settle Germans and Acadians on the southern side (where Joseph was allegedly the oldest settler) and perhaps his bride's family was among those who settled on Manchac. Indeed, Nicholas HAYER does not show up on any St. Charles and St. John the Baptist census after 1763 (St. Charles)--although his second marriage to Rene BARBEE on 4 Jan. 1778 (St. John the Baptist, Edgard, LA, p. 8A) is believed to be reflected--, while the 1772 census of Manchac shows as the household immediately preceding Joseph SYLVESTRE's a "Nicaulary, aged 68 years, with wife age 48 years. (AGI-PPC leg. 202 at folio 242.)

One last additional comment concerning Catherine's identity: The 1772 Manchac census shows that Joseph and his 24 year-old-wife had two children, a girl, five years of age and a son, two years of age. The son does not appear on the 1777 census, but the only child in that household is Marie, age 10, apparently the girl in the 1772 household. The Manchac census was taken 10 May 1772 and the Opelousas census 4 May 1777. Marie was probably born between May 1766 and May 1767. If Catherine was the mother of this child, then the marriage presumably took place no later than 1765-1766. This, more probably than not, was after Joseph SYLVESTER left Mobile when the English arrived in 1763-64. The marriage could have taken place later, however, if Marie was the child of a former marriage. However, Fr. Hebert's abstracts show the following with regard to Marie. She was described as the daughter of Joseph SILVESTER and "Catalina Alere" at her marriage in the Opelousas church on 25 April 1787 (Vol. 1, p. 1) and she is shown as dying at the age of 22 in July or August 1788 (Vol. 1, p. 8; Hebert, Vol. 1, p. 530). Since "Catalina" is Spanish for "Catherine", while "Alere" is par for the course in the Spanish misspellings of HAYER, HAY, HOYER, etc., the probabilities are that Marie is a child of the Joseph-Catherine marriage, unless he was married to two different Catherines. The original church records should be examined.

I note, without exploring the circumstances, one further indicia of a possible Joseph SILVESTER-HAYDEL connection. Glenn Conrad's books on colonial St. John the Baptist pick up a Francois SILVESTRE who lived in the neighborhood of Nicholas HAYDEL. Francois is not as yet identified, but the possibility exists that he was a brother of Joseph likewise emigrating to Spanish Louisiana after the English took Mobile.

It may also be appropriate to note certain further potential clues to Joseph SYLVESTER's Mobile background. The only SILVESTER who has so far surfaced in the published Mobile records is a Claude SILVESTRE, a soldier at Mobile in the French company stationed there (DeVille, "Louisiana Troops 1745", National Gen. Society Quarterly, Vol. 56, No. 1, March, 1968, 32 at p. 40) and who was pensioned at half-pay by the French military on 11 June 1764 (DeVille, Louisiana Troops 1720-1770, Fort Worth, 1965). (This unpaginated work likewise reflects that Joseph FONTENAU was similarly pensioned at about the same time, and that Jean Louis, Louis, Phillipes, and Pierre FONTENAU were discharged about the same time, all of whom showed up in the Opelousas Post area shortly after the surrender of French Alabama to the Brittish following 1763.) One may speculate that Claude was the father of or some relation to Joseph. However, the Mobile church records seem not to have recorded marriages or baptisms when performed by military chaplains, and it may be that the best available clue to Joseph's parentage may be in the Opelousas church records, such as if the baptisms or marriages of his children reflected their parentage, as was however only more rigorously accomplished after the bishop's visit in 1796 criticized the records for their deficiencies in this regard.

We should also note that in both Fr. Hebert's works and in the Spanish censuses collated in Voorhies' Some Eighteenth Century Louisianians (Lafayette, 1973), the only SYLVESTERS listed aside from Joseph and his children are Therese SILVESTRE, age 34 in the Opelousas 1777 census, wife of Jacques BRIGNAC, both of whom indicated in church records as originating in Alabama, and Claude SILVESTRE. This Claude may well be the pensioned soldier described in the preceding paragraph. Claude SILVESTRE, age 62, described as "orphan" (which I translate "without family") is found in the 1777 census of Opelousas in the household of Joseph LaRose FONTENOT and Magdalene HAYS (see Voorhies, p. 293), that is, in the household a daughter of Nicholas HAYER (HEYD), whom we speculate might be a sister of Catherine, wife of Joseph. This household

is immediately adjacent to that of Jacques BRIGNAC-Therese SILVESTRE and their four children; it may, of course, be possible that he was living in the childless household next door because it was more comfortable than living with his daughter and her children (if he was her father), but the probabilities would seem to indicate a less close relationship. Again, perhaps the most fruitful source to discover Therese's parentage should be the Opelousas church records, but unfortunately, none of her children (aged between 4 and 12 in 1777) were born (or at least baptized) in Opelousas. The only potential lead reflected by Hebert's abstracts of church records is the marriage of their son Francois to Marie Louise FONTENOT on 21 May 1794 (Opelousas Church, Vol. 1, p. 50), and the baptisms of their children (some of which occurred after the bishop's 1796 visit required that grandparentage be shown): Celeste, bt. 15 March 1801 (v. 1, p. 242), Emelie, bt.16 May 1809 (v. 1, p. 511), Firmin, bt. 19 July 1807 (v. 1, p. 418), Francois, bt. 16 April 1797 (v. 1, p. 175), Henriette, bt. 4 June 1795 (v. 1, p. 132), Marie Louise, bt. 25 July 1802 (v. 1, p. 283), and perhaps others, in Volume 2 of Hebert. Likewise, the marriages of these children might include information as to grandparentage. I note also that Marie Joseph, a daughter of Jacques and Marie, was married 7 July 1788 to Pedro VIDRINE (v. 1, p. 16) and the baptisms and marriages of their children may shed light on Therese SILVESTER's parentage and her relationship to Joseph and to Claude.

The absence of baptisms of the BRIGNAC children in the Opelousas church records probably reflects that they were among Fr. Valentin's missing records, of which the new pastor Fr. de ARAZENA complained in 1787 (see Nolan, cited above, at page B9-1), for BRIGNAC was one of the French soldiers from the garrison at Fort Toulouse who (along with the FONTENOTs and others) in early 1764 migrated from Mobile via Pointe Coupee to the Opelousas Post area and received grants there. (Brasseaux, "Opelousas the Alabama Immigrants 1763-66", Attakapas Gazette, Vol. XIV, No. 3, Fall, 1979, 112 at pp. 114, 117) He is found in the 1766 census of Alabamas at New Opelousas (Grande Prairie) on the right bank, being listed as having in his household one woman (his wife), and 1 boy (apparently Jacques, age 12 in 1777), and two girls (who, from the ages of the 1777 daughters, 6 and 8, did not survive). The published indexes to the Opelousas colonial archives do not reveal that any records of his transactions survive, however, that he acquired land is certain, for his estate (25 July 1883) is found in the Louisiana State Archives (J. O. Vidrine, The Opelousas Post, 1764-1789, Baton Rouge, 1979, p. 19) as is a request by his widow to sell land, 14 Aug. 1788 (Id., p. 48) Perhaps these estate proceedings will reveal any relationship between Therese (sometimes called Marie Denis) and Joseph, such as his appearing at a family meeting on behalf of the minors or serving as their undertutor. With regard to Jacques BRIGNAC himself, he is listed without detail as a French soldier in Winston DeVille's Louisiana Troops 1720-1770 (Fort Worth, 1965), but another entry shows Mathieu or Jacques BRIGNAC as discharged 15 Sept. 1763 and granted a French military pension, Id. while there is also reference to a Jacques Simon BRIGNAC, who died at the Alibamons on 10 Aug. 1754, and to a Michel and a Pierre Simon BRIGNAC, who were discharged the same date as Mathieu (Jacques), Id. In the Mobile civilian church records, a Marie Francois BRIGNAC is shown as buried on 17 Nov. 1758, she being the wife of Etienne POIRIE, sergeant-major at Mobile, who was buried 8 Dec. 1759 (Winston DeVille, Gulf Coast Colonials, Baltimore, 1968, p. 54). She is quite possibly a sister to Jacques.

Finally, since research in the Mobile church records may uncover further details regarding these SYLVESTERs and BRIGNACS, an effort will be made to approximate birth and other family dates as indicated by the Louisiana records many years after the fact, also recognizing that census ages are often inaccurate guesses by an enumerator: Joseph SYLVESTER - a death record indicates he died 10 Oct. 1810 at the age of 70 years, which would indicate a birth in Mobile ca. 1740. This accords closely with his age as shown in the 1770 Iberville militia, approximately with his age in the 1772 Manchac census, but the age of 44 given for him in the 1777 Opelousas census is obviously in error; Catherine Hayo SILVESTER - as noted, she was probably born on the German Coast, not in Mobile. She is shown as 30 in the 1777 census, 24 in the 1772 Manchac census, which indicates a birth date ca. 1747-48. As noted, the marriage occurred no later than 1765-66; Jacques BRIGNAC - the Opelousas church records indicate he died 8 Oct. 1781 at the age of 44 years, which indicates a birth at Fort Toulouse or Mobile ca. 1737. This accords with his age of 40, as reflected by the 1777 census; Therese (Marie Dion) Sylvester BRIGNAC - she is shown as age 34 on the 1777 Opelousas census, which indicates a birthdate ca. 1743, probably in Mobile. Her first surviving child was born ca. 1765, but in the 1766 census she had two other children who did not survive until the 1777 census. It is possible this marriage took place in Mobile or Fort Toulouse before the migration via Pointe Coupee to Opelousas; Claude SILVESTER - the 1777 census states his age as 62, which indicates a birthdate ca. 1715, almost certainly in France prior to his enlistment.

I now conclude these reflections that were set in motion by the data noted on the two SYLVESTER church records initially described. My hope is that, by collating and summarizing the information discovered by me, I may suggest to other researchers possible additional significance of data discovered by them, as well as lines of future inquiry. It would be my further hope that those who have or will discover findings of interest will communicate them to <u>La Voix</u>, so that perhaps with all our efforts we may bring to light the full story of the interesting SYLVESTER family and of the equally interesting BRIGNACs.

Marguerite BROUSSARD is the daughter of Simon BROUSSARD and Marguerite BLANCHARD, not Jos. BROUSSARD and Marguerite SAVOY. There is a Marguerite BROUSSARD, the daughter of Jos. BROUSSARD and Marguerite SAVOY; however, she married Jean Baptiste BERNARD on 25 June 1782.
